PRESS RELEASE

Revision of the results of the 2011 Population and Housing Census for the Resident, De Jure (registered) and De Facto population of Greece

The Hellenic Statistical Authority informs users that after the completion of the processing and checking of the data collected during the 2011 Population and Housing Census, small discrepancies were observed compared with the initially released data and thus it announces revised data for the:

- **Resident population** (Greek and foreign residents who have their usual residence in every level of administrative division of the Country),
- **De Jure population** (i.e. the number of citizens registered in each Municipality of the Country) and
- De Facto Population (as defined in the public notice on General Censuses with ref. No 1524/Г5-473/2011, published in Government Gazette No 425, Issue B, 2011), namely the number of individuals who were present on the reference date of the Census (9th of May 2011) in every in every level of administrative division of Greece, as derived from the conduct of the 2011 Population and Housing Census.

After the completion of the processing of all the questionnaires and the additional checks in the database of the 2011 Population and Housing Census, the following were observed:

- 1. A very small number of questionnaires (approximately 0.01% of the total resident population) had not been included in the database in the first place.
- 2. A very small number of individuals were recorded under an erroneous geographical code.

The aforementioned observations have only a slight impact on the Resident, De Jure and De Facto population of the Country. The underlying changes, in absolute numbers, are presented analytically, at the level of the Municipality, and in cases where changes do exist in the initially released data, in the following table:
