The Hellenic Statistical Authority (ELSTAT) and Eurostat are pleased to invite you to the *European Conference on Quality in Official Statistics (Q2012)* which will be held in the "Megaron Athens International Conference Centre" in Athens, Greece, on 29 May – 1 June 2012.

The Quality Conferences started in 2001 when the first Conference was held in Stockholm to develop further the conclusions of the Leadership Group on Quality. One of the recommendations of the Conference was to organize Quality Conferences biennially. So far, five Q-conferences have taken place: Q2001 in Stockholm, Q2004 in Mainz, Q2006 in Cardiff, Q2008 in Rome and Q2010 in Helsinki.

Similarly to its predecessors, the Q2012 Conference will offer participants a unique platform for high-level discussions on various types of quality issues and methodological aspects of statistical production. Q2012 will in particular focus on improving quality by the re-engineering of statistical systems and the innovations in the area of quality.

In addition, a series of short training courses will take place on 29 May 2012.

The Conference website will open by September 2011. Information will be given on the conference venue, accommodation, short courses and leisure-time activities and deadlines for submission of papers. The website address is <u>www.Q2012.gr</u>.

Call for papers

Colleagues are invited to take a look at the list of topics and consider submitting an abstract for evaluation. The Q2012 Conference will select papers on the basis of these abstracts. The abstracts should be submitted to the Conference e-mail address <u>Q2012@statistics.gr</u> by 15 November 2011. Their length should not exceed 200 words in either MS-Word (.doc) or pdf-format. The authors will be informed of acceptance by the end of January 2012. Instructions regarding the submission of final papers will be provided at the same time.

Topics

The Conference encompasses relevant topics for improving quality. Areas covered by the Conference are the following:

I. QUALITY MANAGEMENT

Presentations of developments and good practices on quality management related to the following topics:

- Models for quality management
- The European Statistics Code of Practice
- Measuring quality
- Process quality
- Quality assessment
- Standardisation tools
- Communicating quality to users
- Satisfying user needs
- Human resources

II. IMPROVING QUALITY BY THE RE-ENGINEERING OF STATISTICAL SYSTEMS

The re-engineering of statistical systems aims to produce more statistics in a more efficient way and brings a wide range of new challenges to improve quality. The elements below encompass broad areas in which process and output quality could be improved:

- Enterprise architecture
- Process integration and standardisation
- Metadata systems and other infrastructure elements
- The role of administrative data and administrative registers in the re-engineering of statistical systems
- Quality assessment in integrated production models
- New, experimental and model based statistics and quality standards
- The role of self-regulation and legislative frameworks

III. INNOVATIONS IN THE AREA OF QUALITY

New methodological developments leading to quality improvements, as well as quality assessments of non-traditional data sources used for the statistical production are targeted below:

- Total survey design, responsive design
- Mode and non response effects and their treatment
- Total survey errors and bias correction
- Combining data sources and integrating data
- Quality assessment of new data sources (internet, use of private data)
- Measuring cost efficiency and response burden in statistical surveys
- Small area estimation techniques

Training courses

Five one-day courses will be organised on 29 May 2012. The courses will be held at the Megaron Athens International Conference Centre. The topics of the courses are available on the Conference website.

The Q2012 Conference will be held at the Megaron Athens International Conference Centre (www.maicc.gr/en).
