

# **ELSTAT** HELLENIC STATISTICAL PROGRAMME 2020 – 2022

**PIRAEUS 2019** 

# A. INTRODUCTION

Article 5 of the Statistical Law 3832/2010 "Hellenic Statistical System (ELSS) Establishment of the Hellenic Statistical Authority (ELSTAT) as an independent authority", as amended and in force, provides for the compilation, every three years, of a three-year statistical work programme for the ELSS, entitled Hellenic Statistical Programme (ELSP). The ELSP sets out the priorities for the works of the ELSS –i.e., ELSTAT and the other agencies of the ELSS– so that the Country's statistical system can meet the EU and international obligations for the statistics required to be compiled. These priorities take also account of the human and financial resources required, as well as the administrative burden arising from the compilation of the relevant statistics.

The ELSP 2020 - 2022 is the fourth three-year statistical work programme of the ELSS. The previous three programmes concerned the three year-period 2011 - 2013, 2014 - 2016 and 2017 - 2019. It includes the main fields and targets of planned statistical actions of ELSS agencies for the aforementioned three-year period. These statistical actions can be either planned regular actions or ad hoc actions aimed at dealing with new needs. The ELSP 2020 - 2022 is the basis on which the ELSS agencies will compile their annual statistical work programmes for the years 2020, 2021 and 2022.

The basis and reference point for the compilation of the ELSP 2020 – 2022 was the extension of the European Statistical Programme for 2018 – 2020, as well as the strategic priorities of the European Statistical System (ESS) beyond 2020, adopted during the meeting of the European Statistical System Committee (ESSC) on 16 November 2017 and which are classified in 3 main areas:

- <u>Satisfying the needs of users of statistical data</u>: ensure the relevance of the statistics produced for users and the satisfaction of their needs to the maximum extent possible.
- <u>Developing appropriate skills</u>: making the most of the resources available for producing statistics and the
  potential of modern technologies.
- <u>Developing effective partnerships in the ESS</u>: close cooperation between the ESS members, as well as between the ESS and other agencies (international organisations, the European System of Central Banks, Universities, the media, etc.), for the continuous improvement of European statistics.

The new European Statistical Programme will be included in the next Multiannual Financial Framework (MFF) 2021 – 2027.

Part B of the ELSP contains information on the objectives of ELSTAT and the ELSS, in general, as regards the consolidation of the achievements pertaining to the quality of the ELSS statistics and its continuous improvement.

Part C of the ELSP contains information on the actions of ELSTAT that concern both the production of new statistics and the revision of existing statistics in 2020 – 2022, according to national and international obligations and taking into account users' needs.

Part D outlines the objectives and initiatives of the ELSS agencies, besides ELSTAT, as regards the development, production and dissemination of statistics for the period 2020 – 2022.

The Annex lists the statistics of the agencies of the ELSS, except ELSTAT, which are scheduled to be produced within the three-year period 2020 – 2022.

# **B. ENSURING AND FURTHER IMPROVING THE QUALITY OF ELSS STATISTICS**

# 1. Objectives and means

The objectives, for the three-year period 2020 – 2022, are to ensure and further improve the quality of the statistics produced by the ELSS, by following the highest European and international statistical standards, unswervingly observing the existing rules, fulfilling the undertaken obligations and focusing on enhanced exploitation of human and financial resources while reducing, at the same time, the burden on respondents through the use of administrative and other data.

Ensuring and further improving the completeness, quality and timeliness of the statistics of the ELSS will be accomplished by fully implementing the Greek and EU legal and institutional framework on statistics by all ESS agencies and by adopting the highest standards and best practices of the European and International Statistical System. This framework consists of the Greek Statistical Law 3832/2010, as amended and in force, Regulation (EC) 223/2009 on European Statistics, as amended by Regulation (EU) 2015/759, the European Statistics Code of Practice (CoP), EU Regulations on statistics, the Regulation on the Statistical Obligations

of the Agencies of the ELSS, the Regulation on the Operation and Administration of ELSTAT, and the memoranda of cooperation between the agencies of the ELSS. In addition, as stated in the Preamble to the CoP, following its latest revision, which was adopted by the ESSC on 16 November 2017, the common quality framework of the ESS consists of the CoP, which is its cornerstone, the ESS Quality Assurance Framework and the general quality management principles (such as continuous interaction with users, commitment at leadership level, partnership, staff satisfaction, continuous improvement, integration and harmonisation). The Statistical Authorities responsible for the development, production and dissemination of European statistics are bound to observe the CoP.

The full implementation of the Commitment on Confidence in Statistics, which was signed by the Greek Government and the European Commission in 2012 and transposed into the Greek legislation (Law 4051/2012), is crucial for the achievement of the above objectives.

The specific actions of ELSTAT, in the three-year period 2020 – 2022, to achieve the above objectives include, among others, actions to:

- Continue the self-assessment of its statistics produced, in terms of the methodology applied and their overall compliance with the CoP principles so as to meet evolving user needs.
- Continue to cooperate closely with the agencies of the ELSS and to support their statistical activities in the context of the certification of their statistics.
- Continue to organise training series on statistical topics, to enhance the knowledge and skills of its staff, as well as the staff of other ELSS agencies.
- Make further use of administrative and other data sources, as well as new technologies for the collection, processing and dissemination of its statistics, in order to save resources and reduce the burden on respondents.
- Continue its close cooperation with the other members of the ESS in the context of Task Forces / Working Groups and Sector / Directors Group, organised by Eurostat for various statistical issues, and its dynamic presence and effective participation in European decision-making centres on statistical issues.
- Continue and intensify the cooperation of ELSTAT with the academic community; further use the technology
  to present the statistics; improve their accessibility and extend the educational visits to pupils and students
  in Northern Greece, in the context of fostering statistical literacy in Greece.

#### 2. Coordination within and between the ELSS agencies

In accordance with Article 2 of the Statistical Law 3832/2010, as in force, ELSTAT coordinates all the activities of the other agencies of the Hellenic Statistical System concerning the development, production and dissemination of the statistics of Greece, so that these statistics are developed, produced and disseminated in accordance with the principles of the CoP. In the framework of this coordination, memoranda of cooperation between ELSTAT and other ELSS agencies have been signed and continue to be signed, setting out the framework for cooperation between the above agencies in specific statistical domains, and moreover ELSTAT collects, on a yearly basis, information on the planned statistical work for the next year of the other ELSS agencies and on the implementation of their statistical works for the previous year.

With a view to enhancing coordination within and among the ELSS agencies, the ELSS agencies, upon relevant suggestion of ELSTAT, have appointed a Statistical Head, in accordance with the provisions of Principle 1 of the CoP. For the same purpose, the Coordination Committee of the Hellenic Statistical System was established, consisting of the above Statistical Heads and chaired by the President of ELSTAT. The Committee delivers to ELSTAT an opinion on the Regulation on the Statistical Obligations of the ELSS Agencies, on the priorities of the ELSS on the basis of national and international developments and measures to reduce the administrative response cost of the ELSS agencies, as well as on a number of issues related to the production of statistics within the ELSS.

Furthermore, for the above purpose, as well as to assist the ELSS agencies in applying the principles of the CoP, ELSTAT, in accordance with Article 5a (2g) of Regulation (EC) No 223/2009, as amended by Regulation (EU) 2015/759, has compiled the "Guide to the Agencies of the Hellenic Statistical System for the Implementation of the European Statistics Code of Practice", which is expected, among others, to contribute to strengthening, to a significant degree, the coordination of statistical works within the agencies.

The Guide lays down and clarifies the obligations of: a) the agencies, b) the Statistical Heads of the agencies, c) the employees of the agencies involved in the production and dissemination of statistics and d) ELSTAT vis-à-vis the agencies, in the context of compliance with the principles of the CoP. The Guide has 4 Annexes,

which include Templates for the Quality Policy, Statistical Confidentiality Policy, Quality Report and Documentation of Statistical Processes, with the aim of assisting the ELSS agencies in implementing the basic steps for the certification of their statistics. The Guide is a "living" document, which will be revised from time to time, where necessary, on the basis of the experience of ELSTAT gained from the process of certification of the statistics of the ELSS agencies and on the basis of any revision of the CoP.

The implementation of the above Guide by the ELSS agencies, as well as the recognition by them of the role of the Statistical Head and the provision of substantial support to his/her work, are crucial factors in improving coordination within and among the ELSS agencies. ELSTAT works and will continue to work for this purpose over the three-year period 2020 – 2022.

Further strengthening of the coordination between the ELSS agencies is expected in the context of the certification as "official" of the statistics produced by these agencies (see next Chapter), which will be continued and intensified over the three-year period 2020 - 2022, as well as by the conduct of the 3rd round of Peer Reviews planned for the two-year period 2021 - 2022 (see Chapter 4).

#### 3. Certification as "official statistics" of the statistics produced by ELSS agencies

A basic obligation of ELSTAT, in accordance with Article 11(6) of the Greek Statistical Law 3832/2010, as amended and in force, is the certification as "official" of the statistics produced by the other ELSS agencies. This certification is an important factor and a tool for enhancing the quality and reliability of ELSS statistics.

ELSTAT has completed the basic stage of the certification process of the statistics of almost all the ELSS agencies. The ELSS agencies, in which the basic certification stage has been conducted, have been informed by ELSTAT on the basic steps they have to take for the continuation of the certification process. These steps concern horisontal actions that should be undertaken by each agency as a whole and are, more or less, common for all the agencies. Aiming at the implementation of the above actions, ELSTAT provides the agencies, as mentioned above, with relevant guidance, however, until the beginning of 2019, none of the agencies completed all the basic steps to continue the process of certification of its statistics by ELSTAT.

To address the above delays, ELSTAT has undertaken a number of initiatives. More specifically:

- It has prepared, as mentioned above, the "Guide for the Agencies of the Hellenic Statistical System for the Implementation of the European Statistics Code of Practice".
- In cooperation with the competent agencies of the ELSS, as appropriate, in 2018, it compiled the "List of the Statistics of the ELSS Agencies"<sup>(1)</sup>, for the year 2017, which is updated on an annual basis. This list includes the statistics of the ELSS agencies, except ELSTAT, which are candidates for certification. A unique code corresponds to each statistical product, in order to facilitate the monitoring of their changes, while European statistics are flagged, in order to be distinguished from the rest of the statistics. Statistics are classified by agency and statistical domain, there is a reference to the legal framework and links to the data and metadata of the relevant statistical surveys/works, where available. This list should contribute to speeding up the completion of the process of certification of the ELSS agencies.
- It asked all the ELSS agencies to plan, with a specific timetable, the implementation of the steps necessary for the continuation of the process of certification of their statistics.

ELSTAT monitors the implementation of these steps by the agencies, in accordance with their timetable, and will continue to cooperate with them closely, with a view to completing the certification of the agencies' statistics over the three-year period 2020 - 2022.

At the same time, over the next three years, ELSTAT will continue its self-assessment on the implementation of the principles of the CoP so that, together with the certification of the statistics of the ELSS agencies and the overall coordination of the statistical work of the Hellenic Statistical System by ELSTAT, it will improve the comparability and consistency of the ELSS statistics.

#### 4. Conduct of the 3rd round of Peer Reviews

Following the 1st and 2nd round of Peer Reviews, during 2008 – 2009 and 2013 – 2014, respectively, Eurostat plans to launch, during 2021 – 2022, the 3rd round of Peer Reviews, which will assess the compliance of the National Statistical Institutes (NSIs), the Other National Authorities (ONAs) and Eurostat with the CoP, following its last revision in November 2017.

The 3rd round of Peer Reviews will include all the principles of the revised CoP, to the extent necessary, taking

into account the improvements made to the national statistical systems, in the context of the implementation of the recommendations of the previous Peer Reviews. The 3rd round will focus on the new elements of the revised CoP and in particular the new principle of coordination and cooperation, as well as the use of multiple data sources.

The aim of the 3rd round of Peer Reviews is, on the one hand, to demonstrate both within the ESS and external stakeholders, that the ESS is a system which is based on principles and complies with the principles of the CoP and, on the other hand, it provides support to the NSIs and the ONAs producing European statistics for the further development and improvement of their national statistical system, while encouraging national governments to contribute to this purpose.

The proposed schedule for the 3rd round of Peer Reviews is as follows:

- 1. Completion of the review of the European Statistical System Quality Assurance Framework (ESS-QAF) by the Task Force assigned to this task and the Working Group on Quality (January March 2019).
- 2. Approval by the European Statistical System Committee (ESSC) of the mandate of the Peer Reviews Task Force (February 2019).
- 3. Appointment of members of the Peer Review Task Force (March 2019).
- First meeting of the Task Force to discuss issues related to the approach, the scope and coverage of the 3rd round of Peer Reviews (April – May 2019).
- 5. Submission to the ESSC of an analytical report on the implementation of the improvement actions resulting from the peer reviewers' recommendations during the 2nd round of Peer Reviews (May 2019).
- 6. Approval of the revised ESS-QAF by the ESSC (May 2019).
- 7. Second meeting of the Task Force to provide strategic guidance on the general methodology, approach and scope of peer reviews, as well as the criteria for the selection of peer reviewers (July 2019).
- 8. Approval of the general methodology of Peer Reviews by the ESSC (October 2019).
- 9. Third meeting of the Task Force to provide strategic guidance on the communication strategy of the 3rd round of Peer Reviews (February March 2020).
- 10. Meetings of the Working Party on Quality, or sub-group thereof, with a view to developing the analytical methodology for the conduct of peer reviews (e.g., the compilation of the self-assessment questionnaires for the NSIs and the ONAs, the instructions on the NSIs and the peer reviewers, templates for the list of peer reviewers' recommendations, etc.) (September 2019 March 2020).
- 11. Approval of the total methodological package for the peer reviews by the ESSC (May 2020).
- 12. Training of peer reviewers (September October 2020).
- 13. Peer review on Eurostat (November 2020).
- 14. Peer reviews in all the Member States of the European Union and the EFTA countries (2021 2022).
- 15. Meetings of the Peer Review Task Force to provide feedback on peer reviews and possible corrective actions (September 2021 – December 2022).

# 5. Enhanced use of administrative data sources

The use of administrative data sources for the production of statistics contributes not only to saving human and financial resources for the statistical authorities, but also to reducing the burden on respondents and, often, to improving the quality of statistical data (e.g., in relation to their timeliness). For this reason, the European and international statistical community has focused on the use of administrative data and data from other sources, such as big data and privately-held data, for the production of statistics.

In line with the prevailing trend in the European and international statistical community, ELSTAT places particular emphasis on making better use of the data available in the administrative sources of the Country and supports the work done in the ESS for the use of data from other sources. ELSTAT will continue these actions in the three-year period 2020 – 2022, as well. During the three-year period 2020 – 2022, ELSTAT will seek to continue and further develop its cooperation with bodies of administrative data sources, formalising this cooperation through the signing of memoranda of cooperation, where appropriate.

The experience gained and continues to be gained from the integration of enterprises tax data with data from statistical surveys on enterprises for the production of the Structural Business Statistics (SBS), since 2015, is expected to contribute to further improving the quality and timeliness of these statistics, during the three-year period 2020 - 2022. In this context, ELSTAT plans to develop/continue a series of cooperation actions with administrative sources with a view to maximising their exploitation, in order to meet the needs of specific statistical surveys/tasks. Indicatively, the following actions are stated:

- Extension of the use of administrative data in the context of the compilation of short-term economic indices, as well as statistics on short-term leases, vehicles in circulation, property values, etc.
- Development of cooperation with the Independent Authority for Public Revenue (IAPR) and e-Government for Social Security (IDIKA AE), in order to use their available data, in the framework of the General Censuses for Buildings and Population – Housing to be conducted in 2020 – 2021.
- Development of cooperation with the IAPR and the Organisation for Welfare Benefits and Social Solidarity (OPEKA), with a view to making use of available data on income and social allowances, respectively, for the needs of the Survey on Income and Living Conditions of Households (EU-SILC).
- Continuation of the cooperation with the Ministry of Rural Development and Food, in the context of granting access to ELSTAT in the Vineyard Register of the Ministry, as well as with the Payment and Control Agency for Guidance and Guarantee Community Aids (OPEKEPE), for updating the Statistical Farm Register of ELSTAT, on a yearly basis, with the least possible burden on holders of agricultural and livestock holdings, using data from the administrative records of the above Agency.
- Continuation of the cooperation with the Labour Force Employment Organisation (OAED), in order to ensure the coherence and comparability of unemployment statistics.
- Continuation of the cooperation with the ERGANI programme, in the context of the conduct of the Labour Force Survey and exploration of the possibility to extend this cooperation to cover the needs of the Job Vacancy Survey.
- Continuation of the cooperation with the Single Social Security Entity (EFKA) and the Single Payment Authority (SPA), with the aim of exploiting data on wages in the private and public sector, for the needs of the compilation of Labour Cost Indices. Explore the possibility to extend the cooperation with EFKA, with a view to using income data, for the needs of the Survey on Income and Living Conditions of Households (EU-SILC), as well as data for the needs of the Survey on Accidents at Work.
- Continue of cooperation with the Ministry of Environment and Energy to derive environmental data, in the context of the need for compiling the environmental accounts.
- Exploration of establishing cooperation with the Ministry of Shipping and Island Policy, with a view to using the administrative data of its IT systems, such as the Electronic Reservation System and the National Single Window NSW / SSNET, to meet the needs of the passenger and freight traffic statistics.
- Development of cooperation with the Ministry of Justice, Transparency and Human Rights, in order to derive data concerning Civil and Penal Statistics.
- Development of cooperation with the Ministry of Health to derive data on health statistics (Hospital Census, Health Care Census, In-Patient Hospital Care Survey), through the Management Information System and Business Intelligence (MIS-BI).
- Development of cooperation with the Ministry of Migration Policy and the Ministry of Citizen Protection, with a view to using available data in the context of developing statistics on migrants and refugees.
- Development of closer cooperation with the Bank of Greece and formalising such cooperation by signing a relevant memorandum of cooperation, by virtue of Article 1A(3) of the Statistical Law 3832/2010, as in force.

# 6. Using technology to upgrade data collection

In the three-year period 2020 – 2022, ELSTAT will continue its actions to upgrade data collection for the production of its statistics, aiming at exploiting to the maximum extent the possibilities offered by modern technologies for data collection and processing, in order to optimise the relevant procedures, in particular, in terms of saving time and resources.

More specifically, during the three-year period 2020 – 2022, ELSTAT will take the following actions related to the use of new technologies:

- Use, for the first time, of an electronic questionnaire on mobile electronic devices for collecting the data of the 2020 Agricultural – Livestock Census, based on the results of the pilot Agricultural – Livestock Census to be conducted in 2019. The use of an electronic questionnaire is necessary for the Country to fulfil the requirements of Regulation (EU) 2018/1091 and, above all, for the requirement of geographical location (accuracy of one square kilometer grid) of the holdings.
- Conduct of a feasibility study for developing a web-based application for the collection of data of the Annual Agricultural Survey, in order to improve the quality of the collected data.
- Development of electronic questionnaires for collecting the data of the Aquaculture Survey.
- Development of a web application for collecting the data of the Survey on Income and Living Conditions of Households (EU-SILC). Use of ELSTAT telephone centre for communication with households, in order to systematically collect the data from the households participating in previous waves (previous years) of the survey, with the aim of reducing the time of data collection.
- Extension of the web application for data collection for compilating the Industrial Production Index, with the addition of fields for the needs of the Producer Price Index in Industry.

# 7. Enhancing accessibility of produced statistics

Since the previous three-year programming period, ELSTAT has adopted a new strategy for the dissemination and communication of its statistics, placing the users at the centre of its activities. In this context and with a view to a better understanding by users of its statistics produced, it has displayed selected statistics, as well as their production processes, with infographics. Furthermore, it has recently posted on its website anonymised micro-data files with statistics from 8 statistical surveys, which have been anonymised in line with predefined criteria by ELSTAT, so as to render impossible the direct or indirect identification of the surveyed units (Public Use Files).

During the three-year period 2020 – 2022, ELSTAT will continue its actions to further upgrade its statistical products and their means of dissemination and communication, which should contribute to enhancing its visibility and the confidence of users in its statistics. More specifically, it will continue to:

- improve the format and content of the portal and the other ways of disseminating its statistics, both in Greece and internationally, in accordance with evolving international standards, by enriching its web portal with additional selected data from up-to-date surveys and by displaying statistical indicators interesting the majority of users (inflation, GDP, unemployment, exports, retail trade, building activity);
- enrich its portal with additional Public Use Files<sup>(2)</sup>, as well as with standard Scientific Use Files<sup>(3)</sup> of its statistical surveys, on the basis of the anonymised criteria set by ELSTAT, which will be posted on its website;
- display selected statistics, including their production processes, with infographics, targeting their presentation in an easily understandable way for the general public and suitable for reproduction in the social media, which are an important source of information for millions of users;
- use social media (twitter, instragram, linkedin) for the promotion of its statistical work.

At the same time, ELSTAT will focus its efforts on making full use of the digital tools to create innovative products, taking into account the results of the DIGICOM project, which is included in the portfolio of projects of the 2020 Vision of the ESS, in which ELSTAT participates. The purpose of this project is to modernise the communication and dissemination of European statistics, but its results can also be applied to other official statistics.

<sup>(1)</sup> Public Use Files are the micro-data files of ELSTAT's statistical survey statistics which have been anonymised on the basis of predefined anonymisation criteria by ELSTAT, so as to render impossible the direct or indirect identification of the surveyed units.

<sup>(2)</sup> Scientific Use Files are the files containing confidential data for scientific purposes, from which it is theoretically possible to have an indirect identification of the units surveyed. They include confidential data for scientific purposes, where statistical disclosure control methods have been applied, in order to reduce to a certain level the risk of identification of the surveyed unit.

In addition to the above general objectives set for the period 2020 – 2022, ELSTAT has planned, for this period, to develop specific actions to improve the accessibility of statistical information, some of which are, indicatively, listed below:

- Printing the necessary cartographic material to be used for the conduct of the 2020 Agriculture Livestock Census and of the 2021 Population – Housing Census, as well as and for the organisation of information seminars on issues related to the use of the cartographic material and of the digital maps.
- Converting the tables, dating back from 1981, of the annual time series concerning the variables of Labour Force Survey into "pivot tables", in order to be easier to use.
- Integration in the Press Release on Commercial Transactions of Average Value and Volume Indices, in 2020.
- Posting on the portal of ELSTAT of new additional tables on International Trade Statistics, in 2020.

With a view to improving users' accessibility to the micro-data of its statistical surveys, ELSTAT will continue its work on establishing, by the end of 2022, safe centres, where authorised researchers will be able to access confidential data for scientific purposes, on which no methods of statistical disclosure control have been applied.

#### 8. Reducing the burden on respondents

In addition to the benefits in terms of improving the quality and timeliness of the produced business statistics and the saving of human and financial resources, the provision to ELSTAT of tax data of enterprises contributes to the drastic reduction in the nuisance of enterprises and their burden from completing questionnaires. In Section 5 the planned ELSTAT's actions, with regard to the utilisation of administrative data sources, were indicatively mentioned. These actions, if implemented, are expected to contribute to further reducing the burden on respondents.

As part of its continued pursuit of reducing the response burden on the surveyed entities, ELSTAT participated in the SIMSTAT and REDISIGN projects of the 2020 ESS Vision project portfolio and continues to participate in the ESS projects aiming at the above reduction. In particular, ELSTAT participates in sub-projects of the project ESSnet BIG DATA, whose main purpose is to integrate big data into the production of official statistics, through pilot projects exploring selected big data sources for the development of relevant applications. At this point in time, ELSTAT participates in the following sub-projects of the 2nd phase of the project (ESSnet BIG DATA II):

- Work Package E: WPE Tracking Ships, which aims to establish a methodological reference framework, as well as the development of procedures and technical specifications for the integration of the data collected from the ship signal transmission through the Automatic Identification System (AIS) in the production of official statistics. In addition, ELSTAT is exploring the development of a model to verify the arrival and departure data of merchant ships using AIS data, in the context of producing passenger and freight traffic statistics at major ports in the Country.
- Work Package J: WPJ Innovative Tourism Statistics, which aims to develop a conceptual framework and a smart pilot information system, supporting statistical production in the tourism sector, integrating mass and administrative data and using innovative methods. In addition, ELSTAT will develop a feasibility study on the use of the above data for both current tourism statistics and for new statistical user requirements (e.g., provision of statistics to a lower level of administrative division, entering outbound tourism, satellites for tourism accounts).

During the three-year period 2020 – 2022, ELSTAT will continue to provide its assistance for projects aimed at reducing the burden of respondents. In this context, it will continuously follow the developments that will take place in the ESS, concerning the use of big data and "smart" data for the production of official statistics. In addition, it will continue to draw up, on an annual basis, a report assessing the response burden on respondents. The conclusions of the above reports provide useful material for assessing the effectiveness of the actions of ELSTAT in reducing the burden on respondents.

## 9. Regular meetings with users of statistical data

ELSTAT, recognising the usefulness of the conclusions drawn from the User Conferences for the update and improvement of its statistical product and the upgrading of its services, has established the organisation, on an annual basis, of such conferences. The above conclusions, as well as the results of the User Satisfaction Survey, are very useful for the preparation of the Hellenic Statistical Programme and the Annual Statistical Work Programmes.

In order to familiarise users with the statistics and how to better use statistical data, ELSTAT will continue to organise conferences for specific categories of users, during the three-year period 2020 – 2022.

#### 10. Fostering statistical literacy

ELSTAT aiming, since the previous three-year programming period, at promoting statistical literacy in Greece, has implemented the project "Fostering Statistical Literacy", which includes a variety of actions. These actions aim to inform pupils and students of all educational levels in Greece on the applications of statistics in our daily life, the production processes and the use of official statistics, as well as on the principles and rules of the European and international statistical community governing the production and dissemination of official statistics.

In the context of strengthening the effort of ELSTAT to develop statistical literacy, to familiarise pupils with the basic statistical concepts and the understanding of the statistical data and the usefulness of the statistics, a Memorandum of Cooperation was signed, in March 2018, between ELSTAT and the Ministry of Education, Research and Religious Affairs, for the development of statistical literacy and the enhancement of education statistics.

During the three-year period 2020 – 2022, ELSTAT will continue and intensify its actions in the field of fostering statistical literacy. Some of these actions are, indicatively, listed below:

- Continuation of the educational visits of pupils and students to ELSTAT's central premises in Piraeus and Thessaloniki.
- Continuation of the information visits by ELSTAT officials in educational units, for which access to ELSTAT's
  premises is difficult due to distance or other causes.
- Continuation of the information visits/speeches by the President of ELSTAT in educational institutes, in cooperation with University units, as well as in local branches of the Hellenic Mathematical Society, all over Greece.
- Undertaking of initiatives for the certification of other tertiary education institutions in Greece, besides the Aristotle University of Thessaloniki, by the EMOS label (European Master in Official Statistics), which provides post-graduate education in the field of official statistics, at European level.
- Continuing to renew the content of the website of ELSTAT on "Fostering Statistical Literacy".
- Renewal of existing training material and development of new, in the form of books, workbooks, online games, videos, etc., by education level.
- Organisation of webinars, intended to pupils of primary and secondary education schools. In order to implement these seminars, appropriate educational material and software will be developed, supplemented by the necessary support material (tablet/laptop).
- Operation of the "Census@School" platform, for educational purposes, but also with a view to integrating it into the primary and secondary education curriculum.
- Continuing to provide students of tertiary education with the opportunity for internships at ELSTAT's premises.
- Continuing to organise the "Panhellenic Statistics Competition", with the participation of teams of pupils of secondary education schools from all over Greece.
- Organisation of competitions pertaining to the statistical works of ELSTAT with the participation of undergraduate students and students of Universities, Technological Educational Institutions, Colleges and Institutes of Vocational Training.
- Continuation of ELSTAT's participation in the "Summer Vocational Guidance" programme, which concerns upper secondary education school students, with a view to give to students the opportunity to gain an experience that will be a useful tool for their academic and professional careers.
- Continuing to send printed statistical training material to school libraries, including infographics, making it available in the classrooms.
- Continue to promote the programme for "Fostering Statistical Literacy" in the stand of ELSTAT in the Thes-

saloniki International Fair, with actions dedicated to pupils, students and teachers.

- Inclusion of ELSTAT in the visiting programme "Filoxenia", funded by the Hellenic Parliament Foundation. The students participating in the programme are hosted in Athens and, apart from visiting the Greek Parliament, they participate in various cultural and educational activities.
- Integration of the "Fostering Statistical Literacy" project into school projects implemented in primary and lower secondary education.
- Organisation of thematic workshops for teachers from all levels of education, in order to be informed about the work of ELSTAT and to contribute to it with proposals and observations, but also by disseminating the information received from ELSTAT.
- Establishment of cooperation with University Schools, with a view to the compilation of graduate and postgraduate thesis, on a list of topics concerning the development, production and dissemination of official statistics.

### C. NEW AND REVISED STATISTICS DURING 2020 - 2022

The production of new statistics in the ELSS, in the period 2020 - 2022, is based, to a large extent, on the priorities of the European Statistical Programme for 2013 - 2017 and its proposed extension over the period 2018 - 2020, as these are outlined in the aforementioned programme, as well on the strategic priorities of the ESS beyond 2020, and will be further analysed in the annual statistical programmes of the ESS for the years 2020 - 2022. Moreover, the production of new statistics is driven by the requirement to cover users' needs, as these have been recorded by ELSTAT, during its regular meetings with them.

# 1. New statistics of ELSTAT for meeting European and international obligations

The obligation of ELSTAT to produce new statistics in the period 2020 – 2022 is driven, to a large extent, by the need to fulfil its obligations to Eurostat and other European and international organisations. These obligations involve implementing new EU Regulations, ensuring compliance with existing Regulations, filling in questionnaires, updating databases, etc. The new statistics that are planned to be produced in the above three-year period, for such purposes, are the following (by theme):

# 2020

- LABOUR MARKET
  - Statistics on working time and working time arrangements, in the context of an ad hoc module in the Labour Force Survey, for the year 2019 (Regulation (EU) 2017/2384).
- AGRICULTURE LIVESTOCK
  - Statistics on additional variables in the Annual Agricultural Survey, with reference year 2018, relating to livestock, with a view to increasing the degree of consistency and comparability of the relevant results with other ELSTAT surveys and other sources.
- SURVEY ON INCOME AND LIVING CONDITIONS OF HOUSEHOLDS
  - Statistics on intergenerational transmission of social and economic disadvantages and on the change evolution of income, in the context of adding new ad hoc modules in the EU Survey on Income and Living Conditions (EU-SILC), for the year 2019 (Regulation (EU) 2018/174 implementing Regulation (EC)1177/2003).
- INFORMATION SOCIETY
  - Statistics on the use of "smart" devices, e.g., air conditioning, lighting and security systems, cameras, watches, cars, etc., in everyday life (relating to the Internet of Things) and allowing the user to control them from a computer or a mobile phone, etc., as part of the Survey on the Use of Information and Communications Technology (ICT) by Households and Individuals, with reference year 2020 (Regulation to be adopted implementing Regulation (EC) 808/2004).
- TRANSPORT
  - Passenger mobility statistics, with reference year 2018. These statistics concern statistical data about
    population movements (transport mode, trip purpose, fuel type for passenger vehicles, mean distance
    travelled, average travel time, passenger-km, etc.), in the context of meeting the needs of international
    organisations for relevant statistical information.

- HEALTH
  - Statistics on the health status of the population aged 15 years and over, on the use of health services and factors affecting it positively or negatively, in the context of the Health Interview Survey, with reference year 2019 (Regulation (EU) 2018/255 implementing Regulation (EC) No 1338/2008).

#### 2021

- LABOUR MARKET
  - Statistics on accidents at work and other work-related health problems, in the context of conducting an ad hoc module of the Labour Force Survey, for the year 2020 (Regulation (EU) 2018/1709).
- SURVEY ON INCOME AND LIVING CONDITIONS OF HOUSEHOLDS
  - Statistics on over-indebtedness and financial exclusion of households, consumption, wealth and employment, in the context of adding new ad hoc modules to the Survey on Income and Living Conditions of Households (EU-SILC), for the year 2020 (Regulation to be voted implementing Regulation (EC) 1177/2003).
- TRANSPORT
  - Statistics on vehicle-kilometres (VKM), with reference year 2019. These are statistics on traffic on the
    national road network, expressed in vehicle-kilometres (for all modes of transport by type and age of the
    vehicle, fuel, etc.). The compilation of statistics will be carried out on a pilot basis driven by the need to
    update an international database, in the context of a gentlemen's agreement (Eurostat, International
    Transport Forum, UNECE).

#### 2022

- LABOUR MARKET
  - Statistics on the labour market position of migrants, in the context of conducting an additional ad hoc module of the Labour Force Survey, for 2021 (Regulation to be adopted).
- JUSTICE
  - Statistics on gender-based violence, in the context of conducting a relevant survey in 2021.
- SURVEY ON INCOME AND LIVING CONDITIONS OF HOUSEHOLDS
  - Statistics on the living conditions of children, in the context of adding new ad hoc modules to the Survey
    on Income and Living Conditions of Households (EU-SILC), for 2021. These are statistics relating to the
    living conditions of children (time of taking care of them, providing assistance for their homework, house
    amenities, etc.) (Regulation to be voted implementing Regulation (EC) 1177/2003).
- TRANSPORT
  - Statistics on driving licenses, in the context of conducting a feasibility study to meet the need for updating an international database (International Transport Forum – IRTAD).

# 2. 2020 Agricultural – Livestock Census

In 2020, ELSTAT will conduct the Agricultural – Livestock Census. This census is carried out in all Member States of the European Union, in the framework of the implementation of the European Regulation (EU) 2018/1091 on Integrated Farm Statistics (IFS), which will constitute the framework for all structural and other data required at farm level, and furthermore it will incorporate the Surveys on Fruit and Vineyards.

The Agricultural – Livestock Census aims at recording all the agricultural and livestock holdings in the Country, collecting data on the basic characteristics of their structure and on the population employed in them. The evolution of the structure of agricultural holdings is a key element in drawing the national and European policy in the agricultural sector and it is, therefore, necessary to gather information for the compilation of time series with data concerning the characteristics of these holdings. More specifically, the Agricultural – Livestock Census is aiming at collecting statistical data on the following characteristics:

- the number of agricultural and livestock holdings, at national, regional and local level;
- the characteristics of the holdings as regards their legal form, occupation status of the agricultural land and their structure (type of crops, species of farmed animals and birds, cultivation techniques, etc.);
- the agricultural production techniques;

- the population employed in the holdings.

The Agricultural – Livestock Census will be conducted in all Municipal and Local Communities of the Country. The coverage of the Census will encompass all the agricultural, livestock or mixed holdings, irrespective of their legal form (natural persons or legal person under public or private law) and the place of residence of the holder or the place where the areas or animals on the holding are located (urban, semi-urban and rural areas), as well as whether the production is intended for sale or own-consumption. The data of the 2020 Agricultural – Livestock Census are planned to be collected with the use, for the first time, of an electronic questionnaire via mobile electronic devices, in order to cover the requirement of the new Regulation (EU) 2018/1091 for geo-location (i.e., with accuracy of one square kilometer grid) of the holdings.

Below there is an indicative timetable for the works to be carried out by ELSTAT, during 2020 – 2022, in the context of the conduct of the 2020 Agriculture – Livestock Census:

- Completion of the update of the Statistical Farm Register from available administrative sources (2nd semester of 2019 1st semester of 2020)
- Finalisation of the online questionnaire, based on the results of the pilot Agricultural Livestock Census (1st semester of 2020)
- Compilation of the Circular with instructions to the organs conducting the Census (3rd quarter of 2020)
- Selection and appointment of the organs conducting the Census (Senior Supervisors, Supervisors, Assistant Supervisors and Enumerators) (2nd semester of 2020)
- Organisation of training seminars for the organs conducting the Census (2nd and 3rd quarter of 2020)
- Conduct of the Agricultural Livestock Census (4th quarter of 2020)
- Processing of the collected data (1st 3rd quarter of 2021)
- Conduct of quality checks on data (4th quarter of 2021)
- Extraction, tabulation and publication of results (1st semester of 2022)
- Compilation of financial report (2nd quarter of 2022).

#### 3. 2021 General Censuses for Buildings and for Population – Housing

In 2021, ELSTAT will conduct the General Censuses for Buildings and for Population – Housing. The Population – Housing Census is conducted in all Member States of the European Union, pursuant to the European Regulations 2008/763, 2017/543, 2017/881 and 2017/712, and the United Nations Recommendations on 2020 Population – Housing Censuses.

The purpose of the General Censuses for Buildings and for Population – Housing, which are conducted every ten years, is to collect data on the demographic, economic and social characteristics of the population, the composition and housing conditions of households, as well as on the building wealth of the Country.

More specifically:

- a) The <u>Buildings Census</u> is intended to enumerate the buildings in Greece, as a whole and by region, and to collect data on the buildings in terms of their use, ownership status, period of construction, size, building materials, etc.
- b) The <u>Population Housing Census</u> is intended to: i) enumerate the Resident Population of the Country, i.e., the people residing permanently in every level of administrative division of the Country; ii) enumerate the Registered (de jure) Population of the Country, i.e., the number of inhabitants of each Municipality; iii) collect data on the households composition and the demographic, social, educational and economic characteristics of the population and iv) enumerate the number of dwellings, by type, to collect data on the main characteristics of the dwellings and their amenities and to enumerate the dwellings in terms of their ownership status.

Please find below an indicative timetable, per year, of the works to be carried out by ELSTAT, during the period 2020 – 2022, in the context of the conduct of the of the 2021 General Censuses for Buildings and for Population – Housing:

- · Updating existing or new independent settlements in cooperation with the Municipalities
- · Printing of the questionnaires and supporting forms of the General Censuses
- Supply of consumables
- Appointment and training of the organs conducting the Censuses (Senior Supervisors, Supervisors and Assistant Supervisors)
- · Selection of Head of Sections

# 2021

- Distribution of the questionnaires and supporting forms per Census Division and dispatch to the Prefectures and Census Divisions
- Transmission of the list with the Sector Managers to the Census Divisions and appointment and training of the Sector Managers
- Selection of Enumerators, transmission of the lists with the Enumerators to the Census Divisions, appointment and training of Enumerators
- · Conduct of the General Censuses for Building and for Population Housing
- Conduct of the Post Enumeration Survey for the Population Housing Census
- Announcement of the provisional results for the Resident Population
- · Processing of the census data

#### 2022

- · Continuation of the processing of the census data
- · Compilation of draft tables
- · Publication of a Press Release Announcement of the results for the Registered Population
- · Announcement of the results for the Resident Population
- · Compilation of the financial report.

# 4. New statistics of ELSTAT for meeting users' needs

ELSTAT collects the comments and observations made by the participants in its Annual User Conferences, as well as the results from the User Satisfaction Surveys it conducts, with the aim of improving its statistical product and the services provided, as well as identifying any new needs and requirements for the production of statistics (see Box 1).

#### Box 1. User needs

The recorded needs of users cover a wide range of statistical fields. After having processed these needs, ELSTAT identified clear requirements which, indicatively, pertain to the following:

- Production of reliable statistics at a lower administrative level than Greece total.
- Production of more social statistics, in particular in the field of education, such as statistics on post-secondary non-tertiary education, expenditure on education, consumption and subsistence costs of students living in a city other than their place of residence, etc., and reduction of their production time.
- Production of long time series for Annual and Quarterly National Accounts, including before 1995.
- · Development of Regional Accounts for various production sectors.
- Availability of the updated Statistical Business Register, as well as business statistics, at the level of the Region and by produced product.
- Filling the gaps in time series of statistical data and availability of longer time series for more than 10 years.
- Enable users to produce variables of their interest (tailor-made tables) from the statistical survey databases of ELSTAT, without infringing statistical confidentiality.
- · Production of seasonally adjusted short-term indices.
- · Production of energy consumption data.
- Production of statistics on alternative forms of tourism (rural tourism, religious tourism, conference and business tourism, etc.) and green entrepreneurship.
- Addressing the occurrence of divergences between statistical data produced by different agencies and relate to the same variable and cooperation between the different producers of statistics, within ELSTAT, but also among the ELSS agencies under the coordination of ELSTAT, in order to ensure comparability of statistics.
- Recording of suicidal behaviour in Greece and suicide attempts and assessment of the direct and indirect economic costs of suicides for the Country.
- Speeding up regular users' access to micro-data of ELSTAT's statistical surveys.
- Publication on ELSTAT's website of more detailed data from the Population Housing Census and from statistical surveys in the field of agriculture and livestock.
- Exploitation, by ELSTAT, of experienced regular data users for issues pertaining to data collection and production of statistics.
- · Organisation of workshops for targeted user groups.

The satisfaction of these identified and recorded needs of users (including the needs of policymakers) is among ELSTAT's priorities for the three-year period 2020 - 2022. ELSTAT has already set up a priority list of users' needs on the basis of their importance both to users and to its statistical product, and has begun to explore the possibility of satisfying such needs, taking into account the availability of resources and its national and international obligations as, indicatively, set out below.

With a view to improving the quality and reducing the production time of statistical results in various statistical domains, such as business, education and health statistics, ELSTAT has already been active in increasing the use and exploitation of data from administrative sources, as well as new technologies. These actions will continue and be intensified in the three-year period 2020 – 2022.

In order to produce reliable results at a lower administrative level than Greece total, ELSTAT has already started to review the current sampling frames of its sampling statistical surveys. In this context, the gradual increase of the sample of the Survey on Income and Living Conditions of Households (EU-SILC) is included, which took place, in order to produce reliable results at the level of the Region. The review of the current sampling frames of sampling statistical surveys for this purpose will be continued by ELSTAT, during the three-year period 2020 – 2022, in order to assess the additional sample size and costs that will be required, in order to extract reliable results at the level of the Region. The revised sampling frames for carrying out the surveys will depend on the resources available to ELSTAT.

In the context of improving users' accessibility to anonymised micro-data of statistical surveys, ELSTAT has posted on its website anonymised microdata files of 8 statistical surveys. These files have been anonymised

on the basis of anonymisation criteria pre-defined by ELSTAT and are published on its website, so as to render impossible the direct or indirect identification of the surveyed units (Public Use Files). ELSTAT will continue, in 2019 and during the three-year period 2020 – 2023, to compile and post on its website public use files of other statistical surveys. At the same time, as mentioned above, it will continue its work on establishing safe access centres by the end of 2022 (see Part B, Section 7).

The occurrence of discrepancies between statistical data produced by different agencies and relating to the same variable is expected to be addressed, in the context of the certification process of the statistics of the ELSS agencies to be carried out by ELSTAT.

In the framework of the Sustainable Development Indicators (SDGs) to monitor the 17 goals and the 169 targets of the 2030 Agenda for Sustainable Development, ELSTAT works closely with the Secretariat General of the Government, which is the body designated to monitor and coordinate the work on the implementation of the 2030 Agenda, at national level. The purpose of the cooperation is the selection of the indicators, which will monitor the progress of the implementation of the National Implementation Plan for the Sustainable Development Goals, which is expected to be developed. During the three-year period 2020 – 2022, ELSTAT will continue to provide assistance in the compilation of the above indicators, by producing additional statistics from already ongoing surveys or by conducting new statistical surveys, based on its available resources. In the same context, ELSTAT, as the competent body for coordinating the statistical activities of the ELSS agencies, will continue to provide methodological guidance to those agencies for the compilation, within their remit, of the Sustainable Development Indicators and will assess the indicators produced by the agencies in the process of certification of the statistics of the ELSS agencies, with a view to ensuring their quality, so that they can be used to develop appropriate policies.

As part of its outreach strategy, ELSTAT will continue, in 2020 – 2022, to organise workshops for specific categories of users, with a view to informing users about the methodology of production and the correct use of statistics.

#### 5. Other changes in the production and dissemination of statistics

Compliance with EU Regulations and adaptation to users' needs, in combination with constraints in terms of the available human and financial resources, necessitate changes: improvements, revisions and discontinuations in the production and dissemination of statistics.

Eurostat, in the context of the ESS Vision 2020 initiatives for the modernisation of European statistics and with a view to increasing the coherence and comparability of European statistics, while reducing the burden on the respondents, has submitted 3 proposals for Framework Regulations, which consolidate Regulations concerning the agricultural, business and social sectors, respectively. More specifically:

- Proposal for a Regulation on Integrated Farm Statistics (IFS)
- Proposal for a Regulation on Integrated Business Statistics (FRIBS)
- Proposal for a Regulation on Integrated European Social Statistics (IESS).

The aforementioned proposals were submitted for discussion to the Council Working Party on Statistics (CWPS). The discussions for the first one were completed and the relevant Regulation (Regulation 2018/1091) was adopted. As regards the other 2 proposals, the discussions in the Working Group are ongoing. The above Regulations – Frameworks are expected to bring about certain changes in the production and dissemination of agricultural statistics, business statistics and social statistics.

In addition, the following changes are planned for the three-year period 2020 – 2022:

- STRUCTURAL BUSINESS STATISTICS
  - Compilation of a single questionnaire for the Structural Business Survey for all sectors of economic activity covered by the relevant European Regulation (EC) 295/2008 and exploration of the possibility to adapt the questionnaire to any future needs arising from the adoption of a new FRIBS Regulatory Framework.
- INTERNATIONAL TRADE
  - Development, on the basis of a study, of a new system for the compilation of intra-Community trade statistics, as part of the envisaged FRIBS Regulatory Framework for exchanging relevant micro-data between Member States.

- JUSTICE
  - Compilation of the statistics of the Land Registry and Cadastral Offices using administrative data, based
    on the results of a feasibility study with possible year of publication of results the year 2022.
- EDUCATION
  - Change, from 2020 onwards, of the data collection method for tertiary education, for the academic year 2018/2019: the data will be collected via a web-based application (OpenView Technology), while abolishing the OCR questionnaire.
- TRANSPORT
  - Production of road freight transport statistics using big data, based on the results of a relevant study.
  - Production of statistics on passenger and freight traffic at major ports in the Country, using big data (AIS) to verify ship arrival and departure data.
- TOURISM
  - Change in the frequency of the conduct of the Vacation Survey (Survey on Qualitative Characteristics of Resident Tourists) from yearly to quarterly, based on the results of a feasibility study carried out in 2019, with a view to improving the quality of the statistics produced.
  - Compilation of a feasibility study on the use of multiple data sources (administrative, big data, surveys, etc.), both for current tourism statistics and for new statistical user requirements (e.g., provision of statistics at a lower administrative division, inbound outbound tourism).

#### 6. The new Organization of ELSTAT

Since 2000, when the Organisation of the General Secretariat of the National Statistical Service of Greece (G.G. ESYE) entered into force, significant developments in the production of official statistics, both in Greece and in the European Union have taken place. In 2005, the CoP was established in the ESS, in line with which European statistics are to be developed, produced and disseminated, while in 2010, by virtue of the Law 3832/2010, the ELSS was established, which is composed of ELSTAT and other national agencies that develop, produce and disseminate official statistics in Greece. At the same time, since the implementation of the ESYE's Organisation until the present day, new data sources that can be used for the production of statistics have emerged and significant technological developments have taken place, which have been instrumental in the ways of collecting and processing data for the production of statistics, as well as the ways of disseminating statistics. All the above, in combination with the growing demand for reliable and timely statistics across all areas of social life and at a more disaggregated level, have led the NSIs to appropriately adapt their operational architecture, aiming at improving the quality of the statistical output, while reducing the response burden on the respondents and saving of resources.

In this context, it was considered necessary to draw up a new Organisation for ELSTAT, which would meet the obligations and requirements of a modern Statistical Office, so that ELSTAT can successfully fulfil its duties in the ELSS and be an active member of the ESS.

In December 2018, a draft of the new Organisation was submitted to the President of ELSTAT by the Task Force that had been compiling it. The draft was then sent, in early 2019, to the Ministry of Administrative Reconstruction and the Ministry of Finance. Subsequently, it was forwarded to the Council of State and the President of the Hellenic Republic.

The proposed Organisation aims to address existing deficiencies in the production of ELSTAT statistics and to adapt the production and dissemination of those statistics to new technological developments, with sharing of resources. In addition, it aims at adjusting the ELSS to the main orientations of the future European Union statistical production system, as promoted by relevant legislation (single Regulatory Framework for Business Statistics – FRIBS, Social Statistics – IESS and Agricultural Statistics – IFS). The model underpinning the development of the new Organisation of ELSTAT (Generic Statistical Business Process Model – GSBPM) has as a key principle the "shared use of resources" and is the most prevalent in the ESS, as it contributes to resource savings and standardisation of statistical processes, resulting in the production of harmonised and comparable statistics that meet the modern requirements of users.

The total of the organic posts estimated to be necessary for the implementation of the new Organisation of ELSTAT amount to 1,076. These posts include 147 posts created for statistical interviewers/researchers (of secondary education). These personnel to be recruited will be employed in the collection of primary data of statistical surveys, which are used for the production of statistics. The recruitment of the above staff aims at drastically reducing the number of private external interviewers currently used for this purpose. Reducing the number of private interviewers employed should contribute not only to significantly reducing the administrative burden on ELSTAT and saving of resources, but also to improving the quality of the data collected.

#### 7. Conditions for the implementation of the ELSP for the three-year period 2020 - 2022

The implementation of the three-year statistical programme for the ELSS requires the necessary resources from the State Budget and Eurostat, as well as the strengthening of ELSTAT with the necessary and appropriate human resources.

ELSTAT has budgeted the necessary expenditure to carry out its statistical work included in the ELSP for 2020 – 2022. The estimated costs and revenues are presented in the tables below:

#### D. OBJECTIVES AND INITIATIVES OF THE ELSS AGENCIES AS REGARDS THE PRODUCTION AND DISSEMINATION OF STATISTICS

The development and improvement of the Country's statistics is based on the actions of all the agencies of the ELSS. In this context, the ELSS agencies have outlined a set of objectives, for the period 2020 - 2022. These objectives mainly address issues relating to the use of technology to upgrade data collection and improve the production and dissemination of their statistics. Below, these objectives are presented, by each ELSS agency, as follows:

# **Ministry of Interior**

- Make better use of the Integrated Information System (OPS), in terms of the correctness and completeness
  of the recorded data, through the provision of relevant instructions to the Regional Citizenship Services of
  the Country.
- Implementation of a project for upgrading the "Interoperability Hub", with a view to optimising and further automating the process of collecting, processing and publishing the financial data of Local Government, planned to be completed in 2020.
- Posting of statistical releases, on a regular basis (probably every three months), on the evolution of the number of persons acquiring the Greek citizenship, the time waiting for the relevant interview and the total time for the completion of applications for acquiring the Greek citizenship; the publication of these releases is planned to be launched in 2020.
- Integration of operations for the exploitation of financial data of Local Government entities, which are kept in public databases, such as the Central Electronic Public Procurement Register (KIMDIS) and the implementation of the Public Investment Programme (e-PDE), in the context of upgrading the Interoperability Hub.

### **Ministry of Economy and Development**

- Upgrading the applications of the electronic platform for Public Investment Programme NSRF.
- Creation on the website of the Ministry of a special application for official statistics. Development of the electronic platform for the circulation of documents and the maintenance of data, which will be common to all Units of the Ministry and will allow communication with the decentralised services.

# Ministry of Education, Research and Religious Affairs

- The Directorate General for Tertiary Education is in the process of submitting a proposal for a single information system, which will compile comprehensive data on staff and students from tertiary education institutions, both directly and in real time. With regard to the personnel of the institutions, this system, which will also communicate with other public systems (social security platform, civil servants' inventory, Single Payment Authority, etc.) through interoperability, will allow the automated extraction of data among the horizontal IT systems of the administrative sector of tertiary education and the vertical information systems existing in each Institution/Body. As far as students are concerned, the aim is to link all the University students' registers with the relevant information system already in place. The collection of data for the statistical works of the other Services of the Ministry is already being carried out by means of information systems, which are being upgraded in line with the ongoing technological developments.

#### Ministry of Labour, Social Security and Social Solidarity and supervised entities

 Posting on the website of the EFKA of processable frequency and double entry tables for accidents at work, in an excel format; this action is planned to be completed in 2021.

#### **Ministry of Foreign Affairs**

- Use of administrative data, in cooperation with stakeholders providing input from governmental development and humanitarian aid, in the context of improving the production process of the relevant statistics.
- Conduct of a feasibility study on the implementation of an online relational database, with a view to collecting
  and processing the data of the total of Greece's development assistance and humanitarian aid for the production of the relevant statistics.
- Construction of a webpage of the Ministry for the presentation of its statistics produced.

#### Ministry of Justice, Transparency and Human Rights

- Development of an application for the electronic processing and production of statistics from the Unaccompanied Minors' Services.
- Gradually increasing the use of the Integrated System for the Management of Judicial Cases (OSDDY-PP) and making use of its potential to extract reliable statistics, which fall within the remit and competence of the Ministry of Justice, Transparency and Human Rights.
- Expansion of the OSDDY-PP (phase b) and gradual integration of the Country's Courts and Prosecutors' Offices.
- Improving the Integrated Information System of Detention Facilities, with a view to the automatic extraction
  of data from the aforementioned system.

#### **Ministry of Health**

The strategic objectives of the Ministry of Health, regarding the statistical actions for the three-year period 2020 – 2022 are developed on the basis of 3 main pillars:

- The first pillar concerns the use of technology for upgrading the collection of data from supervised entities (e.g., Hospitals) and for the communication between individual systems at the level of different bodies (e.g., ELSTAT). A key player for achieving the objectives of the first pillar is the "Business Intelligence System of the National Health System (BI-Health)", which is already in operation. Special attention will be given, over the next three years, to the completion of the automated collection of disaggregated data (individual-level data) by the IT systems of hospitals at the central hub of the BI-Health, through the appropriate web services. Automated data collection will make a significant contribution both to improving the quality and validity of the Ministry's statistics and to saving time and human resources.
- The second pillar concerns the continuous improvement of the procedures to ensure the quality and reliability of data collected by the Central Service of the Ministry of Health and the supervised entities, taking into account the implementation and the observance of the rules governing the ELSS. In addition, the implementation of new tools to control the completeness and quality of the data is planned.
- The third pillar relates to the statistical processing of data, but also to the improvement of the accessibility of the statistics produced. Under this strand, the Ministry of Health, building on the data already collected through the BI-Health application, is planning to create a core set of indicators, which will assess the efficiency of both the National Health System and the Health Units, with the main aim of improving the health status of the population. At the same time, the Ministry, building on the analytical data collected from the BI-Health application, plans the production of new statistics to monitor and measure morbidity by means of prevalence and incidence indicators. The focus will be on improving access to the statistics produced by communicating to citizens and stakeholders aggregated results and indicators for the National Health System, by further developing the implementation of the Health Atlas and the BI-Health portal. In addition, a specific section will be created on the website of the Ministry of Health, which will display the statistics produced with the relevant supporting material (methodological reports, quality policy, etc.).

Finally, at this point, it is worth mentioning the work of the "National Interoperability Framework", which is one of the most important projects of the Ministry of Health and is in the stage of compiling the technical specifications and drawing up the technical bulletin. One of the first stages of the project will result in the "National Data Set" for Health, which will make a significant contribution to improving data quality, as it will consist of integrated, homogenised and cleared digital registries, characterised by completeness and continuous updates (e.g., Register of Medicines, Register of Health Professionals, Register of Medical Operations, Register of Clinics/Departments of Hospitals, Register of Services Provided to citizens, etc.). In addition, through the use of interoperability standards, the project will significantly contribute to enhancing communication between individual applications in the health ecosystem, either between different agencies (e.g., the Ministry of Health – EOPYY, the Ministry of Health – IDIKA, the Ministry of Health – ELSTAT for the Annual Survey on In-Patient Hospital Care, etc.) or at the level of a health organisation (e.g., exchange of information between the applications in the hospital clinics with the systems of laboratories for medical examinations and the relevant results).

#### Ministry of Culture and Sport

#### Secretariat General for Sport

 Establishment of a digital Register of Sports Associations (federations, associations, clubs, gyms) and a digital Register of Trainers/Coaches. - Organisation of workshops for the presentation of the statistics of the Secretariat General for Sport.

#### Greek Film Centre (EKK)

- Development of the e-ticket infrastructure: this is an online service that enables electronic exchange of business information (tickets) for business operators (distributors) via the internet.
- From 2020 onwards, direct extraction of statistics on the production and distribution of cinematographic films via the EKK's new Integrated Information System, the development of which was launched in 2019, with the aim of centralising information management, monitoring the progress of internal and external requests to and from the EKK, the management of their flow and the automated support for various administrative functions. Monthly publication of a list of the top 10 commercial films, with reference to the title of the film, the distribution company and the number of tickets sold.
- Publication of an annual list containing clear and easy-to-understand information on the actions of the EKK in its different areas of activity, by presenting specific statistics.

#### **Ministry of Environment and Energy**

 Development of an English web page, where the relevant statistics of the Ministry and its supervised entities will be published in English.

#### **Ministry of Infrastructure and Transport**

#### Observatory of Egnatia Odos

- Creation of a new website of Egnatia Odos Observatory, in the context of the renewal and upgrading of the operation of the Observatory website, with the integration of new functions/services, in order for interested users to access information and data in an easy and flexible way, using thematic, time, technical and geo-graphical parameters to select the website. This action is planned and integrated as a separate sub-project in the Observatory's approved financing programme, for the period up to 31 December 2023.

#### **Ministry of Shipping and Island Policy**

Development of a separate section for "Statistics" on the official website of the Ministry of Shipping and Island Policy, in which all the statistics produced by the Ministry and its supervised entities, as an ELSS Agency, will be published, together with their metadata (quality reports), as well as the quality and statistical confidentiality policies, the annual statistical work programmes and the annual reports for the statistical work programmes of the Agency.

#### **Ministry of Rural Development and Food**

 Development of a digital application for compiling the statistics of the Directorate General for Rural Development, in cooperation with the Directorate for e-Government, adapted to the new EU agricultural statistics regulatory framework (SAIO).

# National Research Institute (NRI) - National Documentation Centre (NDC)

- Strengthening the functioning of the statistical information mechanism of the NDC and enlargement of the thematic areas covered, with a view to better supporting public policies in the fields of Research, Technology, Development and Innovation.
- Development of processes and applications in information systems, with a view to "smart" data referencing, as well as the display of indicators and thematic reports, in an interactive and understandable way.
- Development of procedures and applications in information systems, with a view to connecting data, automated updating and enrichment.
- Strengthening and extending partnerships with bodies with administrative data that are relevant and useful to the statistics produced by the NDC.
- Establishment of institutional administrative procedures for the systematic extraction of administrative data, and the operation of information systems, where possible.
- Improvement of procedures and infrastructure to enhance data security, safeguard statistical confidentiality and personal data.

- Continuously upgrading the website to better serve users' needs. Production of new e-books.
- Continuous improvement of the electronic systems and processes used by the NDC to collect data for the
  production of statistics, by applying additional accuracy checks to online questionnaires in real time, continuous updating of software used on platforms and tools, and enrichment of the online helpdesk.

#### Hellenic Telecommunications and Post Commission (EETT)

Design and implementation, in the near future, of an Integrated Market Monitoring System supporting all actions of market monitoring data by providers in the framework of structured questionnaires. More specifically, the Service Provider will be able to submit the market data via an appropriate Web Interface, which will offer the possibility to check the validity and consistency of the submitted data through the use of appropriate tools, arithmetic and statistical control, and finally, a history of publications will be observed, through the assignment of a unique number to each submission of the Provider, which will be able to establish pre-defined, but also plan, dynamic reports, graphs, statistics, indicators and analysis. Through a user-friendly interface, the user will have access to pre-designed, tailor-made and dynamic structures and reports, such as: tables, pivot tables, blocks of correlation, classification and criteria for inclusion. In addition, this system will enable users other than EETT to set up ad hoc indicators and reports from the available data, thus enabling them to access the information, using a web browser, without requiring the installation of additional software.
