
TURNOVER INDEX IN INDUSTRY: July 2019, y-o-y increase of 4.3%

The Hellenic Statistical Authority announces the Turnover Index in Industry with base year 2015=100.0 for July 2019, on the basis of provisional data, which is as follows:

The Overall Turnover Index in Industry (both domestic and non-domestic market) in July 2019 recorded an increase of 4.3% compared with the corresponding index of July 2018. In July 2018, the corresponding annual rate of change of the Overall Turnover Index in Industry was 16.6% (Table 1).

The Overall Turnover Index in Industry in July 2019, compared with June 2019, recorded an increase of 14.9% (Table 6).

The average Overall Turnover Index in Industry for the 12-month period from August 2018 to July 2019 increased by 4.7%, compared with the corresponding index of the 12-month period from August 2017 to July 2018. In July 2018, the corresponding annual rate of change of the Overall Turnover Index in Industry was 7.4% (Table 13).

Evolution of the Overall Turnover Index in Industry in July 2019

I. Annual changes of the Overall Turnover Index in Industry: July 2019/July 2018


The 4.3% increase in the Overall Turnover Index in Industry in July 2019, compared with the corresponding index in July 2018, was due to the following:

1. Changes in the sub-indices of the industrial sections (Table 1):

- The Turnover Index in Manufacturing increased by 4.7%. The increase was mainly the result of the annual changes of the sub-indices in the following 2-digit divisions: beverages, tobacco products, coke and refined petroleum products, basic pharmaceutical products and pharmaceutical preparations.
- The Turnover Index in Mining and quarrying decreased by 22.4%. The decrease was mainly the result of the annual changes of the sub-indices in the following 2-digit divisions: mining of coal and lignite extraction of crude petroleum and natural gas mining support service activities, other mining and quarrying products.

2. Changes in the sub-indices in domestic and non-domestic markets:

- The Turnover Index in Industry in domestic market increased by 5.8% (Table 2).
- The Turnover Index in Industry in non-domestic market increased by 1.4% (Table 3).



II. Annual changes of the Turnover Index in Industry in Domestic Market: July 2019/July 2018

The 5.8% increase of the Turnover Index in Industry in domestic market in July 2019, compared with July 2018, is due to the following annual changes in the sub-indices of the following industrial sections (Table 2):

- The Turnover Index in Manufacturing increased by 5.9%. The increase was mainly the result of the annual changes of the sub-indices in the following 2-digit divisions: beverages, coke and refined petroleum products, basic pharmaceutical products and pharmaceutical preparations, computers, electronic and optical products.
- The Turnover Index in Mining and quarrying decreased by 4.8%. The decrease was mainly the result of the annual change of the sub-index in the following 2-digit divisions: mining of coal and lignite extraction of crude petroleum and natural gas mining support service activities.

III. Annual changes of the Turnover Index in Industry in Non-Domestic Market: July 2019/July 2018


The 1.4% increase of the Turnover Index in Industry in Non-Domestic market in July 2019, compared with July 2018, was due to the following:

1. Changes in the sub-indices of the industrial sections (Table 3):

- The Turnover Index in Manufacturing increased by 2.4%. The increase was mainly the result of the annual changes of the sub-indices in the following 2-digit divisions: beverages, tobacco products, leather and related products, printing and reproduction of recorded products, basic pharmaceutical products and pharmaceutical preparations, rubber and plastic products.
- The Turnover Index in Mining and quarrying decreased by 30.7%. The decrease was the result of the annual changes of the sub-indices in the following 2-digit divisions: mining of coal and lignite extraction of crude petroleum and natural gas mining support service activities, other mining and quarrying products.

2. Changes in the sub-indices in Eurozone and Non-Eurozone countries:

- The Turnover Index in Industry in non-Eurozone countries increased by 2.3% (Table 5).
- The Turnover Index in Industry in Eurozone countries decreased by 0.2% (Table 4).



IV. Monthly changes of the Overall Turnover Index in Industry: July 2019/ June 2019

The 14.9% increase of the Overall Turnover Index in Industry in July 2019, compared with the corresponding index in June 2019, was due to the following:

1. Changes in the sub-indices of industrial sections (Table 6):

- The Turnover Index in Manufacturing increased by 15.6%.
- The Turnover Index in Mining and quarrying decreased by 25.9%.

2. Changes in the sub-indices in domestic and non-domestic market:

- The Turnover Index in Industry in domestic market increased by 18.1% (Table 7).
- The Turnover Index in Industry in non-domestic market increased by 9.2% (Table 8).

METHODOLOGICAL NOTES

Generally

The Industrial Turnover Index is an indicator of an enterprise's business cycle showing the monthly evolution of the market of goods and services in industry. The Turnover Index is compiled since January 2006 with base year 2000=100.0 and is compiled from 2000 and onwards.

Purpose of the index

The purpose of this index is to measure the monthly activity of the industrial sector in terms of value. Turnover comprises the totals invoiced by the observation units during the reference period and corresponds to the market sales of goods or services supplied to third parties. The purposes and the characteristics of the Turnover Index apply, as well, to the indices for the distinction between domestic and non-domestic turnover.

Legal Framework

The compilation and publication of the Turnover Index is based on the framework of requirements of Council Regulation (EC) No 1165/98 concerning short-term statistics (STS-R), as well as Regulation (EC) No 1158/05 of the European Parliament and Council amending Council Regulation (EC) No 1165/98. Furthermore, this index is governed by Regulation (EC) No 1893/2006 of the European Parliament and of the Council, by Commission Regulation (EC) No 656/2007 and by Regulation (EC) No 451/2008 of the Council.

Reference period

Month.

Base year

2015=100.0.

Revision

The latest revision of the Turnover Index in Industry (base year 2015=100.0) took place in the framework of Council Regulation (EC) No 1165/98 concerning short-term statistics. In accordance with this regulation the index is revised every five years, in years ending in 0 or 5.

Statistical classifications

At the level of classes of economic activities, the statistical classification of economic activities NACE Rev. 2 of EU was used (Regulation No 1893/2006), while at the level of main industrial groups, the allocation of two-digit and three-digit NACE Rev. 2 headings to categories of aggregate classification was used, in accordance with Commission Regulation No 656/2007.

Geographical coverage

The index covers the whole Country.

Coverage of economic

activities

The Turnover Index in Industry is compiled for all activities listed in Sections B (mining and quarrying) and C (manufacturing) of the NACE Rev. 2 statistical classification.

Computation of the Index

The Turnover Index in Industry is a fixed base index. This index is calculated at a first stage at the four-digit level of economic activity and subsequently, with the implementation of appropriate weighting coefficients, the index is calculated at higher levels (three-level and two-level of economic activity) as well as at the level of Main Industrial Groupings (MIGs).

Publication of data

The Turnover Index in Industry (2015=100.0) is released since August 2019 with June 2019 as first reference month. Data with base year 2015=100.0 are available from January 2000 onwards.
