# **ECONOMIC ACCOUNTS FOR AGRICULTURE: Year 2017**

The Hellenic Statistical Authority (ELSTAT) announces the results of the Economic Accounts for Agriculture of year 2017, compiled in September 2018, according to the Regulation (EC) 138/2004, and the corresponding revised data for years 2015-2016. The Economic Accounts for Agriculture refer to the Income of the Agricultural Industry (growing crops, farming of animals) they are a satellite account of the system of the National Accounts and provide additional information on the branch of agricultural activity.


The data required for the compilation of the Economic Accounts for Agriculture, are derived from surveys conducted by the ELSTAT, from data of the Ministry of Rural Development and Food, as well as from administrative sources.
