COMMERCIAL TRANSACTIONS OF GREECE : May 2016

(Provisional Data)

The total value of imports-arrivals, in May 2016 amounted to 3531,1 million euros (3982,3 million dollars) in comparison with 3650,2 million euros (4057,6 million dollars) in May 2015, recording a drop, in euros, of **3,3%**. The corresponding change excluding oil products recorded an increase of 6,8 million euros or 0,2% (Table 1)⁽¹⁾.

The total value of exports-dispatches, in May 2016 amounted to 2022,4 million euros (2294,5 million dollars) in comparison with 2309,6 million euros (2582,9 million dollars) in May 2015, recording a drop, in euros, of **12,4%**. The corresponding change excluding oil products recorded a drop of 98,3 million euros or 6,4% (Table 1).

The deficit of the trade balance, in May 2016 amounted to 1508,7 million euros (1687,8 million dollars) in comparison with 1340,6 million euros (1474,7 million dollars) in May 2015, recording an increase, in euros, of **12,5%**. The corresponding change excluding oil products recorded an increase of 105,1 million euros or 8,2% (Table 1).

The total value of imports-arrivals, for the 5-month period from January to May 2016 amounted to 17938,6 million euros (19953,9 million dollars) in comparison with 18547,8 million euros (20555,9 million dollars) for the corresponding period of the year 2015 recording a drop, in euros, of **3,3%**. The corresponding change excluding oil products recorded an increase of 1092,3 million euros or 8,0% (Table 5).

The total value of exports-dispatches, for the 5-month period from January to May 2016 amounted to 9866,6 million euros (11035,4 million dollars) in comparison with 10780,2 million euros (12030,3 million dollars) for the corresponding period of the year 2015, recording a drop, in euros, of **8,5%**. The corresponding change excluding oil products recorded a drop of 55,7 million euros or 0,7% (Table 5).

The deficit of the Trade Balance, for the 5-month period from January to May 2016 amounted to 8072,0 million euros (8918,5 million dollars) in comparison with 7767,6 million euros (8525,6 million dollars) for the corresponding period of the year 2015, recording an increase, in euros, of **3,9%**. The corresponding change excluding oil products recorded an increase of 1148,0 million euros or 18,6% (Table 5).

The monthly data of Intra EU transactions, have been adjusted to the total trade transactions with EU countries, (including the transactions below the statistical threshold ⁽¹⁾), on the basis of the Recapitulative Statements of Intra-EU Deliveries and Acquisitions that are submitted by the enterprises in the Ministry of Finance. Accordingly, the provisional data from the "incomplete customs declarations" have been incorporated in the monthly data on trade with third countries and, after having been completed, they will be replaced by the final data.

⁽¹⁾ By virtue of EU Regulations on the compilation of intra-EU trade statistics, Member States set out a "statistical exemption threshold". On the basis of the exemption threshold, the enterprises whose transactions are below the statistical threshold are exempted from the obligation to submit data on their intra-Community transactions (Intrastat declaration). The aim is to reduce the burden on enterprises. The statistical exemption threshold, valid for each year, is specified and released by ELSTAT on a yearly basis.

USD million**







USD million**







Transactions referring to services are not included, while they are taken into account for the compilation of the National Accounts tables, along with the commercial transactions.

In compliance with the obligations provided in the EU Regulations regarding the compilation of external trade statistics, these transactions are calculated on the basis of the Recapitulative Statements of Intra-EU Deliveries and Acquisitions that all the enterprises are obliged to submit to the Ministry of Finance.</p> <p>ELECTRONIC SUBMISSION: Intrastat declarations are submitted electronically via the following links: http://eurostat.statistics.gr or www.statistics.gr.</p> <p>EXTRASTAT: It is a statistical survey where data are collected by administrative sources.
