COMMERCIAL TRANSACTIONS OF GREECE : October 2017

(Provisional Data)

The total value of imports-arrivals, in October 2017 amounted to 4,666.9 million euros (5,469.9 million dollars) in comparison with 4,098.4 million euros (4,505.2 million dollars) in October 2016, recording an increase, in euros, of **13.9%**. The corresponding change excluding oil products in October 2017 recorded an increase of 321.8 million euros or 10.3% and the corresponding change excluding oil products and ships in October 2017, recorded an increase of 380.2 million euros or 14.0% (Table 1).

The total value of exports-dispatches, in October 2017 amounted to 2,491.9 million euros (2,938.2 million dollars) in comparison with 2,294.2 million euros (2,537.2 million dollars) in October 2016, recording an increase, in euros, of **8.6%**. The corresponding change excluding oil products recorded in October 2017 an increase of 189.8 million euros or 11.9% and the corresponding change excluding oil products and ships in October 2017 recorded an increase of 189.9 million euros or 11.9% (Table 1).

The deficit of the trade balance, in October 2017 amounted to 2,175.0 million euros (2,531.7 million dollars) in comparison with 1,804.2 million euros (1,968.0 million dollars) in October 2016, recording an increase, in euros, of **20.6%**. The corresponding change of deficit excluding oil products in October 2017 recorded an increase of 132.0 million euros or 8.6% and the corresponding change excluding oil products and ships in October 2017 recorded an increase of 190.3 million euros or 17.0% (Table 1).

The total value of imports-arrivals, for the 10-month period from January to October 2017 amounted to 41,899.4 million euros (46,674.7 million dollars) in comparison with 36,344.5 million euros (40,407.4 million dollars) for the corresponding period of the year 2016, recording an increase, in euros, of **15.3%**. The corresponding change excluding oil products recorded an increase of 2,796.8 million euros or 9.6% and the corresponding change excluding oil products and ships recorded an increase of 1,884.3 million euros or 6.9% (Table 5).

The total value of exports-dispatches, for the 10-month period from January to October 2017 amounted to 23,611.3 million euros (26,514.3 million dollars) in comparison with 20,893.3 million euros (23,364.4 million dollars) for the corresponding period of the year 2016, recording an increase, in euros, of **13.0%**. The corresponding change excluding oil products recorded an increase of 1,074.8 million euros or 7.0% and the corresponding change excluding oil products and ships recorded an increase of 1,078.7 million euros or 7.1% (Table 5).

The deficit of the Trade Balance, for the 10-month period from January to October 2017 amounted to 18,288.1 million euros (20,160.4 million dollars) in comparison with 15,451.2 million euros (17,043.0 million dollars) for the corresponding period of the year 2016, recording an increase, in euros, of **18.4%**. The corresponding change excluding oil products recorded an increase of 1,722.1 million euros or 12.4% and the corresponding change excluding oil products and ships recorded an increase of 805.6 million euros or 6.7% (Table 5).

The monthly data of Intra EU transactions, have been adjusted to the total trade transactions with EU countries, including the transactions below the statistical threshold ⁽¹⁾, on the basis of the Recapitulative Statements of Intra-EU Deliveries and Acquisitions that are submitted by the enterprises in the Ministry of Finance. Accordingly, the provisional data from the "incomplete customs declarations" have been incorporated in the monthly data on trade with third countries and, after having been completed, they will be replaced by the final data.

⁽¹⁾ By virtue of EU Regulations on the compilation of intra-EU trade statistics, Member States set out a "statistical exemption threshold". On the basis of the exemption threshold, the enterprises whose transactions are below the statistical threshold are exempted from the obligation to submit data on their intra-Community transactions (Intrastat declaration). The aim is to reduce the burden on enterprises. The statistical exemption threshold, valid for each year, is specified and released by ELSTAT on a yearly basis.

Diagram 1. Imports - Arrivals, Exports - Dispatches, October 2015-2017

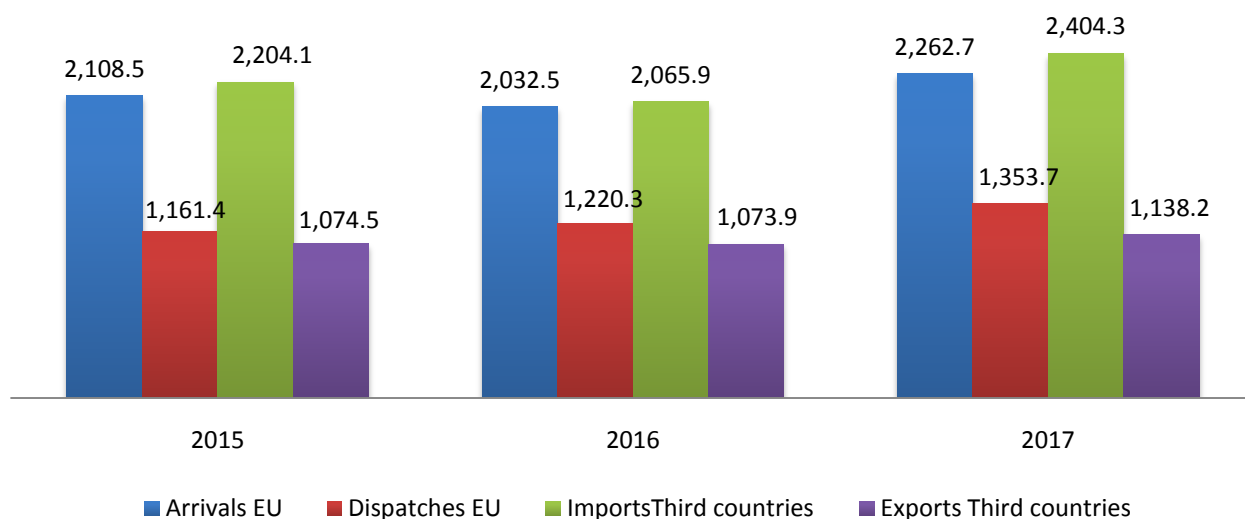

Diagram 2. Imports - Arrivals, Exports - Dispatches excluding oil products, October 2015-2017, million €

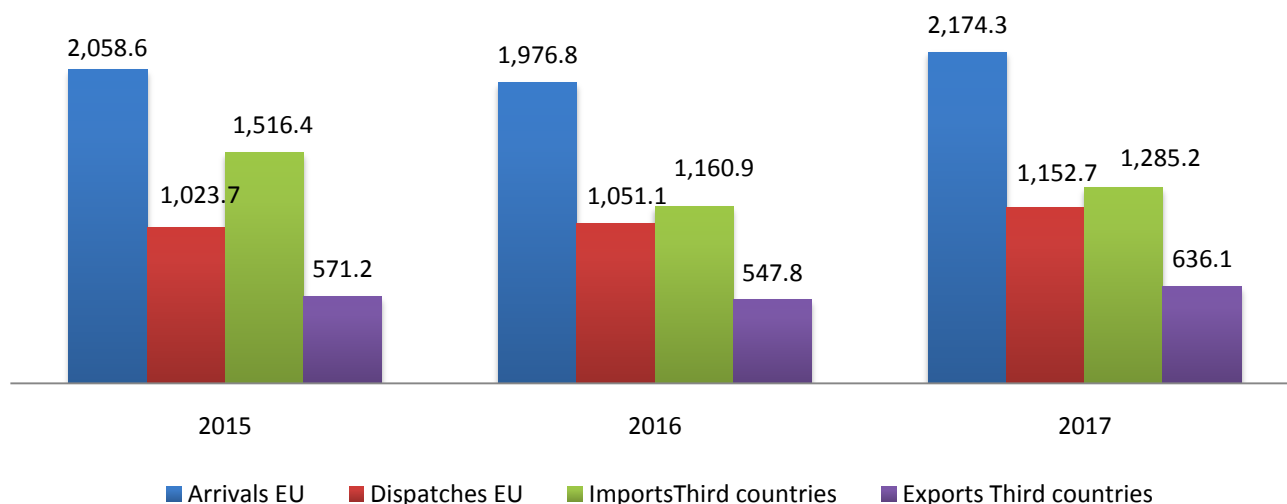

Diagram 3. Imports - Arrivals, Exports - Dispatches excluding oil products and ships October 2015-2017, million €

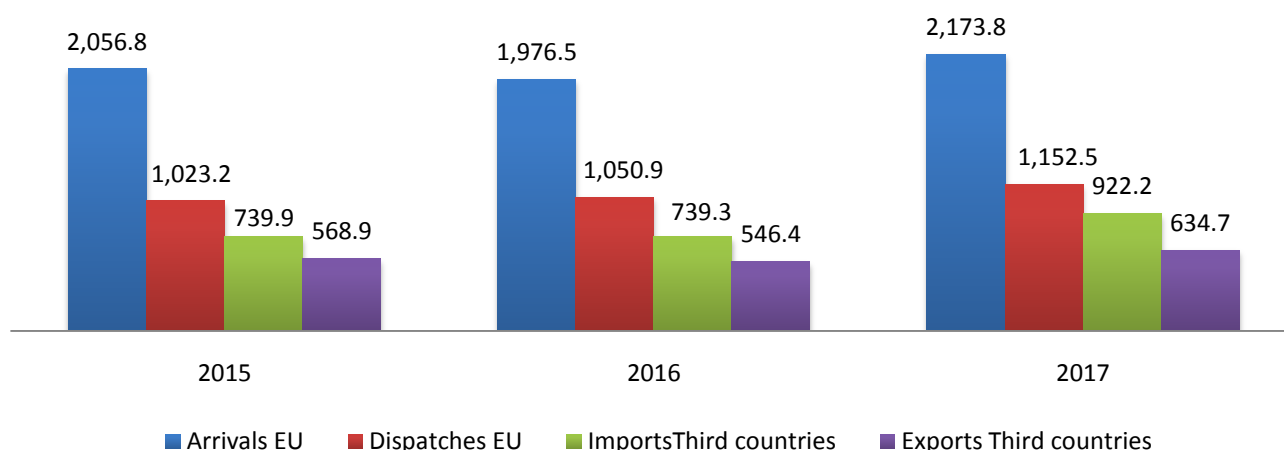

Diagram 4. Imports - Arrivals, Exports - Dispatches, January - October 2015-2017, million €

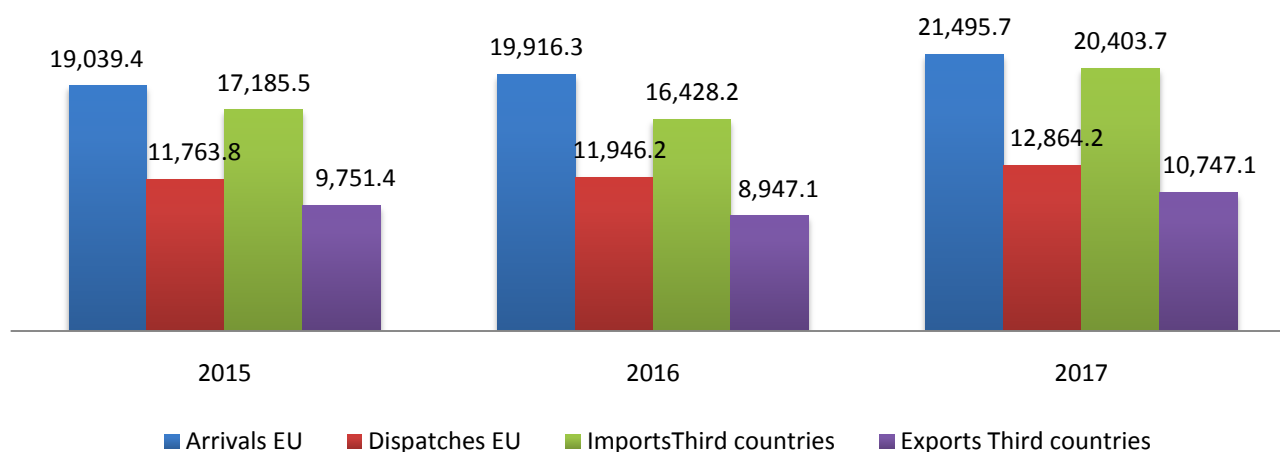

Diagram 5. Imports - Arrivals, Exports - Dispatches, excluding oil products, January - October 2015-2017, million €

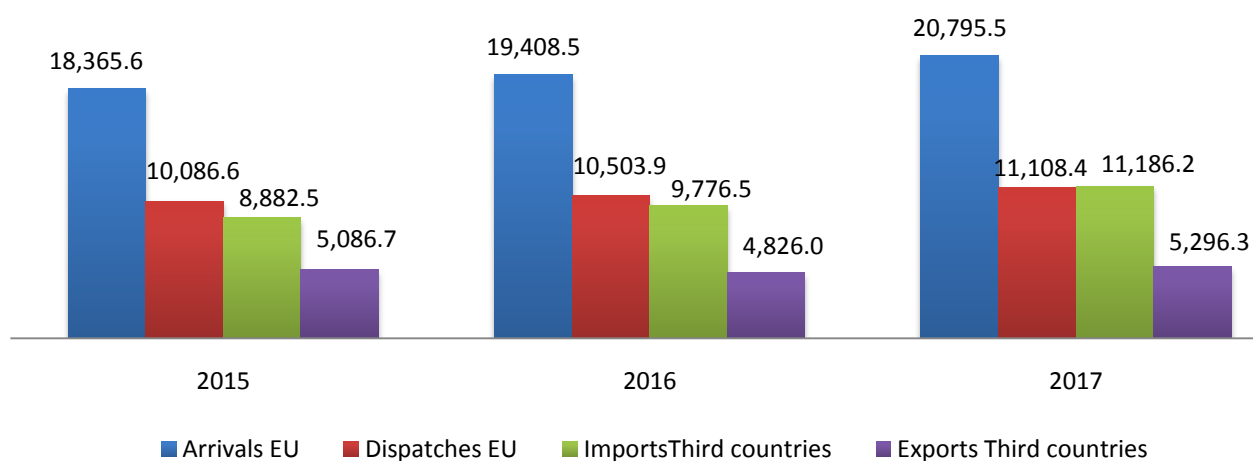

Diagram 6. Imports - Arrivals, Exports - Dispatches, excuding oil products and ships, January - October 2015-2017, million €

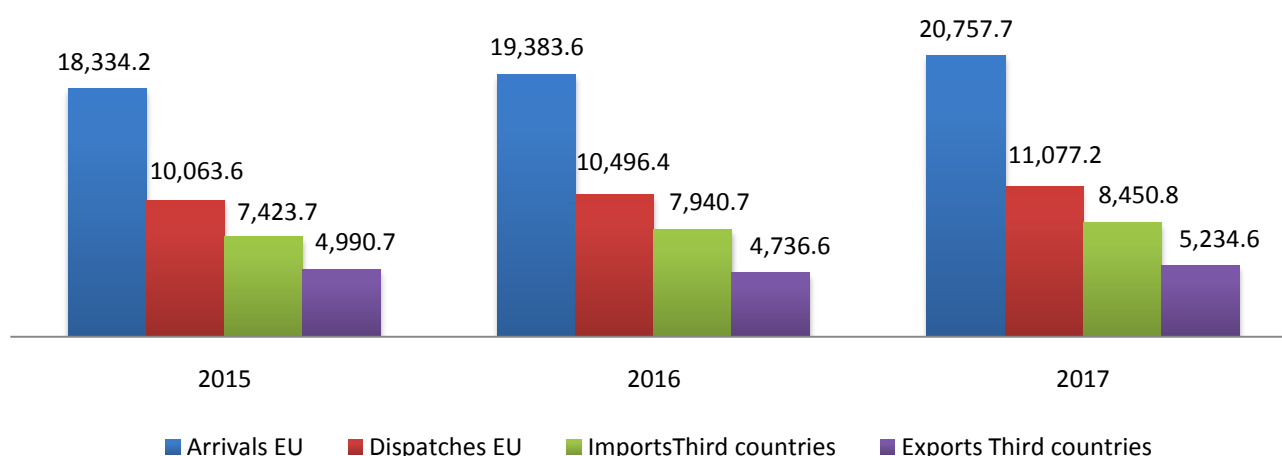

Diagram 7a. Percentage (%) distribution of E.U. arrivals by SITC sections, October 2017

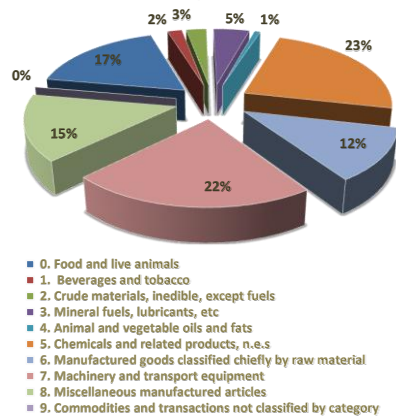


Diagram 7b. Percentage (%) distribution of Third countries imports by SITC sections, October 2017

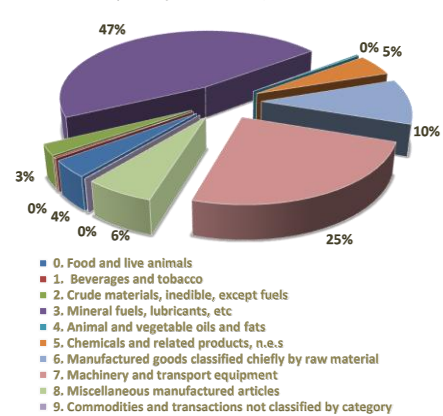


Diagram 8a Percentage (%) distribution of E.U. dispatches by SITC sections, October 2017

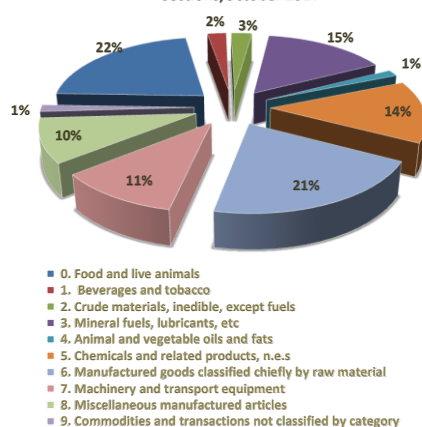


Diagram 8b. Percentage (%) distribution of Third countries exports by SITC sections, October 2017

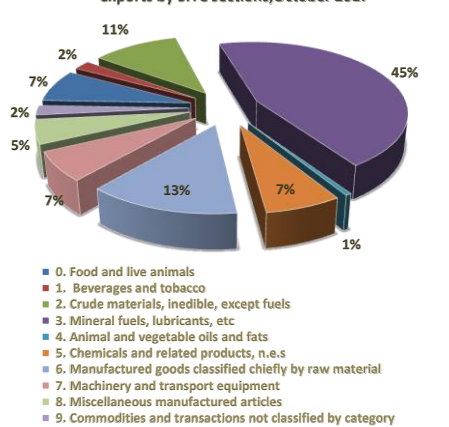


Diagram 9. Imports - Arrivals E.U. & Third countries by SITC sections, Jan. - Oct. 2017 million €

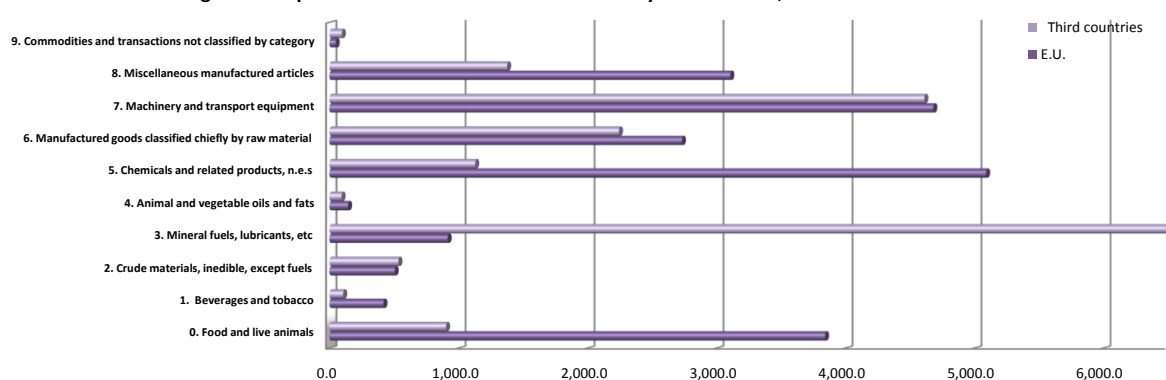


Diagram 10. Exports - Dispatches E.U. & Third countries by SITC sections, Jan. - Oct. 2017 million €

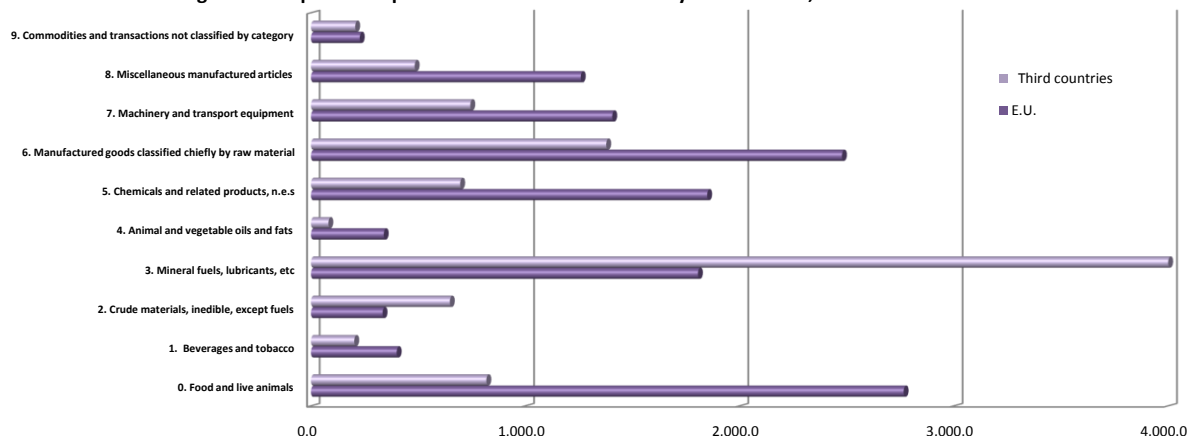

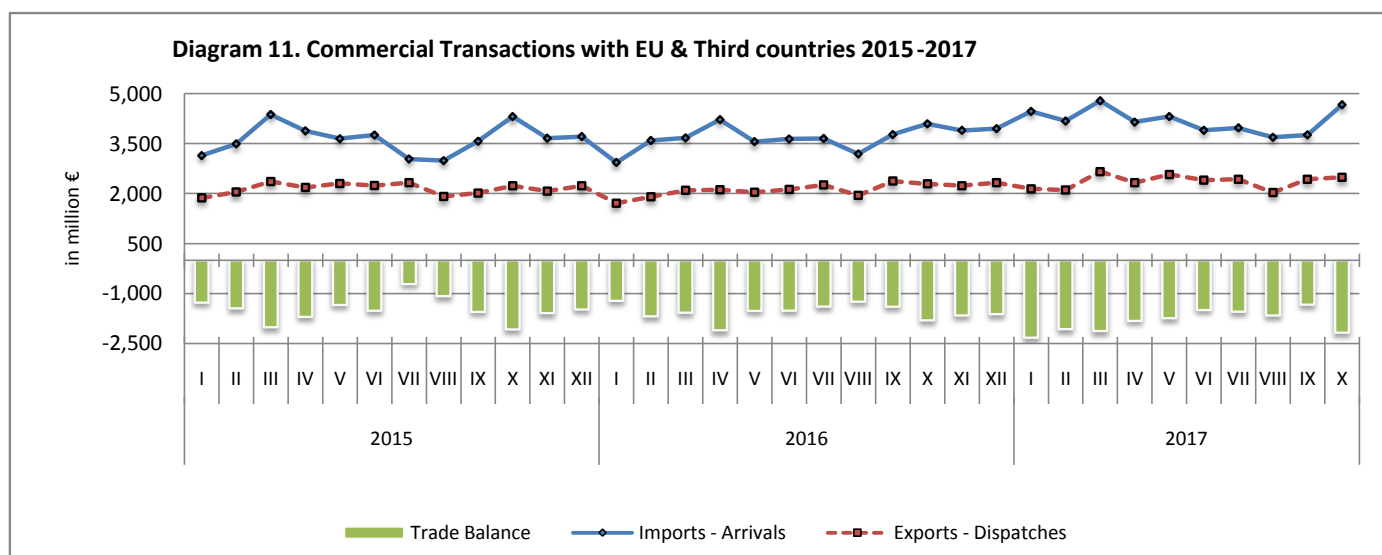

Commercial Transactions of Greece	The Commercial Transactions of Greece are recorded on a monthly basis aiming at monitoring the total value of Imports-Arrivals, Exports-Dispatches as well as the relevant changes of the above-mentioned categories. Transactions referring to services are not included, while they are taken into account for the compilation of the National Accounts tables, along with the commercial transactions.

In compliance with the obligations provided in the EU Regulations regarding the compilation of external trade statistics, these transactions are calculated on the basis of the Recapitulative Statements of Intra-EU Deliveries and Acquisitions that all the enterprises are obliged to submit to the Ministry of Finance.</p> <p>ELECTRONIC SUBMISSION: Intrastat declarations are submitted electronically via the following links: http://eurostat.statistics.gr or www.statistics.gr.</p> <p>EXTRASTAT: It is a statistical survey where data are collected by administrative sources. The Customs Authorities collect the relevant statistical data on trade by filling in the Single Administrative Document (SAD). All the transactions with third countries above the amount of 1.000 euros are registered. In the beginning of each month Customs Authorities transmit to Hellenic Statistical Authority an electronic file with the customs data of statistical relevance of the previous month.</p> <p>The statistical data of imports and exports of goods with the Third Countries, are derived from the data transmitted by the Customs Authorities.</p> <p>The incorporation, henceforth, of the provisional data from the "incomplete customs declarations" - which concern mainly petroleum products - in the monthly data on trade with third countries; the "incomplete customs declarations" data after having been completed will be replaced by the final data.</p> <p>IMPORTS AND EXPORTS OF SHIPS: The data on imports and exports of ships from Third Countries are transmitted by the Customs Authorities and they are based on data pertaining to the registration and de-registration of ships under the Greek flag.</p> <p>Classification of goods: The goods are classified in compliance with the 8-digit Combined Nomenclature Code (CN/8) and the Standard International Trade Classification (SITC).</p>
