The Hellenic Statistical Authority (ELSTAT) announces the quarterly Press Release presenting data on Short-Term Indices of Employment, Hours Worked and Gross Wages and Salaries in main sections of the economy for the 2<sup>nd</sup> quarter 2019.



In the following table, the Short-Term Indices of Employment, Hours Worked and Gross Wages and Salaries without any adjustment (seasonal or adjustment for the number of working days) are presented analytically in ten main sections<sup>1</sup> of the NACE Rev.2 classification of economic activities. Furthermore, data on the annual change of each index are presented.

In the Graphs 1 to 10 that follow the evolution over time of the Indices of Employment, Hours Worked and Gross Wages and Salaries broken down by NACE Rev. 2 section for the 2<sup>nd</sup> quarter of the years 2010 up to 2019 is shown, as well as their annual changes.






Graph 1: B-Mining and quarrying







**Graph 2: C-Manufacturing** 







Graph 3: D-Electricity, gas, steam and air conditioning







Graph 4: E-Water supply, sewerage, waste management and remediation activities






**Graph 5: F-Construction** 







**Graph 6: H-Transportation and Storage** 







**Graph 7: I-Activities Accommodation Services and Food Services** 







**Graph 8: J-Information and Communication** 







Graph 9: M-Professional, scientific and technical activities

#### **METHODOLOGICAL NOTES**

## Generally

The Short-term Indices of Persons Employed, Hours worked and Gross wages and salaries are quarterly indices concerning the Sections of economic activities B to E (Mining-quarrying, Manufacturing, Energy and Water Supply), F (Construction), H to J and M to N (Other Services) of the European Economic classification NACE Rev.2, having 2015 as the base year (2015=100.00).

#### Purpose of the index

The purpose of the indices is to present the evolution of Persons Employed, Hours worked and Gross wages and salaries on a quarterly basis in sections of economic activities B to E (Mining-quarrying and Industry), F (Construction), H to J and M to N (Other Services) of the European classification NACE Rev.2.

## **Legal Framework**

The Council Regulation (EC) No.1165/98 concerning short-term statistics and Council Regulation (EC) No.1503/2006 as regards definitions of variables, list of variables and frequency of data compilation.

#### Geographical coverage

Greece, total.

#### **Reference Period**

Quarter.

## **Definitions**

As **Number of Persons Employed** is defined the total number of persons employed in the enterprise, irrespectively of their status (owners, partners and their family members) and the nature of their work (managers, sales persons and auxiliary staff) and irrespectively of whether they work temporarily or seasonally, full-time or parttime employment, with or without remuneration.

As **Hours Worked** is defined the total number of hours actually worked in the enterprise during the reference quarter. It includes hours actually worked during normal working hours; hours worked in addition to those, with or without remuneration, time that is spent at the place of work on tasks such as preparing the site and time corresponding to short periods of rest at the work place. This variable excludes hours paid but not actually worked such as for annual leave, holidays and sickness leave.

As **Wages and salaries** is defined the total remuneration, in cash or in kind, payable to all persons counted on the payroll, in return for work done.
