Information note on the updating of the Consumer Price Indices, National Index (CPI) and Harmonised Index (HICP)

**Base period: December 2015** 

Piraeus, February 2016

#### Introduction

The Hellenic Statistical Authority (ELSTAT), in the context of implementing the chain linking method for the compilation of the Consumer Price Index (national consumer price index:CPI and harmonised index of consumer prices:HICP) carried out the annual update of the indices in order to ensure their representativeness.

More specifically:

- updated the weights of the national index on the basis of the latest available data of the 2014 Households Budget Survey(HBS).
- updated the weights of the harmonised index on the basis of the latest available national accounts data of the year 2014, pursuant to Regulation (EC) 549/2013 on ESA 2010.
- Updated the population weights by taking into account expenditure data.
- Rescaling the HICP reference year to 2015=100.0.

# **1.** Updating the weights of the National index of Consumer Prices (CPI)

The item's weights of CPI are based on the results of the 2014 HBS, ajusting the expenditure data of this survey to the prices of December 2015 which is the base month of the new CPI.

These weights refer to the average composition of monthly expenditure consumption of the total private households in the country, as resulted from the HBS. More specifically, the weight of each group, sub-group and species (of goods and services) represents the share of the average household expenditure for this group, sub-group and species in the total average household expenditure.

The weights of the items on the basis of the results of the 2014 HBS adjusted to December 2015 prices are expressed in ‰, for the 12 main Divisions in the following table. For comparison reasons, the weights of the CPI of December 2015, on the basis of the 2013 HBS, are also presented in the same table.

The weights on the basis of the 2014 HBS have been extrapolated to December 2015 prices reflecting a current pattern of the composition of the households' consumption expenditure.

### 2. Updating the weights of the Harmonised index of Consumer Prices (HICP)

Pursuant to Regulation (EC) 1114/2010, the HICP class weights are based on the consumption pattern as this is derived from the national accounts data. Detailed product weights are derived from the HBS.

In order to calculate the weights of the HICP for the year 2016, national accounts data of the year 2014 are used after their extrapolation to December 2015 prices. It is noted that the latest national accounts data for the year 2014 have been calculated in compliance with the Regulation on the European Systems of Accounts ESA2010 (Regulation EC 549/2013).

The following table shows, for the 12 expenditure categories and the basic groups, in ‰, the weights for the year 2016 and the weights that were applied in the year 2015.

### 3. Updating population weights based on expenditure data of households and population.

For the calculation of population weights, the population data of the 2011 census population and the results of the 2014 HBS were taken into account.

On the basis of the results of the HBS, i.e. the average monthly expenditure by expenditure category and per household in each of the 13 regions of the country and the number of households by region, as determined as an average by the HBS for the year 2014, the annual expenditure for the total number of the households by region was calculated, i.e., extrapolating the HBS results, on an annual basis, for the total number of the households in every region.

In a later stage, the number of households of each region was allocated in the price collection cities on the basis of the number of households of each city as derived from the 2011 census. The percentage distribution of population of the region on the price collection cities was implemented on the expenditure that was calculated for every expenditure category of COICOP12 at the level of the region, on the basis of the HBS results. The weighting coefficient of each city, by expenditure category, is calculated as the expenditure in each city to the total expenditure for this category in the country.

In general, the population weights are used for the weighting of the individual indices (sub-indices) of the items for each price collection city, in order to calculate these sub-indices for the whole country.

# 4. Rescaling of the reference year of the Harmonised Index of Consumer Prices (HICP) to 2015 = 100.0.

The Harmonized Indices of Consumer Prices are compiled by the Member States in the frame of the basic Council Regulation (EC) No 2494/95 "for the establishment of Harmonized Indices of Consumer Prices" and of other 19 Council and Commission EC Regulations, which lay down particular implementation measures governing the compilation of HICPs.

One of them is the common reference year of HICP. From January 2006 onwards the HICPs were being calculated with base year 2005=100.0 in the frame of the Regulation (EC) No 1708/2005 for all HICPs of EU Member States.

Regulation EE No 2015/2010 of 11 November 2015 established a new common reference year, 2015=100.0, to be implemented in January 2016. According to this Regulation, ELSTAT undertook a number of works aiming at the revision of the reference year of HICP which is published in February 2016 with January 2016 as the first reference month. The time series of the index with base year 2015=100.0 starts from January 1996.

In some cases, the revision of the reference year has as a result to appear small differences (of size 0.1) on the rates of change of the HICP indices in comparison with the previous chronological series with base year 2005 = 100.0.
