REGIONAL ACCOUNTS: Gross Value Added data for the year 2012 and revised data for the years 2000-2011

The Hellenic Statistical Authority (ELSTAT) announces the National Accounts results on the level of Region (NUTS II), regarding Gross Value Added for the year 2012, as well as the corresponding revised data for the years 2000 - 2011. Data are compiled according to the European System of Accounts ESA2010 and are consistent with the respective annual national figures.

On 26 June 2013, the Regulation (EU) No 549/2013 of the European Parliament and of the Council on the European System of National and Regional Accounts in the European Union - ESA 2010 was published in the Official Journal of the European Union (L 174/1). The new European System of National and Regional Accounts (ESA2010) replaced ESA 1995, in order for the national accounts to be adapted to the new economic environment and developments in methodological research, as well as to users' needs.

In accordance with the provisions of Regulation (EU) 549/2013 pertaining to the data transmission program, the new system of National Accounts (ESA 2010) is required to be implemented also for the compilation of regional accounts for the period starting from 2000 onwards.

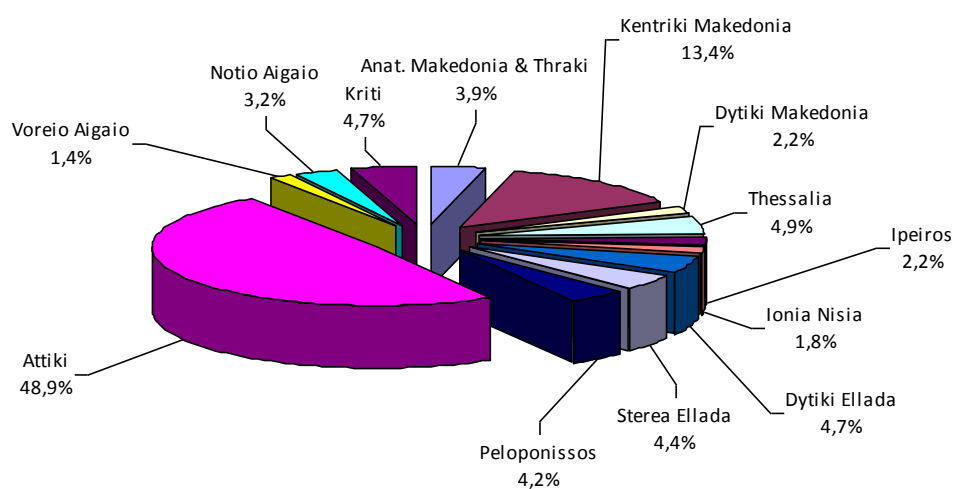

For the entire country, Gross Value Added (GVA) in 2012 decreased by 6.1% (Table 1). The biggest decrease occurred in the regions of Ipeiros, Kentriki Makedonia and Kriti.

Regarding the participation of regions in the production of GVA, the biggest share is held by the region of Attiki with 48.9%; the region of Kentriki Makedonia follows with 13.4% (Diagram 1)

Diagram 1: Regions contribution to total GVA.

On the basis of the regional GVA allocation and population statistics data (mid-year estimated population), the per capita regional Gross Domestic Product (GDP) is compiled. Its analysis shows a decrease of 6.3% for the entire country between 2011 and 2012 (Table 2). The regions with the largest decrease are Ipeiros, Anat.Makedonia & Thraki and Kriti.

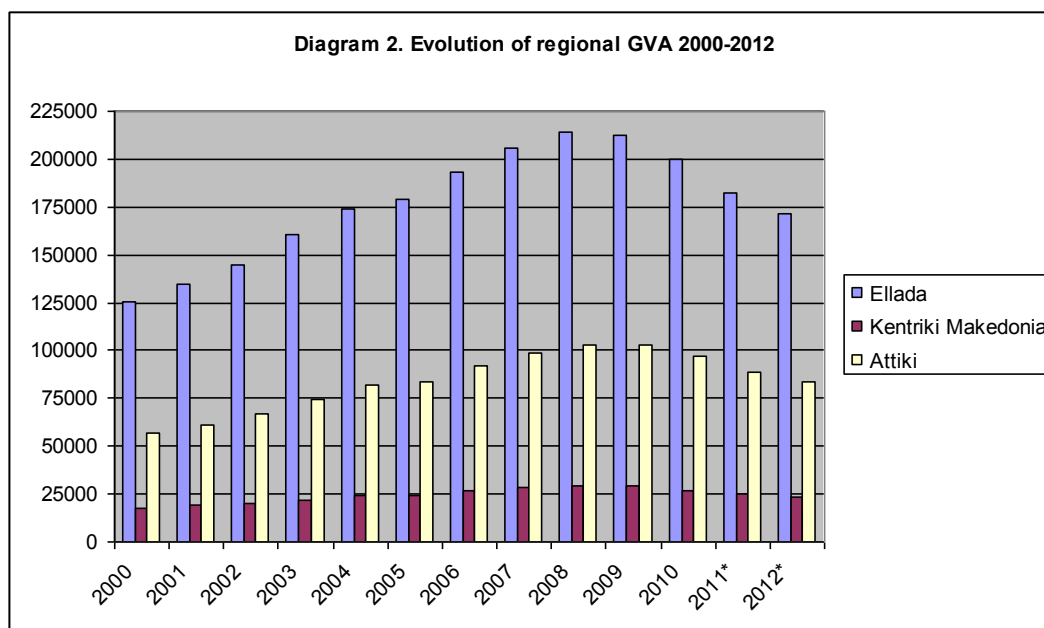

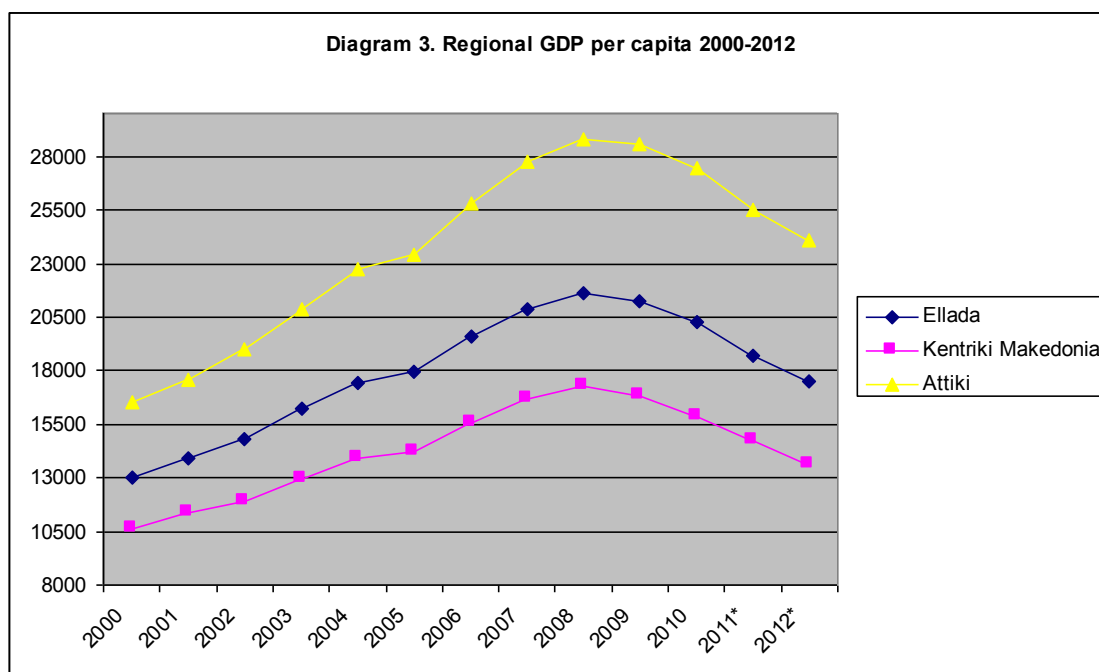
