BUILDING ACTIVITY

FEBRUARY 2009

The General Secretariat of the National Statistical Service of Greece publishes provisional data on the Building Activity, on the basis of the building permits issued from the Greek Town-Planning Offices during February 2009.

DECREASE OF THE TOTAL BUILDING ACTIVITY (PRIVATE-PUBLIC) DURING JANUARY - FEBRUARY 2009 IN COMPARISON WITH THE SAME PERIOD OF 2008

During the period January - February 2009, the magnitude of the total Building Activity (private-public), in the whole Country, measured on the basis of building permits issued, amounted to 8.343 building permits, which correspond to 1.904,6 thousand m² of surface and 7.557,3 thousand m³ of volume, as compared to 10.254 building permits that were issued during the same period of 2008 and corresponded to 2.813,1 thousand m² of surface and 10.743,3 thousand m³ of volume.

Thus, there was a decrease in the number of building permits by 18,6%, in surface by 32,3% and in volume by 29,7%.

The percentage contribution of the Public Building Activity in the total building volume, for the above period of 2009, is 3,8%.

In February 2009 the magnitude of the total Building Activity (private-public), in the whole Country, amounted to 4.508 building permits, which correspond to 1.064,1 thousand m² of surface and 4.255,8 thousand m³ of volume, as compared to 5.308 building permits that where issued during the same month of 2008 and corresponded to, 1.495,3 thousand m² of surface and 5.786,0 thousand m³ of volume. Thus, there was a decrease in the number of building permits by 15,1%, in surface by 28,8% and in volume by 26,4%.

The magnitude of the Public Building Activity in February 2009, in the whole Country, amounted to 46 building permits, which correspond to 53,6 thousand m² of surface and 233,9 thousand m³ of volume, as compared to 56 building permits that where issued during the same month of 2008 and corresponded to 25,9 thousand m² of surface and 118,8 thousand m³ of volume. The percentage contribution of the Public Building Activity in the total building activity , in February 2009, is 5,5%.

DECREASE OF THE PRIVATE BUILDING ACTIVITY DURING JANUARY - FEBRUARY 2009 IN COMPARISON WITH THE SAME PERIOD OF 2008

As concerns the Private Building Activity in the whole Country, during the period January - February 2009, there was a decrease in the number of building permits by 18,6%, in surface by 33,7% and in volume by 31,1%, as compared to the same period of 2008.


The building volume in the region of Attiki, during January - February 2009, has come up to 1.781,2 thousand m³, as compared to 2.455,2 thousand m³, of the same period of 2008 (decrease by 27,5%).

The building volume in rest of the Country, during January - February 2009, has come up to 5.486,8 thousand m³, as compared to 8.093,7 thousand m³, of the same period of 2008 (decrease by 32,2%).

between 2008 and 2009




In February 2009 the magnitude of the Private Building Activity, in the whole Country, amounted to 4.462 building permits, which correspond to 1.010,4 thousand m² of surface and 4.021,9 thousand m³ of volume, as compared to 5.252 building permits that were issued during February 2008 and corresponded to 1.469,4 thousand m² of surface and 5.667,2 thousand m³ of volume. Thus, there was a decrease in the number of building permits by 15%, in surface by 31,2% and in volume by 29%.

Summary metadata: The data above refer to the authorized building activity (public and private).

Specifically, the above results refer to data on building permits totally issued by the competent authorities. Such data are collected through a special monthly survey, the Building Permits Survey. The data are collected from administrative sources (Town Planning Offices). External engineers, simultaneously with the issue of a building permit, fill in the relevant questionnaire, properly designed for the survey.

A building permit is an authorization to start work on a building project. Thus, a building permit is the final stage of planning and building authorizations, prior to the start of work.

The legal basis of the survey is the Law 2396/96 (concerning the access of the General Secretariat of the National Statistical Service of Greece to administrative sources and archives and the regulation of issues regarding census surveys and statistical works) and the following STS Regulations:

- Council Regulation (EC) No 1165/98 (concerning short-term statistics)
- Regulation (EC) of the European Parliament and of the Council No 1158/05 (amending Council Regulation (EC) No 1165/98).
