# Price Indices of Work Categories and Construction Costs Indices of New Residential Buildings<sup>1,2,3,4</sup>

# 3<sup>rd</sup> Quarter 2007

The Construction Price Indices aim at providing information on the development of prices of work categories (producer prices) and of overall costs (material and labour costs) in the construction industry of New Residential Buildings.

#### Price Index of work categories (PPI in construction)

The Price Index of Work Categories (PPI) in the 3<sup>rd</sup> quarter of 2007 as compared to the 3<sup>rd</sup> quarter of 2006, recorded a rise of 2,6%. A year earlier the index was increased by 3,0%.

That index in the 3<sup>rd</sup> quarter of 2007, as compared to the 2<sup>nd</sup> quarter of 2007 increased by 0,5%. A year earlier, the index was increased by 1,2%.

<sup>&</sup>lt;sup>2</sup> The Price Index of Work Categories expresses the price change paid to the contractors or subcontractors of the various departments in the construction process of new residential buildings.

<sup>&</sup>lt;sup>3</sup> The Construction Costs Index shows the development of costs incurred by the contractor or subcontractor to carry out the construction process for residential buildings, as a construction input price index.

<sup>&</sup>lt;sup>4</sup> The above indices were compiled and released for the first time, in 1981 based in 1980. Afterwards, the indices were revised based in 1990 and lately in 2000. With the latest revision, the Price Indices of Work Categories and Construction Costs Indices, comply to the requirements of the Council Regulation (EC) 1165/98 "on short term statistics", and of the Commission Regulation (EC) 588/2001 as regards "the definition of variables".

## **Construction Cost Index**

The Construction Cost Index in the 3<sup>rd</sup> quarter of 2007 as compared to the 3<sup>rd</sup> quarter of 2006 pointed a rise of 4,3%. A year earlier the index was increased by 4,2%.

That index in the 3<sup>rd</sup> quarter of 2007, as compared to the 2<sup>nd</sup> quarter of 2007 increased by 0,5%. A year earlier, the index was increased by 1,2%.

The Construction Cost Index from the 2<sup>nd</sup> quarter of 2007 to the 3<sup>rd</sup> quarter of 2007, rose by 0,5%, due to the changes of the component costs indices, as following:

- The Material Cost Index grew by 0,7%
- The Labour Cost Index grew by 0,3%
- The Other expenditure Costs index grew by 0,4%.

It is noted that the Material Costs Index is released monthly by a separate Press Release. More information on the rate of change of the Price Indices of Work Categories and Construction Costs Indices of New Residential Buildings are presented in the annexed tables.
