# Producer Price Index in Industry<sup>1.2</sup>

# August 2009

The National Statistical Service of Greece announces that the Producer Price Index in Industry (PPI) (with base year 2005=100.0) in August 2009 as compared to August 2008 recorded a fall of 7.8%. A year earlier, the annual rate of change of the PPI was 13.3%.

The PPI in August 2009 as compared to July 2009 recorded a rise of 1.7%. A year earlier the PPI decreased by 1.8%.

In the twelve-month period September 2008 – August 2009, the annual average rate of change of the PPI decreased by 4.4%. A year earlier the annual average rate of change of the PPI increased by 10.9%.

The National Statistical Service of Greece availability of data of PPI with base year 2005=100.0 starts from January 2000, with the distinction of the index of Non-Domestic Market in Eurozone and non-Eurozone from January 2004 onwards.

<sup>&</sup>lt;sup>1</sup>The Producer Price Index (PPI) in Industry is released from February 2009 revised and re-based in 2005=100.0 with January 2009 as first reference month. The purpose of the PPI is to measure the monthly rates of change in the prices of goods that are produced in the economic territory and are sold on the domestic market or exported to euro-zone countries and non-euro-zone countries.

<sup>&</sup>lt;sup>2</sup> The revision with base year 2005=100.0 is done in the framework of the Short –Term Statistics (STS) Council Regulation (EC) no 1165/98 concerning short-term statistics. According to this Regualtion the index in question is updated every five years. in years ending in 0 or 5. At this revision has been applied (Council Regulation 1893/2006) the new Eurostat classification NACE Rev. 2 (at the level of categories of economic activity). In addition, at product level has been applied the new Eurostat classification CPA 2008 (Council Regulation 451/2008).

# Monthly rates<sup>3</sup>

Prices in total industry in August 2009, as compared to the previous month July 2009, increased by 1.7% due to the monthly changes of the Main Industrial Groupings prices, as following:

- □ Intermediate goods prices grew by 0.6%.
- □ Capital goods prices remained unchanged.
- Durable consumer goods prices grew by 0.3%.
- □ Non-Durable goods prices grew by 0.3%.
- □ Prices in Energy grew by 4.7%.

## Annual rates<sup>4</sup>

Prices in total industry in August 2009, as compared to August 2008, decreased by 7.8% due to the annual changes of the Main Industrial Groupings prices, as following:

- □ Intermediate goods prices fell by 2.2%.
- □ Capital goods prices fell by 2.1%.
- Durable consumer goods prices grew by 3.6%.
- □ Non-Durable goods prices grew by 0.7%.
- □ Prices in Energy fell by 19.7%.

More information on the rates of change of the PPI, as it concerns the distinction in Domestic and Non-Domestic market, are presented in the annexed tables (1,2,3,4,5).
