
# PRODUCTION INDEX IN INDUSTRY: October 2016 y-o-y increase by 6.8%

The evolution of the Production Index in Industry (IPI) with base year 2010=100.0 for October 2016, according to provisional data, is as follows:

The Production Index in Industry (IPI), according to working day adjusted data, in October 2016 compared with October 2015 recorded an increase of 6.8%. In October 2015, the annual rate of change of the IPI was -1.7% (Table 1).

In the 10-month period from January 2016 to October 2016, according to working day adjusted data, the average rate of change of the IPI was 2.3%. In October 2015, the corresponding average rate of change of the IPI was 0.3% (Table 2).


The seasonally adjusted Production Index in Industry (IPI), after eliminating the monthly effects (e.g. holidays, tourist period etc), in October 2016 compared with September 2016 recorded an increase of 4.3% (Table 4).



It should be noted that the whole series with seasonally adjusted indices is recalculated every time a new observation is added in time series. Therefore, the seasonally adjusted data differ from the published data of the previous Press Release.

### Comparisons of the Industrial Production Index in October 2016

I. Annual comparison of the Industrial Production Index (Table 1)

The **increase** of IPI by **6.8**%, according to working day adjusted data, in **October 2016** compared with the corresponding index in **October 2015** is due to the following annual changes in the industrial sections:

#### 1. Increases of indices:

- By **7.2%** of the Manufacturing Production Index.
- By 8.9% of the Electricity Production Index.
- By 2.6% of the Water Supply Production Index.

### 2. Decreases of indices:

- By 3.1% of the Mining and Quarrying Production Index.
- 2. Comparison of average rates of change of the Industrial Production Index of the period January October 2016 with January October 2015 (Table 2)

The **increase** of IPI by **2.3**%, according to working day adjusted data, in the 10-month period **January – October 2016**, compared with the corresponding index in the period **January – October 2015** is due to the following 10-month average rates of change in the industrial sections:

#### 1. Increases of indices:

- By 4.8% of the Manufacturing Production Index.
- By **0.3%** of the Water Supply Production Index.

#### 2. Decreases of indices:

- By 16.9% of the Mining and Quarrying Production Index.
- By 0.8% of the Electricity Production Index.
- 3. Monthly comparison of the Industrial Production Index (Table 4)

The **increase** of IPI by **4.3**%, according to seasonally adjusted data, in **October 2016** compared with the corresponding index in **September** 2016 is due to the following monthly changes in the industrial sections:

#### Increases of indices:

- By 2.8% of the Mining and Quarrying Production Index.
- By **3.7%** of the Manufacturing Production Index.
- By **6.6%** of the Electricity Production Index.
- By 2.1% of the Water Supply Production Index.

The following graph depicts the evolution of the Industrial Production Index and the Industrial Sections Indices.



#### **METHODOLOGICAL NOTES**

Generally The Industrial Production Index (IPI) is being compiled since 1959.

### Purpose of the index

The IPI is an important business cycle indicator, which shows the monthly activity in the Mining-Quarrying, Manufacturing, Electricity and Water Supply sectors. A more specific object of the Industrial Production Index is to compare the magnitude (volume) of the current month's output at any given time with the corresponding figure for a given base period. The IPI shows the evolution of value added, at factor cost, of production, at constant prices.

#### **Legal basis**

The compilation of IPI is governed by Council Regulation (EEC) No.1165/98 "concerning short-term statistics". Furthermore, the IPI is governed by the Regulation (EEC) No.1893/2006 of the European Parliament and of the Council, by the Commission Regulation (EEC) No.656/2007 and by the Regulation (EEC) No.451/2008 of the Council.

#### Reference period Month

Base year 2010=100.0.

#### Revision

The IPI is a fixed base index. Pursuant to the provisions of Council Regulation No 1165/98 concerning short-term statistics, the index in question is updated every five (5) years in years ending in 0 or 5.

#### Statistical classifications

At the level of categories of economic activities the Eurostat classification NACE Rev. 2 was used (Regulation 1893/2006), while at the level of main industrial groups, the allocation of two-digit and three-digit NACE Rev. 2 headings to categories of aggregate classification was used, in accordance with the Council Regulation 656/2007. At product level, the Eurostat classification CPA 2008 was used, according to the Council Regulation 451/2008.

### Geographical coverage

The Index covers the whole country.

# Coverage of economic

activities

The index covers all the sections of industry, the main industrial groups, all the levels of economic activities (divisions, groups, classes) and the level of products.

## Statistical survey

The data are collected from a sample of 1,338 enterprises. The survey covers a total of 354 products and the measurement of the surveyed products is made in terms of output quantities or in terms of production value or turnover, according to the specific situation in each branch of economic activity.

#### Seasonal adjustment

Seasonal adjustment is the procedure followed to remove the impact of seasonality on the time-series in order to improve the comparability over time. The method used is the TRAMO-SEAT method with the use of JDemetra+ 2.0.0.

For the seasonal adjustment of the Industrial Production Index at 2-digit level of NACE Rev.2, at section level (B – Mining – Quarrying, C – Manuafcturing, D – Electricity and E – Water Supply) and for the Main Industrial Groupings (MIGs), the direct approach is applied, namely each time-series is seasonally adjusted independently. For the overall Industrial Production Index, the indirect approach is applied, with the seasonally adjusted IPI being computed by aggregating the seasonally adjusted MIGs using appropriate weights.

#### **Publication of data**

The IPI with the new base year (2010) is being released since August 2014 with June 2014 as first reference month. Data with base year 2010=100.0 are available from January 2000 onwards.
