



## TURNOVER INDEX IN INDUSTRY: October 2014

The Turnover Index in Industry (both domestic and non-domestic market) in October 2014 compared with October 2013 recorded an increase of 4.1%. In October 2013, the annual rate of change of the Turnover Index in Industry was -10.1%.

The average Turnover Index in Industry for the 12-month period from November 2013 to October 2014, as compared to the 12-month period from November 2012 to October 2013, decreased by 2.4%. In October 2013, the corresponding average rate of change of the Turnover Index in Industry was -4.1%.

Diamantaki Aikaterini Karathanos Panagiotis Tel: 0030 213 1352122 Fax: 0030 213 1352738 The Hellenic Statistical Authority (ELSTAT) according to the European Statistics Code of Practice and the national Revision Policy principles<sup>1</sup>, informs that the time series January 2010 – September 2014 of the Turnover Index in Industry with base year 2010=100.0, which was published by ELSTAT on 19 November 2014, along with the announcement of the Press Release of the Index for September 2014, have been modified after corrections deemed necessary to the computing program for complete alignment with Regulation (EC) 1165/98.

More specifically, in the previous computing program the sub-indicators were calculated independently for each market. With the new computing program the "Turnover Index in Industry for Non-Domestic Market", is derived as a weighted index of individual markets "Non-Domestic Market in Eurozone Countries" and "Non-Domestic Market in Non-Eurozone Countries" and the index "Turnover Index in Industry (Total market)" as a weighted index of individual markets "Domestic Market".

The revision concerns the Turnover Indices in Industry for "Turnover Index in Industry (Total market)" and "Turnover Index in Industry for Non-Domestic Market". The Indices "Domestic Market", "Non-Domestic Market in Eurozone Countries" and "Non-Domestic Market in Non-Eurozone Countries" remain unchanged. In Table 9 the Overall Turnover Indices for Total Market and Total External Market before and after the correction are provided.

Also the backwards time series January 2000 - December 2009 for the aforementioned markets have been revised.

The increase of the Turnover Index in Industry by 4.1% in October 2014, compared with October 2013, was due to the annual changes as following:

- by Industrial Sections

- Mining and quarrying turnover increased by 1.5%.
- Manufacturing turnover increased by 4.1%.

In addition, the increase of the Turnover Index in Industry by 4.1% in October 2014, compared with October 2013, was due to the annual changes of the indices of the markets as following:

- The Turnover Index in Industry for the domestic market increased by 1.3%.
- The Turnover Index in Industry for the non-domestic market increased by 8.0%.

The increase of the Turnover Index in Industry for the non-domestic market by 8.0% in October 2014, compared with October 2013, was due to the annual changes as following:

- The Turnover Index in Industry for the Eurozone countries increased by 1.5%.
- The Turnover Index in Industry for the non-Eurozone countries increased by 10.9%.

#### **METHODOLOGICAL NOTES**

**Generally** The Turnover Index is being compiled since 2006.

- **Purpose of the index** The purpose of this index is to measure the monthly activity of the industrial sector in terms of value. Turnover comprises the totals invoiced (without VAT) by the observation units during the reference period and corresponds to the market sales of goods or services supplied to third parties. The purposes and the characteristics of the Turnover Index apply, as well, to the indices for the distinction between domestic and non-domestic turnover.
  - Legal basis The compilation and publication of the Turnover Index is based on the framework of requirements of the Council Regulation (EC) No 1165/98 concerning short-term statistics (STS-R), as well as the amendment Regulation (EC) No 1158/05 of the European Parliament and Council, amending the Council Regulation (EC) No 1165/98. Furthermore, this index is governed by the Regulation (EEC) No.1893/2006 of the European Parliament and of the Council, by the Commission Regulation (EEC) No.656/2007 and by the Regulation (EEC) No.451/2008 of the Council.

Reference period Month

**Base year** 2010=100.0.

- **Revision** The last revision of the Turnover Index in Industry with base year 2010=100.0 is done in the framework of the Short Term Statistics (STS) Council Regulation (EC) No 1165/98 concerning short-term statistics. According to this regulation the index in question is updated every five years, in years ending in 0 or 5.
- Statistical At the level of categories of economic activities the Eurostat classification NACE Rev. 2 was used (Regulation 1893/2006), while at the level of main industrial groups, the allocation of two-digit and three-digit NACE Rev. 2 headings to categories of aggregate classification was used, in accordance with the Commission Regulation 656/2007. At product level, the Eurostat classification CPA 2008 was used, according to the Council Regulation 451/2008.

**Geographical** The Index covers the whole country.

#### **Coverage of economic** activities The Turnover Index in Industry covers the whole country and is compiled for all activities listed in Sections C (mining and quarrying) and D (manufacturing) of the NACE Rev.2 classification.

- Publication of data The Turnover Index with base year 2010=100.0 is being released since November 2014 with September 2014 as first reference month. Data with base year 2010=100.0 are available from January 2000 onwards.
