COMMERCIAL TRANSACTIONS OF GREECE : April 2021

(Provisional Data)

The total value of imports-arrivals, in April 2021 amounted to 5,014.8 million euros (5,975.6 million dollars) in comparison with 3,198.8 million euros (3,464.2 million dollars) in April 2020, recording an increase, in euros, of **56.8%**. The corresponding value excluding oil products in April 2021 recorded an increase of 1,182.9 million euros or 44.7% and the corresponding value excluding oil products and ships in April 2021 recorded an increase of 1,170.2 million euros or 44.4%, in comparison with April 2020 (Table 1).

The total value of exports-dispatches, in April 2021 amounted to 3,172.1 million euros (3,803.0 million dollars) in comparison with 2,119.3 million euros (2,308.9 million dollars) in April 2020, recording an increase, in euros, of **49.7%**. The corresponding value excluding oil products recorded in April 2021 an increase of 657.0 million euros or 37.6% and the corresponding value excluding oil products and ships in April 2021 recorded an increase of 650.2 million euros or 37.2%, in comparison with April 2020 (Table 1).

The deficit of the trade balance, in April 2021 amounted to 1,842.7 million euros (2,172.6 million dollars) in comparison with 1,079.5 million euros (1,155.3 million dollars) in April 2020, recording an increase, in euros, of **70.7%**. The corresponding value of deficit excluding oil products in April 2021 recorded an increase of 525.9 million euros or 58.8% and the corresponding value excluding oil products and ships in April 2021 recorded an increase of 520.0 million euros or 58.6%, in comparison with April 2020 (Table 1).

The total value of imports-arrivals, for the 4-month period from January to April 2021 amounted to 18,530.8 million euros (22,202.5 million dollars) in comparison with 16,436.6 million euros (18,014.1 million dollars) for the corresponding period of the year 2020, recording an increase, in euros, of **12.7%**. The corresponding value excluding oil products recorded an increase of 1,728.3 million euros or 13.6% and the corresponding value excluding oil products and ships recorded an increase of 1,737.3 million euros or 13.8%, in comparison with the period from January to April 2020 (Table 5).

The total value of exports-dispatches, for the 4-month period from January to April 2021 amounted to 11,949.7 million euros (14,407.5 million dollars) in comparison with 10,099.4 million euros (11,132.3 million dollars) for the corresponding period of the year 2020, recording an increase, in euros, of **18.3%**. The corresponding value excluding oil products in comparison with the period from January to April 2020, recorded an increase of 1,355.5 million euros or 17.6% and the corresponding value excluding oil products and ships recorded an increase of 1,350.7 million euros or the same change rate, 17.6% (Table 5).

The deficit of the trade balance, for the 4-month period from January to April 2021 amounted to 6,581.1 million euros (7,795.0 million dollars) in comparison with 6,337.2 million euros (6,881.8 million dollars) for the corresponding period of the year 2020, recording an increase, in euros, of **3.8%**. The corresponding value excluding oil products in comparison with the period from January to April 2020, recorded an increase of 1,355.5 million euros or 17.6% and the corresponding value excluding oil products and ships recorded an increase of 1,350.7 million euros or the same percentage rate of 17.6%. The monthly data of Intra EU transactions, have been adjusted to the total trade transactions with EU countries, including the transactions below the statistical threshold⁽¹⁾, on the basis of the Recapitulative Statements of Intra-EU Deliveries and Acquisitions that are submitted by the enterprises to the Ministry of Finance. Accordingly, the provisional data from the "incomplete customs declarations" have been incorporated in the monthly data on trade with third countries and, after having been completed, they will be replaced by the final data.

⁽¹⁾ By virtue of EU Regulations on the compilation of intra-EU trade statistics, Member States set out a "statistical exemption threshold". On the basis of the exemption threshold, the enterprises whose transactions are below the statistical threshold are exempted from the obligation to submit data on their intra-Community transactions (Intrastat declaration). The aim is to reduce the burden on enterprises. The statistical exemption threshold, valid for each year, is specified and released by ELSTAT on a yearly basis.

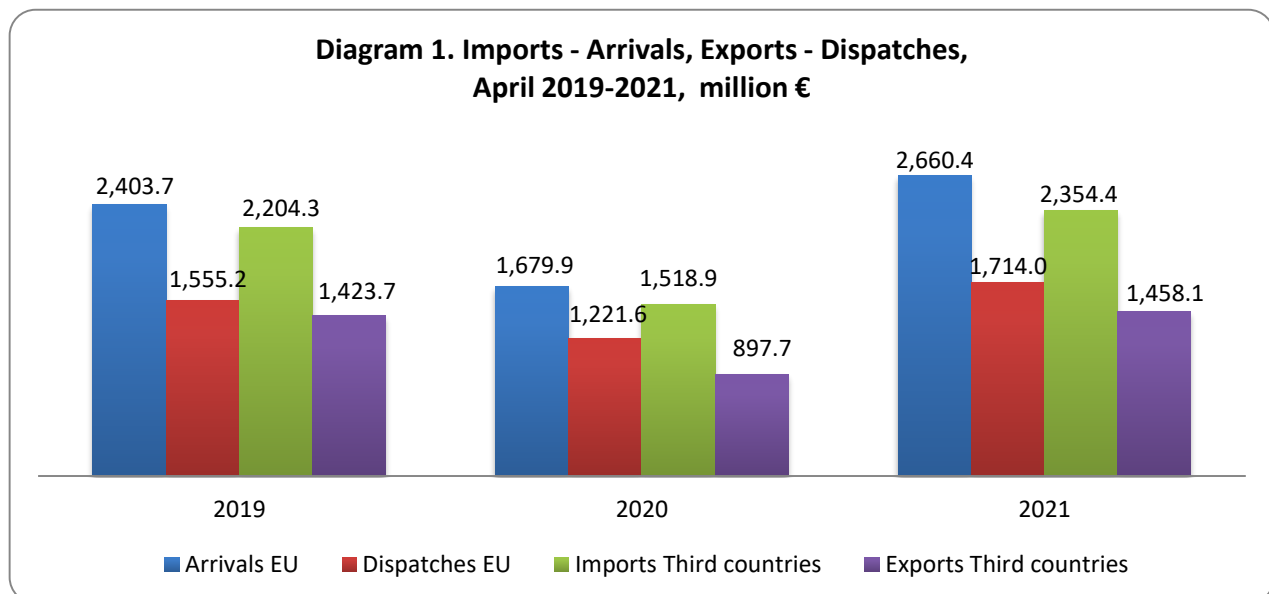

Diagram 2. Imports - Arrivals, Exports - Dispatches excluding oil products, April 2019-2021, million €

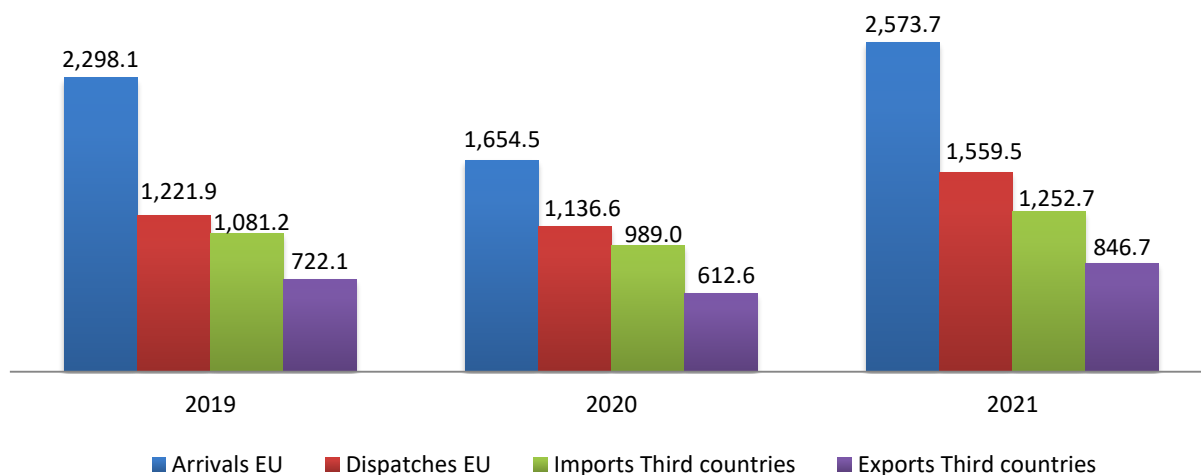

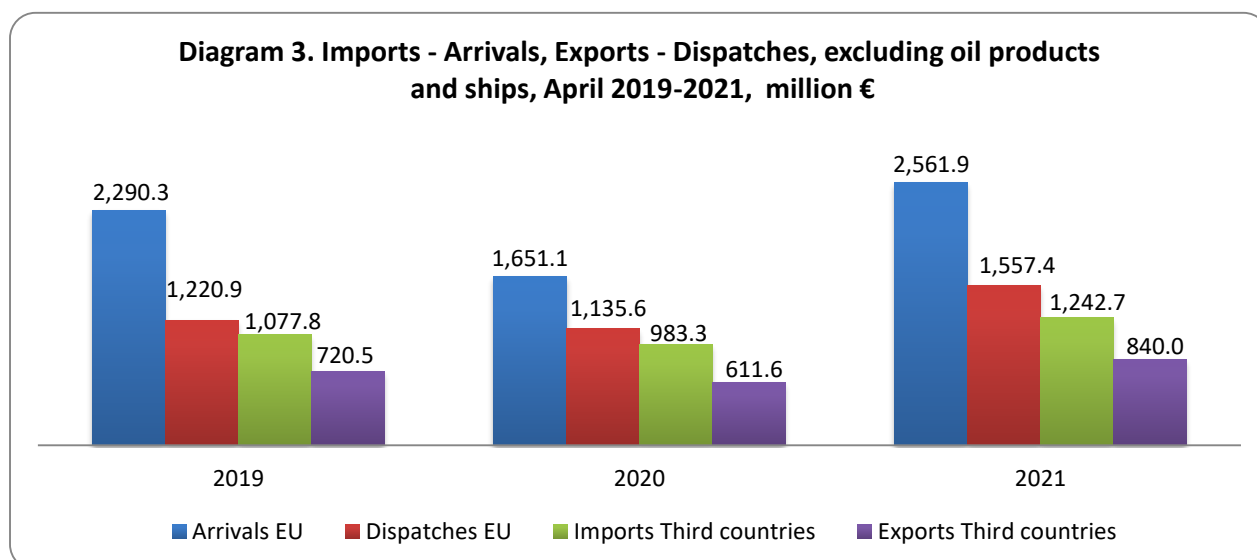

Diagram 4. Imports - Arrivals, Exports - Dispatches, January - April 2019-2021, million €

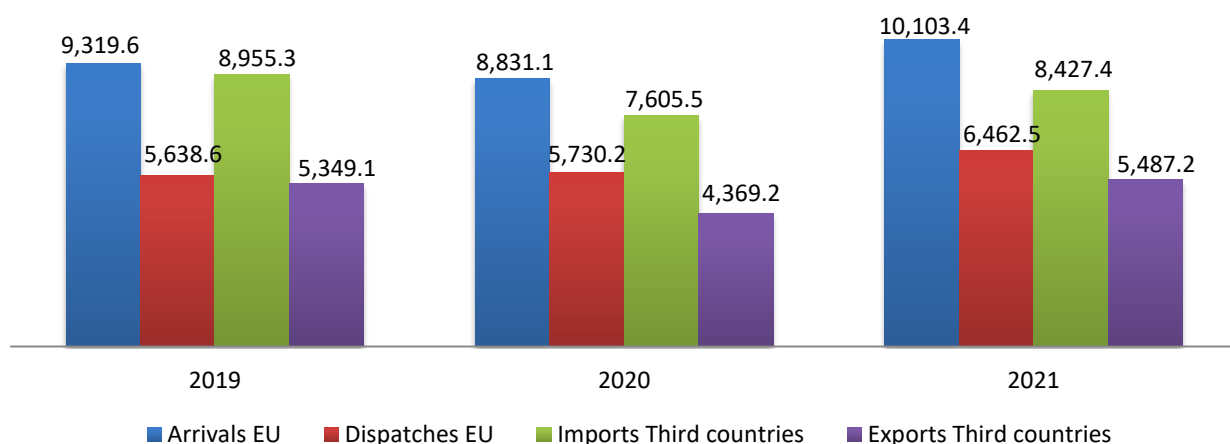

Diagram 5. Imports - Arrivals, Exports - Dispatches, excluding oil products, January - April 2019-2021, million €

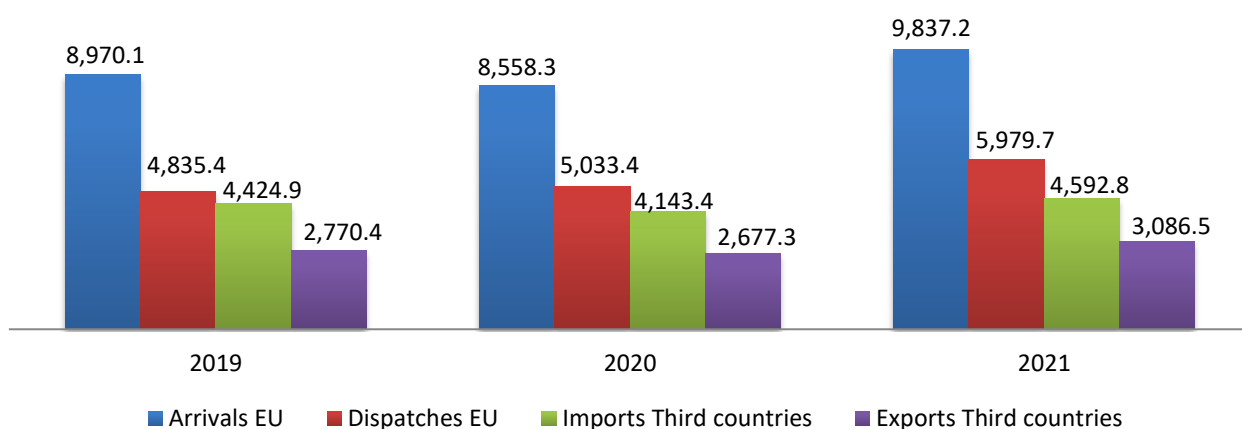

Diagram 6. Imports - Arrivals, Exports - Dispatches, excluding oil products and ships, January - April 2019-2021, million €

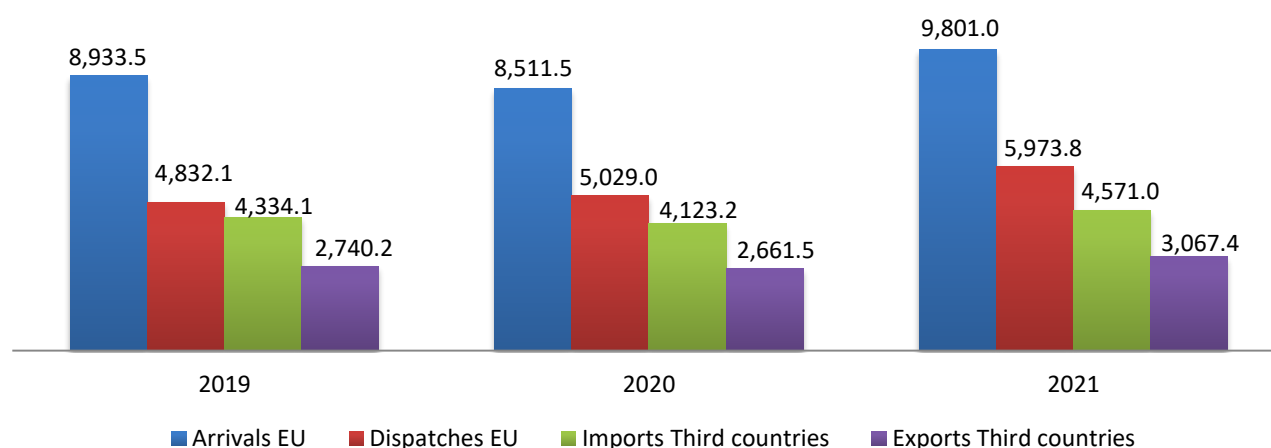

Diagram 7a. Percentage (%) distribution of E.U. arrivals by SITC sections, April 2021

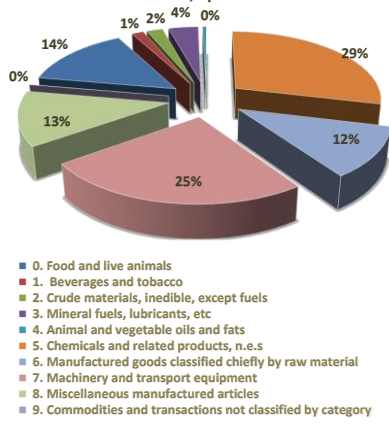


Diagram 7b. Percentage (%) distribution of Third countries imports by SITC sections, April 2021

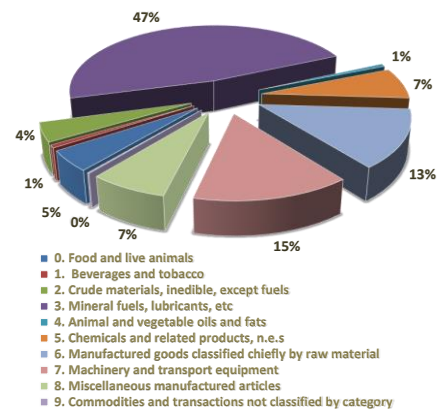


Diagram 8a. Percentage (%) distribution of E.U. dispatches by SITC sections, April 2021

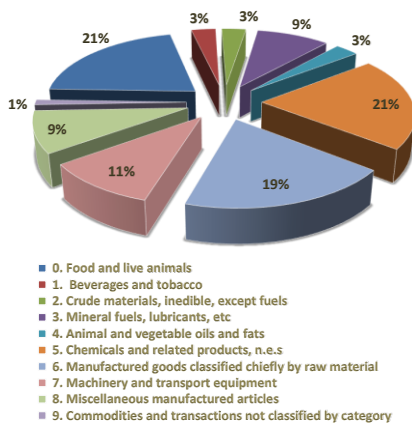


Diagram 8b. Percentage (%) distribution of Third countries exports by SITC sections, April 2021

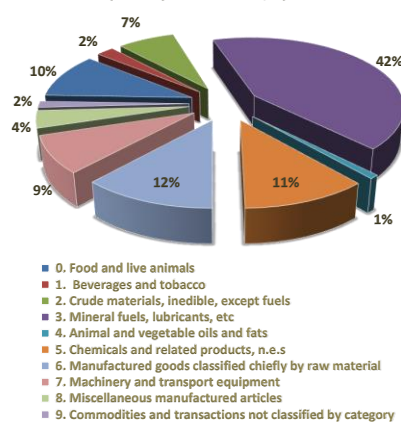


Diagram 9. Imports - Arrivals E.U. & Third countries by SITC sections, Jan. - Apr. 2021, million €

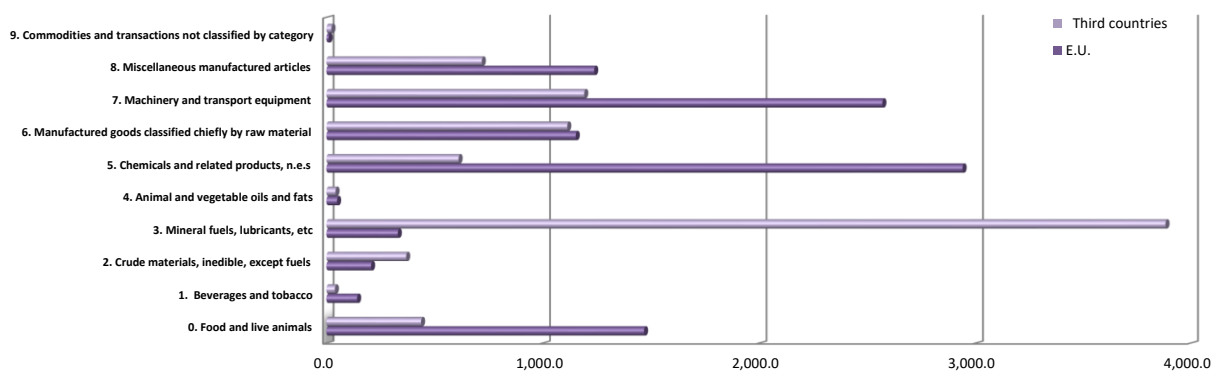


Diagram 10. Exports - Dispatches E.U. & Third countries by SITC sections, Jan. - Apr. 2021, million €

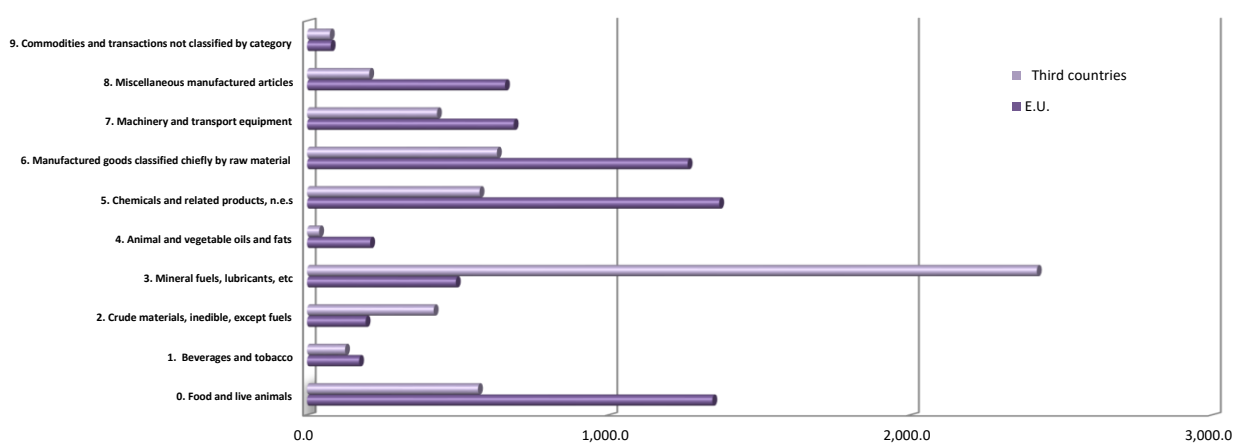

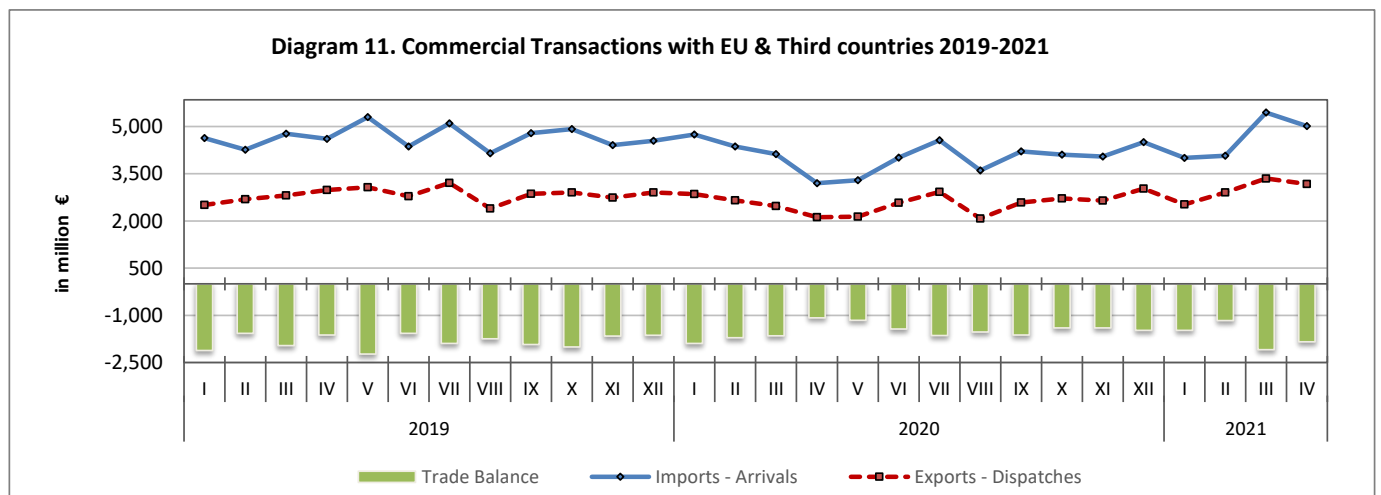
