



EVOLUTION OF TURNOVER OF ENTERPRISES IN ACCOMMODATION AND FOOD SERVICE ACTIVITIES

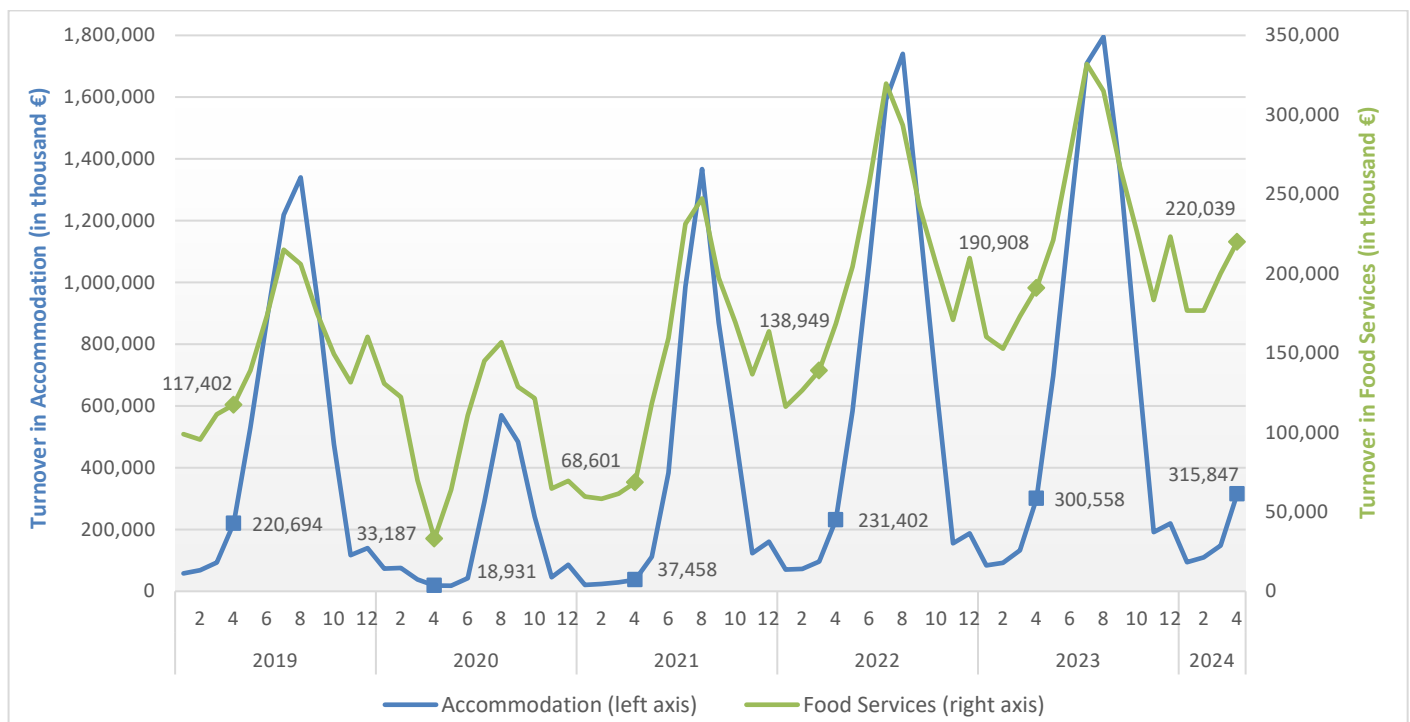

The Hellenic Statistical Authority (ELSTAT) announces data on the evolution of turnover of enterprises in the Accommodation and Food and Beverage Service Activities divisions, per Regional Unit, incorporating the most recent data on turnover from Administrative Sources for **April 2024**.

For the enterprises in **Accommodation Activities** (division 55 of NACE Rev.2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in April 2024 amounted to 315,846,962 euro, recording an increase of 5.1% in comparison with April 2023, when the respective turnover was 300,558,085 euro (Graph1, Table 2).

For the enterprises in **Food and Beverage Service Activities** (division 56 of NACE Rev.2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in April 2024 amounted to 220,039,364 euro, recording an increase of 15.3% in comparison with April 2023, when the respective turnover was 190,908,039 euro (Graph1, Table 2).

In total, for the enterprises in the **Accommodation and Food and Beverage Service Activities** (divisions 55 and 56 of NACE Rev. 2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in April 2024 amounted to 535,886,326 euro, recording an increase of 9.0% in comparison with April 2023, when the respective turnover was 491,466,124 euro (Table 2).

For the Regional Units with a contribution to the total turnover of the year 2023 greater than 1.0% (Table 1), the biggest increase in the turnover of April 2024 compared with April 2023 was recorded in the Regional Unit Zakynthos (41.4%) and the smallest increase (0.8%) was recorded in the Regional Unit Rethymno, while the biggest decrease (24.9%) was recorded in the Regional Unit Kerkyra (Table 3).

(Double underline): The turnover of enterprises that changed the frequency of data submission to the tax authorities from monthly to quarterly basis is included.

Note:

Enterprises with single-entry accounting bookkeeping are obliged to submit data to tax authorities on a quarterly basis while enterprises with double-entry accounting bookkeeping are obliged to submit data on a monthly basis. Therefore, for the total of enterprises data are available only on a quarterly basis.

Generally The statistical data presented in this announcement have been compiled on the basis of the linking and processing of primary data from the following sources:

- The final Statistical Business Register of ELSTAT of the reference year 2021.
- Administrative registers of enterprises, of the reference years 2022 and 2023.
- Administrative transactions files (tax, etc) of the reference years 2019 to 2024.

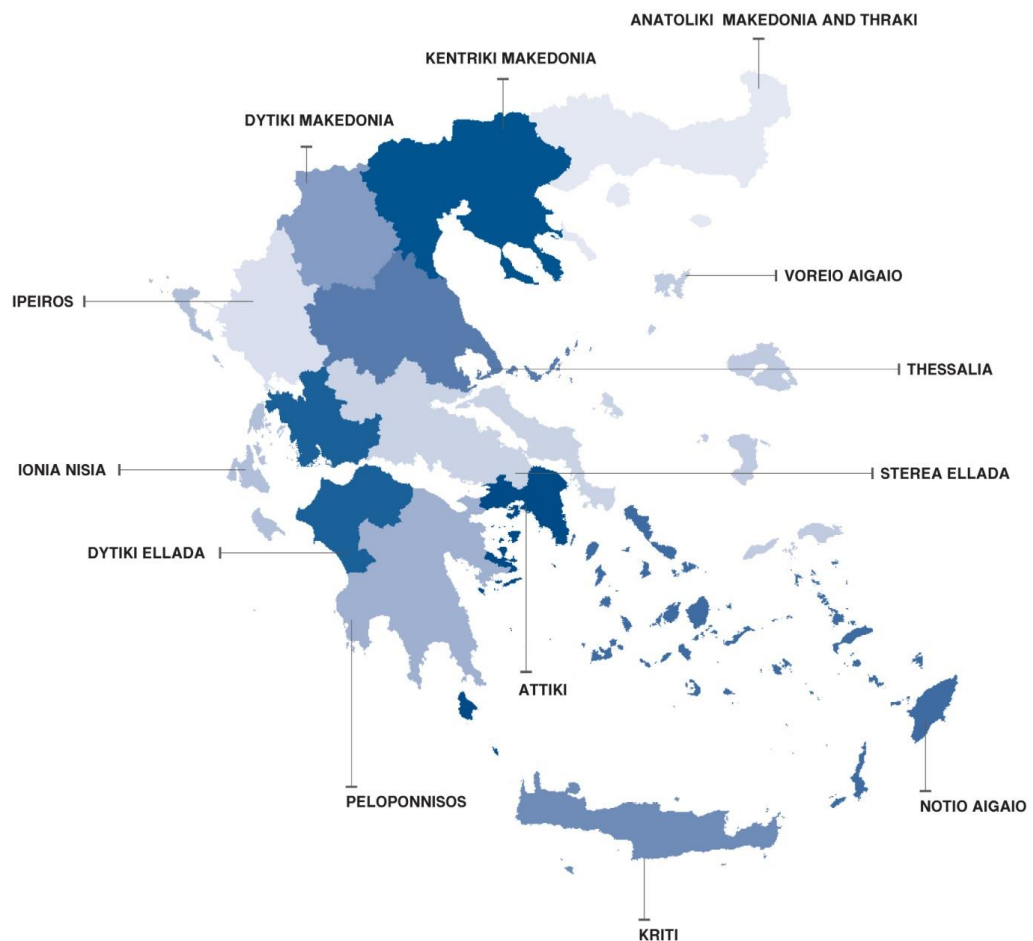
In particular the following primary data have been used per source:

- Active enterprises and the economic activity class from the final Statistical Business Register of the reference year 2021.
- The economic activity class for the enterprises that started their activity after the reference year 2021 and have a significant turnover, from administrative registers of enterprises of the reference years 2022 and 2023.
- Income data from administrative transaction files of the years 2019 to 2024.

It is noted that the geographical classification of enterprises is based on the location of the enterprise's headquarters.

Statistical classifications For the economic activities the European statistical classification of economic activities [NACE Rev.2](#) is used.

Statistical unit The statistical unit is the legal unit (distinct Tax Identification Numbers (TIN)).

Comparability The announced statistical data are comparable with the data of the final Statistical Business Register of ELSTAT of the reference year 2021 (relevant link from the webpage of ELSTAT where tables and information on the methodology applied are provided [Statistical Business Register](#)).
