## 2011 Population and Housing Census

### Statistical data on the reasons on account of which immigrants (with Greek or foreign citizenship) settle in Greece

The Hellenic Statistical Authority (ELSTAT), after having processed and checked all the variables included in the questionnaires of the 2011 Population-Housing Census, announces data on the reasons on account of which immigrants settle in Greece.

It should be noticed that ELSTAT has already announced data on migration (internal migration- immigration) of the Resident Population in a previous press release.

#### **Reasons for settling in Greece one year before the Census**

On the basis of the results of the 2011 Population-Housing Census, the total number of immigrants who settled in Greece one year before the Census amounted to 79,554 (43,341 males and 36,213 females). Out of the total number of immigrants, 33,751 (42.4%) had Greek citizenship, while 45,803 (57.6%) had foreign citizenship.

The biggest share, 36.7%, of immigrants with Greek citizenship who settled in Greece one year before the census, reported moving back to Greece for repatriation reasons. On the other hand, the biggest share, 39.9%, of immigrants with foreign citizenship reported moving to Greece in order to find a job.

Available census data indicate that out of the number of 18,264 immigrants with foreign citizenship that reported moving to Greece in order to find a job, 10,285 (56.3%) of them reported that they were employed during the last week before the reference date of the Census (3-9/5/2011), while 4,852 (26.6%) reported that they were seeking for a job and 3,127 (17.1%) were not economically active.

Tables 1 and 2 below depict the distribution of immigrants who settled in Greece, one year before the census, according to their citizenship (Greek-foreign) and by age group and reason for settling in Greece.





Graphs 1 and 2 below illustrate the reasons for moving to Greece as regards the immigrants with Greek and foreign citizenship, respectively , by countries of previous residence, from where came the biggest share of immigrants, one year before the Census.

Reasons for settling in Greece five years before the Census

On the basis of the results of the 2011 Population-Housing Census, the total number of immigrants who settled in Greece five years before the Census amounted to 329,556 (172,055 males and 157,501 females). Out of the total number of immigrants, 128,434 (39.0%) had Greek citizenship, while 201,122 (61.0%) had foreign citizenship.

The biggest share of immigrants with Greek citizenship, 38.9%, who settled in Greece the last five years before the census, reported moving back to Greece for repatriation reasons. On the other hand, the biggest share of immigrants with foreign citizenship, 43.1% reported moving to Greece in order to find a job.

Available census data indicate that out of the number of 86,584 immigrants with foreign citizenship that reported moving to Greece in order to find a job, 52,763

(60.9%) of them reported that they were employed during the last week before the reference date of the Census (3-9/5/2011), while 17,211 (19.9%) reported that they were seeking for a job and 16,610 (19.2%) were not economically active.

Tables 3 and 4 below depict the distribution of immigrants who settled in Greece, during the last five years before the census, according to their citizenship (Greek-foreign) by age group and reason for settling in Greece.







## Methodological Note

#### 1. Legal Framework

The conduct of the General Censuses of Population-Housing and Buildings is provided for in article 10 of the Law 3832/2010 "Hellenic Statistical System (ELSS). Establishment of the Hellenic Statistical Authority (ELSTAT) as an independent authority".

In particular, the 2011 Censuses of Buildings and of Population – Housing were conducted on the basis of Presidential Decree 168 (Government Gazette 223, issue A/2008) and in compliance with the methodological principles of Regulation (EC) 763/2008 of the European Parliament and of the Council and its implementing Regulations related to Population and Housing Censuses, the Joint Ministerial Decision 1524/ $\Gamma$ 5-473 (Government Gazette 425, issue B/2011) and its amendment (Government Gazette 783, issue B/2011), and with the Legislative Act relating to the Conduct of the Population-Housing Census (Government Gazette 106 issue A/2011), as it was ratified by the Law 3995/2011 (Government Gazette 166 issue A/2011).

#### 2. Purpose

The purpose of the General Censuses is to collect data on the Resident Population of the Country, the demographic, economic and social characteristics of the population, their housing conditions and the characteristics of their dwellings, along with data on the stock of buildings of the Country.

### 3. Useful concepts- basic definitions

**3.1 Employed** are the persons aged 15 years or older, who during the week preceding the Census, declared:

(a) that they worked, even for just one hour, for pay or profit, in cash or in kind

(b) they were not at work but had a job or business from which they were temporarily absent.

**3.2 Seeking for job** are the persons aged 15 and over who during the week preceding the Census, declared:

(a) that they were without work i.e, they were neither employed nor self-employed, or

(b) they were currently available for work , i.e., they were ready to start working as salaried employees or self-employed during the week preceding the Census and for two weeks after the Census and

(c) they were seeking for a job, i.e., they had taken all the necessary steps to search for a salaried job or self-employment, within 4 weeks from the end of the week preceding the Census.

**3.3 Economically non-active** are those persons who are younger than the working age (on the basis of the national definition for the minimum working age) for having an economic activity, as well as pensioners, capital income recipients, etc.
