Building Activity Survey: August 2020

The Hellenic Statistical Authority (ELSTAT) announces the provisional data, for the month August 2020, of the Building Activity Survey. More specifically:

- The Total Building Activity (private-public) in Greece, in August 2020 which is calculated on the basis of the number of issued building permits, amounted to 1,294. This figure corresponds to 296.5 thousand m² of surface and 1,360.2 thousand m³ of volume, reflecting, respectively, a 3.3% decrease in the number of building permits, an 8.7% decrease in surface and an 11.0% decrease in volume, compared with the corresponding month of 2019 (Table 1).
- The building permits for the Private Building Activity issued in Greece in August 2020 amounted to 1,287. This figure corresponds to 295.2 thousand m² of surface and 1,356.0 thousand m³ of volume. In comparison with the same month of 2019 there is a 3.5% decrease in the number of building permits, an 8.9% decrease in surface and an 11.1% decrease in volume (Table 2).
- The building permits for the Public Building Activity issued in Greece in August 2020 amounted to 7. This figure corresponds to 1.4 thousand m² of surface and 4.2 thousand m³ of volume. Public Building Activity accounted for 0.3% of the total building volume in August 2020.
- In the last twelve months, from September 2019 until August 2020, Total Building Activity (private-public) in Greece, calculated on the basis of the number of issued building permits, amounted to 18,744. This figure corresponds to 4,081.0 thousand m² of surface and 17,865.7 thousand m³ of volume. In comparison with the corresponding period from September 2018 until August 2019, there is a 16.5% increase in the number of building permits, a 13.9% increase in surface and a 13.9% increase in volume (Table 3).
- In the same period, from September 2019 until August 2020, Private Building Activity in Greece recorded a 16.5% increase in the number of issued building permits, a 15.9% increase in surface and a 17.1% increase in volume, compared with the corresponding period from September 2018 to August 2019 (Table 4). During the same period, Public Building Activity accounted for 1.0% of the total building volume.
- During the period January August 2020, Total Building Activity (private-public) in Greece recorded a 13.7% increase in the number of issued building permits, a 13.6% increase in surface and a 13.5% increase in volume, compared with the corresponding period of 2019 (Table 5). During the same period, January August 2020, Private Building Activity in Greece recorded a 13.3% increase in the number of issued building permits, a 14.7% increase in surface and a 15.5% increase in volume, in comparison with the corresponding period of January August 2019 (Table 6).





Graph 1. Private Building Activity (volume), by Region (NUTS II), August 2019 and 2020*





Graph 2. Private Building Activity (volume), by Region (NUTS II), September 2018 – August 2019 and September 2019 – August 2020*





EXPLANATORY NOTES

Building Activity Survey

The Building Activity Survey has been providing exhaustive data on a monthly and yearly basis, since 1964. The purpose of this survey is to register the total number of building permits issued by the responsible administrative authorities, which are devolved to complete the questionnaire. The survey covers all the features of building activity, such as the type of building permit, the type of construction, the type and the characteristics of the building and its auxiliary spaces, as well as building usage, surface, volume and value.

Legal Framework

The survey is fully harmonized with the European legislation. The primary legislative act is Regulation (EC) No 1165/1998, as it was amended according to Regulation (EC) No 1158/2005.

Reference Period


August 1, 2020 to August 31, 2020.

Coverage

The survey is exhaustive and covers the total number of issued building permits across the Country.

Geographical classification

The geographical classification is based on Nomenclature of Territorial Units for Statistics (NUTS).

Definitions Building Permit refers to all types of building permits. These are permits for new buildings or permits for additions, repair, renovation, demolition, legitimization, amendment and modification of a building.

The denotation of "built-property" is equal to "building".

Building is every permanent and independent structure, which has walls and a roof and consists of one or more rooms and other complementary spaces. Normally, buildings feature four walls. However, a construction open from one or even two sides will be considered a building, as long as it has a roof.

New building is any built-property raised on an uncovered site or in the place of an old building that has been demolished.

Building addition is every construction that adds building volume (space) to an existing building, in terms of surface, height or both and creates a residence, a shop or both.

Building volume (the gross building volume) refers to the area that is included between the external surface of the external walls, the lowest level (the basement or the subbasement, if it exists) and the roof of the building. If there is an open ground floor not enclosed within walls between the lower floor and the roof, its volume is taken into account. The relevant authorities calculate the volume of the building during the issuing of the building permit.

Surface of new-built property is considered to be the sum of each floor area along with the outer side of the outer walls, as well as other auxiliary spaces.

Data collection and processing in No impact occurred to the completeness and the timely transmission of the data on the the context of COVID-19 issued building permits from the competent administrative authorities.

General Remark Any delineation that may occur either between the sum of sub totals and the totals or in the change rates, is due to rounding.
