- Appearance of the family status of individuals, broken down into three (3) categories: a) single, b) married or in a civil partnership including those who are separated and c) widowed or divorced.
- Appearance of the occupation of individuals, by 1-digit ISCO code.
- Appearance of the branch of main economic activity of the enterprises in which the individuals work, broken down into three (3) categories: Primary sector; Secondary sector; Tertiary sector (i.e., Agriculture-Livestock-Fishery; Manufacturing-Construction; Trade and Services).
- Appearance of the occupational status of individuals, broken down into four (4) categories: a) Self-employed with employees, b) Self-employed without employees, c) Employee and d) Family worker.
- Appearance of the current labour status – occupation of individuals, broken down into eight (8) categories: a) Employed (including the unpaid family workers, the paid apprentices and those temporarily absent from their work), b) Unemployed, c)
