COMMERCIAL TRANSACTIONS OF GREECE : June 2025

(Provisional Data)

The total value of imports, in June 2025 amounted to 7,080.6 million euros (8,130.2 million dollars) in comparison with 6,657.2 million euros (7,141.4 million dollars) in June 2024, recording an increase, in euros, of **6.4%**. The corresponding value excluding oil products in June 2025 recorded an increase of 560.9 million euros or 10.9% and the corresponding value excluding oil products and ships in June 2025 recorded an increase of 560.6 million euros or 11.0%, in comparison with June 2024 (Table 1).

The total value of exports, in June 2025 amounted to 3,943.0 million euros (4,554.7 million dollars) in comparison with 4,301.7 million euros (4,641.9 million dollars) in June 2024, recording a drop, in euros, of **8.3%**. The corresponding value excluding oil products recorded in June 2025 an increase of 108.8 million euros or 3.7% and the corresponding value excluding oil products and ships in June 2025 recorded an increase of 140.3 million euros or 4.8%, in comparison with June 2024 (Table 1).

The deficit of the trade balance, in June 2025 amounted to 3,137.6 million euros (3,575.5 million dollars) in comparison with 2,355.5 million euros (2,499.5 million dollars) in June 2024, recording an increase, in euros, of **33.2%**. The corresponding value of deficit excluding oil products in June 2025 recorded an increase of 452.1 million euros or 20.5% and the corresponding value excluding oil products and ships in June 2025 recorded an increase of 420.3 million euros or 19.1%, in comparison with June 2024 (Table 1).

The total value of imports, for the 6-month period from January to June 2025 amounted to 40,656.7 million euros (44,315.8 million dollars) in comparison with 42,122.1 million euros (45,396.5 million dollars) for the corresponding period of the year 2024, recording a drop, in euros, of **3.5%**. The corresponding value excluding oil products recorded an increase of 1,454.4 million euros or 4.7% and the corresponding value excluding oil products and ships recorded an increase of 1,377.9 million euros or 4.4%, in comparison with the period from January to June 2024 (Table 5).

The total value of exports, for the 6-month period from January to June 2025 amounted to 24,113.2 million euros (26,424.8 million dollars) in comparison with 25,360.3 million euros (27,497.3 million dollars) for the corresponding period of the year 2024, recording a drop, in euros, of **4.9%**. The corresponding value excluding oil products recorded an increase of 974.7 million euros or 5.5% and the corresponding value excluding oil products and ships recorded an increase of 1,021.0 million euros or 5.8%, in comparison with the period from January to June 2024 (Table 5).

The deficit of the trade balance, for the 6-month period from January to June 2025 amounted to 16,543.5 million euros (17,891.0 million dollars) in comparison with 16,761.8 million euros (17,899.2 million dollars) for the corresponding period of the year 2024, recording a drop, in euros, of **1.3%**. The corresponding deficit excluding oil products recorded an increase of 479.7 million euros or 3.6% and the corresponding deficit excluding oil products and ships recorded an increase of 356.9 million euros or 2.7% (Table 5).

The monthly data of Intra-EU transactions, have been adjusted to the total trade transactions with EU countries, including the transactions below the statistical threshold⁽¹⁾, on the basis of the Recapitulative Statements of Intra-EU Deliveries and Acquisitions that are submitted by the enterprises to the Independent Authority of Public Revenue. Accordingly, the provisional data from the "incomplete customs declarations" have been incorporated in the monthly data on trade with third countries and, after having been completed, they will be replaced by the final data.

⁽¹⁾ By virtue of EU Regulations on the compilation of intra-EU trade statistics, Member States set out a "statistical exemption threshold". On the basis of the exemption threshold, the enterprises whose transactions are below the statistical threshold are exempted from the obligation to submit data on their intra-EU transactions (Intrastat declaration). The aim is to reduce the burden on enterprises. The statistical exemption threshold, valid for each year, is specified and released by Hellenic Statistical Authority on a yearly basis.

Diagram 1. Imports, Exports, June 2023-2025, million €

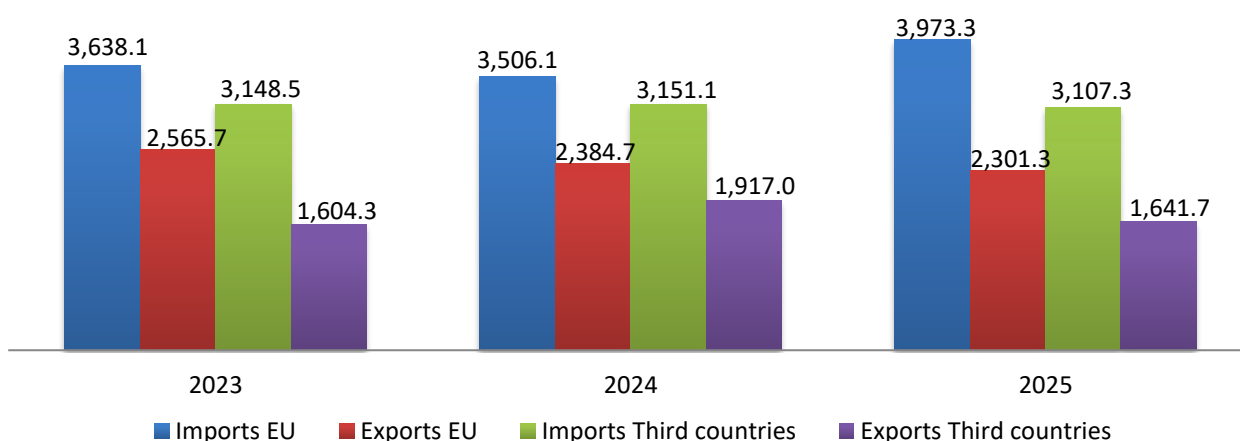

June 2023–2025, million €**

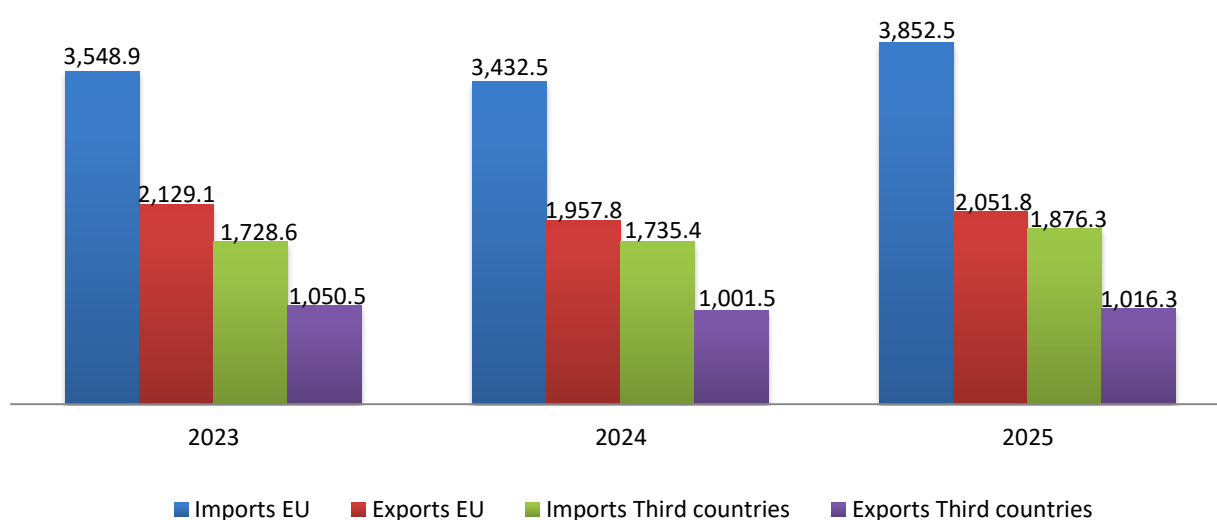

June 2023-2025, million €**

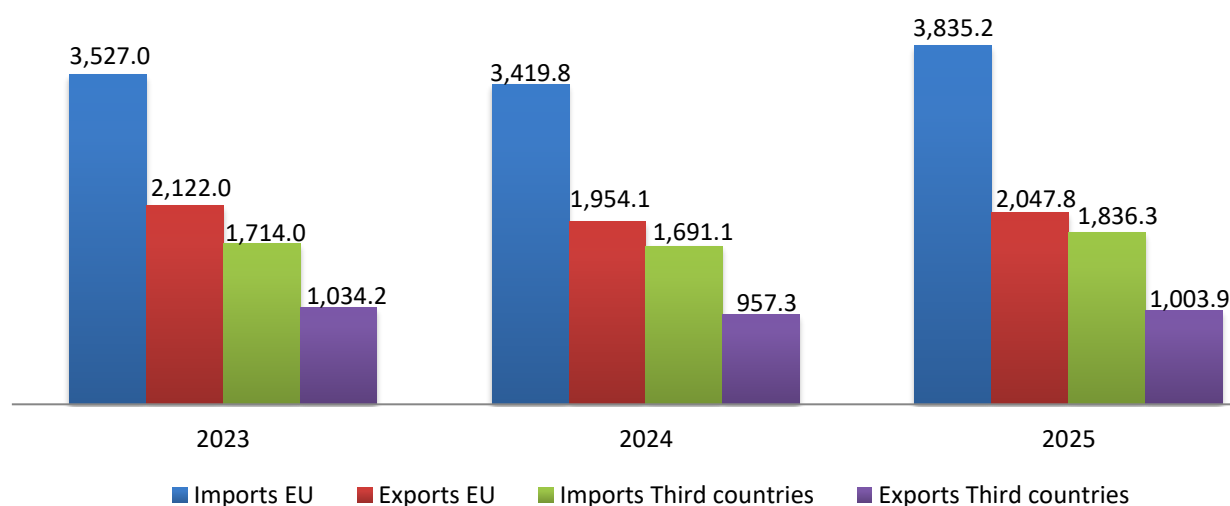

January - June 2023-2025, million €**

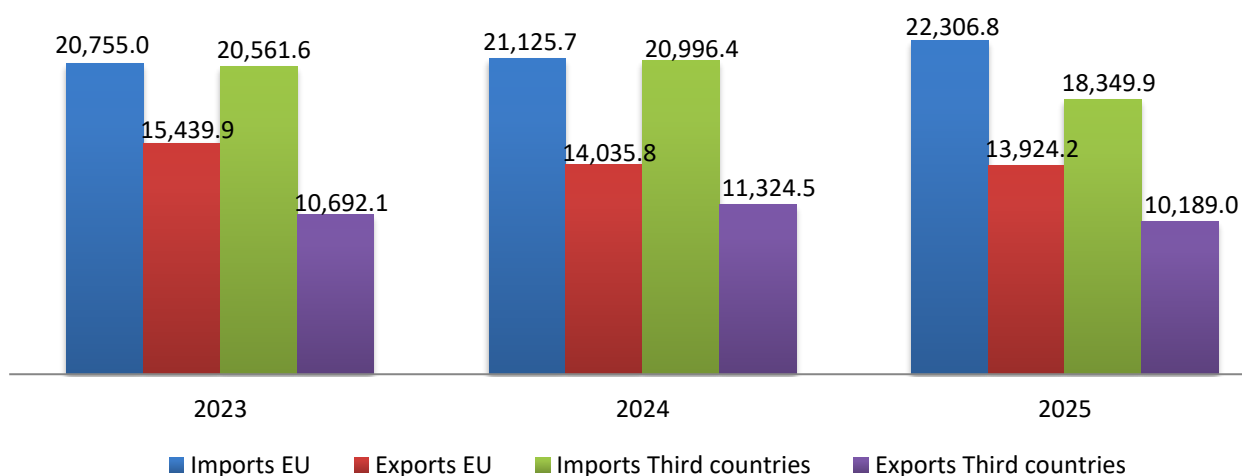

Diagram 5. Imports, Exports, excluding oil products, January - June 2023-2025, million €

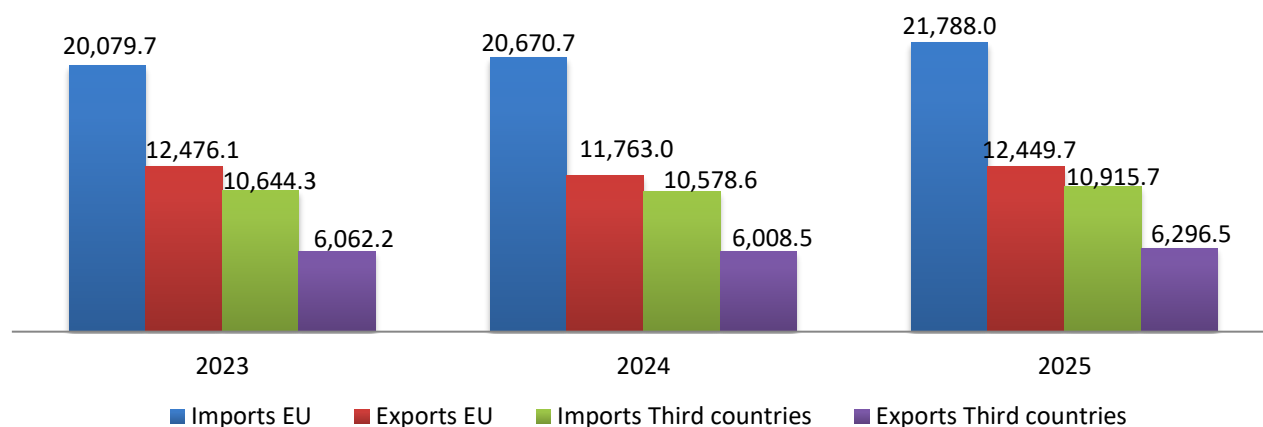

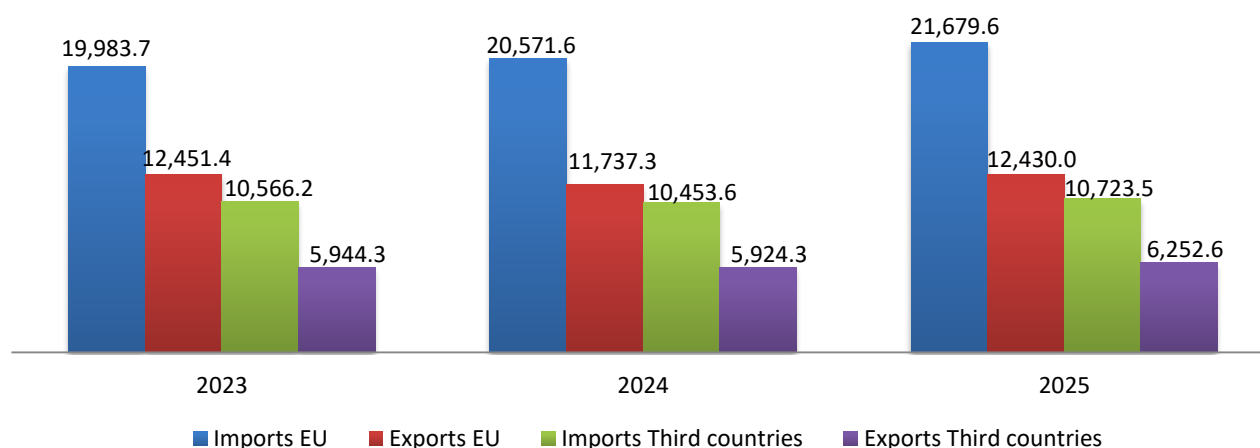

Diagram 7a. Percentage (%) distribution of E.U. imports by SITC sections, June 2025

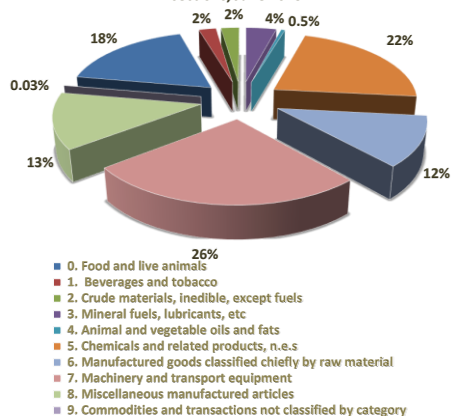


Diagram 7b. Percentage (%) distribution of Third countries imports by SITC sections, June 2025

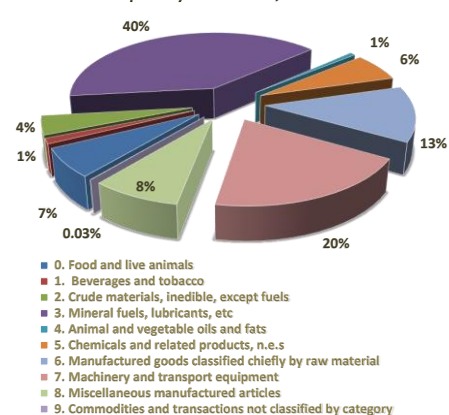


Diagram 8a. Percentage (%) distribution of E.U. exports by SITC sections, June 2025

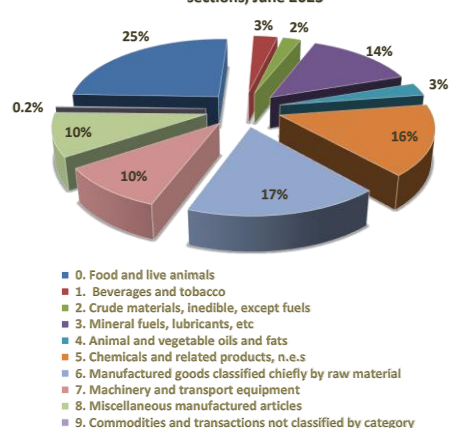


Diagram 8b. Percentage (%) distribution of Third countries exports by SITC sections, June 2025

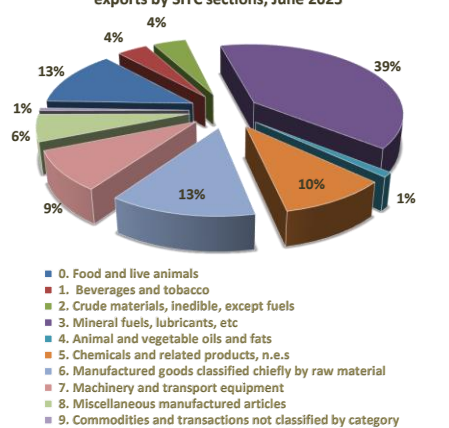


Diagram 9. Imports E.U. & Third countries by SITC sections, Jan. - Jun. 2025, million €

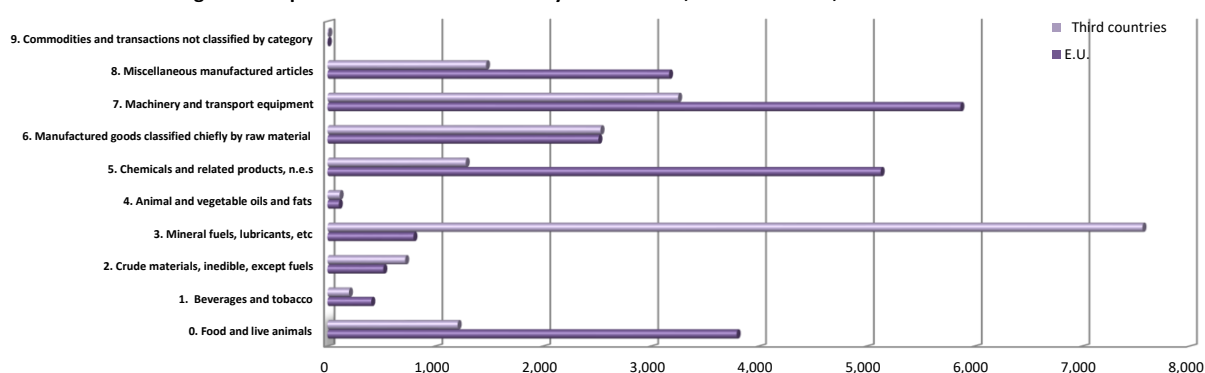


Diagram 10. Exports E.U. & Third countries by SITC sections, Jan. - Jun. 2025, million €

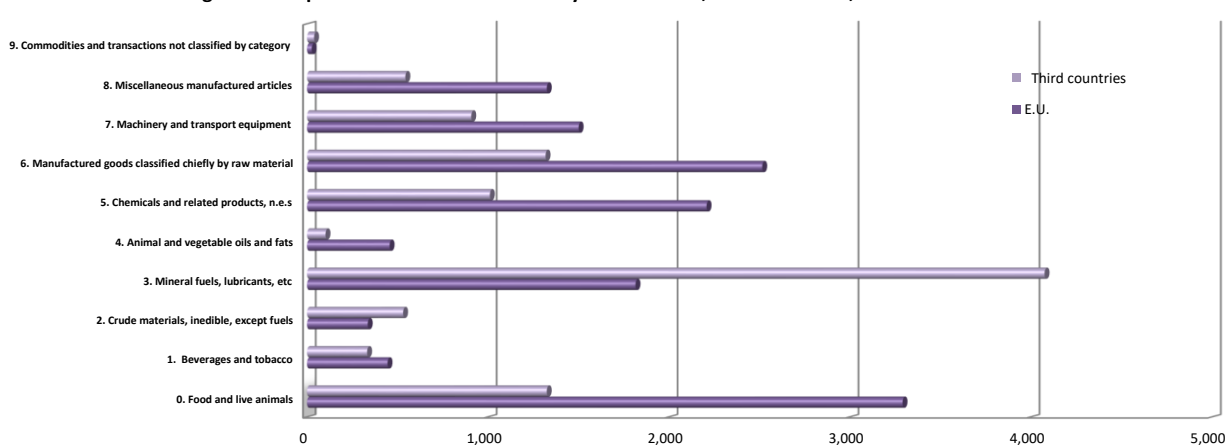

Commercial Transactions	The Commercial Transactions are recorded on a monthly basis aiming at monitoring the total value of imports, exports and their changes. This recording does not include the imports and exports of services.
Legal Framework	The survey is conducted for Intra-Union trade and for trade with third countries in accordance with Regulations (EU) 2019/2152 and (EU) 2020/1197.
Reference Period	June 2025
Provision of Results	38 days after the end of the reference month (provisional data). The provisional data are revised and disseminated on a monthly basis for all the previous months until the finalization of the yearly data, which takes place ten months after the end of the reference year.
Definitions	<p>INTRASTAT is the system for collecting Intra-Union statistical data (among the EU countries). It was implemented on January 1st, 1993.</p> <p>Import is considered every import of goods from a country of the EU.</p> <p>Export is considered every export of goods to a country of the EU.</p> <p>EXTRASTAT is the system for collecting external trade data with third countries (countries outside the EU).</p> <p>Import is considered every import of goods from a third country (outside the EU).</p> <p>Export is considered every export of goods to a third country (outside the EU).</p>
Methodology	<p>INTRASTAT: It is an exhaustive statistical survey. The parties responsible for providing statistical information through Intrastat System are the enterprises which perform Intra-Union trade transactions and they have exceeded the applied statistical thresholds. The statistical thresholds are readjusted each year. The statistical thresholds for 2025 are the following:</p> <ul style="list-style-type: none"> • Intra-Union Imports: € 200,000.00 (95.7% coverage) • Intra-Union Exports: € 90,000.00 (98.7% coverage) <p>The statistical data of Intra-Union Trade include also the transactions of the enterprises, which are not obliged to submit Intrastat data since the value of their transactions is below the applied statistical threshold. In compliance with the obligations provided in the EU Regulations regarding the compilation of external trade statistics, these transactions are calculated on the basis of the Recapitulative Statements of Intra-EU Deliveries and Acquisitions that all the enterprises are obliged to submit to the Independent Authority of Public Revenue.</p> <p>ELECTRONIC SUBMISSION: Intrastat declarations are submitted electronically via the following links: http://eurostat.statistics.gr or www.statistics.gr.</p> <p>EXTRASTAT: It is a statistical survey where data are collected by administrative sources. The Customs Authorities collect the relevant statistical data on trade by filling in the Single Administrative Document (SAD). All the transactions with third countries above the amount of 1,000 euros are registered. In the beginning of each month Customs Authorities transmit to the Hellenic Statistical Authority an electronic file with the customs data of statistical relevance of the previous month.</p> <p>The statistical data of imports and exports of goods with the Third Countries, are derived from the data transmitted by the Customs Authorities.</p> <p>Henceforth, the provisional data from the "incomplete customs declarations" - which concern mainly petroleum products - are incorporated in the monthly data on trade with third countries; the "incomplete customs declarations" data after having been completed will be replaced by the final data.</p> <p>IMPORTS AND EXPORTS OF SHIPS AND AIRCRAFTS: In accordance with EU Regulations entered into force in 2010 (Regulations (EU) 2010/96, 2010/113) and in accordance with Regulations (EU) 2019/2152 and (EU) 2020/1197 entered into force in 2022, the EU Member States are obliged to record the transactions of special goods and movements and more specifically of vessels and aircrafts in line with the principle of economic ownership.</p> <p>"Economic ownership" means the right of a taxable person to claim the benefits associated with the use of a vessel or aircraft in the course of an economic activity by virtue of accepting the associated risks.</p> <p>For the compilation of statistics on imports and exports of ships are used Intrastat statistical survey data, data from administrative sources (Customs, Ministry of Marine and Island Policy), as well as data from national and international commercial databases based on the estimation model of the Bank of Greece for the Greek shipping (see Press Release on Balance of Payments published by the Bank of Greece on 20.11.2018).</p> <p>The compilation of statistics on imports and exports of aircrafts is based on Intrastat statistical survey data and data from administrative sources (Customs, Hellenic Civil Aviation Authority).</p> <p>Classification of goods: The goods are classified in compliance with the 8-digit Combined Nomenclature Code (CN8) and the Standard International Trade Classification (SITC).</p>
