EVOLUTION OF TURNOVER OF ENTERPRISES IN ACCOMMODATION AND FOOD SERVICE ACTIVITIES JUNE – 2nd QUARTER 2023

The Hellenic Statistical Authority (ELSTAT) with this sectoral publication, presents the map with the evolution of the turnover of enterprises classified in the **Accommodation and Food and Beverage Service Activities** divisions. These economic activities have been over time in the focus of interest due to the significant weight they bear on the Greek economy as a whole, but also due to their extensive dispersion, with a significant presence in all regional units and a significant contribution to the respective local economies of Greece, often associated with the tourist product of the country.

The current publication is part of the announcements published by ELSTAT ([link](#)), since April 2020, incorporating the most recent data on turnover from Administrative Sources for **June and 2nd quarter 2023**.

In particular, ELSTAT announces data on a monthly and quarterly basis and at the regional unit country-level of analysis, for the turnover of enterprises classified in the divisions Accommodation and Food and Beverage Service Activities (divisions 55 and 56 of the NACE Rev.2 classification) for the period 2019-2023.

The published data can highlight, at a detailed local level, the current evolution in the performance, in terms of turnover, of enterprises having activity in key classes of the tourism sector and thus provide quick and highly relevant information on the evolution of the tourist product of Greece.

Specifically,

For the total of enterprises in **Accommodation Activities** (division 55 of NACE Rev.2 classification), the turnover in the second quarter 2023 amounted to 2,455,714,744 euro, recording an increase of 16.6% in comparison with the second quarter 2022, when the respective turnover was 2,105,983,075 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2022 greater than 1.0% (Table 5), the biggest increase in the turnover of the second quarter 2023 compared to the second quarter of 2022 was recorded in the Region Attiki (23.8%) and the smallest increase (1.5%) was recorded in the Regional Unit Mykonos (Table 1).

For the total of enterprises in **Food and Beverage Service Activities** (division 56 of NACE Rev.2 classification), the turnover in the second quarter 2023 amounted to 2,253,518,458 euro, recording an increase of 9.1% in comparison with the second quarter 2022, when the respective turnover was 2,064,837,572 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2022 greater than 1.0% (Table 5), the biggest increase in the turnover of the second quarter 2023 compared to the second quarter of 2022 was recorded in the Regional Unit Etoloakarnania (21.7%) and the smallest increase (1.8%) was recorded in the Regional Unit Thessaloniki, while a decrease was recorded in the Regional Unit Mykonos (4.9%) (Table 2).

For the enterprises in **Accommodation Activities** (division 55 of NACE Rev.2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in June 2023 amounted to 1,168,607,895 euro, recording an increase of 13.1% in comparison with June 2022, when the respective turnover was 1,033,074,661 euro (Table 3).

For the enterprises in **Food and Beverage Service Activities** (division 56 of NACE Rev.2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in June 2023 amounted to 257,455,020 euro, recording an increase of 6.4% in comparison with June 2022, when the respective turnover was 242,038,027 euro (Table 3).

In total, for the enterprises in **Accommodation and Food and Beverage Service Activities** (divisions 55 and 56 of NACE Rev. 2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in June 2023 amounted to 1,426,062,915 euro, recording an increase of 11.8% in comparison with June 2022, when the respective turnover was 1,275,112,688 euro. For the Regional Units with a contribution to the total turnover of the year 2022 greater than 1.0% (Table 5), the biggest increase in the turnover of June 2023 compared with June 2022 was recorded in the Regional Unit Lassithi (16.7%) and the smallest increase (4.4%) was recorded in the Regional Unit Kos (Table 4).

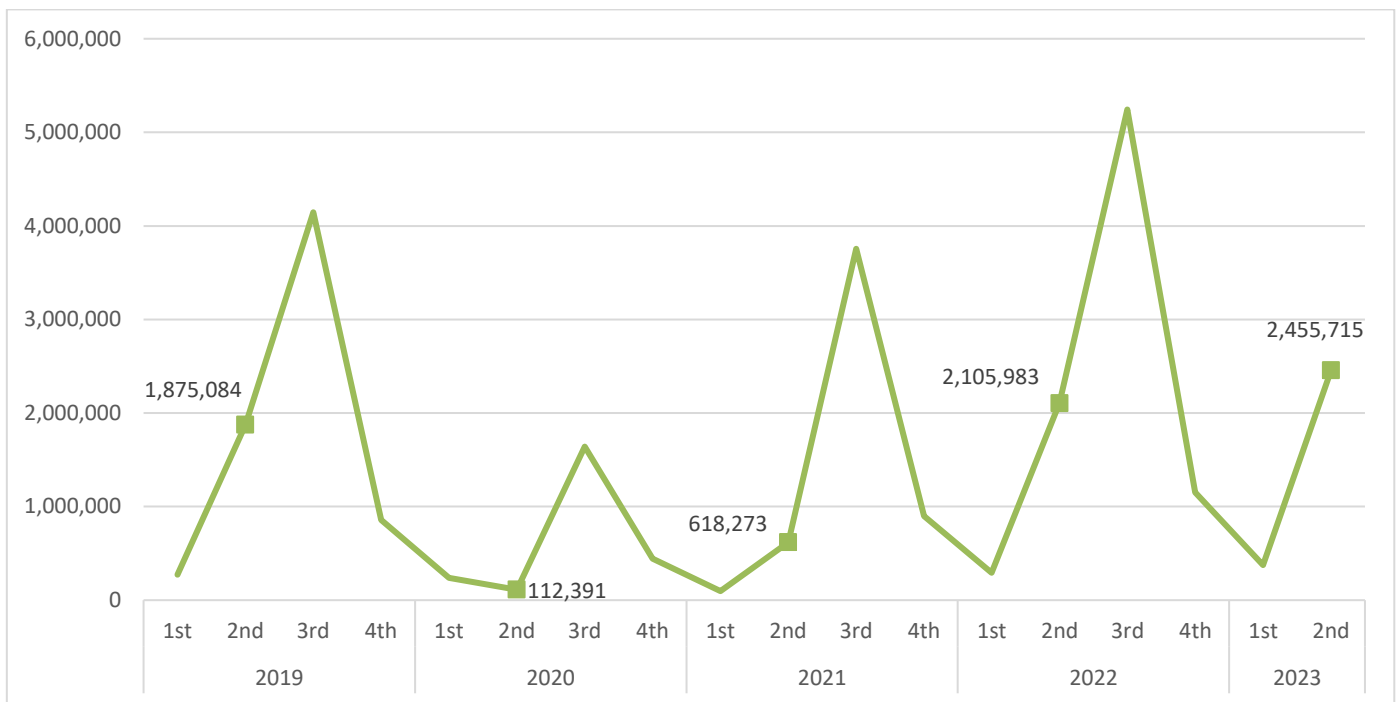

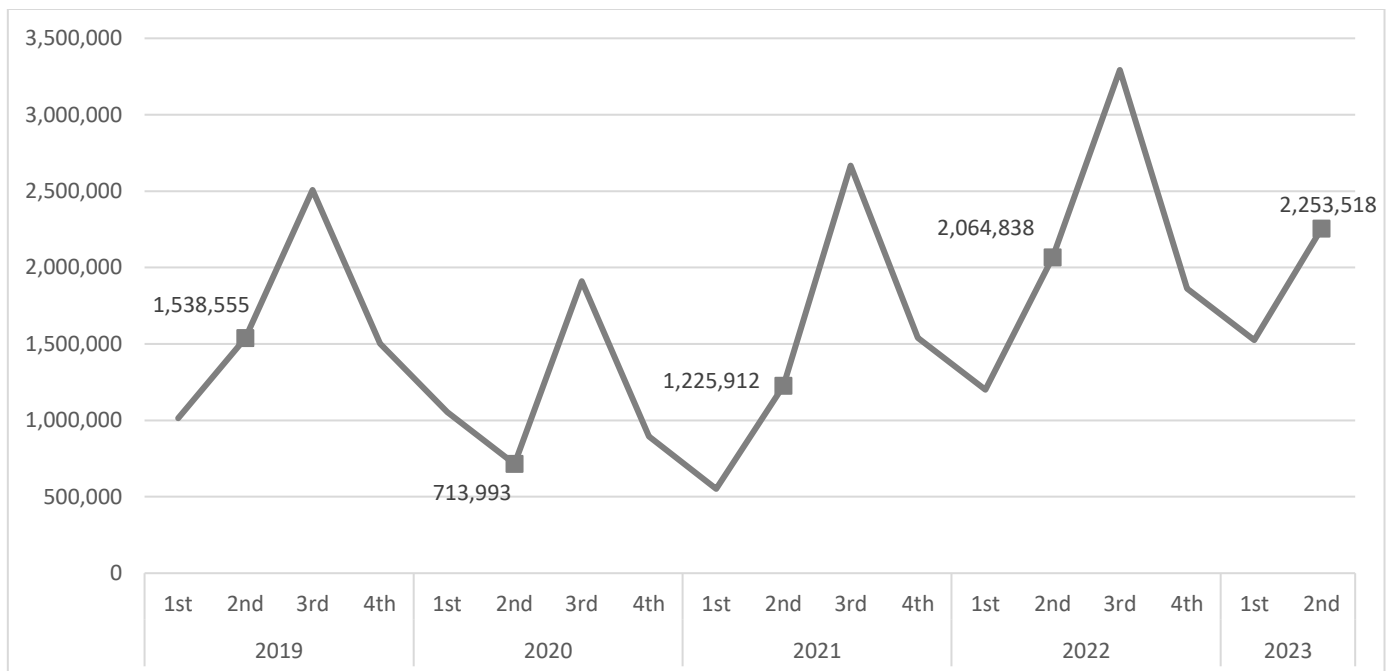

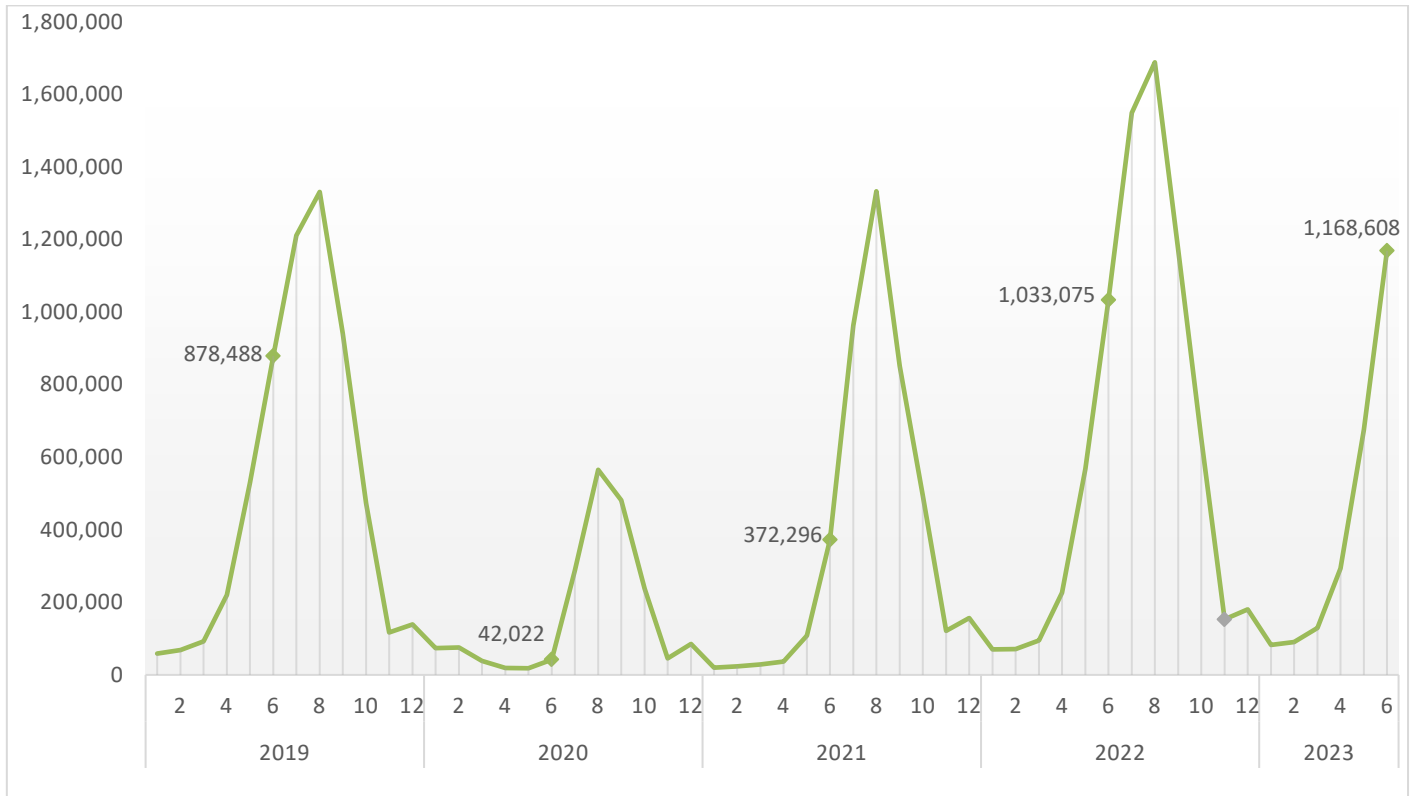
Graph 1: Turnover (in thousand €) of the total of enterprises in the Accommodation Activities (division 55 of NACE Rev. 2 classification)



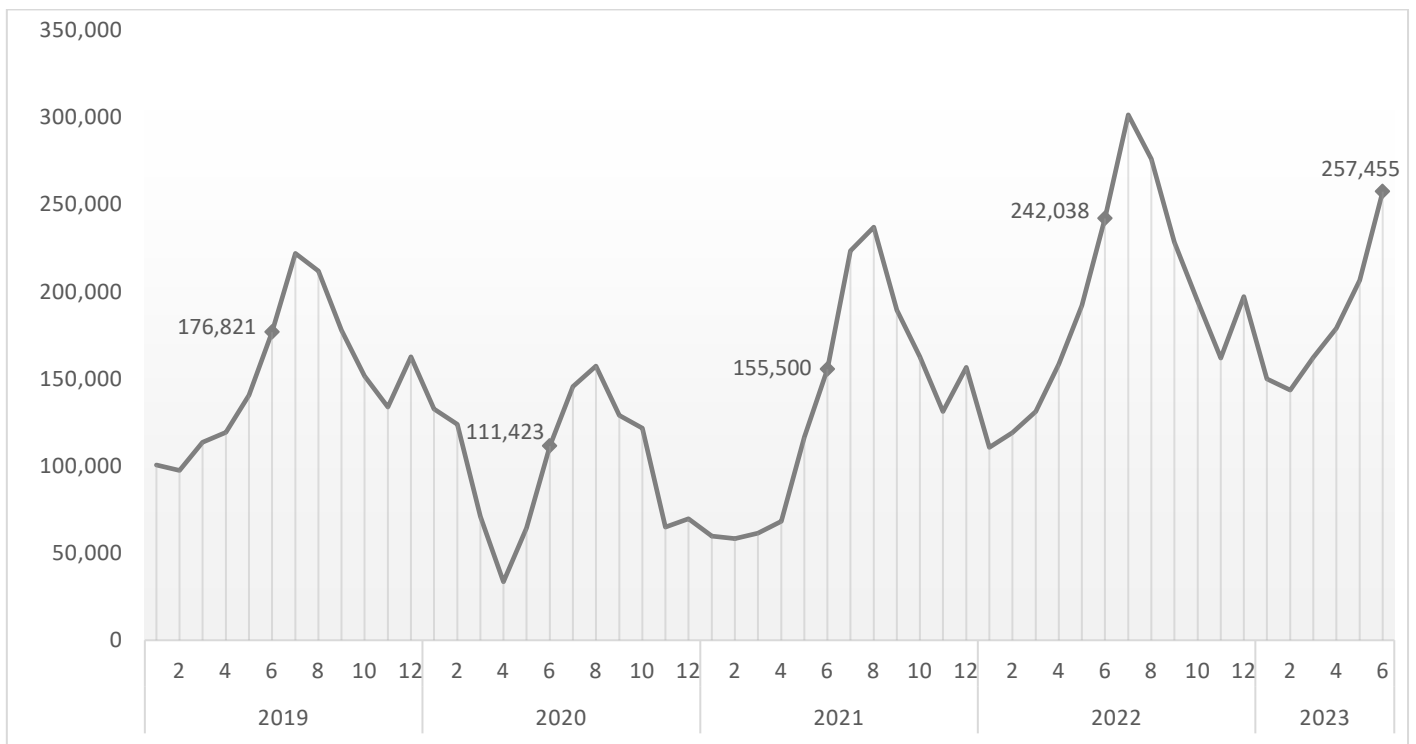
Graph 2: Turnover (in thousand €) of the total of enterprises in the Food and Beverage Service Activities (division 56 of NACE Rev. 2 classification)

- Administrative registers of enterprises, of the reference years 2021 and 2022.
- Administrative transactions files (tax etc) of the reference years 2019, 2020, 2021, 2022 and 2023.

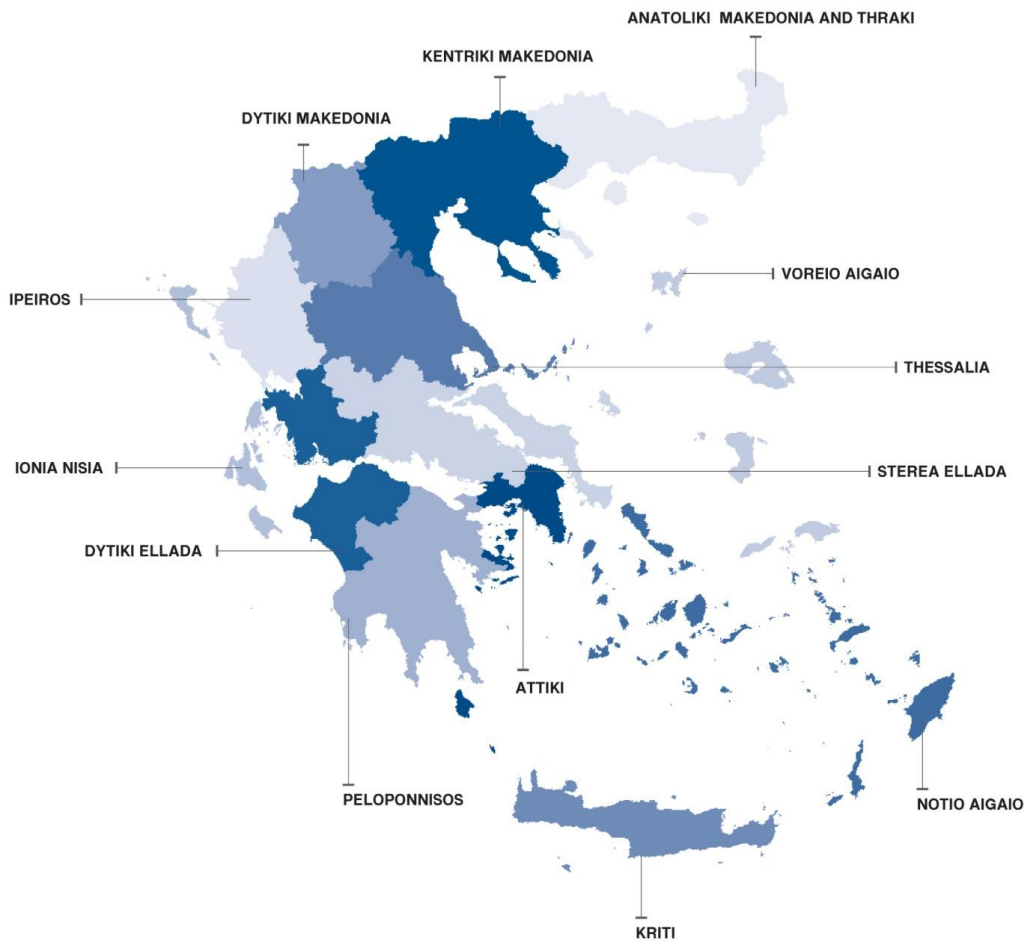
In particular the following primary data have been used per source:

- Active enterprises and the economic activity class from the final Statistical Business Register of the reference year 2020.
- The economic activity class for the enterprises that started their activity after the reference year 2020 and have a significant turnover, from administrative registers of enterprises of the reference years 2021 and 2022.
- Income data from administrative transaction files of the years 2019, 2020, 2021, 2022 and 2023.

It is noted that the geographical classification of enterprises is based on the location of the enterprise’s headquarters.

Statistical classifications For the economic activities the European statistical classification of economic activities NACE Rev.2 is used.
