



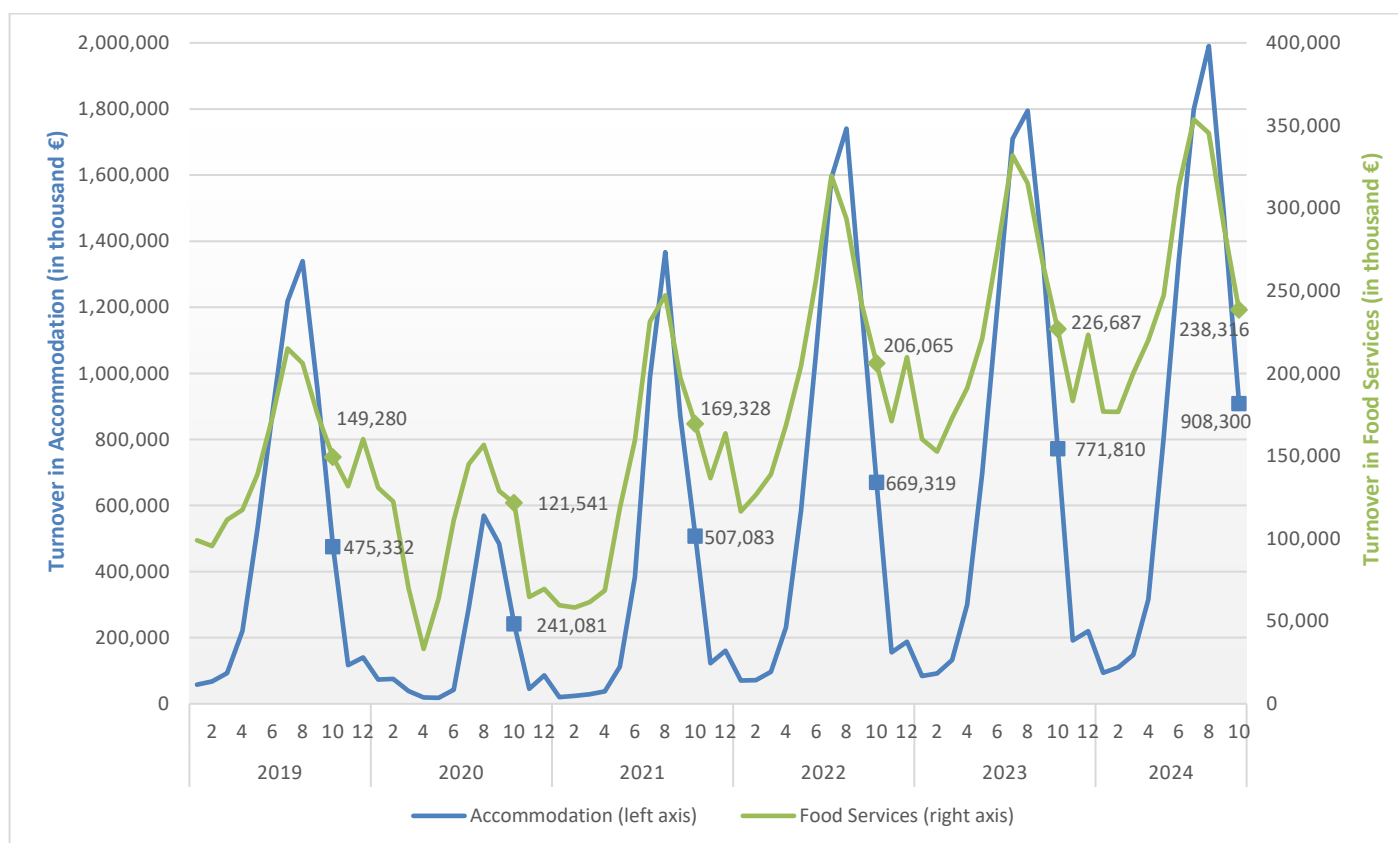
## EVOLUTION OF TURNOVER OF ENTERPRISES IN ACCOMMODATION AND FOOD SERVICE ACTIVITIES OCTOBER 2024

The Hellenic Statistical Authority (ELSTAT) announces data on the evolution of turnover of enterprises in the Accommodation and Food and Beverage Service Activities divisions, per Regional Unit, incorporating the most recent data on turnover from Administrative Sources for **October 2024**.

For the enterprises in **Accommodation Activities** (division 55 of NACE Rev.2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in October 2024 amounted to 908,300,237 euro, recording an increase of 17.7% in comparison with October 2023, when the respective turnover was 771,809,950 euro (Graph1, Table 2).

For the enterprises in **Food and Beverage Service Activities** (division 56 of NACE Rev.2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in October 2024 amounted to 238,316,228 euro, recording an increase of 5.1% in comparison with October 2023, when the respective turnover was 226,686,750 euro (Graph1, Table 2).

In total, for the enterprises in the **Accommodation and Food and Beverage Service Activities** (divisions 55 and 56 of NACE Rev. 2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in October 2024 amounted to 1,146,616,465 euro, recording an increase of 14.8% in comparison with October 2023, when the respective turnover was 998,496,700 euro (Table 2).

For the Regional Units with a contribution to the total turnover of the year 2023 greater than 1.0% (Table 1), the biggest increase in the turnover of October 2024 compared with October 2023 was recorded in the Regional Unit Kerkyra (51.7%) and the smallest increase (8.4%) was recorded in the Region Attiki (Table 3).

**Note:**

Enterprises with single-entry accounting bookkeeping are obliged to submit data to tax authorities on a quarterly basis while enterprises with double-entry accounting bookkeeping are obliged to submit data on a monthly basis. Therefore, for the total of enterprises data are available only on a quarterly basis.

**Generally** The statistical data presented in this announcement have been compiled on the basis of the linking and processing of primary data from the following sources:

- The final Statistical Business Register of ELSTAT of the reference year 2021.
- Administrative registers of enterprises, of the reference years 2022 and 2023.
- Administrative transactions files (tax, etc) of the reference years 2019 to 2024.

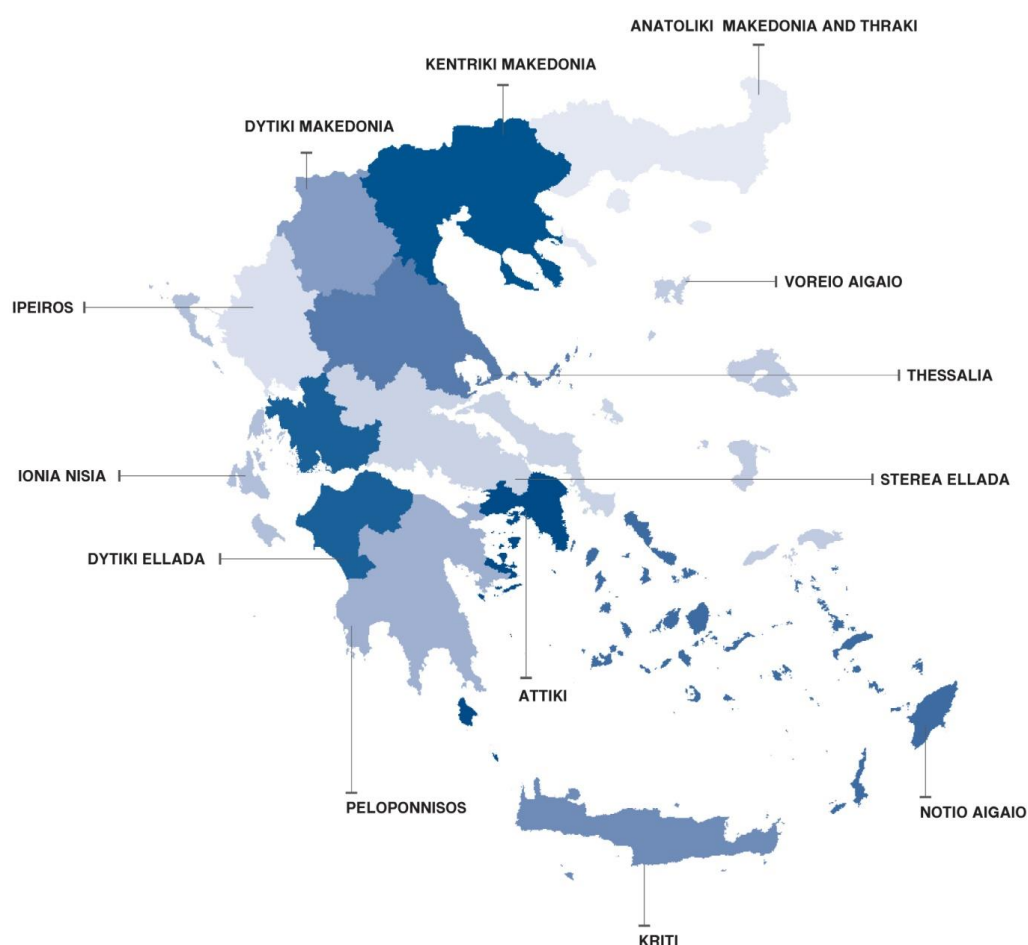
In particular the following primary data have been used per source:

- Active enterprises and the economic activity class from the final Statistical Business Register of the reference year 2021.
- The economic activity class for the enterprises that started their activity after the reference year 2021 and have a significant turnover, from administrative registers of enterprises of the reference years 2022 and 2023.
- Income data from administrative transaction files of the years 2019 to 2024.

It is noted that the geographical classification of enterprises is based on the location of the enterprise's headquarters.

**Statistical classifications** For the economic activities the European statistical classification of economic activities [NACE Rev.2](#) is used.

**Reference Period** October 2024.

**Statistical unit** The statistical unit is the legal unit (distinct Tax Identification Numbers (TIN)).

**Comparability** The announced statistical data are comparable with the data of the final Statistical Business Register of ELSTAT of the reference year 2021 (relevant link from the webpage of ELSTAT where tables and information on the methodology applied are provided [Statistical Business Register](#)).
