# EVOLUTION OF TURNOVER OF ENTERPRISES UNDER SUSPENSION OF OPERATION DUE TO THE PANDEMIC OF THE CORONA VIRUS DISEASE 2019 (COVID-19)

# DECEMBER AND 4<sup>th</sup> QUARTER 2020 ANNUAL DATA 2019, 2020

The Hellenic Statistical Authority (ELSTAT) announces data on the evolution of turnover of the enterprises that were under suspension of operation in March 2020, on the basis of state order, due to the pandemic of the corona virus disease 2019 (COVID-19) (corresponding link, available only in Greek, <u>KAD of closed enterprises</u>).

Moreover, additional discrete data are announced for the enterprises that were under suspension of operation in November 2020, on the basis of state order, for the limitation of the dispersion of the corona virus (COVID-19) (corresponding links, available only in Greek, *Government Gazette B'*/4899/06.11.2020 and *List of KAD under suspension of operation*).

The current publication is a sequel of the relevant Press Releases published by ELSTAT (PR link), incorporating the most recent data on turnover from Administrative Sources for December and 4<sup>th</sup> quarter 2020. Similar publications have been planned and are issued on a monthly basis, during the whole period in which the recording of the impact of COVID-19 on the performance of Greek enterprises that were under suspension of operation in the framework of the confinement measures remains relevant and warranted.

In addition, starting from the Press Release published in June 2020, tables and graphs presenting aggregated turnover data for all enterprises and sectors of the economy throughout the period under review have been incorporated, as a comparative basis for the assessment of the effects of COVID-19 pandemic, in terms of turnover rates of change, in total and by sector.

The purpose served by these publications is to both monitor and present the evolution of the basic economic concept of interest (turnover from Administrative Sources) for the enterprises under suspension of operation, in distinct periods ranging from the beginning of the year 2020, during the whole period of the implementation of the confinement measures and during the period of the gradual lifting of these measures, as well as in comparison with the corresponding months of 2019.

The published data can on the one hand highlight, which enterprises suffer more in terms of turnover decrease during the implementation period of the confinement measures and on the other hand the relative speed at which enterprises recovered upon the gradual lifting of these measures.

Moreover, on the basis of the published data, it can be concluded from the supply side, which enterprises responded – adapted faster to the lifting of the confinement measures and to the operation under the newly imposed conditions due to the pandemic. In parallel, from the demand side, useful conclusions can be drawn indirectly as regards the enterprises that were chosen in priority and more massively by the consumers (natural persons and enterprises) from the beginning of the lifting of the confinement measures, in order to satisfy their basic and other needs.

Tel.: +30 213 135 2022, 2308, 2310 E-mail: data.dissem@statistics.gr Concerning the enterprises and the activities of the economy as a whole, the turnover in 2020 amounted to 266,083,826 thousand euro, recording a decrease of 13.5% in comparison with 2019, when the respective turnover was 307,704,921 thousand euro. The largest increase in turnover per 3.1% in 2020 compared with 2019 was recorded from the enterprises of the section Agriculture, Forestry and Fishing. The largest decrease in turnover per 53.4% in 2020 compared with 2019 was recorded from the enterprises of the section Accommodation and Food Service Activities, while the smallest decrease in turnover per 2.4% was recorded from the enterprises of Water Supply, Sewerage, Waste Management and Remediation Activities section (Table 1).

Concerning the enterprises and the activities of the economy as a whole, the turnover in the fourth quarter 2020 amounted to 72,243,603 thousand euro, recording a decrease of 8.6% in comparison with the fourth quarter 2019, when the respective turnover was 79,017,709 thousand euro. The largest increase in turnover per 7.1% in the fourth quarter 2020 compared with the fourth quarter 2019 was recorded from the enterprises of the section Human Health and Social Work Activities. The largest decrease in turnover per 47.9% in the fourth quarter 2020 compared with the fourth quarter 2019 was recorded from the enterprises of the section Accommodation and Food Service Activities, while the smallest decrease in turnover per 0.4% was recorded from the enterprises of Financial and Insurance Activities section (Table 1a).

For the enterprises of the economy as a whole, obliged to double-entry accounting bookkeeping, for which data are available on a monthly basis, the turnover in December 2020 amounted to 21,905,296 thousand euro, recording a decrease of 7.8% in comparison with December 2019, when the respective turnover was 23,756,221 thousand euro. The largest increase in turnover per 14.0% in December 2020 compared with December 2019 was recorded from the enterprises of the section Human Health and Social Work Activities. The largest decrease in turnover per 78.5% in December 2020 compared with December 2019 was recorded from the enterprises of the section Arts, Entertainment and Recreation, while the smallest decrease in turnover per 0.2% was recorded from the enterprises of Other Service Activities section (Table 1b).

From the 205,984 enterprises that were under suspension of operation in March 2020, the turnover in 2020 amounted to 18,789,821 thousand euro, recording a decrease of 36.4% in comparison with 2019, when the respective turnover was 29,564,997 thousand euro. The largest decrease in turnover per 67.5% in 2020 compared with 2019 was recorded from the enterprises of the activity class Accommodation, while the smallest decrease in turnover per 6.9% was recorded from the enterprises of the activity class Social work activities without accommodation (Table 2).

From the 205,984 enterprises that were under suspension of operation in March 2020, the turnover in the fourth quarter 2020 amounted to 4,295,386 thousand euro, recording a decrease of 37.8% in comparison with the fourth quarter 2019, when the respective turnover was 6,909,448 thousand euro. An increase in turnover per 20.7% in the fourth quarter 2020 compared with the fourth quarter 2019 was recorded from the enterprises of the activity class Sports activities and amusement and recreation activities. The largest decrease in turnover per 88.5% in the fourth quarter 2020 compared with the fourth quarter 2019 was recorded from the enterprises of the activity class Motion picture, video and television programme production, sound recording and music publishing activities, while the smallest decrease in turnover per 2.8% was recorded from the enterprises of the activity class Social work activities without accommodation (Table 2a).

For the enterprises under suspension of operation in March 2020, obliged to double-entry accounting bookkeeping, for which data are available on a monthly basis, the turnover in December 2020 amounted to 728,476 thousand euro, recording a decrease of 53.9% in comparison with December 2019, when the respective turnover was 1,580,951 thousand euro. The largest increase in turnover per 35.6% in December 2020 compared with December 2019 was recorded from the enterprises of the activity class Creative, arts and entertainment activities and recreation activities. The largest decrease in turnover per 92.0% in December 2020 compared with December 2019 was recorded from the enterprises in the activity class Gambling and betting activities, while the smallest decrease in turnover per 13.4% was recorded from the enterprises in the activity class Architectural and engineering activities; technical testing and analysis (Table 2b).

In comparison with the enterprises that were under suspension of operation in March 2020, **in November 2020 were additionally under suspension of operation** 41 enterprises of the activity class Travel agency, tour operator and other reservation service and related activities and 737 enterprises of the activity class Human health activities. Data on the evolution of the quarterly and monthly turnover of these classes are presented in tables 2c and 2d.










Graph 3. Turnover (in thousand €), for the Total of Enterprises in the Greek Economy





#### **METHODOLOGICAL NOTES**

#### Generally

The present Press Release provides statistical data on enterprises classified in the economic activity classes that were or are under suspension of operation on the basis of state order in March 2020, due to the pandemic of the corona virus disease 2019 (COVID-19), (relevant link from the Ministry of Finance webpage, available only in Greek, <u>KAD of closed enterprises</u>).

These statistical data have been compiled on the basis of the linking and processing of primary data from the following sources:

- The most recent published Statistical Business Register of ELSTAT, of the reference year 2017.
- Administrative registers of enterprises, of the reference year 2019.
- Administrative transactions files (tax, etc) of the reference years 2019 and 2020.

In particular, the following primary data have been used per source:

- Active enterprises and the economic activity class from the Statistical Business Register of the reference year 2017.
- The population of legal units (VAT number) classified in KAD (Codes of Activity) with temporary suspension of operation, from administrative registers of enterprises, of year 2019.
- Income data from administrative transaction files of the years 2019 and 2020.

It has to be noted, that after the process of matching the KAD codes to the classes of the Statistical Classification of Economic Activities (NACE Rev. 2), for which a total (referring to all the underlying activities) or a partial suspension of operation is applied for the enterprises that are classified to them on the basis of state order in March 2020, follows the linking with the data of the Statistical Business Register of the year 2017, which is the main reference framework for the current Press Release. This linking leads to different results as regards the share of enterprises under suspension of operation per economic activity class NACE Rev.2, (mainly, because there are enterprises that were operating during the whole or part of the year 2017 and they were closed from 2018 onwards).

After the application of the same methodology, the number of enterprises that were under suspension of operation in November 2020, on the basis of state order, has been defined (corresponding links, available only in Greek, *Government Gazette B'*/4899/06.11.2020 and *List of KAD under suspension of operation*).

#### Statistical classifications

For the economic activities, the European statistical classification of economic activities <u>NACE Rev. 2</u> is used. It is noted that an automatic transition from KAD to codes of NACE Rev. 2 classification was applied on the basis of valid correspondence rules.

#### **Reference Period**

December and 4th quarter 2020.

## Statistical unit

The statistical unit is the legal unit (distinct VAT numbers).

## Comparability

The announced statistical data are comparable with the data of the most recent Statistical Business Register of ELSTAT, of the reference year 2017 (relevant link from the webpage of ELSTAT, where tables and information on the methodology applied are provided <u>Statistical Business Register</u>).
