EVOLUTION OF TURNOVER OF ENTERPRISES JANUARY 2025


The Hellenic Statistical Authority (ELSTAT) announces data on the evolution of turnover of enterprises in all sectors of the economy, incorporating the most recent data on turnover from Administrative Sources for **January 2025**.

Starting from the current announcement, an updated framework for the determination of the total of enterprises in the Greek Economy is used, which occurs from the linking at microdata level of <u>administrative transactions files</u>, of the reference years 2019 to 2025, and of the <u>final Statistical Business Register</u>, of the reference year 2022, that provides a standardized set of data, harmonized with European classifications.

For the enterprises of the economy as a whole, obliged to double-entry accounting bookkeeping, for which data are available on a monthly basis, the turnover in January 2025 amounted to 28,213,975 thousand euro, recording an increase of 7.4% in comparison with January 2024, when the respective turnover was 26,275,971 thousand euro (Graph 1, Table 2).

The biggest increase in turnover in January 2025 compared with January 2024 was recorded from the enterprises of the section Electricity, Gas, Steam and Air Conditioning Supply, per 26.4%, while a decrease was recorded from the enterprises of the section Human Health and Social Work Activities, per 0.7% (Table 2).

- Wholesale and Retail Trade; Repair of Motor Vehicles and Motorcycles (37.0%)
- Manufacturing (19.7%)
- Electricity, Gas, Steam and Air Conditioning Supply (6.0%)
- Transportation and Storage (5.5%)
- Accommodation and Food Service Activities (4.6%)

Graph 2. Sections of economic activity with the biggest share (%) in the total turnover of the year 2023 and of the year 2024



METHODOLOGICAL NOTES

Generally

The current announcement provides statistical data on turnover for all enterprises and sections of the economy.

These statistical data have been compiled on the basis of the linking and processing of primary data from the following sources:

- The final Statistical Business Register of ELSTAT, of the reference year 2022.
- Administrative transactions files (tax, etc) of the reference years 2019 to 2025.

In particular, the following primary data have been used per source:

- Active enterprises and the economic activity class from the final Statistical Business Register of the reference year 2022.
- Income data from administrative transactions files of the reference years 2019 to 2025.

Statistical classifications

For the economic activities, the European statistical classification of economic activities NACE Rev. 2 is used.

Reference Period

January 2025.

Statistical unit

The statistical unit is the legal unit (distinct TIN).

Comparability

The announced statistical data are comparable with the data of the final Statistical Business Register of ELSTAT, of the reference year 2022 (relevant link from the webpage of ELSTAT, where tables and information on the methodology applied are provided <u>Statistical Business Register</u>).
