



TURNOVER INDEX IN INDUSTRY: July 2024, y-o-y increase of 11.7%

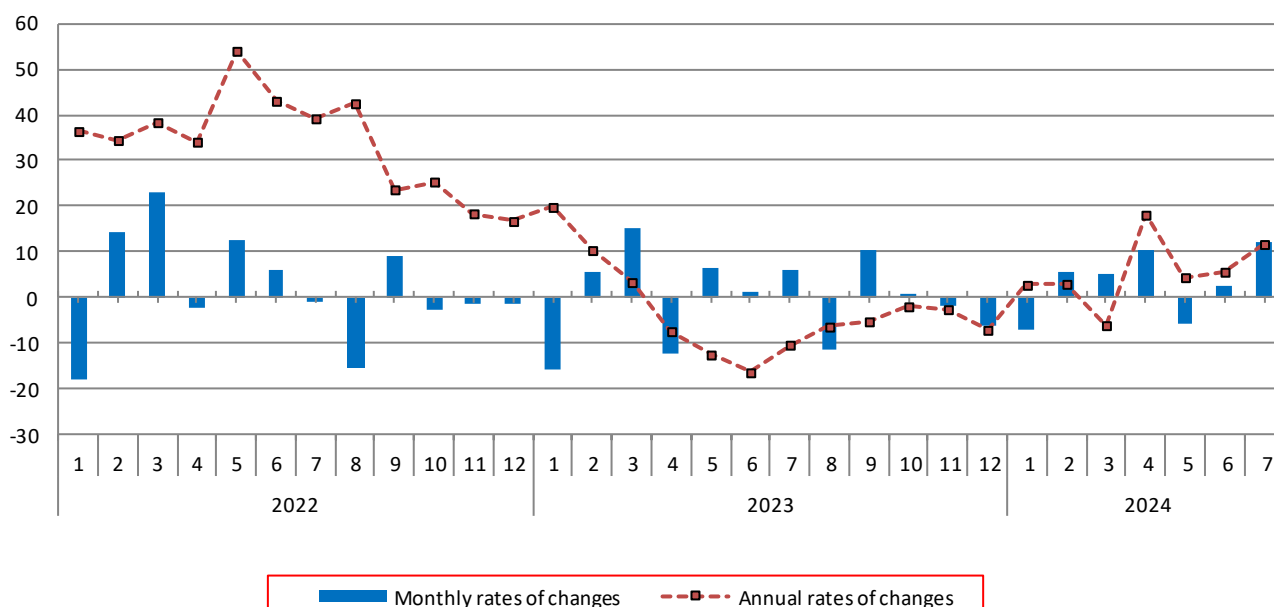
The Hellenic Statistical Authority announces the Turnover Index in Industry with base year 2015=100.0 for July 2024, the evolution of which on the basis of provisional data, is as follows:

The Overall Turnover Index in Industry (both Domestic and Non-Domestic Market) in July 2024 recorded an increase of 11.7% compared with the corresponding index of July 2023. The Overall Turnover Index in Industry in July 2023 decreased by 10.3% compared with the corresponding index in July 2022 (Table 1).

The Overall Turnover Index in Industry in July 2024, compared with June 2024, recorded an increase of 12.3% (Table 6).

The average Overall Turnover Index in Industry for the 12-month period from August 2023 to July 2024 increased by 1.1%, compared with the corresponding index of the 12-month period from August 2022 to July 2023. The average Overall Turnover Index in Industry for the 12-month period from August 2022 to July 2023 increased by 6.8% compared with the corresponding index of the 12-month period from August 2021 to July 2022 (Table 13).

Evolution of the Overall Turnover Index in Industry in July 2024

I. Annual changes of the Overall Turnover Index in Industry: July 2024 / July 2023

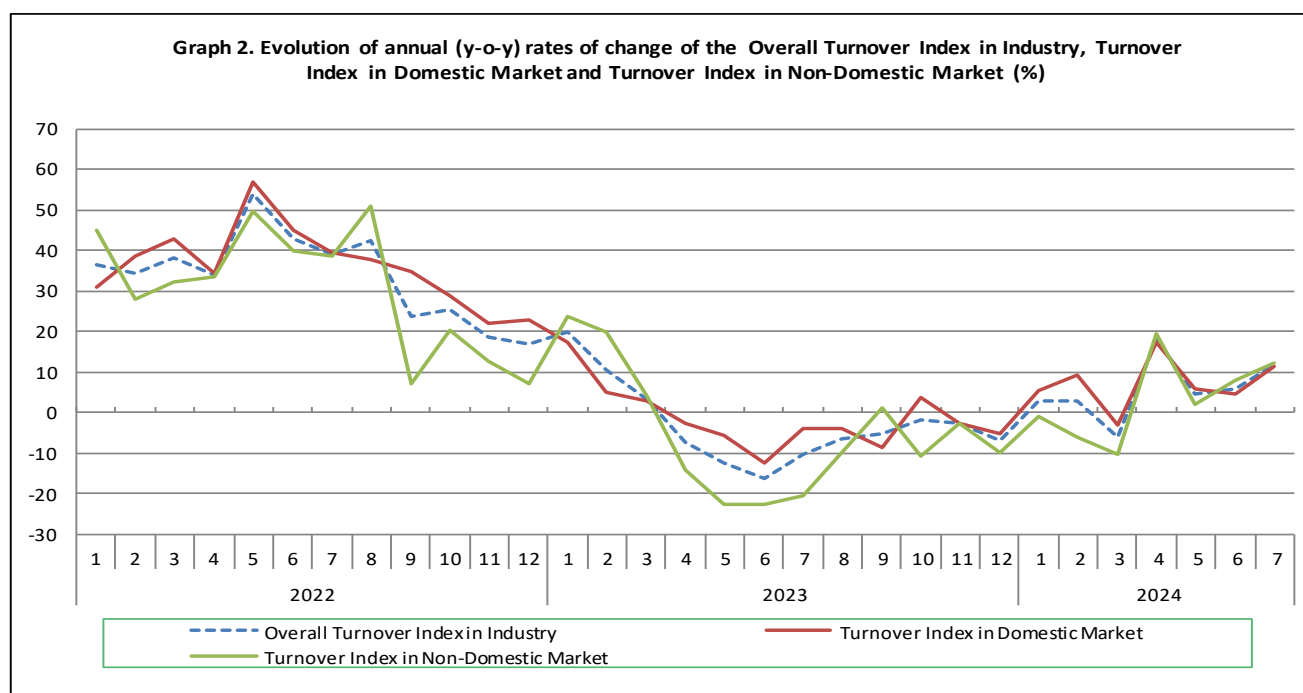
The 11.7% increase in the Overall Turnover Index in Industry in July 2024, compared with the corresponding index in July 2023, was due to the following:

1. Changes in the sub-indices of the industrial sections (Table 1):

- The Turnover Index in Mining and quarrying increased by 49.7%. The increase was mainly the result of the annual changes of the sub-indices in the following 2-digit divisions: mining of coal and lignite - extraction of crude petroleum and natural gas - mining support service activities, mining of metal ores.
- The Turnover Index in Manufacturing increased by 11.4%. The increase was mainly the result of the annual changes of the sub-indices in the following 2-digit divisions: electrical equipment, tobacco products, computers, electronic and optical products, machinery and equipment n.e.c., chemicals and chemical products.

2. Changes in the sub-indices in Domestic and Non-Domestic Markets:

- The Turnover Index in Industry in Non-Domestic Market increased by 12.1% (Table 3).
- The Turnover Index in Industry in Domestic Market increased by 11.5% (Table 2).



II. Annual changes of the Turnover Index in Industry in Domestic Market: July 2024 / July 2023

The 11.5% increase of the Turnover Index in Industry in Domestic Market in July 2024, compared with July 2023, is due to the annual changes in the sub-indices of the following industrial sections (Table 2):

- The Turnover Index in Mining and quarrying increased by 24.0%. The increase was the result of the annual changes of the sub-indices in the following 2-digit divisions: mining of metal ores, other mining and quarrying products.
- The Turnover Index in Manufacturing increased by 11.4%. The increase was mainly the result of the annual changes of the sub-indices in the following 2-digit divisions: computers, electronic and optical products, electrical equipment, machinery and equipment n.e.c., other non-metallic mineral products, tobacco products, fabricated metal products, except machinery and equipment.

III. Annual changes of the Turnover Index in Industry in Non-Domestic Market: July 2024 / July 2023

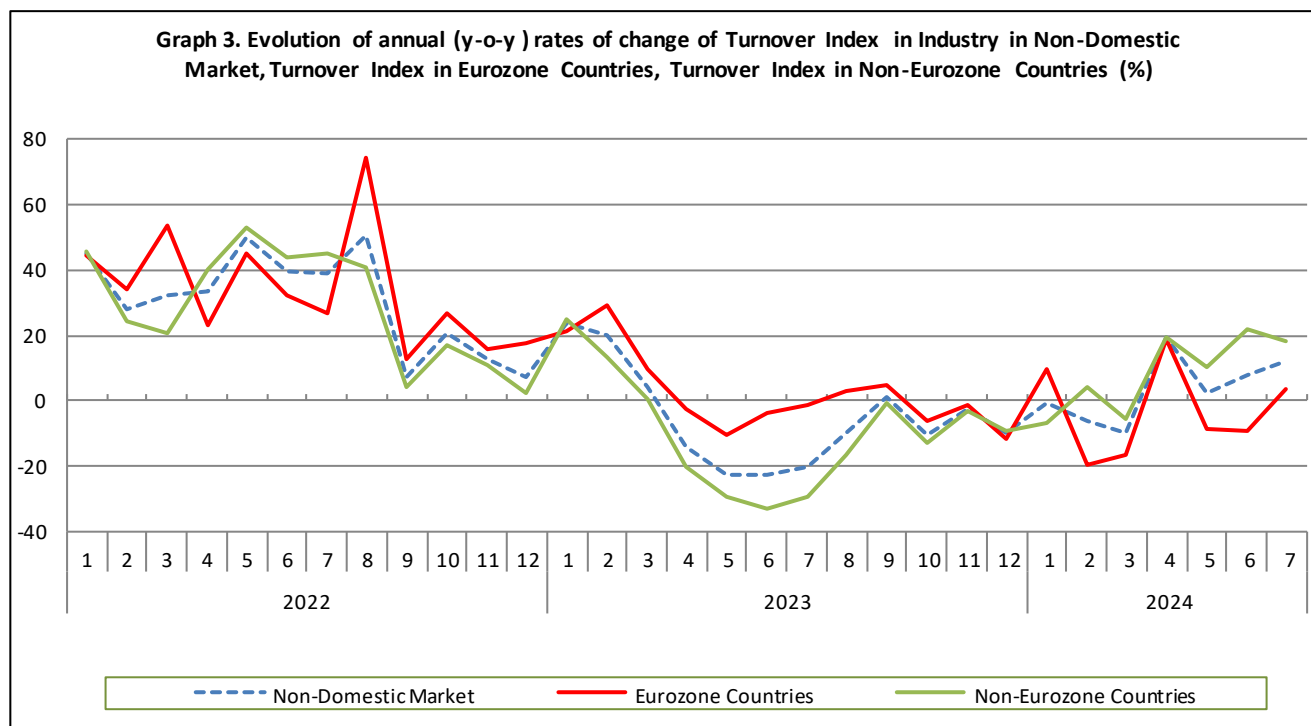
The 12.1% increase of the Turnover Index in Industry in Non-Domestic Market in July 2024, compared with July 2023, was due to the following:

1. Changes in the sub-indices of the industrial sections (Table 3):

- The Turnover Index in Mining and quarrying increased by 79.9%. The increase was the result of the annual changes of the sub-indices in the following 2-digit divisions: mining of metal ores, other mining and quarrying products.
- The Turnover Index in Manufacturing increased by 11.4%. The increase was mainly the result of the annual changes of the sub-indices in the following 2-digit divisions: electrical equipment, tobacco products, printing and reproduction of recorded products, paper and paper products, repair and installation of machinery and equipment, chemicals and chemical products.

2. Changes in the sub-indices in Eurozone and Non-Eurozone countries:

- The Turnover Index in Industry in Non-Eurozone countries increased by 18.0% (Table 5).
- The Turnover Index in Industry in Eurozone countries increased by 3.6% (Table 4).



IV. Monthly changes of the Overall Turnover Index in Industry: July 2024 / June 2024

The 12.3% increase of the Overall Turnover Index in Industry in July 2024, compared with the corresponding index in June 2024, was due to the following:

1. Changes in the sub-indices of industrial sections (Table 6):

- The Turnover Index in Mining and quarrying increased by 29.1%.
- The Turnover Index in Manufacturing increased by 12.1%.

2. Changes in the sub-indices in Domestic and Non-Domestic Market:

- The Turnover Index in Industry in Domestic Market increased by 13.2% (Table 7).
- The Turnover Index in Industry in Non-Domestic Market increased by 10.5% (Table 8).

METHODOLOGICAL NOTES

Generally	The Industrial Turnover Index is an indicator of an enterprise's business cycle showing the monthly evolution of the market of goods and services in industry. The first compilation of the Turnover Index was completed by the Hellenic Statistical Authority in 2006, with base year 2000=100.0 and is compiled from 2000 onwards.
Purpose of the index	The purpose of this index is to measure the monthly activity of the industrial sector in terms of value. Turnover comprises the totals invoiced by the observation units during the reference period and corresponds to the market sales of goods or services supplied to third parties. The purposes and the characteristics of the Turnover Index apply, as well, to the indices for the distinction between domestic and non-domestic turnover.
Legal Framework	The compilation and publication of the Turnover Index is based on the framework of the implementation of Council Regulation (EC) No 1165/1998 concerning short-term statistics (STS-R), as well as Regulation (EC) No 1158/2005 of the European Parliament and of the Council amending Council Regulation (EC) No 1165/1998. Furthermore, this index is governed by Regulation (EC) No 1893/2006 of the European Parliament and of the Council, by Commission Regulation (EC) No 656/2007, by Regulation (EC) No 451/2008 of the Council, by Regulation (EU) No 2019/2152 of the European Parliament and of the Council on European business statistics, as well as Commission Implementing Regulation (EU) No 2020/1197 laying down technical specifications and arrangements pursuant to Regulation (EU) No 2019/2152.
Reference period	Month.
Base year	2015=100.0.
Revision	The latest revision of the Turnover Index in Industry (base year 2015=100.0) took place in the framework of Council Regulation (EC) No 1165/1998 concerning short-term statistics. In accordance with this regulation the index is revised every five years, in years ending in 0 or 5.
Statistical classifications	At the level of classes of economic activities, the statistical classification of economic activities NACE Rev. 2 of EU was used (Regulation No 1893/2006), while at the level of main industrial groupings, the allocation of two-digit and three-digit NACE Rev. 2 headings to categories of aggregate classification was used, in accordance with Commission Regulation No 656/2007.
Geographical coverage	The index covers the whole Country.
Coverage of economic activities	The Turnover Index in Industry is compiled for all activities listed in Sections B (mining and quarrying) and C (manufacturing) of the NACE Rev. 2 statistical classification.
Computation of the Index	The Turnover Index in Industry is a fixed base index. This index is calculated at a first stage at the four-digit level of economic activity and subsequently, with the implementation of appropriate weighting coefficients, the index is calculated at higher levels (three-level and two-level of economic activity) as well as at the level of Main Industrial Groupings (MIGs).
Publication of data	The Turnover Index in Industry (2015=100.0) is released since August 2019 with June 2019 as first reference month. Data with base year 2015=100.0 are available from January 2000 onwards.
