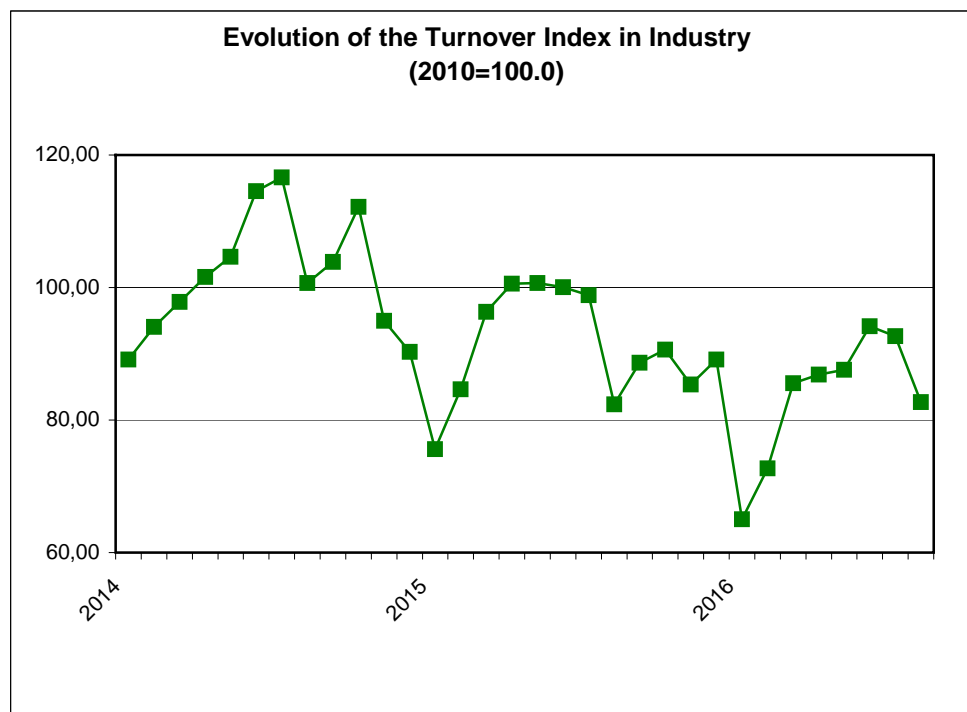
## PRESS RELEASE

### TURNOVER INDEX IN INDUSTRY: August 2016

The evolution of the Turnover Index in Industry with base year 2010=100.0 for August 2016, according to provisional data, is as follows:

The Overall Turnover Index in Industry (both domestic and non-domestic market) in August 2016 compared with the corresponding index of August 2015 recorded an increase of 0.2%. In August 2015 the annual rate of change of the Overall Turnover Index in Industry recorded a decrease of 18.0% (Table 1).

The average Overall Turnover Index in Industry for the 12-month period from September 2015 to August 2016, compared with the corresponding index of the 12-month period from September 2014 to August 2015, decreased by 10.5%. In August 2015, the corresponding average annual rate of change of the Overall Turnover Index in Industry recorded a decrease of 6.3% (Table 8).

The increase of the Overall Turnover Index in Industry by 0.2% in August 2016, compared with the corresponding index in August 2015, was due to the annual changes as following (Table 1):

- by Industrial Sections

- Mining and quarrying turnover increased by 2.0%.
- Manufacturing turnover increased by 0.2%.

In addition, the increase of the Turnover Index in Industry by 0.2% in August 2016, compared with August 2015, was due to the annual changes of the indices of the markets as following (Tables 2, 3):

- The Turnover Index in Industry for the domestic market increased by 6.6%.
- The Turnover Index in Industry for the non-domestic market decreased by 8.7%.

The decrease of the Turnover Index in Industry for the non-domestic market by 8.7% in August 2016, compared with August 2015, was due to the annual changes as following (Tables 4, 5):

- The Turnover Index in Industry for the Eurozone countries decreased by 21.3%.
- The Turnover Index in Industry for the non-Eurozone countries decreased by 1.6%.

## METHODOLOGICAL NOTES

**Generally** The Turnover Index is being compiled since January 2006.

**Purpose of the index** The purpose of this index is to measure the monthly activity of the industrial sector in terms of value. Turnover comprises the totals invoiced (without VAT) by the observation units during the reference period and corresponds to the market sales of goods or services supplied to third parties. The purposes and the characteristics of the Turnover Index apply, as well, to the indices for the distinction between domestic and non-domestic turnover.

**Legal basis** The compilation and publication of the Turnover Index is based on the framework of requirements of the Council Regulation (EC) No 1165/98 concerning short-term statistics (STS-R), as well as the amendment Regulation (EC) No 1158/05 of the European Parliament and Council, amending the Council Regulation (EC) No 1165/98. Furthermore, this index is governed by the Regulation (EEC) No.1893/2006 of the European Parliament and of the Council, by the Commission Regulation (EEC) No.656/2007 and by the Regulation (EEC) No.451/2008 of the Council.

**Reference period** Month

**Base year** 2010=100.0.

**Revision** The last revision of the Turnover Index in Industry with base year 2010=100.0 has been done in the framework of the Short – Term Statistics (STS) Council Regulation (EC) No 1165/98 concerning short-term statistics. According to this regulation the index in question is revised every five years, in years ending in 0 or 5.

**Statistical classifications** At the level of categories of economic activities, the classification of NACE Rev. 2 was used (Regulation 1893/2006), while at the level of main industrial groups, the allocation of two-digit and three-digit NACE Rev. 2 headings to categories of aggregate classification was used, in accordance with the Commission Regulation 656/2007. At product level, the Eurostat classification CPA 2008 was used, according to the Council Regulation 451/2008.

**Geographical coverage** The Index covers the whole country.

**Coverage of economic activities** The Turnover Index in Industry covers the whole country and is compiled for all activities listed in Sections C (mining and quarrying) and D (manufacturing) of the NACE Rev.2 classification.

**Computation of the Index** The Turnover Index in Industry is a fixed base index. This index is calculated initially at the four-digit level of economic activity and subsequently, with the implementation of appropriate weighting coefficients, the index is calculated at higher levels (three-level, two-level and one-level of economic activity) or at the level of Main Industrial Groupings (MIGs).

**Publication of data** The Turnover Index with base year 2010=100.0 is being released since November 2014 with September 2014 as first reference month. Data with base year 2010=100.0 are available from January 2000 onwards.
