Building Activity Survey: June 2016

According to provisional data published by the Hellenic Statistical Authority (ELSTAT), in June 2016 the Total Building Activity (private-public) in Greece, which is calculated on the basis of the number of issued building permits, amounted to 1,081. This figure corresponds to 222.9 thousand m² of surface and 940.1 thousand m³ of volume, reflecting, respectively, a 21.7% decrease in the number of building permits, a 15.3% decrease in surface and a 22.7% decrease in volume, compared with the corresponding month of 2015 (Table 1).

The building permits for the Private Building Activity issued in Greece in June 2016 amouted to 1,072. This figure corresponds to 213.4 thousand m^2 of surface and 891.9 thousand m^3 of volume. In comparison with the same month of 2015 there is a 21.3% decrease in the number of building permits, an 18.0% decrease in surface and a 26.1% decrease in volume (Table 2).

The building permits for the Public Building Activity issued in Greece in June 2016 amouted to 9.This figure corresponds to 9.5 thousand m^2 of surface and 48.3 thousand m^3 of volume. Public Building Activity accounted for 5.1% of the total building volume in June 2016.

In the last twelve months, from July 2015 until June 2016, Total Building Activity (private-public) in Greece, calculated on the basis of the number of issued building permits, amounted to 12,077. This figure corresponds to 2,488.3 thousand m^2 of surface and 13,570.4 thousand m^3 of volume. In comparison with the corresponding period from July 2014 until June 2015, there is a 13.0% decrease in the number of building permits, a 7.6% decrease in surface and a 16.6% increase in volume (Table 3).

In the same period, from July 2015 until June 2016, Private Building Activity in Greece recorded a 13.1% decrease in the number of issued building permits, a 17.7% decrease in surface and a 15.3% decrease in volume, compared with the corresponding period from July 2014 to June 2015 (Table 4). During the same period, Public Building Activity accounted for 28.8% of the total building volume.

During the period January - June 2016, Total Building Activity (private-public) in Greece recorded a 17.2% decrease in the number of issued building permits, a 20.8% decrease in surface and a 21.5% decrease in volume, compared with the corresponding period of 2015 (Table 5).

During the same period, January - June 2016, Private Building Activity in Greece recorded a 17.3% decrease in the number of issued building permits, a 21.7% decrease in surface and a 22.2% decrease in volume, in comparison with the corresponding period of January - June 2015 (Table 6).

EXPLANATORY NOTES

- **Building Activity Survey** The Building Activity Survey has been providing data on a monthly and yearly basis, since 1964. The purpose of this survey is to register the total number of building permits issued by the responsible administrative authorities, which are devolved to complete the questionnaire. The survey covers all the features of building activity, such as the type of building permit, the type of construction, the type and the characteristics of the building and its auxiliary spaces, as well as building usage, surface, volume and value.
- **Legal Framework** The survey is fully harmonized with the European legislation. The primary legislative act is Regulation (EU) 1165/1998, as it was amended according to Regulation (EU) 1158/2005.
- **Reference Period** 01/06/2016 to 30/06/2016
- **Coverage** The survey is exhaustive and covers the total number of issued building permits across the country.
- **Definitions Building Permit** refers to all types of building permits. These are permits for new buildings or permits for additions, repair, renovation, demolition, legitimization, amendment and modification of a building.

The denotation of "built-property" is equal to "building".

Building is every permanent and independent structure, which has walls and a roof and consists of one or more rooms and other complementary spaces. Normally, buildings feature four walls. However, a construction open from one or even two sides will be considered a building, as long as it has a roof.

New building is any built-property raised on an uncovered site or in the place of an old building that has been demolished.

Building Addition is every construction that adds building volume (space) to an existing building, in terms of surface, height or both and creates a residence, a shop or both.

Building volume (the net building volume) refers to the area that is included between the external surface of the external walls, the lowest level (the basement or the sub-basement, if it exists) and the roof of the building. If there is an open ground floor not enclosed within walls between the lower floor and the roof, its volume is taken into account. The relevant authorities calculate the volume of the building during the issuing of the building permit.

Surface of new-built property is considered to be the sum of each floor space along with the outer space of the outer walls.

- **General Remark** Any delineation that may occur between the sum of sub totals and the totals is due to rounding.
