
EVOLUTION OF TURNOVER OF ENTERPRISES IN RETAIL TRADE JUNE, 2ND QUARTER 2024

The Hellenic Statistical Authority (ELSTAT), presents the evolution of the sales/turnover of all classes of activity of the retail trade section, incorporating the most recent data on turnover from Administrative Sources for **June 2024 and 2nd quarter 2024**.

For the **total of enterprises in retail trade**, the turnover in the **second quarter of 2024** amounted to 18.11 billion euro, recording an increase of 4.3% in comparison with the second quarter of 2023, when the respective turnover was 17.37 billion euro and an increase of 15.4% in comparison with the first quarter of 2024, when the respective turnover was 15.69 billion euro.

For the **enterprises in retail trade divisions, excluding vehicles, food and fuel classes**, the turnover in the **second quarter of 2024** amounted to 6.57 billion euro, recording an increase of 4.1% in comparison with the second quarter of 2023, when the respective turnover was 6.31 billion euro and an increase of 22.8% in comparison with the first quarter of 2024, when the respective turnover was 5.35 billion euro (Graph 1, Table 1).

1. Total of enterprises in retail trade

1.1 Quarterly Data (Tables 1, 3)

For the **total of enterprises in retail trade**, the activities that recorded the <u>biggest increase</u> in turnover in the **second quarter of 2024** compared with the corresponding quarter of 2023 are:

- Sale of other motor vehicles, increase 30.0%.
- Sale, maintenance and repair of motorcycles and related parts and accessories, increase 17.6%.

The activities that recorded the <u>biggest decrease</u> in turnover in the **second quarter of 2024** compared with the corresponding quarter of 2023 are:

- Retail sale of computers, peripheral units and software in specialized stores, decrease 3.2%.
- Retail sale of electrical household appliances in specialized stores, decrease 2.3%.

The Regions that recorded the <u>biggest increase</u> in turnover in the **second quarter of 2024** compared with second quarter of 2023 are:

- Region of Voreio Aigaio, increase 6.8%.
- Region of Notio Aigaio, increase 5.8%.

1.2 Monthly Data-Enterprises obliged to double-entry accounting bookkeeping (Tables 2, 5)

For the **enterprises in retail trade divisions obliged to double-entry accounting bookkeeping**, for which data are available on a monthly basis, the turnover in **June 2024** amounted to 3.91 billion euro, recording an increase of 3.0% in comparison with June 2023, when the respective turnover was 3.79 billion euro and an increase of 5.1% in comparison with May 2024, when the respective turnover was 3.72 billion euro.

The activities that recorded the <u>biggest increase</u> in turnover in **June 2024** compared with June 2023 are:

- Sale of other motor vehicles, increase 14.4%.
- Retail sale of cosmetic and toilet articles in specialized stores, increase 14.3%.

The activities that recorded the biggest decrease in turnover in June 2024 compared with June 2023 are:

- Retail sale of textiles in specialized stores, decrease 10.6%.
- Retail sale of books in specialized stores, decrease 6.0%.

The Regions that recorded the <u>biggest increase</u> in turnover in **June 2024** compared with June 2023 are:

- Region of Dytiki Ellada, increase 8.9%.
- Region of Kentriki Makedonia, increase 4.3%.

The Region that recorded <u>decrease</u> in turnover in June 2024 compared with June 2023 is:

• Region of Sterea Ellada, decrease 3.2%.

2. Enterprises in retail trade divisions, excluding vehicles, food and fuel classes¹

2.1 Quarterly Data (Table 3)

For the **enterprises in retail trade divisions, excluding vehicles, food and fuel classes**, the Regions that recorded the <u>biggest</u> <u>increase</u> in turnover in the **second quarter of 2024** compared with the corresponding quarter of 2023 are:

- Region of Thessalia, increase 5.3%.
- Region of Attiki, increase 4.8%.

2.2 Monthly Data (Tables 2, 5)

For the enterprises in retail trade divisions, excluding vehicles, food and fuel classes, obliged to double-entry accounting **bookkeeping**, for which data are available on a monthly basis, the turnover in **June 2024** amounted to 1.09 billion euro, recording an increase of 2.8% in comparison with June 2023, when the respective turnover was 1.06 billion euro and an increase of 7.0% in comparison with May 2024, when the respective turnover was 1.01 billion euro.

The Regions that recorded increase in turnover in June 2024 compared with June 2023 are:

- Region of Attiki, increase 2.4%.
- Region of Kentriki Makedonia, increase 1.2%.

The Regions that recorded decrease in turnover in June 2024 compared with June 2023 are:

- Region of Sterea Ellada, decrease 8.4%.
- Region of Dytiki Ellada, decrease 1.1%.

3. Small and medium sized enterprises (Tables 4, 6)

3.1 Small and medium sized enterprises in retail trade divisions

For the total of small and medium sized enterprises² in retail trade divisions, the turnover in the **second quarter 2024** amounted to 10.63 billion euro, recording an increase of 4.0% in comparison with the second quarter of 2023, when the respective turnover was 10.22 billion euro.

For the small and medium sized enterprises in retail trade divisions **obliged to double-entry accounting bookkeeping**, for which data are available on monthly basis, the turnover in **June 2024** amounted to 1.37 billion euro, recording an increase of 3.7% in comparison with June 2023, when the respective turnover was 1.32 billion euro.

3.2 Small and medium sized enterprises in retail trade divisions, excluding vehicles, food and fuel classes

For the total of small and medium sized enterprises in retail trade divisions, excluding vehicles, food and fuel classes, the turnover in the **second quarter of 2024** amounted to 4.99 billion euro, recording an increase of 3.2% in comparison with the second quarter of 2023, when the respective turnover was 4.83 billion euro.

For the small and medium sized enterprises in retail trade divisions, excluding vehicles, food and fuel classes, **obliged to doubleentry accounting bookkeeping**, for which data are available on a monthly basis, the turnover in **June 2024** amounted to 0.540 billion euro, recording a decrease of 0.8% in comparison with June 2023, when the respective turnover was 0.544 billion euro.











METHODOLOGICAL NOTES

Generally The statistical data presented in this announcement have been compiled on the basis of the linking and processing of primary data from the following sources:

- The final Statistical Business Register of ELSTAT, of the reference year 2021.
- Administrative registers of enterprises, of the reference years 2022 and 2023.
- Administrative transactions files (tax, etc) of the reference years 2019 to 2024.

In particular, the following primary data have been used per source:

- Active enterprises and the economic activity class from the final Statistical Business Register of the reference year 2021.
- The economic activity class for the enterprises that started their activity after the reference year 2021 and have a significant turnover, from administrative registers of enterprises of the reference years 2022 and 2023.
- Income data from administrative transactions files of the reference years 2019 to 2024.


Definitions Small and Medium sized enterprises (SMEs) (from the European business statistics methodological manual for statistical business registers – 2021 edition)

- 1. The category of micro, small and medium-sized enterprises (SMEs) is made up of enterprises which employ fewer than 250 persons and which have an annual turnover not exceeding EUR 50 million, and/or an annual balance sheet total not exceeding EUR 43 million.
- 2. Within the SME category, a small enterprise is defined as an enterprise which employs fewer than 50 persons and whose annual turnover and/or annual balance sheet total does not exceed EUR 10 million.
- 3. Within the SME category, a micro enterprise is defined as an enterprise which employs fewer than 10 persons and whose annual turnover and/or annual balance sheet total does not exceed EUR 2 million.

It is noted that as "Medium enterprises" are defined the enterprises of the "Small and Medium sized enterprises" category, which are not classified in the categories of "Small enterprises" and "Micro enterprises".

 For the economic activities, the European statistical classification of economic activities <u>NACE Rev. 2</u> is used.
