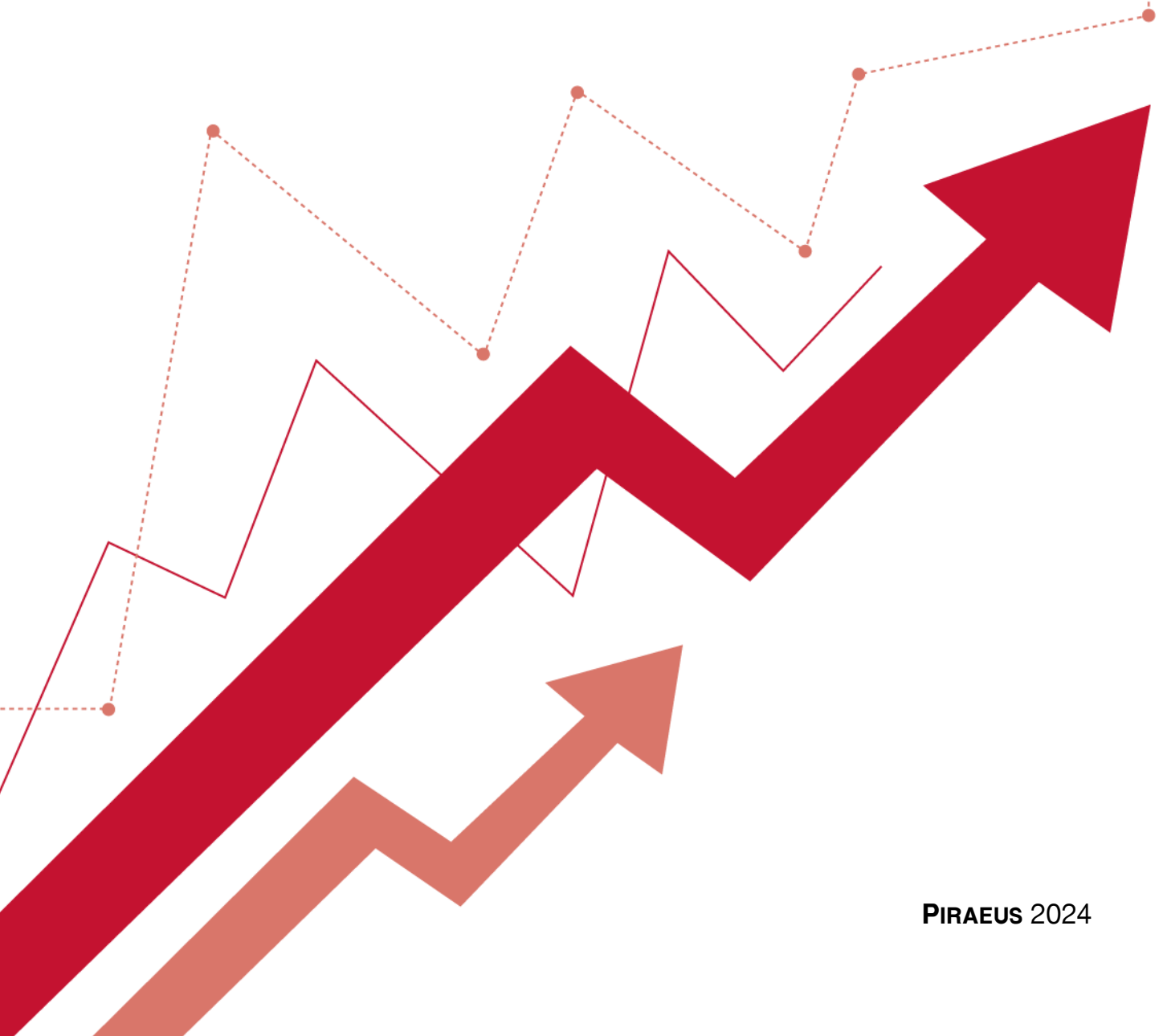

A. INTRODUCTION

The Annual Statistical Work Programme of the Hellenic Statistical Authority (ELSTAT) for the year 2024 (hereinafter 2024 AWP) includes information on the statistics to be compiled and published during 2024 (see Annex), as well as the planned changes to already produced statistics. These changes concern either the production of new statistics, mainly due to the implementation of new European Regulations, or the amendment of produced statistics, in order to fully comply with existing European Regulations and/or to respond more effectively to the needs of users of official statistics. In addition, the 2024 AWP includes information on the planned actions of ELSTAT, for 2024, that aim at further enhancing the quality of its statistics and the access of users to them. The 2024 AWP has been compiled on the basis of the Hellenic Statistical Programme (ELSP) for the three-year period 2023 – 2025.

ELSTAT has set as a primary objective, in 2024 AWP, the further improvement of completeness, quality and timeliness of its statistics, by unswervingly observing the statistical legal framework⁽¹⁾ and by adopting best standards and practices of the European and International Statistical System. In this context and in line with the prevailing trend, it aims to further exploit administrative and other data sources, as well as to make use of new technologies for the production of its statistics, with the aim of enhancing their quality, completeness and speed of production, saving resources and reducing the burden of the surveyed units (households and/or enterprises).

Among ELSTAT's objectives, for 2024, remains the coordination and cooperation with the agencies of the Hellenic Statistical System (ELSS), as well as the maintenance of its active role in the European Statistical System (ESS). The election, in July 2022, of the President of ELSTAT, Mr. Athanasios C. Thanopoulos, as the Head of the Partnership Group (PG), the high-level group of elected Heads of the National Statistical Institutes of the ESS, has marked the unreserve and wide recognition by his counterparts, and of the ESS in general, of the significant and steady progress made, during the last years, in the field of official statistics of our Country and the consolidation of the reliability of statistics of Greece. Mr. Thanopoulos is the first Greek who has been elected and undertaken the post of the President of the PG, since the creation of the institution, at a crucial time during which the PG will be asked to identify the main guidelines for the revision of the European Statistical Regulation 223/2009, which constitutes the basic legislative act for the planning, development and dissemination of European official statistics. The revision of this Regulation will shape the future developments in the field of European statistics.

In addition, ELSTAT, recognising since 2016 the importance of fostering statistical education in Greece, aims to further develop the actions of its strategy regarding the cultivation and strengthening of statistical consciousness in the general public. Accordingly, the actions of ELSTAT to achieve the "democratisation" of statistical information are further promoted.

B. NEW AND EXPERIMENTAL STATISTICS

1. Implementing European Regulations and fulfilling European and international obligations, and national needs

The statistical obligations of our Country towards the European Commission (Statistical Office of the European Union – Eurostat) and other European and international organisations is mainly the trigger for the production of new statistics by ELSTAT, in 2024. The production of these new statistics results from the implementation of new European Regulations, ensuring compliance with existing Regulations and the needs arising from the "Agenda 2030" and the UN Sustainable Development Goals (SDGs). The utilisation of existing surveys, the designing and conduct of new ones, as well as the access and use of administrative data, are the basic tools.

In addition, ELSTAT, in the framework of its mission to produce up-to-date and useful statistics for citizens, businesses and policymakers, continues to produce experimental statistics, launched in 2020, whose main objective is to provide direct statistical information on selected important issues of the economic and social life of Greece.

The new statistics, as well as the experimental statistics scheduled to be produced, in 2024, for the above purposes, are the following by theme:

1.1. New statistics

- INDUSTRY, TRADE AND SERVICES

- *New Monthly Turnover Indices in the Services Sector* (Regulation (EU) 2019/2152 and Implementing Regulation (EU) 2020/1197) that will be published on a quarterly basis.
- *New Monthly Volume Indices (indices at constant prices) in the Services Sector* (Regulation (EU) 2019/2152 and Implementing Regulation (EU) 2020/1197), which will be published on a quarterly basis.
- *New indices for the branches: Real Estate Activities (L68), Rental and Leasing Activities (N77), Combined Facilities Support Activities (N81.1) and Landscape Service Activities (N81.3) of the European Statistical Classification of Economic Activities NACE Rev.2*, in the framework of compiling the Producer Price Indices in Services and the Turnover Indices in Services (Regulation (EU) 2019/2152 and Implementing Regulation (EU) 2020/1197).

- ECONOMY AND PRICES

- *Data processing of residential real estate transactions from data kept in the database myProperty of the Independent Authority for Public Revenue (IAPR)*, for the production of Residential Properties Price Indices on a quarterly basis. Start of publication, in June 2024 (Regulation (EU) 2016/792).

- POPULATION AND SOCIAL CONDITIONS

- *Publication, during the 1st and 2nd quarter of 2024, of the final results of the 2021 Buildings and Population – Housing Censuses, for all the variables of the Resident Population of the Country* (Regulation (EU) 763/2008, in conjunction with Implementing Regulation (EU) 2017/712).
- *Publication, in the 2nd quarter of 2024, of the final results for key variables of the Resident Population of the Country, geocoded in grids of one square kilometer* (Regulation (EU) 763/2008, in conjunction with Implementing Regulation (EU) 2018/1799).

- *Publication, during the 4th quarter of 2024, of the final results of the 2021 Buildings Census, to meet national needs.*
- LABOUR MARKET
 - *Statistics on the position of young people in the labour market*, in the framework of conducting a supplementary ad hoc survey of the Labour Force Survey, of 2024 (Regulation (EU) 2019/1700).
 - *Statistics on pensions and labour market participation*, in the framework of conducting a supplementary ad hoc survey of the Labour Force Survey (Regulations: (EU) 2019/1700, (EU) 2020/1640 and (EU) 2020/1642).
- INCOME AND LIVING CONDITIONS OF HOUSEHOLDS
 - *Statistics on access to services*: use of services –including care services and services for independent living–, affordability to use the above services and reasons for not using them (Implementing Regulation (EU) 2022/2498 of Regulation (EU) 2019/1700).
 - *Statistics on child health, access to health services, and material goods and services deprivation of children*: general health status, activity limitation, non-use of health services when needed and reasons for not using them, and deprivation of children (Implementing Regulation (EU) 2019/2242 of Regulation (EU) 2019/1700).
- SCIENCE, TECHNOLOGY, DIGITAL SOCIETY
 - *Addition of a question to the Use of Information and Communication Technologies Survey by Households and Individuals, regarding the problems encountered, during the closure of application account or service account* (Implementing Regulation, under issue, of Regulation (EU) 2019/1700).

1.2. Experimental statistics

- INDUSTRY, TRADE AND SERVICES
 - *Continuation of the monthly Statistical Announcements on the evolution of the business cycle of the Greek economy, of the enterprises in the branches of Accommodation and Food Services, at regional level, and of the enterprises in the individual branches of Retail Trade.*
- POPULATION AND SOCIAL CONDITIONS
 - *Continuation of the extraordinary Statistical Announcements on provisional death data by week, based on primary data coming from the Registries.*
 - *Results of a pilot survey on the living conditions of LGBTQ+ people and the discrimination due to sexual orientation.* The survey is conducted in accordance with the guidelines and proposals that have been set, which are inspired by the principle of equality and the prohibition of discrimination based on sexual orientation, identity, characteristics and gender expression.
- TOURISM
 - *Statistics on arrivals and overnights at short-term rental accommodations.* Registration of tourist traffic in the accommodations that operate through a digital platform, in the framework of developing experimental statistics using administrative sources and data from Eurostat, to fully cover tourist traffic.

- *Investigating the possibility of using big data*, in the framework of producing tourism statistics.
 - *Monitoring the study and compilation project of the Tourism Account Satellite in collaboration with the competent Services.*
- **INTERNATIONAL TRADE**
 - *Pilot survey on global value chains and international sourcing*, in the framework of compiling International Trade in Goods statistics, before the mandatory collection of the data every three years, as provided for in Regulation (EU) 2019/2152.
 - *Preparatory work concerning the methodology analysis and the creation of questionnaire* for the development of the new statistical thematic field "International Trade in Services Statistics – Way of providing the service through a commercial presence (case 3), Mode of Supply – MoS 3".

2. General Censuses on Buildings and Population – Housing of 2021

After the completion of the field work of the 2021 Population – Housing Census, the post-census work started, which mainly concerned the data processing for the production of the results on the Resident Population of the Country, as well as for the export of the results on the Registered Population of the Country, which were announced in accordance with the constitutional obligation, one year after the completion of the Census (Government Gazette No 6951/issue B/30.12.2022). Moreover, in late 2022, aggregated data and metadata on the total population, geocoded to grids of 1 square kilometer were submitted to Eurostat, in application of Regulation (EU) 2018/1799 of the Commission.

The processing of the census material is ongoing, with quality and completeness checks of the variables being carried out, taking into account relevant data from administrative sources, with the aim, on the one hand, of extracting, within the 1st semester of 2024, of the final results of the 2021 Buildings and Population – Housing Censuses, for all the variables of the Resident Population of the Country, and on the other hand the preparation of the Statistical Registers on Buildings and Population provided for in Law 4772/2021 (Government Gazette No 17/issue A/5.2.2021).

It is emphasised that, for the first time, the Census results for the variables whose processing has been completed are gradually announced, well before the termination, by law, date.

3. Satisfying users' needs

ELSTAT, taking into consideration the comments and proposals of the users of its statistics, including those who draw up public policies, records their needs and includes them in its priorities. The main communication channels of ELSTAT with the users are the User Conferences it organises and the User Satisfaction Survey it conducts.

In this context, in 2024, ELSTAT is planning the following actions:

- Compilation of additional Public Use Files (PUFs)⁽²⁾, as well as standardised Scientific Use Files (SUFs)⁽³⁾ of ELSTAT statistical surveys, according to predefined anonymisation criteria of the microdata of the surveys.
- Continuation of the work for the creation of a safe centre, where authorised researchers will be able to access confidential data for scientific purposes, on which no methods of statistical

disclosure control have been applied. More precisely, in 2024, the following actions are planned:

- a) Cooperation with experts for the creation of a safe centre and the selection of its functioning mode.
 - b) Determination of the requirements of the centre in terms of human resources and equipment, and estimation of the relevant cost.
 - c) Registration of the required actions and compilation of a time-schedule for the pilot functioning of the centre.
- Continuation of the coordination of the ELSS agencies for the development and monitoring of the 2030 individual indicators of the UN Sustainable Development Goals (2030 SDGs), with constant cooperation with the international agencies (custodian agencies) that have under their responsibility the compilation of individual indicators.
 - Further exploitation of data from administrative and other sources, as well as of new technologies, with the aim of improving the quality, reducing the production time of statistics, saving resources and reducing the burden on respondents.
 - Improving the extroversion and presence of ELSTAT on the internet, through the planned upgrading of ELSTAT's website, with the aim of providing users with a comprehensive experience of accessing statistics, always based on the best international practices and technologies. The new ELSTAT website will offer multiple possibilities to access statistical results, including the use of a dissemination database, as well as the provision of statistics in the form of open data.
 - Redesign and "lightening" of the already used online questionnaire of the User Satisfaction Survey, with the aim of improving the quality of its results, through the participation in it of more users of statistical data. The new application is expected to be operational, within 2024.

C. OTHER CHANGES IN THE PRODUCTION AND DISSEMINATION OF STATISTICS

Compliance with European Regulations and adaptation to users' needs, in combination with constraints in terms of available resources, necessitate changes, such as improvements, revisions and discontinuations, in the production and dissemination of statistics.

In the context of the modernisation of European statistics and with the aim of improving their coherence and comparability, while reducing the burden on the surveyed units, the Commission (Eurostat) is preparing the following legislative Proposals, to be submitted to the European Parliament and to the Council:

- Proposal for a Regulation on European fisheries and aquaculture statistics. The legislative proposal is expected to be submitted by the Commission, in the 2nd semester of 2024.

Currently, the following legislative files are in the consultation stage, in the Council and the European Parliament:

- Proposal for a Regulation amending Regulation (EC) 223/2009 on European statistics, as amended by Regulation (EU) 2015/759.
- Proposal for a Regulation on Labour Market Statistics on Businesses.
- Proposal for a Regulation amending Regulation (EU) 691/2011 on the European environmental economic accounts.
- Proposal for a Regulation on European statistics on population (ESOP).

In addition, the following changes are planned, for 2024:

- NATIONAL ACCOUNTS

- *Revision of National Accounts data, with a new base year 2020=100.0.*
- *Benchmark revision of National Accounts data, of reference year 2021, with the incorporation of methodological improvements*, in the context of the verification cycle of the methods and sources of the Gross National Income.
- *Incorporation into the National Accounts of the results of the 2021 Population – Housing Census, regarding the employment and the dwellings.*
- *Incorporation into the National Accounts of the results of the Structural Business Survey, of reference year 2021, for all the sectors of economic activity*, including the sectors that were added to the Survey in accordance with Regulation (EU) 2019/2152 and concern Financial and Insurance Activities, Education, Activities related to Human Health and Social Care, Arts, Entertainment and Recreation.
- *Incorporation into the National Accounts of new and updated data from various sources*, such as: Household Budget Survey (HBS) of 2023, Statistical Business Register of 2021, Foreign Trade and Balance of Payments, financial data, data on Non-Profit Institutions Serving Households (NPISHs) from administrative sources, updated data for the Agriculture, Forestry and Fishery sectors, updated data of short-term indices and updated employment data, for the years up to and including 2023.

- DEMOGRAPHY

- *Development of Statistical Registers on Buildings and Population, based on the future requirements of the new regulatory framework* (Regulation on European population statistics – ESOP, under preparation). Development of synergies with the aim of drawing up memoranda of cooperation for the provision of administrative data deemed necessary for the production of population statistics, particularly in light of the future requirements of the new regulatory framework, from the entities possessing data on population and buildings, such as: Ministry of Interior, Ministry of Migration and Asylum, Ministry of Labour and Social Security, IAPR, IDIKA, etc.

- INFORMATION SOCIETY

- *Discontinuation of the sections "Use of electronic identification (e-ID)" and sub-sections "Origin of sellers of physical products purchased online, online purchase from physical persons/individuals from collaborative economy platforms or applications"*, in accordance with the Implementing Regulation, under issue, of Regulation (EU) 2019/1700.

- INCOME AND LIVING CONDITIONS OF HOUSEHOLDS

- *Discontinuation of statistics on: a) labour market and housing, b) intergenerational transmission of advantages and disadvantages, c) housing difficulties and d) household energy efficiency to address energy poverty*, in the context of addition of new ad hoc modules in the Survey on Income and Living Conditions of Households (EU-SILC), of 2023 (Implementing Regulation (EU) 2021/2052 of Regulation (EU) 2019/1700).

- BUSINESS REGISTERS

- *Creation of a unified database and development of special management software for the automated and centralised updating of the Statistical Business Register from multiple data sources.*

In the new database, all the necessary information to feed the EuroGroups Register (EGR) and to compile the Annual Business Demography will be kept.

- *Development of a special application, through which the basic consistency checks of the Multi-national Enterprise Groups data, which will be studied, in the context of the Large Case Unit (LCU), will be carried out automatically.*
- *Preparation for the implementation, from 2024, of the revised classification of economic activities NACE Rev.2.1.*

- **SHORT TERM INDICES**

- *Change of the periodicity of compiling the Turnover Indices in Services Sector (transport, information and communication, accommodation and food and other service sectors) from quarterly to monthly, in application of Implementing Regulation (EU) 2020/1197 of Regulation (EU) 2019/2152.*
- *Discontinuation of the compilation of the Employment Indices for the branch 47 of Retail Trade concerning the variables: Employed Persons, Working Hours, Wages and Salaries.* Those indices will henceforth be calculated from the Survey on the Compilation of the Labour Cost Index (LCI), with increased sample.
- *Change of the base year (2021=100.0) of the following indices, in the context of the requirements of Regulation (EU) 2019/2152 and of its Implementing Regulation (EU) 2020/1197:*
 - a) Price Index of Work Categories and Construction Cost Index of New Residential Buildings
 - b) Material Cost Index for the Construction of New Residential Buildings
 - c) Producer Price Index in Industry
 - d) Production Index in Construction
 - e) Import Price Index in Industry
 - f) Industrial Production Index
 - g) Turnover Index in Industry
 - h) Turnover Index in Retail Trade
 - i) Turnover Index in the Services Sector
 - j) Turnover Index in Wholesale Trade
 - k) Turnover Index in Motor Trade
 - l) Services Producer Price Index
 - m) Employment Indices (Employed Persons, Working Hours, Wages and Salaries).

- **RETAIL PRICE INDICES**

- *Preparatory work for the implementation, from January 2026, of the new classification COICOP 18, in accordance with Regulation (EU) 2016/792.*

- **INTERNATIONAL TRADE**

- *Study of the exchanged data of intra-Union exports for the development of a methodology, with the aim of calculating intra-Union imports using the export data of EU member states, in accordance with Regulation (EU) 2019/2152, and the subsequent reduction of the burden on the enterprises.*

D. IMPROVING THE QUALITY OF PRODUCED STATISTICS

ELSTAT will continue, in 2024, its actions to ensure and further improve the quality of its produced statistics and to uphold users' trust in them. These objectives will be accomplished by unswervingly implementing the statistical legislative framework and by adopting best practices and standards of the European and International Statistical System.

Among the actions ELSTAT will carry out, in 2024, aimed at accomplishing the above objectives, is the continuation of its close cooperation with the ELSS agencies and the support of their statistical activities, in the framework of exercising its coordinating role.

Besides the above actions, a series of actions is envisaged in areas such as: using technology to upgrade data collection, further utilising administrative and other data sources for the production of statistics, reducing the burden on respondents, training the staff of ELSTAT and of the other ELSS agencies, as well as fostering statistical literacy.

1. Improvement actions for the implementation of the recommendations made in the context of the 3rd round of Peer Reviews in the ESS

In July 2023, Eurostat and ELSTAT published the Peer Review Report for the ELSS, reflecting for the first time the full compliance of ELSTAT with the Principles of the European Statistics Code of Practice (CoP).

The Report includes recommendations of the Reviewers for further improvement and development of the ELSS, and for their implementation, ELSTAT prepared a draft of improvement actions with a timetable for their completion. The draft will be finalised in cooperation with Eurostat. A significant number of these actions have been scheduled to be completed, within 2024.

2. Coordination of the actions of the ELSS agencies

ELSTAT, in the framework of its coordinating role in ELSS, will continue, during 2024, its close cooperation with the ELSS agencies, with the aim of their full compliance with the CoP Principles, and it will take the necessary actions for the compilation and monitoring of implementation of the improvement actions to be undertaken by the Other National Authorities that participated in the 3rd round of Peer Reviews.

3. Implementation of the General Data Protection Regulation

ELSTAT, in the framework of implementing Regulation (EU) 2016/679 of the European Parliament and of the Council, on the protection of natural persons against the processing of personal data and for the free movement of such data (General Data Protection Regulation – GDPR), has completed, during the previous years, a series of important actions, which resulted in its full compliance with the GDPR provisions.

In 2024, the work of assessing the implementation of GDPR will continue within ELSTAT, so as to further increase the level of consolidation of the GDPR provisions by ELSTAT's staff and to ensure their full and correct implementation in their daily work. In particular, as, in 2024, 6 years have passed since the start of implementation of GDPR, ELSTAT plans the conduct of additional specialised actions of personalised assessment of the consolidation and implementation of the GDPR provisions in the daily work of each ELSTAT's employee, but also at the level of organic units. The findings of the above actions will be included in an evaluation report and will be used as a guide for future improvement interventions.

Moreover, relevant training and information actions for newly hired employees at ELSTAT will be carried out, so as to achieve the same level of awareness as of the existing staff. In addition, the actions aimed

at cultivating culture and informing – training the staff, which have started since 2018 and include educational seminars and informative one-day conferences on specialised issues of GDPR implementation for the production of official statistics, addressed to the entire ELSTAT's staff, will continue, with the coverage of new relevant topics. More precisely, within 2024, targeted training and information programmes for the staff will continue, which concern more specialised issues of GDPR implementation in the area of the production of official statistics.

Finally, depending on the results of the assessment, there will be corrective actions and readjustment of the implementation measures, if this is deemed necessary. As a continuing action, the policies related to the GDPR implementation in ELSTAT will be updated, as the case may be, where required, while at the same time new ones will be developed, where this is necessary to cover new needs and areas of action. In parallel, the evaluation and updating of the log files of the activities of ELSTAT's organic units concerning the processing of personal data, as well as of the files of the detailed recording of the procedures followed by the above organic units will be completed.

4. Use of new technologies to upgrade data collection

ELSTAT will continue, in 2024, its actions to take advantage of the possibilities offered by modern data collection and processing technologies. More specifically:

- RETAIL PRICE INDICES
 - *Investigating the feasibility of collecting prices (pilot price collection) for the Consumer Price Index (CPI) and the Harmonised Index of Consumer Prices (HICP), for the categories of electrical goods and hotels, using the "Web Scraping" method.*
 - *Investigating the feasibility of collecting prices for the CPI and HICP, using the "Scanner Data" method – preparatory work.*

The above actions are dictated by the need to modernise the collection of prices for the compilation of the HICP, in accordance with Eurostat guidelines.

- TOURISM
 - *Survey of Qualitative Characteristics of Resident Tourists.* Collection of the primary data of the survey through the use of tablets, with the aim of reducing their collection and processing time, mainly due to the prospect of conducting the survey with quarterly periodicity.
- ROAD FREIGHT TRANSPORT
 - *Road Freight Transport Survey.* Electronic collection of the primary data of the survey, through the use of tablets and web application (the collection through printed questionnaires remains where necessary), with the aim of reducing their collection and processing time, as well as the time for the execution of computerised checks.

5. Utilising administrative data sources for the production of statistics

The European and international statistical community have focused on the utilisation of administrative data and data from other sources, such as big data and privately held data, for the production of statistics. In line with the prevailing trend, ELSTAT has proceeded to the signing of memoranda of cooperation with ELSS agencies and has developed close cooperation with administrative data sources. ELSTAT will seek to continue and further expanding its cooperation with administrative data sources, formalising such cooperation through the signing of memoranda of cooperation, where required.

In this context, ELSTAT plans to develop/continue, within 2024, a series of cooperation actions with administrative sources, with the aim of maximising their utilisation to meet the requirements of specific statistical surveys/tasks. Indicatively, the following actions are stated:

- Continuation of the cooperation with the General Commercial Registry (GEMI), for the provision of business data that is kept electronically in GEMI.
- Continuation of the regular cooperation with the IAPR to access data of the Tax Register and Tax Forms (Income, Indirect Taxes, etc.) used to update the Statistical Business Register, compile short-term statistics and structural business statistics, as well as for the provision of data from the Tax Form "Report by Country on Multinational Enterprise Groups", in the framework of producing statistics on enterprise groups in Greece and updating the structure of the groups in the Statistical Business Register.
- Continuation of the cooperation with the IAPR, with the aim of utilising data on electronic distance sales, from businesses to individuals in another EU member state, in the framework of compiling statistics on intra-EU trade.
- Continuation of the cooperation with the IAPR, with the aim of utilising data from the "my Property" database, for the needs of the House Price Indices Survey.
- Continuation of the cooperation with the IAPR, for the provision of data on the income of wage-earners.
- Continuation of the regular cooperation with the Customs Authorities, for the provision and utilisation of customs data, in the context of the compiling statistics on the trade of goods with third countries.
- Continuation of the cooperation with the IAPR and the Bank of Greece (BoG), with the aim of utilising available data for the needs of the International Trade in Services Survey of the BoG.
- Continuation of the cooperation with the IAPR, for the extraction of data, in the framework of producing statistics on the activities of tourist accommodations and further updating the Statistical Register of Tourist Accommodations.
- Continuation of the cooperation with the Ministry of Tourism, in the framework of compiling Tourism Satellite Accounts.
- Continuation of the cooperation with the Electronic National Social Security Entity (e-EFKA) and the Single Payment Authority (EAP), for the provision of data from the above entities for updating the Statistical Business Register.
- Continuation of cooperation with e-EFKA, for the provision of monthly data of the entity for the compilation of short-term employment and labour cost indices, as well as development of cooperation with the aim of utilising data on pensions, in the context of the Survey on Income and Living Conditions of Households (EU-SILC).
- Development of cooperation with the IAPR and the Organisation of Welfare Benefits and Social Solidarity (OPEKA), in order to utilise their available data on income and social benefits, respectively, for the needs of the Survey on Income and Living Conditions of Households (EU-SILC).
- Development of cooperation with the Ministry of Interior, in the framework of the breakdown of the cohabitation agreements by number of previous agreements.
- Development of cooperation with the Interoperability Center (KED) of the Ministry of Digital Governance, in order to use the web services that have been developed, regarding births, marriages, cohabitation agreements, divorces and deaths.

- Continuation of the cooperation with the Ministry of Rural Development and Food and the Payment and Control Agency for Guidance and Guarantee Community Aid (OPEKEPE), for the annual update of the Agricultural Statistical Register of ELSTAT.
- Development of cooperation with the Ministry of Rural Development and Food, as well as with the Directorate General of Sustainable Fisheries, with the aim of conducting, henceforth, the Survey on Sea Fishery with the use of administrative sources.
- Continuation of cooperation with the Ministry of Interior, the Ministry of Labour and Social Security, the Ministry of Migration and Asylum, the Ministry of Digital Governance, the IAPR and the Hellenic Cadastre, in the framework of compiling and updating the Population and Buildings Statistical Registers, as well as of producing basic statistics, on an annual basis, after 2025.
- Investigating the use of land cover geospatial data from international databases and information systems (e.g. Corine Land Cover database of the Copernicus system), with the aim of compiling ecosystem accounts in the future.
- Continuation of the cooperation with the "ERGANI" Programme, in the framework of conducting the Labour Force Survey, and exploring the possibility of expanding this cooperation to cover the needs of the Job Vacancy Survey and of the Statistical Population Register under development.
- Continuation of the cooperation with the National Centre for Social Research (EKKE), in the context of the Task Force of Eurostat for the reformulation of the questionnaire of the gender based violence survey.
- Continuation of the cooperation with the Hellenic Authority for Higher Education (HAHE), with the aim of harmonising the national data in the field of higher education.
- Continuation of the cooperation with the Hellenic Cadastre, to which the Land Registries are gradually included, for the provision of the data required for the needs of the Survey on Land Registries.
- Development of cooperation with the Ministry of Education, Religious Affairs and Sports, for the provision of data from the myschool platform, for the needs of the Survey on Private Primary and Secondary Schools.
- Development of cooperation with the Ministry of Infrastructure and Transport, for the pilot processing of administrative data from the KTEO database, for the estimation of vehicle kilometers (V-km) by vehicle category.
- Development of cooperation with the Ministry of Maritime Affairs and Insular Policy, for the utilisation of the administrative data of its information systems, such as the Electronic System for Booking Seats and Issuing Passenger Tickets, and the National Single Window NSW/SSNET, in the framework of producing passenger and freight traffic statistics.
- Investigating the feasibility of using administrative data provided by the information systems of ERGANI (2019) and e-EFKA (2022), both to improve the quality of the statistics produced by the Labour Statistics Section and to reduce the response burden of the enterprises surveyed in the Labour Cost Survey and the Job Vacancy Survey.
- Development of collaborations, with the aim of compiling memoranda of cooperation for the provision of administrative data (Ministry of Interior, Ministry of Migration and Asylum, Ministry of Labour and Social Security, IAPR, IDIKA, etc.) that are deemed necessary for the production of population statistics, especially in the light of the future requirements of the new regulatory framework (under preparation).

- Collection of data from the Health Regions, regarding the equipment and beds of the Primary Health Care Units.

E. ENHANCING ACCESSIBILITY TO THE STATISTICS PRODUCED

1. Upgrading the portal of ELSTAT

ELSTAT has adopted a strategy for the dissemination and communication of its statistics, putting the users at the heart of its activities.

In this context, ELSTAT, within 2024, will proceed to the completion of works related to the overall upgrade of its web portal and its enrichment with new capabilities of searching and extracting statistical results, based on criteria and personalised queries, which the user will configure through an easy-to-use and flexible search environment. In parallel, the system will also provide advanced visualisation capabilities of the results (data visualisation). To achieve the above, ELSTAT's portal will provide access to a specialised dissemination database, which will be developed for this purpose and will leverage experience from best international practices.

Also, in the context of the implementation of the Implementing Regulation (EU) 2023/218 of the Commission on the compilation of a list of specific high value datasets and the definition of the arrangements for their publication and further use, ELSTAT plans the disposal of the datasets, concerning statistics, through its website, in the form of open data that can be received in bulk through appropriate Application Programming Interface (API).

In addition, ELSTAT will continue the constant upgrading of statistical products, and of dissemination and communication means, in line with evolving international standards and making the most of digital tools for the creation of innovative products, by enhancing the format and enriching the content of its portal.

Therefore, ELSTAT will continue, during 2024, to: a) enrich its portal and dissemination system with new statistical results, time series of the statistics produced and public use files, b) develop standardised scientific use files, for the needs of researchers, with predefined criteria for anonymising the microdata of its relevant statistical surveys, c) illustrate its selected statistics, as well as their production processes, with infographics, aiming to present them in a way that is understandable to the general public and suitable for reproduction on social media, d) to develop procedures and make available its selected statistical products in the form of open data and e) utilise the social media, for the promotion of its statistical work.

To speed up the access process of researchers to standardised use files, while reducing the administrative burden, ELSTAT, in 2024, will complete the procedures for their uploading on the website. The access of researchers to the files will be granted upon submission of their research proposal, fully and correctly completed, and the signing of the relevant contract for the observance of statistical confidentiality, of the declaration of personal data and of the authorisation forms, where required.

2. Fostering Statistical Literacy

ELSTAT will continue, in 2024, its strategy on "Fostering Statistical Literacy" in Greece. ELSTAT's objectives are to:

- inform about the applications of Statistics in everyday life,
- develop statistical consciousness,
- inform pupils/students about the production processes of official statistics,

- inform about the CoP Principles and, in particular, about Principle 5 regarding the observance of statistical confidentiality and data protection.

For 2024, ELSTAT plans the following actions:

- Taking initiatives with the aim of expanding the awarding of the European Master in Official Statistics (EMOS) label and in other university institutions of the Country, apart from the Aristotle University of Thessaloniki and the Athens University of Economics and Business, to which the specific label has been awarded.
- Continuation of educational presentations at ELSTAT's premises, for pupils and students, in Athens and Thessaloniki.
- Continuation of educational presentations at the ELSTAT stand, during the Thessaloniki International Fair (TIF).
- Expansion of informative visits of ELSTAT executives to educational units (schools/universities).
- Continuation of the informative visits/speeches of the President of ELSTAT in educational institutions.
- Continuation of the promotion of the educational programme "Census@School" to teachers and pupils.
- Continuation of providing opportunities for practical training to students, at ELSTAT's premises.
- Conduct of the 7th Panhellenic Competition in Statistics, with the participation of groups of pupils from lower and upper secondary schools of the Country.
- Continuation of cooperation with university schools, with the aim of preparing theses of post-graduate students, with thematology related to the development, production and dissemination of official statistics.
- Continuation of ELSTAT's participation in the Cross-Border Internship Programme of EMOS students. ELSTAT, and more specifically its mentor representative, has the obligation to work closely with the intern, depending on the thematic area assigned to her/him, and to provide support, encouragement and information to the intern, depending on her/his work and experience in relation with the host institution (organisation culture, informal codes and behaviours, etc.).
- Continuation of ELSTAT's participation in the "Summer Vocational Guidance" programme, addressed to upper secondary education pupils, with the aim that the experience gained by the pupils to be a useful resource for their academic and professional career. The action is activated after a relevant request submitted by school units.

F. ORGANISATION OF CONFERENCES, INTERNATIONAL RELATIONS AND DEVELOPMENT OF STATISTICAL COLLABORATIONS

In the framework of renewing and improving the statistical products, of upgrading its services provided, as well as of cultivating cooperation bonds and of strengthening bilateral relations with the National Statistical Institutes (NSIs) of EU member states, but also of developing further collaborations, both at national and international level, in areas of common interest, ELSTAT, during 2024, plans the following actions:

- Organisation of the 13th User Conference.
- Organisation, in March 2024, of a meeting of the Partnership Group (PG) of the ESS, under the chairmanship of the President of ELSTAT, in the framework of the Group's activities.
- Visit of a delegation of the Statistical Office of the Republic of Cyprus to ELSTAT's premises, aiming at continuing and strengthening the cooperation of the 2 NSIs, in the framework of their joint actions in the European and international statistical community, with a view to continuously ensuring the quality and reliability of official statistics, as well as to cooperating more closely with producers and users of statistics and responding to their ever-increasing needs.
- Organisation of the 12th International Conference "Use of R in Official Statistics" (uRos2024).
- Continuation of the organisation of visits of ELSTAT representatives to NSIs of other countries. The purpose of the meetings is the development of synergies and the exchange of know-how, experiences and good practices. For 2024, the organisation of a meeting of senior officials of the Statistical Office of Malta, the Statistical Office of the Republic of Croatia, the Statistical Service of Cyprus and ELSTAT is planned.
- In the context of the cooperation that has developed in recent years with the Statistical Service of the Czech Republic (Czech Statistical Office – CZSO), the organisation of bilateral meetings between executives of the 2 Services will continue, in 2024. The purpose of these meetings is to further develop synergies and to exchange know-how and experiences, within the framework of the ESS.
- Continuation of ELSTAT's participation in the Instrument for Pre-accession Assistance (IPA) 2019 programme of Eurostat, intended to the provision, by the NSIs of the EU member states, of training to statistical employees of the IPA countries.

G. ESTIMATION OF EXPENDITURE FOR THE IMPLEMENTATION OF THE STATISTICAL WORK PROGRAMME

The implementation of the 2024 AWP presupposes the allocation of the necessary resources from the State Budget and Eurostat, as well as the reinforcement of ELSTAT with the required and appropriate human resources. The Commitment on Confidence in Statistics contains explicit commitments for the Government and the Greek State to reinforce ELSTAT with the necessary resources, so that it can fulfill all its obligations, at national and European level, and provide users with high-quality statistics.

The budgeted expenses, for 2024, are estimated at a total of 40,206,502.00 euros and are classified into the following categories:

- a) Labour cost: salaries of ELSTAT's staff, including basic salary, allowances (family allowance, liability position allowance, etc.), social security contributions, remuneration for overtime work, etc.
- b) Expenses related to staff travel within Greece and abroad, i.e., travel, accommodation and daily allowance expenses for the employees of ELSTAT travelling:
 - in Greece, out of home or outside the office, for conducting statistical surveys in the field, and
 - abroad, for participating in meetings, seminars, etc. organised by Eurostat and other international organisations.
- c) Other operating expenses, including expenses related to ELSTAT's premises (Central Service and Regional Statistical Offices), such as rents, expenses for electricity, telecommunications, water supply, security and maintenance of buildings, expenses for advertising and public relations,

subscriptions, expenses for the provision of consumables (paper, stationery, medical and pharmaceutical supplies, materials for the maintenance and repair of premises and equipment), fuel, etc. This category also includes expenses for the provision of capital formation goods (furniture, PCs, printers, photocopiers and other office equipment), as well as the remuneration of private collaborators, who are used by ELSTAT for the collection of data of statistical surveys it conducts.

- d) Expenses for projects financed by Eurostat (for conducting surveys, studies and other statistical tasks).
- e) Expenses for the 2021 Censuses of Agriculture – Livestock, Buildings and Population – Housing.

Table 1 presents the budget estimate of ELSTAT (in euros) for 2024, in comparison with the approved budget of 2023:
