


ELSTAT HELLENIC STATISTICAL PROGRAMME





A. INTRODUCTION

The three-year statistical work programme of the Hellenic Statistical System (ELSS), the Hellenic Statistical Programme (ELSP), is compiled every 3 years, in accordance with Article 5 of the Greek Statistical Law 3832/2010 "Hellenic Statistical System Establishment of the Hellenic Statistical Authority (ELSTAT) as an Independent Authority", as amended and in force. The ELSP determines the priorities of the ELSS –i.e., of ELSTAT and of the other ELSS agencies— so that the statistical system of the Country can meet its EU and international obligations, regarding the required statistics for compilation. These priorities are determined taking into consideration the required human and financial resources, as well as the administrative burden which the compilation of the relevant statistics entails.

The ELSP 2023 – 2025 is the fifth three-year statistical programme of the ELSS. The 4 previous ELSPs had been compiled for the three-year periods 2011 - 2013, 2014 - 2016, 2017 - 2019 and 2020 - 2022. It contains the major fields and objectives of the statistical actions scheduled by the ELSS agencies for the above three-year period. These statistical actions are either planned regular actions or ad hoc actions for dealing with new needs. The ELSP 2023 - 2025 is the basis on which the ELSS agencies compile their annual statistical work programmes for 2023, 2024 and 2025.

Guide and point of reference for the compilation of the ELSP 2023 – 2025 was the European Statistical Programme for the period 2021 – 2027, which aims at modernising and improving the quality of European statistics, through the development of new methods and methodologies, as well as investigating new data sources for the production of official statistics.

The election, in July 2022, of the President of ELSTAT, Mr. Athanasios C. Thanopoulos, as President of the Partnership Group (PG), the high-level group of elected Heads of National Statistical Institutes (NSIs) of the European Statistical System (ESS), marks the unreserved and wide recognition by his counterparts, and of the ESS in general, of the significant and steady progress made in recent years in the field of official statistics of our Country, and the consolidation of the reliability of statistics of Greece. Mr. Thanopoulos is the first Greek who is elected and undertakes the post of the President of the Partnership Group, since the creation of the institution, at a crucial time during which the PG will be asked to identify the main guidelines for the revision of the European Statistical Regulation 223/2009, which constitutes the basic legislative act for the planning, development and dissemination of European official statistics. The revision of this Regulation will shape the future developments in the field of European statistics.

Section B of the ELSP contains information on the objectives of ELSTAT and of the ELSS, in general, as regards the consolidation of the achievements pertaining to the quality of the ELSS statistics and its continuous improvement.

Section C contains information on ELSTAT's actions that concern both the production of new statistics and the revision of produced statistics in the period 2023 – 2025, according to its national and international obligations and taking into account users' needs.

Section D contains information on the other ELSTAT's actions aiming at further improving the completeness, quality and timeliness of its statistics, saving human and financial resources, as well as at fostering statistical literacy in Greece.

Section E presents the budget for the implementation of the ELSP.

Section F outlines the objectives and initiatives of the ELSS agencies, apart from ELSTAT, in the areas of development, production and dissemination of statistics, for the period 2023 – 2025.

The Annex contains the list of statistics of the ELSS agencies, apart from ELSTAT, which are planned to be produced in the period 2023 – 2025.

B. ENSURING AND FURTHER IMPROVING THE QUALITY OF ELSS STATISTICS

1. Objectives and means

The objectives for the three-year period 2023 – 2025 are to ensure and further improve the completeness, quality and timeliness of statistics produced by the ELSS, by following the highest international statistical standards, unswervingly observing the prescribed rules, fulfilling the undertaken obligations and focusing on the better exploitation of the available human and financial resources, while reducing the burden on respondents through the use of administrative and other data sources. The assurance and further improvement of the completeness, quality and timeliness of ELSS statistics require the faithful application, by all the ELSS agencies, of the national and European statistical legal framework in force and the adoption of best practices and standards of the ESS, with further utilisation of administrative and other data sources, and use of new technologies.

This framework includes:

- 1. the Greek Statistical Law 3832/2010, as amended and in force,
- 2. the Regulation (EC) 223/2009 on European statistics, as amended by Regulation (EU) 2015/759,
- 3. the European Statistics Code of Practice (CoP),
- 4. the EU Regulations on statistics,
- 5. the Regulation on the Operation and Administration of ELSTAT,
- 6. the Regulation on the Statistical Obligations of the ELSS Agencies, and
- 7. the memoranda of cooperation between the ELSS agencies.

As it is also mentioned in the Preamble of the CoP, after its last revision, which was adopted by the European Statistical System Committee on the 16th November 2017, the common quality framework of the ESS is composed of the CoP, which is its cornerstone, the ESS Quality Assurance Framework and the general quality management principles (such as continuous interaction with users, commitment of leadership, partnership, staff satisfaction, continuous improvement, integration and harmonisation).

The Statistical Authorities that are responsible for developing, producing and disseminating European statistics are committed to observe the CoP. In particular, the ELSS agencies are obliged to implement the CoP when developing, producing and disseminating their statistics, whether it concerns national or European statistics.

The full implementation of the Commitment on Confidence in Statistics, which was signed by the Greek Government and the European Commission in 2012 and incorporated in the Greek legislation (Law 4051/2012) is crucial for the achievement of the objectives of the ELSS agencies.

Among the specific actions of ELSTAT, in the three-year period 2023 – 2025, for the achievement of the above objectives, the following actions are included:

- Continuation of the self-assessment of its produced statistics, as regards the methodology applied and the general compliance of statistics with the CoP Principles, so that they meet the evolving users' needs.
- Continuation of its close cooperation with the ELSS agencies and the support of their statistical activities, in the framework of the certification process of their statistics.
- Further utilisation of administrative and other data sources, as well as of the new technologies for the data collection and processing, and the dissemination of its statistics, with the aim of saving resources and reducing the burden of surveyed units.
- Continuation of its close cooperation with the other ESS members, in the context of work meetings (Task Forces/Working Groups and Sector/Directors' Groups) organised by Eurostat on various statistical matters, and of its dynamic presence and substantial participation in European decision-making centres on statistical matters.
- Continuation of the statistical coordination and the close cooperation with the other ELSS members, for the more complete monitoring of the indicators mentioned in the 2030 Sustainable Development Goals⁽¹⁾ of UN and of the individual indicators of Eurostat.
- Continuation of organisation of training seminars on statistical matters, for enriching the knowledge and improving the skills of ELSTAT's staff and the staff of the other ELSS agencies.
- Further utilisation of modern communication and technology means for the presentation of statistics and the improvement of their accessibility by the general public.
- Continuation of actions, in the framework of the development of ELSTAT's strategy for promoting statistical literacy in Greece.

· Continuation and intensification of the cooperation of ELSS with the academic community.

2. Coordination within and between the ELSS agencies

According to Article 2 of the Greek Statistical Law 3832/2010, as in force, ELSTAT coordinates the activities of the other ELSS agencies which concern the development, production and dissemination of the Country's official statistics, so that these statistics are developed, produced and disseminated in accordance with the CoP Principles. In the framework of this coordination, ELSTAT collects, on annual basis, information on the planned for the next year statistical tasks of the other ELSS agencies, as well as on the implementation of their statistical tasks of the previous year.

ELSTAT works and will continue, during the three-year period 2023 – 2025, to work on the improvement of the coordination within and between the ELSS agencies. Crucial factors for the achievement of this objective are the acknowledgment by the ELSS agencies of the role of the statistical head, who has been appointed, in line with the provisions of Principle 1 of the CoP, in almost all the ELSS agencies and the substantial support of her/his work, as well as the implementation of the "Guide to the Hellenic Statistical System Agencies for the Implementation of the European Statistics Code of Practice", which was compiled, with the aim of a more complete understanding and implementation of the CoP by the agencies.

Further strengthening of the coordination between the ELSS agencies is expected, in the framework of the process of certifying as "official" the statistics produced by the said agencies (see next paragraph), which will continue and be intensified during the three-year period 2023 – 2025.

3. Certification as "official" of the statistics of ELSS agencies

A basic obligation of ELSTAT is, in accordance with Article 11(6) of the Greek Statistical Law 3832/2010, as amended and in force, is the certification as "official" of the statistics produced by the other ELSS agencies. This certification is an important factor and a tool for enhancing the quality and reliability of ELSS statistics.

ELSTAT has completed the basic stage of certification of statistics for almost all the ELSS agencies. The ELSS agencies have been informed by ELSTAT on the horizontal actions they have to take for the certification of their statistics. It should be noted that several agencies have implemented a large part of these actions. ELSTAT will continue the close cooperation with the agencies, aiming at completing the certification of their statistics, in the thee-year period 2023 - 2025.

4. Conduct of the 3rd round of Peer Reviews

In the framework of the 3rd round of Peer Reviews conducted in all Member States of the European Union and of the European Free Trade Association (EFTA), as well as in Eurostat, with the aim of assessing the compliance with all the CoP Principles, ELSTAT, in 2022, participated in that process.

The Peer Review of the 3rd round was carried out in our Country on 17 - 21 October 2022. The team of reviewers appointed for this purpose assessed the compliance of ELSTAT and of the 3 other National Authorities of the ELSS that participated in the Peer Review (Ministry of Labour and Social Affairs, Ministry of Environment and Energy, National Documentation Centre) with the 16 CoP Principles. On the basis of the findings of the above assessment, the reviewers will compile a Report, in which any recommendations for ELSTAT and the other 3 National Authorities that participated in the Peer Review will be included, with the aim of fuller complying with the CoP Principles.

The Report is expected to be published in March 2023, while the reviewers, already during their visit, found that ELSTAT, for the first time, is one of the few NSIs of the ESS that is in line with all the CoP Principles.

In the three-year period 2023 – 2025, ELSTAT will undertake all the necessary measures for the implementation of the improvement actions that may arise for it from the conduct of the Peer Review of the 3rd round in our Country. In parallel, ELSTAT, in the framework of its coordinating role in the ELSS, will undertake further initiatives, if needed, with the aim of providing information, clarifications and guidance for the implementation of the improvement actions that may arise for the ELSS agencies.

5. Enhanced use of administrative data sources

The use of administrative data sources for the production of statistics contributes not only to saving human and financial resources for Statistical Authorities, but also to reducing the statistical burden on respondents

and, in many cases, to improving the quality of statistical data (e.g., in relation to their timeliness, more complete coverage, greater analysis, etc.). For this reason, the European and international statistical community has focused on the utilisation of administrative and other data sources, like Big Data and privately held data, for the production of statistics.

ELSTAT, aligning with the prevailing trend in the European and international statistical community, places particular emphasis on better utilisation of the data available in the administrative sources of the Country and supports the work that takes place in the ESS for the utilisation of other data sources. ELSTAT will continue its above actions, during the three-year period 2023 – 2025.

During the above three-year period, ELSTAT will seek the continuation and further development of its cooperation with administrative data agencies, with formalisation of this cooperation through the signing of memoranda of cooperation, where required.

In this context, ELSTAT plans to develop/continue a series of collaborations with administrative data agencies, with the aim of maximising their utilisation to meet needs of specific statistical surveys/works. Indicatively, the following actions are mentioned:

- Continuation of the cooperation with the General Commercial Registry (GEMI), for the provision of business
 data that are held electronically in GEMI.
- Continuation of the cooperation with the Independent Authority for Public Revenue (IAPR) and the Organisation of Welfare Benefits and Social Solidarity (OPEKA), with the aim of utilising their available data on income and social benefits, respectively, for the needs of the Survey on Income and Living Conditions of Households (EU-SILC).
- Continuation of the cooperation with the IAPR and the Bank of Greece (BoG), with the aim of utilising available data to the IAPR for the needs of the International Trade in Services Survey of the BoG.
- Expanding the cooperation with the IAPR, with the aim of utilising data on electronic distance sales from businesses to individuals in another Member State, in the framework of compiling statistics on intra-EU trade.
- Continuation of the cooperation with the IAPR, with the aim of utilising data from the database of "My Property", for the needs of compiling the Residential and Owner-occupied Dwellings Price Indices.
- Continuation of the cooperation with the IAPR, for the extraction of data, in the framework of producing tourist accommodations statistics and further updating the Statistical Register on Tourist Accommodations.
- Continuation of the cooperation with the IAPR, the Ministry of Interior, the Ministry of Migration and Asylum, the General Secretariat of Social Solidarity and the Fight Against Poverty, the Ministry of Digital Governance, and the Hellenic Cadastre, in the framework of compiling and updating Statistical Population and Buildings Registers, as well of presenting basic statistics on annual basis, after 2025.
- Development of cooperation with the Ministry of Rural Development and Food, as well as with the General Directorate of Sustainable Development, with the aim of conducting the Sea Fishery Survey using hereafter administrative sources.
- Continuation of the cooperation with the Ministry of Rural Development and Food and the Payment and Control Agency for Guidance and Guarantee of Community Aid (OPEKEPE), for updating the Statistical Agricultural Register of ELSTAT, on a yearly basis.
- Investigating the use of geospatial land data from international databases and information systems (e.g., Corine Land Cover database of the Copernicus system), with the aim of compiling ecosystem accounts in the future.
- Continuation of the cooperation with the "ERGANI" Programme, in the framework of conducting the Labour Force Survey, and investigating the possibility of expanding this cooperation for meeting the needs of the Job Vacancy Survey.
- Development of cooperation with the Electronic Unified Agency of Social Insurance (e-EFKA), with the aim
 of utilising data on pensions, in the framework of the Survey on Income and Living Conditions of Households
 (EU-SILC).
- Development of cooperation with the Hellenic Cadastre, to which the Land Registries joined, with the aim
 of providing data for the needs of the Survey on Land Registries.

- Development of cooperation with the Ministry of Education and Religious Affairs, for the provision of data from the myschool platform, for the needs of the Survey on Private Schools of Primary and Secondary Education.
- Development of cooperation with the Interoperability Center (KED), of the Ministry of Digital Governance, with the aim of using the web services they have been developed, regarding births, marriages, cohabitation agreements, divorces and deaths.
- Continuation of the cooperation with the Hellenic Authority for Higher Education (HAHE), with the aim of harmonising the national data, in the field of higher education.
- Development of cooperation with the Ministry of Infrastructure and Transport, with the aim of pilot processing administrative data from the database of Vehicle Technical Check Centers, for the estimation of vehicle kilometers (V-km) by vehicle category.
- Development of cooperation with the Ministry of Maritime Affairs and Insular Policy, for the utilisation of administrative data of its information systems, such as the Electronic Reservation and Ticketing System and the National Single Window NSW/SSNET, in the framework of producing the passenger and freight traffic statistics.

6. Using technology to upgrade data collection

During the three-year period 2023 – 2025, ELSTAT will carry on the efforts for upgrading data collection for the production of its statistics, aiming at taking full advantage of the possibilities offered by the new technologies for data collection, with the aim of optimising the relevant procedures, especially with regard to saving time and resources.

More specifically, during the period 2023 – 2025, ELSTAT plans the following actions related to the use of new technologies:

- Development of a web application for the Annual Agricultural Statistical Survey and the Survey on Acquacultures.
- Development of a database for the Statistical Business Register of ELSTAT and for the EuroGroups Register, for the automation of their compilation processes and the further enhancement of quality (accuracy and over time comparability) of their data.
- Development of a special application for the automation of processing and checking the collected data of the Survey on Intra-group Transactions and the production of final statistical data.
- Development of a special application, through which basic consistency checks of the data of the Multinational Enterprise Groups will be conducted automatically.
- Development and operation of a web application for the data collection of Structural Business Surveys.
- Development of a new version of the Intrastat electronic application, with the aim of modernising the programming language of the existing version and extending it for the communication with the enterprises to automate processing.
- Development of an application, in the framework of microdata exchange between Statistical Authorities of the ESS.
- Development of a web application for introducing primary and secondary confidentiality in international trade in goods statistics.
- Improvement of the existing web application for data collection, in the framework of producing statistics on global value chains and international supply sources of enterprises.
- Development of a web application for the collection of administrative data, in the context of cooperation
 with the Bank of Greece for the international trade in services statistics.
- Improvement of the existing web application for the collection and management of data of the Survey on the Expectations of Greek Export Enterprises, regarding the exports that they are going to carry out.
- Pilot use of a web questionnaire (CAWI), for the collection of Labour Force Survey data.

- Development of a web application for the data collection of the Labour Cost and Job Vacancy Surveys.
- Development of web application for the collection and processing of data via mobile phone (sensors, web questionnaire, etc.) or via tablet, for the needs of the Time Use Survey.
- Development of a web application, compatible with use on tablets, for the data collection of the Road Freight Transport Survey.
- Investigating the possibility of developing a web application for the data collection of the Survey on Freight and Passenger Traffic in Greek Ports.
- Development of a web application, compatible with use on tablets, for the data collection of the Survey on the Qualitative Characteristics of Resident Tourists.
- Upgrading the web application "Xenios Zeus", for the data collection of the Survey on Tourist Accommodation Movement.
- Upgrading existing applications (e.g., of tertiary education, of General Government Entities, etc.).
- Development of ELSTAT's Geoportal: In-house development of the website, where the geospatial data owned, managed and developed by ELSTAT will be provided.
- Integration into the daily operation of ELSTAT and use of the "Iris" software, for the electronic circulation of ELSTAT's documents.
- Automated production of the publication "Greek Economy" and reconstruction of some applications of ELSTAT's Integrated Information System.

7. Enhancing accessibility of produced statistics

ELSTAT, already in the three-year programming period 2017 – 2019, has adopted a new dissemination and communication strategy of its statistics, putting users at the heart of its activities. In this context, and with the aim of a better understanding of its produced statistics by the users, it will continue displaying selected statistics of it and their production processes, with infographics, as well as posting microdata files of its statistical surveys, which have been anonymised with anonymisation criteria predefined by ELSTAT, so that the direct or indirect disclosure of the surveyed units is not possible (public use files).

During the three-year period 2023 – 2025, ELSTAT will continue its actions for further upgrading its statistical products and their dissemination and communication means, which is expected to contribute to enhancing its recognition and user confidence in its produced statistics. More specifically, it will continue:

- to improve the layout and content of its electronic portal and of the other dissemination means of its produced statistics, both in Greece and internationally, according to the evolving international standards,
- to enrich its website with additional Public Use Files⁽²⁾, as well as with standardised Scientific Use Files⁽³⁾ of its statistical surveys, with anonymisation criteria predefined by ELSTAT that will be posted on its website,
- to illustrate selected statistics of it, as well as their production processes, with infographics, aiming at presenting them in a way that is understandable to the general public and suitable for reproduction also in social media, which are an important source of information for millions users,
- to use the social media for promoting its statistical work.

In addition to the general objectives set for the period 2023 – 2025, ELSTAT has planned, for the said period, the development of specialised actions for enhancing accessibility to statistical information. Some of these actions are listed, indicatively, below:

 Creation of reference databases of its statistics, in order to enable the external users to generate/extract statistical data according to their needs.

(3) Anonymised microdata files of statistical surveys, which allow the indirect identification of the surveyed units.

- Adaptation of ELSTAT's BI Analytics, so that it supplies the portal with the necessary data of the main applications.
- Improvement of existing and compilation of new metadata, regarding international trade statistics, on the basis of the requirements of Regulation (EU) 2019/2152 on European Business Statistics.
- Improvement of existing and creation of new tables, regarding international trade statistics posted on the portal.
- Improvement of published statistics on the website (announcements of statistical data, tables, metadata) for some Environmental Accounts, such as the Material Flow Accounts and the Environmental Taxes.
- Posting a time series on the financial data of education, where the evolution of key variables will be presented on annual basis.
- In addition, ELSTAT will continue its work on the operation, within the three-year period 2023 2025, of a safe centre, where authorised researchers will be able to access to confidential data for scientific purposes, on which no methods of statistical disclosure control have been applied.

8. Reducing the burden on respondents

In addition to the benefits in the area of improving the quality and timeliness of produced business statistics and the saving of human and financial resources, the provision to ELSTAT of administrative business data contributes to drastically reducing the nuisance on enterprises and their burden for completing questionnaires. The planned actions by ELSTAT, regarding the further utilisation of administrative data sources were indicatively mentioned in Paragraph 5. These actions are expected, if implemented, to contribute to reducing the burden of surveyed units.

ELSTAT will continue, during the three-year period 2023 – 2025, to provide assistance to projects aimed at reducing the burden on respondents. In this context, it will continuously follow up the developments that will take place in the ESS, as regards the use of big data and "smart" data for the production of official statistics. In addition, it will continue to compile, on annual basis, a report on the assessment of the response burden of surveyed units. The conclusions of the above reports provide useful material for evaluating the effectiveness of ELSTAT's actions, regarding the reduction of the burden on respondents.

9. Regular meetings with users of statistical data

ELSTAT, acknowledging the usefulness of the conclusions of the User Conferences in updating and improving the statistical product, as well as in upgrading its provided services, has established the organisation of such conferences, on annual basis. The conclusions from these conferences, as well as the results of the User Satisfaction Survey conducted by ELSTAT, constitute a very useful background for the compilation of the ELSP and of the annual statistical work programmes.

Aiming at familiarising users with the statistical data and the better use of the data by them, ELSTAT will continue, within the three-year period 2023 – 2025, the organisation of one-day conferences for targeted categories of users.

C. NEW, REVISED AND EXPERIMENTAL STATISTICS, IN THE PERIOD 2023 - 2025

The production of new statistics in the ELSS, during the period 2023 - 2025, is based, to a large extent, on the priorities of the European Statistical Programme for 2021 - 2027, which will be analysed in the annual statistical programmes of the ESS for the years 2023 - 2025. Moreover, the production of new ELSS statistics is driven by the requirement to satisfy users' needs, as these have been recorded by ELSTAT, in the framework of its regular meetings with the users.

1. New statistics of ELSTAT for meeting European and international obligations

The obligation of ELSTAT to produce new statistics, during the period 2023 – 2025, arises, in a large part, from the need to fulfill its obligations towards Eurostat and other European and international organisations. These involve implementing new European Regulations, ensuring compliance with existing Regulations, fill-

ing-in questionnaires, updating databases, etc. The new statistics that are planned to be produced in the above three-year period for such purposes are the following (by theme):

2023

- POPULATION HOUSING CENSUS
 - Results of the 2021 Population Housing Census, for the total Resident Population of the Country, geocoded in a grid of one square kilometer (Regulation (EC) 763/2008 on Population and Housing Censuses, in conjunction with the Implementing Regulation (EU) 2018/1799).
 - Results of the 2021 Population Housing Census, for key demographic variables of the Resident Population (gender, age, nationality, households) and the characteristics of dwellings.
- LABOUR MARKET
 - Statistics on work skills, in the framework of conducting a supplementary ad hoc survey, of the Labour Force Survey, of reference year 2022 (Regulations: (EU) 2019/1700, (EU) 2020/1640 and (EU) 2020/1642).
- INCOME AND LIVING CONDITIONS OF HOUSEHOLDS
 - Statistics on: a) quality of life, b) participation in cultural and social activities and c) health, in the framework of new ad hoc modules added in the Survey on Income and Living Conditions of Households (EU-SILC), of reference year 2022 (Regulation (EU) 2021/2052, Implementing Regulation (EU) 2019/1700).
- SHORT-TERM INDICES
 - Statistics for the House Price Index and the Owner-occupied Housing Price Index, on quarterly basis (Regulations (EU) 2016/792 and (EU) 2020/1148).
- EDUCATION AND TRAINING
 - Statistics on the participation in education and in lifelong learning activities, the types and characteristics of educational activities, in the framework of the Adult Education Survey (Regulations (EU) 2019/1700, (EU) 2021/859 and (EU) 2021/861).
- BUSINESS REGISTERS
 - Incorporation of the statistical unit "Kind of Activity Unit" into the Statistical Business Register of ELSTAT, of reference year 2021, in application of Regulation (EU) 2019/2152 and of Implementing Regulation (EU) 2020/1197.
 - Application of the statistical unit "Enterprise" in the Business Demography Statistics, of reference year 2021.
- BUSINESS STRUCTURE
 - Extending the coverage of Structural Business Statistics in the sectors P (Education), Q (Human health and social work activities), R (Arts, entertainment and recreation) and for the branch S96 (Other personal service activities) of the statistical classification of economic activities NACE Rev. 2 (Regulation (EU) 2019/2152).
- INTERNATIONAL TRADE
 - Statistics on the number of enterprises with more than 50 employees, of the branches of economic activity B to N of the NACE Rev. 2, by business operation and geographic region, in the framework of the Global Value Chains and International Sourcing Survey, with reference period 2018 – 2020.
- INFORMATION SOCIETY
 - Statistics on: a) the use of electronic identification (e-ID), b) e-skills and c) the protection of privacy and personal data, in the framework of the Survey on the Use of Information and Communication Technologies (ICT) in Households by Individuals, of reference year 2023 (Regulation (EU) 2022/1399, Implementing Regulation (EU) 2019/1700).

2024

- POPULATION HOUSING CENSUS
 - Results of the 2021 Population Housing Census, for all the variables of the Resident Population (Regulation (EC) 763/2008 on Population and Housing Censuses, in conjunction with Implementing Regulation (EU) 2017/712).

- Results on the basic variables of the Resident Population, geocoded in a grid of one square kilometer (Regulation (EC) 763/2008 on Population and Housing Censuses, in conjunction with Implementing Regulation (EU) 2018/1799).
- LABOUR MARKET
 - Statistics on pensions and on the participation in the labour market, in the framework of conducting a supplementary ad hoc survey of the Labour Force Survey (Regulations: (EU) 2019/1700, (EU) 2020/1640 and (EU) 2020/1642).

 - Statistics on the access to services, in the framework of new added ad hoc modules in the Survey on Income and Living Conditions of Households (EU-SILC), of reference year 2024 (Regulation to be adopted, Implementing Regulation 2019/1700).

 - Statistics on the time use of the members of households of the Country. The Time Use Survey (TUS) will be conducted in 2024, on a voluntary basis by the Member States.

- DEMOGRAPHY
- Data on weekly deaths, based on primary data from the Registries.
- BUSINESS REGISTERS
- Statistics on the evolution of turnover of enterprises. This publication is continuation of the Press Releases
 published by ELSTAT on the Evolution of Turnover of Enterprises under Suspension of Operation, due to
 COVID-19 pandemic.
- Statistics on the evolution of turnover of enterprises in accommodation and food service activities. The aim of these publications is to map the evolution of the turnover of enterprises classified in the Accommodation, and Food and Beverage Service Activities divisions. These economic activities have been, over time, in the focus of interest, due to the significant weight they bear on the Greek economy as a whole, but also due to their extensive dispersion, with a significant presence in all Regional Units and a significant contribution to the respective local economies of Greece, often associated with the tourist product of the Country.
- Statistics on the evolution of turnover of enterprises in retail trade. The aim of these publications is the detailed presentation of the evolution of the sales/turnover of all activity classes of the retail trade sector, which has always been an important productive tertiary sector of the Greek economy, with a significant contribution to the Gross Domestic Product. The follow-up of the evolution of the aggregates of the retail trade activity

classes is important, due to the resulting conclusions on the evolution of consumption (in terms of volume, characteristics, preferences and substitution of products) of the Greek society, the citizens and the enterprises of the Country.

- INTERNATIONAL TRADE OF GOODS
- Statistics on the expected value of exports of goods in 2023 compared to 2022, in percentage terms of change, with the aim of capturing the expectations of enterprises regarding the exports that they are going to carry out during 2023, providing an ex-ante estimate of the trend of change in Greek exports of goods, between 2022 and 2023.
- LIVING CONDITIONS OF LGBTQI PERSONS
- Pilot survey on the living conditions of LGBTQI people and on the discriminations due to sexual orientation.

3. New statistics of ELSTAT for meeting users' needs

ELSTAT collects the comments of the participants in its annual User Conferences and takes into consideration the results of the User Satisfaction Survey it conducts, with the aim of improving its statistical product and its services provided, as well as identifying new needs and requirements for the production of statistics.

The User Conference did not take place in 2020 and 2021, due to the COVID-19 pandemic, however ELSTAT, responding to the new requirements and conditions created by the pandemic, developed new statistical products, in addition to its regular official statistics, which capture the effects of the pandemic, to cover the needs of users. The production of the said statistical products and their publication on ELSTAT's website (https://www.statistics.gr/en/covid-19) continues.

The satisfaction of the needs of users (including those of policy makers) is among ELSTAT's priorities, for the three-year period 2023 – 2025. ELSTAT has already proceeded to the prioritisation of the above needs, on the basis of their importance for users and their criticality for its statistical product, and has begun investigating the possibilities of satisfying them, on the basis of its available resources and its national and international obligations, as indicatively described below. In addition, in this direction, ELSTAT is planning the conduct of pilot studies for the compilation of statistics, with disaggregation into population groups with sensitive characteristics (health, sexual orientation).

With the aim of improving the quality and reducing the production time of the statistical results in various areas, such as in the areas of business, education and health statistics, ELSTAT, as above mentioned, has already been active in the direction of expanding the use and utilisation of data from administrative sources, as well as of new technologies. The relevant actions will continue and will be intensified, during the three-year period 2023 – 2025.

In order to produce reliable results at a level lower than the Whole Country, ELSTAT has already started reviewing existing sampling plans of its sample statistical surveys. In this framework, the increase of the sample of surveyed units (households, individuals, enterprises) for estimates, at the level of Region, taking into account ELSTAT's available resources, is included. In this context: a) in the Vacation Survey, of reference year 2020, the sample size was increased from 8,786 to 9,475 households and b) in the Survey on Electronic Commerce in Enterprises, of reference year 2022, the sample size was increased from 5,000 to 6,000 enterprises.

The review of existing sampling plans of sample statistical surveys for the above purpose will continue by ELSTAT, during the three-year period 2023 – 2025, in order to estimate the additional sample size and cost that will be required to derive reliable survey results, at the level of Region. The implementation of the revised sampling plans for conducting the surveys will depend on ELSTAT's available resources.

ELSTAT, in the framework of improving user accessibility to anonymised microdata of its statistical surveys⁽⁴⁾, has posted on its website (https://www.statistics.gr/el/public-use-files) anonymised microdata files for certain statistical surveys it conducts. The said files have been anonymised with anonymisation criteria predefined by ELSTAT, which are published on its website, so that it is not possible the direct or indirect identification of the surveyed units (Public Use Files). ELSTAT will continue, in the three-year period 2023 – 2025, the compilation and posting on its website of public use files also of other statistical surveys it conducts. At the same time, it will proceed to the compilation and posting on the website of standardised scientific use files, to which researchers will have access under specific conditions. In addition, it will continue its work on the operation of a safe centre (see Section B, Paragraph 7).

In the framework of the compilation of indicators to follow up the 17 Sustainable Development Goals (SDGs) of the 2030 Agenda for Sustainable Development of the United Nations, ELSTAT works closely with the General Coordination Secretariat, which is the competent body for monitoring and coordinating the works, at national level, for the implementation of the 2030 Agenda. The object of the cooperation is the selection and provision of data for national indicators, on the basis of which the progress of the Country regarding the SDGs is monitored. ELSTAT, which is responsible for the statistical coordination of the 2030 Agenda, will continue, during the three-year period 2023 - 2025, to provide its assistance in the compilation of the above indicators, with the production of additional statistics from already conducted surveys or the conduct of new statistical surveys, on the basis of its available resources. In the same framework, ELSTAT, as the competent by law authority for coordinating the statistical activities of the ELSS agencies, will continue to provide methodological guidance to the said agencies for the production of statistical data to follow-up the respective indicators and will assess the data, during the certification process of the statistics of ELSS agencies. The purpose of this assessment is the use of official statistics from international agencies and the ensuring of quality of produced statistics, so that they can be used to make appropriate policies. It is emphasised that ELSTAT has developed the national platform (https://www.statistics.gr/en/sdgs) from which users can obtain the necessary information, regarding the statistics used to follow-up the SDGs.

ELSTAT, in the framework of the extroversion strategy it has developed, will continue, also during the threeyear period 2023 – 2025, the organisation of one-day conferences for specific categories of users, with the aim of informing the users about the production methodology and the proper use of its statistics.

4. Other changes in the production and dissemination of statistics

Compliance with European Regulations and adaptation to users' needs, in combination with constraints in terms of the available human and financial resources, necessitate changes: improvements, revisions, discontinuations in the production and dissemination of statistics.

In the context of modernising European statistics and aiming at increasing their coherence and comparability, while reducing the burden on the surveyed units, the Commission (Eurostat) is preparing the following legislative Proposals:

- Proposal for a Regulation on European fisheries and aquaculture statistics.
- Proposal for a Regulation amending Regulation (EU) 691/2011 on European environmental economic accounts.
- Proposal for a Regulation on European Statistics on Population (ESOP).
- Proposal for a Regulation amending Regulation (EC) 223/2009 on European statistics, as amended by Regulation (EU) 2015/759.

In addition, the following changes are planned, for the three-year period 2023 – 2025:

- DEMOGRAPHY
- Modification, from 2023, of the statistics on cohabitation agreements, by analogy with the statistics on marriages, following user requests, in the framework of the Natural Movement of Population Survey. Information will be collected on any previous cohabitation agreement(s) (until now information was collected only on previous marriages). It will be implemented in collaboration with the Ministry of Interior.
- Review, from 2024, of the compilation of statistics on weekly deaths, on the basis of Eurostat guidelines and the evolution of the COVID-19 pandemic.
- LABOUR MARKET
- Reduction of the weeks for transmitting to Eurostat the quarterly data of the Labour Force Survey, from 10 to 8 after the end of the reference period (quarter), from 2023 instead from 2024 (Regulation (EU) 2019/1700), with a corresponding presentation of the data at national level.
- Increase of the sample of the Labour Force Survey (LFS), from 2024. The increase of the sample is necessary, in order to meet the accuracy requirements for the LFS estimates (Regulation (EU) 2019/1700, Annex II).
- Improvement of the seasonal adjustment model of the results of the Job Vacancy Survey and collection of the survey data by electronic means (use of an electronic questionnaire), with the aim of improving the quality of the results and reducing the administrative burden.

- Changes to the Job Vacancy Survey and to the Labour Cost Survey in Enterprises, due to the new Regulation on the labour market statistics, which is under consultation and is expected to take effect, from 2025. The changes concern the reduction of the transmission time to Eurostat of the data of Labour Cost Indices (LCI) from t+70 to t+65 days, after the end of the reference period t (quarter), and the compilation and transmission to Eurostat of additional Indices on Working Hours and Labour Cost, from the 1st quarter of 2025 onwards.
- BUSINESS STATISTICS
- Development and maintenance of relationships with the management and financial services of Multinational Enterprise Groups, through which it will be possible to obtain information about their operation and structure, with the aim of reconciling the financial statements of the enterprises with the statistical data provided by the enterprises.
- Implementation of the PRODCOM product list, of 2022, in the framework of conducting the Survey on the Production and Sales of Manufacturing Products (PRODCOM).
- JUSTICE
- Investigation of new administrative sources, from 2023, for collecting the data of the Survey on Convicted Persons.
- SHORT-TERM INDICES
- Change of the base year (2021= 100.0), in 2024, in the framework of the requirements of Regulation (EU) 2019/2152 and of Implementing Regulation (EU) 2020/1197, in the following surveys:
 - Survey for the compilation of the Production Index in Construction.
 - Survey for the compilation of Price Indices of Work Categories and Construction Cost Indices of New Residential Buildings.
 - Survey for the compilation of Short-Term Indices on Employment, Working Hours and Earnings.
 - Survey for the compilation of the Material Cost Index for the Construction of New Residential Buildings.
 - Survey for the compilation of the Producer Price Index in Industry.
 - Survey for the compilation of the Import Price Index in Industry.
 - Survey for the compilation of the Industrial Production Index.
 - Survey for the compilation of the Turnover Index in Industry.
 - Survey for the compilation of the Turnover Index in Retail Trade.
 - Survey for the compilation of the Turnover Indices in the Services Sector.
 - Survey for the compilation of the Turnover Index in the Wholesale Sector.
 - Survey for the compilation of the Turnover Index in Motor Trade.
 - Survey for the compilation of the Services Producer Price Indices.
- Compilation and publication of the sub-indices of the Production Index in Construction, for the 2-digit branches of economic activity F41, F42 and F43 of the NACE rev.2 classification, in replacement of the 2 sub-indices (building construction and civil engineering) that are compiled and published, in the framework of the requirements of Regulation (EU) 2019/2152 and of Implementing Regulation (EU) 2020/1197.
- Change of the frequency of conducting the Survey for the compilation of the Turnover Indices in the Services Sector from quarterly to monthly, in 2024, in the framework of the requirements of Regulation (EU) 2019/2152 and of Implementing Regulation (EU) 2020/1197.
- Production of Short-Term Indices on Employment, Working Hours and Earnings for the branch G47 of NACE rev.2, with the exception of the branch of fuels G473, in 2024, in the framework of the requirements of Regulation (EU) 2019/2152 and of Implementing Regulation (EU) 2020/1197.

- INTERNATIONAL TRADE
- Greater analysis of currencies, from 2023, in the framework of the Survey on International Trade in Goods Statistics, by Invoicing Currency (Regulation (EU) 2019/2152 on European Business Statistics (EBS) and Implementing Regulation (EU) 2020/1197).
- Expanding the linking of international trade in goods statistics, by business characteristics, with variables of business statistics and of foreign affiliates trade statistics, and change of the due date for compiling the above statistics, from t+18 months (until 2021) to t+12 months, from the end of the reference year t, in the framework of the Survey on International Trade in Goods Statistics, by Business Characteristics (Regulation (EU) 2019/2152 on European Business Statistics (EBS) and Implementing Regulation (EU) 2020/1197). More specifically, the results will be transmitted to Eurostat as follows:

for the year 2021, until 30 June 2023,

for the year 2022, until 31 December 2023,

for the year 2023, until 31 December 2024,

for the year 2024, until 31 December 2025.

- AGRICULTURAL PRICES AND INDICES
- Change of the base year of the Agricultural Price Indices (APIs), from 2015=100.0 to 2020=100.0. The
 work for the change of the base year of the APIs started in 2022, but will be completed in 2023. According
 to the current ESS agreement, the new weighting factors should be transmitted in June 2023 and the new
 time series in December 2023.
- AGRICULTURAL INPUT OUTPUT STATISTICS
- Changes to the variables and the frequency of conduct of the Surveys on Livestock and Pesticides, from 2025, on the basis of the new draft Regulation on Agricultural Input – Output (SAIO).
- TOURISM
- Participation in the project of studying and compiling the Tourism Satellite Account (TSA), in collaboration
 with the Ministry of Tourism.
- INFORMATION SOCIETY
- Cessation of production of statistics of the Survey on the Use of Information and Communication Technologies (ICT) in Households by Individuals, concerning the following:
 - a) e-government services,
 - b) Internet of Things,
 - c) Green ICT.
 - d) Internet activities, such as: entertainment (music, watching internet television, video on demand, video from You Tube), e-Health, online appointment, via website or via application, with a practitioner (of a hospital, of a health care centre, private practitioner), online access to personal medical records and use of health services (prescription, consultation, etc.), via website or application,
 - in accordance with Regulation to be adopted Implementing Regulation (EU) 2019/1700.

D. NEW ACTIONS, DURING THE PERIOD 2023 – 2025

During the period 2023 – 2025, ELSTAT will carry out a series of new actions aimed at further improving the completeness, quality and timeliness of its statistics, saving human and financial resources, as well as fostering statistical literacy in Greece.

1. Development and updating of Statistical Registers on Buildings and Population

After the completion of the conduct of the 2021 Population – Housing Census, the first digital census in our Country, post-census work will continue, during the period 2023 - 2025, for the processing of the census material, in order to prepare and set up the Statistical Registers on Buildings and Population prescribed in Law 4772/2021 (A' 17).

It is pointed out that the quality and depth of the data collected allow, for the first time, the creation of a reliable Statistical Population Register and the full representation of all inhabitants of the Country in the official statistics. After their compilation, the said Registers will be updated on the basis of data from administrative sources, in order for our Country to respond to its new statistical obligations towards the Statistical Service of the European Union (Eurostat).

2. New classification COICOP 2018

According to Article 10 of Regulation (EU) 2016/792 on Harmonised Indices of Consumer Prices, the new version of the classification of individual consumption by purpose COICOP 2018 should be put in place until February 2026.

Since the transition to the new COICOP 2018 classification requires a large-scale and multi-year implementation planning, the following actions will be carried out in the period 2023 – 2025:

- · Classification of existing species, according to the new classification.
- Finding of new species to cover the codes of the new classification that are not covered from the existing species.
- Computerised reconstitution of the calculation files of the Harmonised Index of Consumer Prices (HICP), based on the new classification.
- Simultaneous application of the new classification to the National Consumer Price Index (CPI), for reasons of compatibility of the two indices.
- Calculation of the time series of the CPI and the HICP, according to the new classification.

3. Exploiting the possibilities of modern technologies

ELSTAT, during the period 2023 – 2025, will continue its actions to exploit the possibilities offered by modern technologies in the entire range of production and dissemination processes of its statistics, with a view to their faster production, the cost reduction and the minimisation of the burden of respondents.

In addition, it will carry out actions to upgrade its portal, so that the dissemination of its statistics is easier in a more friendly and functional environment for the users, while it will continue the actions to promote open data with full respect in ensuring statistical confidentiality.

The initiatives to define areas in which the geodata can support the compilation and assist the follow-up of national and European statistical indicators are expected to be important, while the investigation of the use of new data sources (high frequency data, big data, etc.) in the production of official statistics will continue.

4. International presence

ELSTAT, in the framework of the strategy of extroversion that it has developed in recent years, plays an important leading role, at European and international level, having an active participation with speeches, presentations and publications in the most distinguished European and international statistical and economic conferences and fora.

The election of the President of ELSTAT, in 2022, as President of the Partnership Group of the ESS, which will be asked to identify the main guidelines for the revision of the European Statistical Regulation (EC) 223/2009, which constitutes the basic legislative act for the planning, development and dissemination of European official statistics, will shape the future developments in the field of European statistics.

At the same time, the bilateral collaborations with Statistical Services of other countries and the interaction with international organisations on methodological issues regarding the production and dissemination of official statistics will continue. ELSTAT will continue to provide expertise and aims at creating thematic units for the European Statistical Training Programme (ESTP).

5. Modernisation of ELSTAT's Statistical Business Register

The Statistical Business Register provides the frame for correctly identifying the target population in statistical business surveys, for the selection of the surveyed units and the extrapolation of the collected sample data to aggregated statistical results concerning the target population. At the same time, the current trend in official statistics is for the Statistical Business Register to be a direct source of information for the production of business statistics, as it includes very desirable characteristics for the dissemination of statistics, such as the complete coverage and the high consistency level of the information it incorporates on enterprises.

Therefore, the Statistical Business Register can play a vital and central role in the process of integrating data from different and multiple sources and to producing new statistics that are distinguished by the aforementioned desirable characteristics.

In particular, as the enterprises nowadays navigate in a complex and rapidly evolving economic and regulatory environment, within which they constantly need to adapt their legal and business structure, the adoption of a business-centric approach is very important, from a strategic point of view, for the compilation of business statistics that are characterised by accuracy, usefulness, consistency and complete coverage. Such a business-centric approach can facilitate issues such as data integration, prioritisation of sources and integration priorities, data quality assurance, data exchange and sharing capability, surveillance of legal changes of enterprises and data linking, both at micro-level and at aggregate level.

In this framework, ELSTAT proceeds to the implementation of 2 important actions that will contribute positively to the further modernisation of the Statistical Business Register:

- It will design, develop and put in place a new unified database and a special management software for the
 automated, central and, where appropriate, in real-time updating of the Statistical Business Register from
 multiple data sources. The new software will also serve the automation of the classification and the standardisation of the data included in the Statistical Business Register, the application of hierarchy and priority
 rules for integrating relevant data from different sources, the automated conduct of quality checks and the
 automated production of data that are fully consistent with the Statistical Business Register and feed the
 Register of European Multinational Enterprise Groups.
- It will expand its existing cooperation with the Bank of Greece, which is aimed at sharing and common use
 of data between the 2 agencies, with emphasis on multinational enterprise groups. Through this cooperation
 the different sources with business register data, to which the 2 agencies have access individually, will be
 fully utilised, and the full alignment, in terms of coherence and consistency, of business statistics compiled
 by the 2 agencies will become feasible.

6. Fostering Statistical Literacy

ELSTAT, since 2016, has implemented various actions, in the framework of its strategy for the "Fostering of Statistical Literacy in Greece". These actions aim to inform the citizens, and mainly pupils and students, on the applications of Statistics in everyday life, the production processes and use of statistics, as well as on the principles and rules of the European and international statistical community that govern the production and dissemination of official statistics.

During the three-year period 2023 – 2025, ELSTAT will continue and intensify its relevant actions. Some of these actions are listed, indicatively, below:

- Taking initiatives for the awarding of the European Master in Official Statistics (EMOS) and in other Higher Education Institutions of the Country, apart from the Departments of Mathematics and Statistics of the Aristotle University of Thessaloniki (AUTh), in 2019, and of the Athens University of Economics and Business (AUEB), in 2022, respectively. The EMOS provides postgraduate education in the field of official statistics and is recognised at European level.
- Continuation of the organisation of the "Hellenic Statistics Competition", with the participation of teams of secondary school pupils from all over Greece and of the participation of the distinguished teams in the "European Statistics Competition" of Eurostat.
- Continuation of the educational visits of pupils and students to ELSTAT's premises in Piraeus and Thessaloniki and of the informative visits of ELSTAT's executives to educational units, for which the access to ELSTAT's premises is difficult, due to distance or other reasons.
- Updating the existing and creating new educational material, in the form of books, theory and exercise books, web games, videos, etc., by education level, and forwarding the educational material to teachers.
- Continuation of the cooperation with university schools, with the aim of elaborating theses of postgraduate students, with thematology that will arise from a list of topics related to the development, production and dissemination of official statistics.
- Making web presentations, addressed to pupils of primary and secondary education schools, with the aim
 of promoting ELSTAT's work and informing them on the available results of the 2021 Population Housing
 Census.
- Continuation of ELSTAT participation in the Cross-Border Internship Programme. ELSTAT, and more specifically its mentor representative, has the obligation to work closely with the intern, depending on the thematic area assigned to her/him, and to provide support, encouragement and information to the intern, depending

on her/his work and experience in relation to the host institution (organisation culture, informal codes and behaviours, etc.).

- Continuation of ELSTAT participation in the "Statistics Coded" initiative, organised by Eurostat for the EMOS students. ELSTAT participated, for the first time, in the said initiative, during the time period September November 2021, with 8 lectures and subject: "Data Analytics and Official Statistics". These lectures provide a learning opportunity of modern programming techniques, using the R programming language, as well as tools, such as the Github and the Slack.
- Continuation of providing opportunities for practical training to students, at ELSTAT's premises.
- Continuation of the promotion to teachers and pupils of the educational programme "Census@School", with
 the ultimate objective of integrating it into the educational programme of primary and secondary education.
- Organisation of thematic one-day conferences addressed to teachers from all educational levels, in order to be informed on ELSTAT's work and to contribute to it with proposals, remarks, but also with the dissemination of the information they will receive from ELSTAT.
- Continuation of ELSTAT's participation in the "Summer Vocational Guidance" programme, addressed to
 upper secondary education school pupils, with the aim that the experience gained by the pupils to be a
 useful resource for their academic and professional career (the action is activated upon a relevant request
 submitted by school units).
- Inclusion of the viewing of ELSTAT's historical archive of maps in the educational visits of schools and universities. The cartographic material, available to ELSTAT from the Population Housing Censuses, will be exhibited in the area under construction located on the ground floor of the Central Service of ELSTAT.

It is pointed out that the actions concerning school units of primary and secondary education are carried out after approval by the competent Ministry of Education and Religious Affairs.

7. Enrichment of ELSTAT's Digital Library

ELSTAT will continue the enrichment and promotion of its Digital Library, with the aim of utilising and preserving the printed material, but also all its electronic, now, publications, in order to make the historical records available in its library freely available to the public.

E. BUDGET FOR THE IMPLEMENTATION OF ELSP 2023 - 2025

The implementation of the three-year statistical programme of the ELSS presupposes the provision of the necessary financial resources from the State Budget, as well as the reinforcement of ELSTAT with the necessary and appropriate human resources.

ELSTAT has budgeted the necessary expenditures for the implementation of its statistical works included in the ELSP 2023 – 2025. The estimated expenses and revenues figure in the following tables:

F. OBJECTIVES AND INITIATIVES OF THE ELSS AGENCIES IN THE AREA OF PRODUCTION AND DISSEMINATION OF STATISTICS

The development and improvement of the produced official statistics of the Country is based on the actions of all the agencies that constitute the ELSS. In this context, the other ELSS agencies, apart from ELSTAT, have outline a set of objectives for the period 2023 - 2025. These objectives mainly cover issues related to the use of technology to upgrade the data collection and to the improvement of the production and dissemination of their statistics. The set objectives, per ELSS agency, are listed below:

Ministry of Development and Investments

- Updating and enriching the electronic platform anaptyxi.gov.gr, so that it includes the National Strategic Reference Framework (NSRF) data for the new Programming Period 2021 – 2027.
- Upgrading the data visualisation screens for the contracts of the Central Electronic Public Procurement Registry (KIMDIS) and the electronic tenders of the National System of Electronic Public Procurement (ESIDIS) (Supplies – Services).
- Further use of technology and digitisation of the notification procedures of the establishment and/or operation of economic activities in physical space, through the information system notifybusiness.gov.gr.
- Upgrading the provided functions of the Integrated Information System of Public Investment Programme OPS-PDE (e-pde), through which all the procedures of the Public Investment Programme (PIP) have been computerised and carried out (budget, compilation, funding, allocation and payment). The following are mentioned indicatively: complete computerisation of the PDE project payment process, issuance of offsetting money orders, integration in the e-pde of the Register of General Government Entities, when drawing up payment orders, introduction of the classification of the functions of government (COFOG) and improvement

of the remaining classifications (economic, administrative and geographical), upgrading of the interfaces with third party systems (Bank of Greece, Integrated Information System OPS-NSRF, General Accounting Office, IAPR, e-EFKA/IDIKA, Interoperability Center).

Ministry of Foreign Affairs

- Utilisation of administrative data, in cooperation with involved agencies that provide data on state development ment assistance and humanitarian aid, in the framework of improving the production process of relevant statistics.
- Elaboration of a feasibility study for the implementation of an integrated information system, with the aim
 of gathering and processing the data on the overall provided development assistance and humanitarian aid
 of Greece, for the production of the relevant statistics.

Ministry of Health

- Continuation of the effort to upgrade the data collection, taking advantage of the possibilities offered by modern technologies. Weight will be given to data collection through interoperability mechanisms from the Hospital Information Systems. The automated data collection will contribute significantly both to improving quality and validity of the statistics produced by the Ministry of Health, and in saving time and human resources.
- Further utilisation of health data, with improved accessibility and capability of their reuse, by always respecting the principles of personal data protection.
- Utilisation of modern data analysis and visualisation tools that do not presuppose specialised programming knowledge and their use is user-friendly, with the main goal of users familiarisation with the data and better understanding of statistical results.

Ministry of Citizen Protection

- Improving and upgrading the Integrated Information System of the Prisoners Holding Premises, with the aim of extracting more data from the above system.
- Inclusion of additional statistics in the statistical yearbook.

Ministry of Culture and Sports:

a) Greek Film Centre (GFC)

- Recording of as much of the tickets distributed by the film distribution companies as possible and participation of all these companies in its exchange programme of the number of weekly tickets.
- Extracting statistics from the catalogs issued by the GFC, three to four times a year. The statistics refer to
 the number and type of motion pictures included in the financial programmes of the Organisation, as well
 as to the course of these motion pictures in the international film festivals.

b) Hellenic Copyright Organisation (HCO)

Gathering information regarding piracy and court rulings on copyright infringement issues.

c) General Secretariat of Sports (GSS)

- Creation of a digital Coaches Register, in which all coaches who are legally employed in Sports Clubs and Sports Federations will be registered.
- Formation of a National Sports Volunteering Network, in which those volunteers who wish to participate in sporting events, but also those agencies which organise sporting events and wish to use volunteers will be registered.
- Presentation of statistics of the Sports Federations evaluation system "CHILON", regarding the individual performances and presence of Sports Federations.
- Presentation of figures from the Register of Sports Associations, regarding the number of legal and active sports associations, by Sports Federation and Region.
- Presentation of statistics of the Digital Platform for Recording Sports Facilities "PELOPAS", regarding the sports facilities, registered by the Municipalities, in collaboration with the Central Union of Municipalities of

Greece.

- Presentation of statistics of the National Sports Integrity Platform, regarding the number and the handling
 of reports on suspected matches for manipulation.
- Presentation posting of statistics on the Help Desk operation on the GSS website, regarding the overall
 performance of the system and the number of cases that have been processed.

Ministry of Justice

- The issuance of the relevant Presidential Decree that will regulate issues related to the establishment, organisation and operation of the Office of Collection and Processing of Judicial Statistical Data (Juststat) is expected.
- Cooperation with the judicial and prosecutorial authorities of the Country, to fill in questionnaires sent by
 national and European/international agencies (National Transparency Authority, OECD, Office of the National Rapporteur on Trafficking in Human Beings, Eurostat, CEPEJ, UNODC and university schools of the
 Country) and concern the provision of standardised primary data of statistical surveys, in the framework of
 evaluations of the Country.
- Standardisation of the process of providing statistical data to private researchers.
- Adoption by the judicial and prosecutorial authorities of the Country of the list of offenses provided for in the Criminal Code and the special criminal laws, according to their matching with the lists of the ICCS (International Classification of Crime for Statistical Purposes).

Ministry of Interior

- Improving the statistics that are produced and disseminated by the services of the Ministry of Interior, as well as monitoring and integration of their production processes in the programme of regular internal audits of the Ministry.
- Better utilisation of the Integrated Information System, as regards the correctness and completeness of data entry, through the provision of relevant instructions to the Regional Citizenship Services of the Country.
- Monitoring the operation of the Interoperability Hub, with the aim of optimising and further automating the
 process of collecting, processing and publishing financial data of the Local Self-Government Organisations.
- Integration of utilisation functionalities of data of economic interest for the Local Self-Government Organisations, which are kept in statutory databases of the State, such as the Central Electronic Public Procurement Registry (KIMDIS) and implementation of the Public Investment Programme (e-pde), in the framework of upgrading the Interoperability Hub.
- Care for the completion of the procedures related to the certification by ELSTAT of statistics produced by the Ministry of the Interior as "official", in line with the provisions of Law 3832/2010, as amended and in force.

Ministry of Migration and Asylum

- Full integration of security policies, completion of adoption procedures, on the basis of the existing legislative framework, and use of the modern infrastructures of the Ministry, to strengthen the data security, ensure statistical confidentiality and protect personal data.
- Completion of the development of the new information systems (IS) of the Ministry, aiming at the optimal electronic management, and full interconnection of data and information concerning:
 - · the flows and arrivals of third country citizens,
 - those residing in the new Closed Controlled Access Centers (CCAC) of Islands, in the Reception and Identification Centers (RIC) and in all Inland Structures,
 - · the beneficiaries of housing programmes and of other prescribed benefits,
 - all the procedures of 1st and 2nd degree of applicants for international protection,
 - · the social integration procedures of beneficiaries of international protection.

- Integration of the existing IS of the Ministry (Integrated Information System of Legal Migration, CHELIDON, etc.), as well as of their interoperability, where this is provided for legislatively and operationally, respecting the principle Once-Only, in the new developing IS and hosting them in the modern and secure infrastructures of the Ministry.
- Development of new and improvement of existing interoperabilities with third parties (Hellenic Police, IAPR, IDIKA, etc.), with which the Ministry services collaborate operationally, aiming at:
 - the optimal and rapid electronic service of the beneficiaries of these services and of the benefits/rights provided for in the existing legal framework,
 - the full harmonisation of the registers of the IS of the Ministry and of the third parties collaborating with it.
- Development of applications and of business intelligence systems on the IS of the Ministry, through which the following will be carried out:
 - · extraction of "real time" operational data and information,
 - · correlation and standardisation of this information,
 - · display of indicators and thematic reports, in an interactive and comprehensible way.

The ultimate goal is the support of the work of executives who make decisions, with BI tools, the support of public policies and the optimal coverage of regular and non-regular obligations and commitments of the Ministry to the domestic agencies (ELSTAT, cooperating Ministries, etc.) and the international organisations (EU, Eurostat, EUAA, UNHCR, IOM, etc.).

- Strengthening and expanding collaborations with international agencies that cooperate and support the actions of the Ministry, through the structured exchange of information of operational nature and with a view to ensuring the confidentiality of the information exchanged.
- Continuous upgrading of the website, for the best possible satisfaction of information needs of all agencies (domestic and international), as well as of private individuals, regarding the operational actions of the Ministry, the produced results and the prevailing trends.

Ministry of Infrastructure and Transport

- Development and Operation of a National Access Point (NAP). Central data access point, in accordance with Delegated Regulations of the Directive 2010/40/EU (ITS) and provision of value added services. Individuals, businesses and Public Authorities will have the possibility to have and to use datasets of intelligent transport systems, for personal or commercial purposes.
- Development and Operation of an Electronic Register of Infrastructures and e-Mobility Market Bodies (MYFAH). The operators of the e-mobility market will have the possibility to be registered in the Electronic Register and obtain a unique identification code. The charging points will appear in digital open maps, in real time, as soon as the Operators of Recharging Infrastructures of Electric Vehicles send the data.
- Development of an Electronic System for the Determination of the Cost of Production Factors of Technical Projects (ISPCSPTE). Electronic web platform supporting the Unified System of Technical Specifications and Pricing of Technical Projects and Studies "ESTEP-TIM-TEM" (Article 84 of Law 4782/2021). It will include the following web applications, compatible with the Building Information Modeling (BIM) technology: Price Observatory, Price Analysis and Cost Determination System and Uniform Technical Specifications System.
- Development of an Integrated Electronic Data Collection System (Open Data Kit ODK) for the compensation of those affected by natural disasters. The ODK is a data collection platform for filling in, via tablets, the autopsy reports used by the engineers for the compensation of those affected, in cases of natural disasters. The purpose, inter alia, is to strengthen the security of official data and of personal data.
- Provision of data on Public Works Contracts. The Ministry supports the publication of data tender procedures and contracts for all types of contracts under its jurisdiction (supplies, projects, services) at KIMDIS and ESIDIS of the Ministry of Development and Investments.
- Keeping the Registers of the Ministry, regarding the issuance of business licenses (MEK, MEEP, etc.), driving licenses and traffic licenses, Register of Fuel and Power Supply Stations, Digital Register of Passenger Cars, etc.

- Smart Bridges (RRF:16949). Equipment of the bridges with special load measurement systems and sensors or optical fibers that measure their displacement in real time. This information will be recorded and processed with special algorithms, with the aim of assessing the structural vulnerability of the bridges, thus improving the safety level of bridges and preventing accidents, due either to the passage of heavy vehicles or to risks because of the climate change.

Ministry of Maritime Affairs and Insular Policy

 Collection of the statistics produced by the Ministry, as well as of the statistics of its supervised entities, through a specific channel of the official webpages of the Ministry, so that their searching by the stakeholders is easy.

Ministry of Rural Development and Food

The Ministry seeks to improve its statistical products, given that these products are used for agricultural policy making and disseminated to research institutes for the elaboration of studies for the agricultural sector. Although there is a serious personnel shortage in the Ministry, actions are planned in the following axes:

- Further utilisation of administrative and other data sources, in combination with the use of new technologies, for the production and dissemination of the Ministry statistics, and the timely response in the relevant EU Regulations.
- Increasing the degree of coherence and comparability of the Ministry statistics with relevant statistics produced by ELSTAT's surveys (Annual Agricultural Statistical Survey, etc.).
- Continuation of the cooperation with ELSTAT, regarding the certification process of the Ministry statistics.
- Development of a digital application for the compilation of the statistics of the Directorate General of Rural Development, in collaboration with the Directorate of e-Governance, adapted to the new EU Regulatory Framework for agricultural statistics (SAIO).

Ministry of Tourism

The Ministry is planning the conduct carry of 2 new surveys in 2 thematic forms:

- Mountain tourism. The main objective is to record and analyse key issues regarding the current situation of mountain tourism in our Country, the conceptual demarcation of the mountain tourism, through the description of the range of tourist services which may include and the design of a mountain tourism development model, according to the parameters of sustainability (economic, environmental, social) and the characteristics of the place.
- Yachting. Through extensive consultations with the competent agencies and the overview of available secondary data, it was found that the systematic recording of the specific thematic form of tourism is lacking, with the consequence of the difficulty of drawing up an informed policy. The aim is to establish a constant flow of data for yachting, which is a thematic form demonstrating great resilience in the midst of crisis.

Bank of Greece (BoG)

 Making Statistics on Payments available to the general public in a machine-readable format, through the certified Open Data Portal (https://opendata.bankofgreece.gr/el/home) of the BoG.

National Documentation Centre (EKT)

- Commitment to ensuring and continuously improving the quality of statistics. Continuation of production of
 statistics in the fields of research, development and innovation, which cover the obligations of the Country,
 as regards the observance of the European Regulations, and ensure the compliance with the quality rules
 and methodological requirements of the ELSS and the ESS.
- Strengthening the role of EKT in documenting and valuating national public policies, such as the smart specialisation strategy 2021 – 2027, the specialised human resource, the digital transformation, the National Simplification of Procedures Programme.
- Emphasis on improving accessibility and understanding of statistics, on improving and expanding the use
 of administrative data sources and on improving the satisfaction of users' needs, taking advantage of the
 possibilities offered by modern technologies.

In 2023, a large part of the infrastructures and services which are developed in projects implemented by EKT, based on its statistical activities and the digital governance of its statistics, will be completed and put

into operation. These projects are characterised by high innovation character and results with a significant impact, both for the statistical operation of EKT and for the users of its statistics –those practicing public policies, the scientific, research and business community of the Country. More specifically, the actions of the projects aim to:

- the provision of integrated digital services of data, to serve the public administration and the user communities of EKT, as well as to support the documentation and valuation of public interventions and policy on the basis of concrete evidence,
- the creation of "data registers" concerning enterprises, public organisations, research activity, specialised human resources and outputs/results, from the individual statistical (micro)databases available to EKT and from external public data sources,
- the integration and interconnection of (micro)data (microdata linking) from different statistics and databases, with the aim of utilising the "hidden" value contained in the data and the production of new statistics that highlight new patterns, trends and behaviours,
- the integrated governance of administrative data collected from public sources for the statistical purposes
 of EKT, with the aim of improving their collection procedures and their further combined utilisation, so
 that, ultimately, the load of respondents for filling in questionnaires is reduced.
- Production of new and experimental statistics, in the direction of immediate response to users' needs and alignment with the statistical priorities, digital requirements and major technological, economic and social issues, the measurement of which concerns the international statistical community. Specifically:
 - Enrichment of EKT statistics with new variables and production of statistics covering emerging needs, for the documentation and planning of public policies at national and European level.
 - Enhancing the national statistics of EKT that are part of the digital agenda, such as the digital transformation of enterprises, the digitisation of science, the Greek scientific production and research in cutting-edge technology sectors, such as artificial intelligence, etc.
 - Highlighting the gender dimension in the European and national statistics of EKT: integration of the gender dimension at the level of microdata analysis, particularly with regard to the specialised human resources, release of discrete statistical publications, conduct of targeted surveys on current issues.
 - Production of new statistics related to measuring the degree of bureaucracy and the simplification of administrative procedures, to support the Bureaucracy Observatory and the documentation of the National Simplification of Procedures Programme.
 - Commitment to enhancing human resources, numerically and in skills, and the technological and organisational infrastructures of EKT, so as to ensure its operation as a reliable National Authority of the ELSS and member of the ESS.

Hellenic Telecommunications and Post Commission (EETT)

Design and implementation of an Integrated Market Monitoring System, which will support all submissions
of market tracking data from providers, in the framework of structured questionnaires.

More precisely, the Provider will be able to submit the market data, via an appropriate Web Interface, it will be possible to check the validity and consistency of the submitted data, through the use of appropriate tools of logical, numerical and statistical check, and finally a history of editions will be kept, through the assignment of a unique number in each submission of the Provider, which will be automatically notified to the Provider. Through the Integrated Market Monitoring System, EETT users will have the ability to create predefined and to design dynamic reports, to produce graphs, statistical data, indicators and analyses. Through a friendly and easy-to-use interface environment, the user will have access to pre-designed and dynamically configurable, in accordance with its preferences, data structures and reports, such as tables, pivot tables, pivot table cubes with correlation, sorting and criteria inclusion capabilities. In addition, the available data, thus giving them the ability of accessing the information, using a web browser, without the prerequisite of installing additional software.

During the current period, an open international public electronic tender is being held and the contractor selection process is expected to be completed within 2022.
