



EVOLUTION OF TURNOVER OF ENTERPRISES IN ACCOMMODATION AND FOOD SERVICE ACTIVITIES

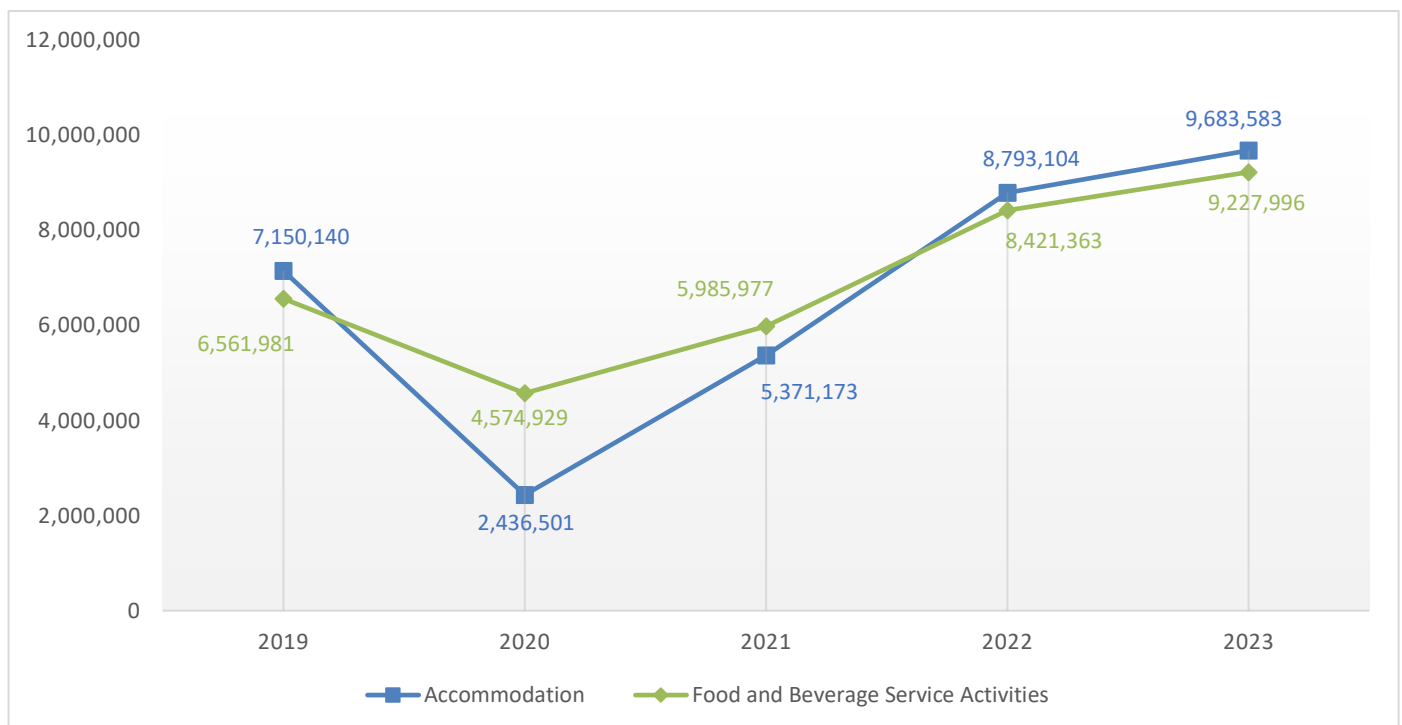
DECEMBER AND 4th QUARTER 2023
ANNUAL DATA 2023

The Hellenic Statistical Authority (ELSTAT) announces data on the evolution of turnover of enterprises in the Accommodation and Food and Beverage Service Activities divisions, per Regional Unit, incorporating the most recent data on turnover from Administrative Sources for **December and 4th quarter 2023**.

For the enterprises in **Accommodation Activities** (division 55 of NACE Rev.2 classification), the turnover in 2023 amounted to 9,683,582,528 euro, recording an increase of 10.1% in comparison with 2022, when the respective turnover was 8,793,103,758 euro.

Respectively, for the enterprises in **Food and Beverage Service Activities** (division 56 of NACE Rev.2 classification), the turnover in 2023 amounted to 9,227,995,765 euro, recording an increase of 9.6% in comparison with 2022, when the respective turnover was 8,421,363,364 euro (Graph 1, Table 1).

For the enterprises in **Accommodation Activities** (division 55 of NACE Rev. 2 classification), of the Regional Units with a contribution to the total turnover of the year 2023 greater than 1.0%, the biggest increase in turnover in 2023 compared with 2022 was recorded in the Regional Units Zakynthos (21.7%) and Chalkidiki (19.4%), while a decrease was recorded in the Regional Units Mykonos (10.9%) and Thira (3.0%) (Table 1).

For the enterprises in **Food and Beverage Service Activities** (division 56 of NACE Rev. 2 classification), of the Regional Units with a contribution to the total turnover of the year 2023 greater than 1.0%, the biggest increase in turnover in 2023 compared with 2022 was recorded in the Regional Units Korinthia (21.3%) and Zakynthos (21.0%), while a decrease (2.9%) was recorded in the Regional Unit Mykonos (Table 1).

In total, for the enterprises in **Accommodation and Food and Beverage Service Activities** (divisions 55 and 56 of NACE Rev. 2 classification), the turnover in 2023 amounted to 18,911,578,292 euro, recording an increase of 9.9% in comparison with 2022, when the respective turnover was 17,214,467,122 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2023 greater than 1.0%, the biggest increase in turnover in 2023 compared with 2022 was recorded in the Regional Units Zakynthos (21.5%) and Chalkidiki (16.4%), while a decrease was recorded in the Region Units Mykonos (8.1%) and Thira (2.1%) (Table 4).

For the total of enterprises in **Accommodation Activities** (division 55 of NACE Rev. 2 classification), the turnover in the fourth quarter 2023 amounted to 1,315,040,025 euro, recording an increase of 14.2% in comparison with the fourth quarter 2022, when the respective turnover was 1.151,321,445 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2023 greater than 1.0% (Table 1), the biggest increase in the turnover of the fourth quarter 2023 compared to the fourth quarter of 2022 was recorded in the Regional Unit Kos (28.6%) and the smallest increase (3.8%) was recorded in the Regional Unit Kefallinia, while a decrease was recorded in the Regional Units Thira (2.7%) and Mykonos (1.7%) (Table 2).

For the total of enterprises in **Food and Beverage Service Activities** (division 56 of NACE Rev. 2 classification), the turnover in the fourth quarter 2023 amounted to 1,979,722,478 euro, recording an increase of 6.3% in comparison with the fourth quarter 2022, when the respective turnover was 1,861,816,389 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2023 greater than 1.0% (Table 1), the biggest increase in the turnover of the fourth quarter 2023 compared to the fourth quarter of 2022 was recorded in the Regional Unit Kerkyra (12.5%) and the smallest increase (2.2%) was recorded in the Regional Unit Rethymno, while the biggest decrease was recorded in the Regional Unit Magnissia (6.0%) (Table 3).

For the enterprises in **Accommodation Activities** (division 55 of NACE Rev.2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in December 2023 amounted to 206,688,127 euro, recording an increase of 14.7% in comparison with December 2022, when the respective turnover was 180,165,140 euro (Table 5).

For the enterprises in **Food and Beverage Service Activities** (division 56 of NACE Rev.2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in December 2023 amounted to 211,034,600 euro, recording an increase of 7.1% in comparison with December 2022, when the respective turnover was 197,091,272 euro (Table 5).

In total, for the enterprises in **Accommodation and Food and Beverage Service Activities** (divisions 55 and 56 of NACE Rev. 2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in December 2023 amounted to 417,722,727 euro, recording an increase of 10.7% in comparison with December 2022, when the respective turnover was 377,256,412 euro. For the Regional Units with a contribution to the total turnover of the year 2023 greater than 1.0% (Table 4), the biggest increase in the turnover of December 2023 compared with December 2022 was recorded in the Regional Unit Mykonos (58.3%) and the smallest increase (3.0%) was recorded in the Regional Unit Attiki, while the biggest decrease (26.4%) was recorded in the Regional Unit Chalkidiki (Table 6).

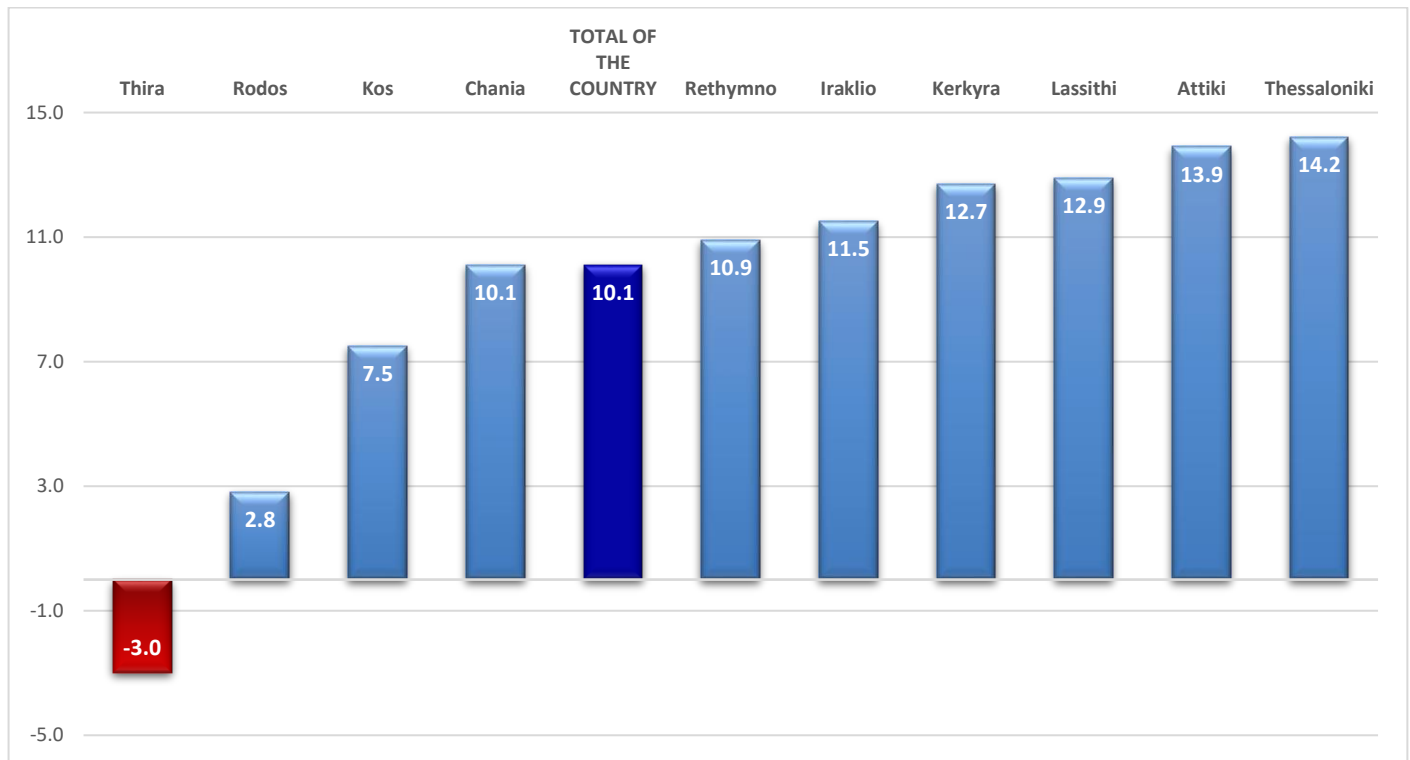

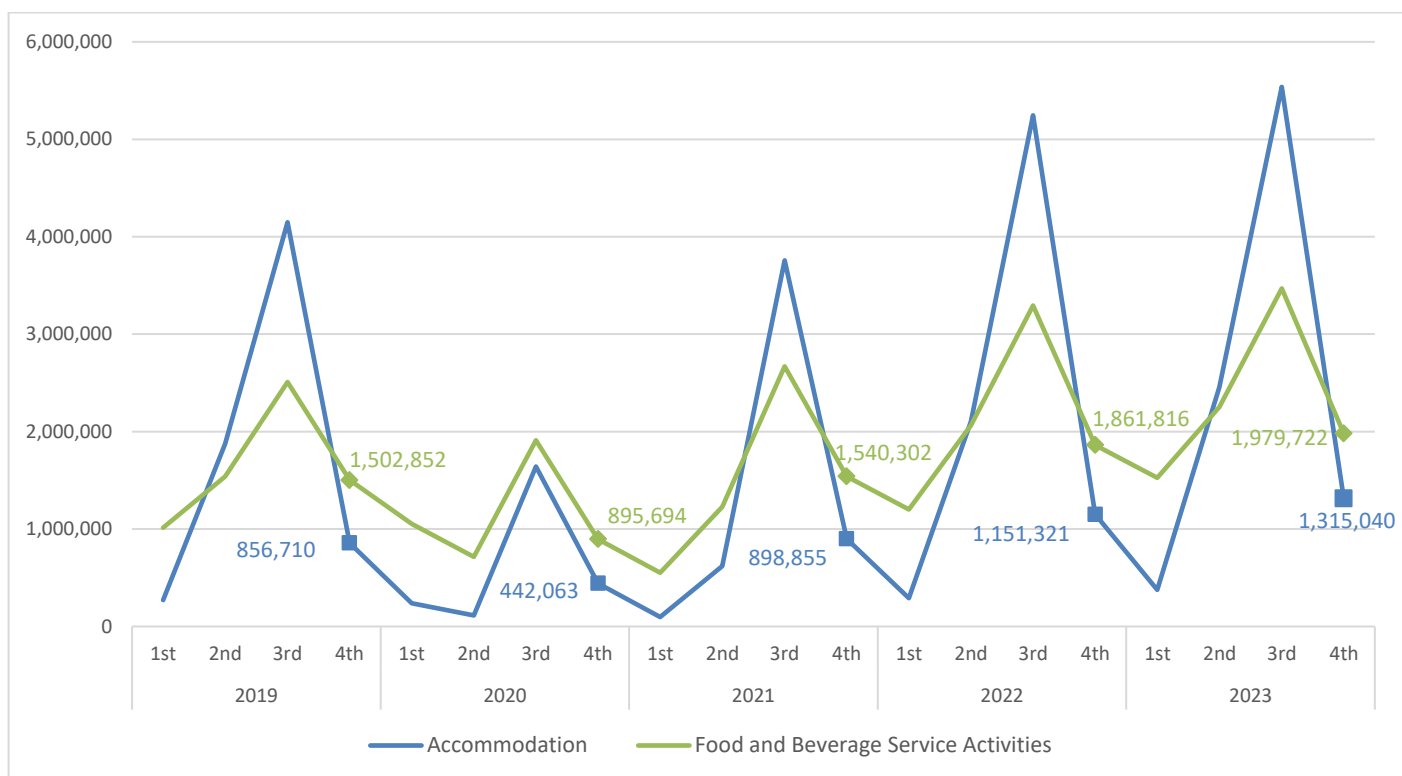

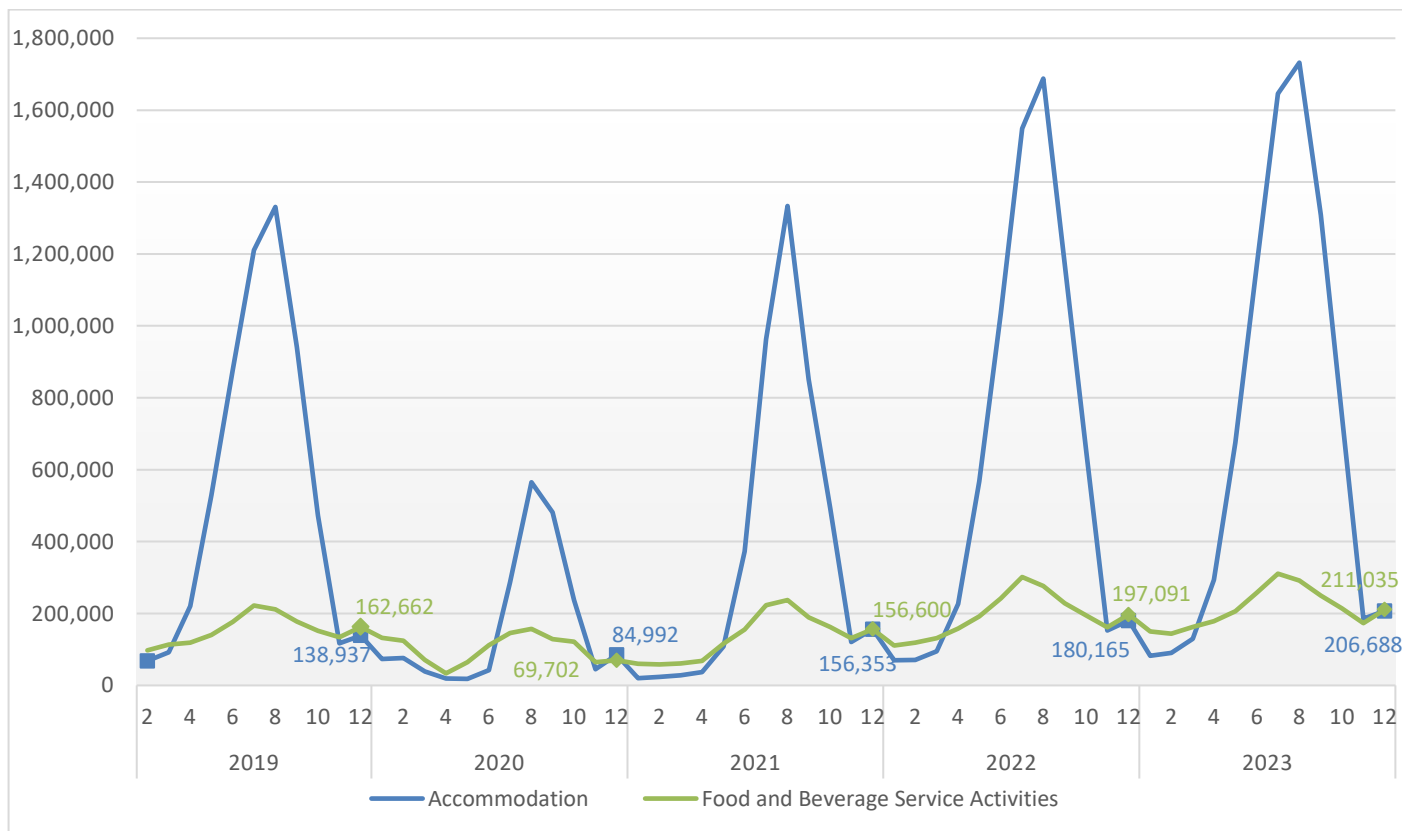

Generally The statistical data presented in this announcement have been compiled on the basis of the linking and processing of primary data from the following sources:

- The final Statistical Business Register of ELSTAT of the reference year 2020.
- Administrative registers of enterprises, of the reference years 2021 and 2022.
- Administrative transactions files (tax etc) of the reference years 2019, 2020, 2021, 2022 and 2023.

In particular the following primary data have been used per source:

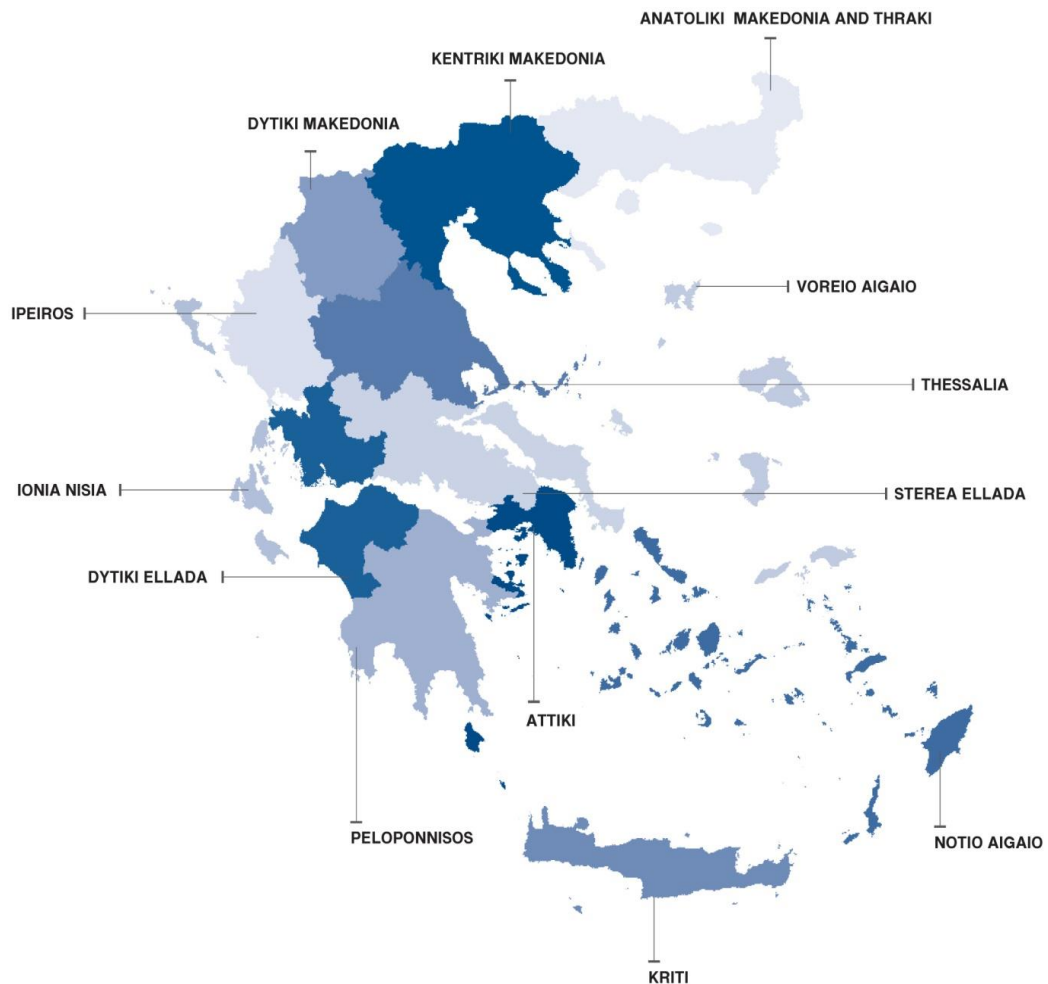
- Active enterprises and the economic activity class from the final Statistical Business Register of the reference year 2020.
- The economic activity class for the enterprises that started their activity after the reference year 2020 and have a significant turnover, from administrative registers of enterprises of the reference years 2021 and 2022.
- Income data from administrative transaction files of the years 2019, 2020, 2021, 2022 and 2023.

It is noted that the geographical classification of enterprises is based on the location of the enterprise's headquarters.

Statistical classifications

For the economic activities the European statistical classification of economic activities NACE Rev.2 is used.
