



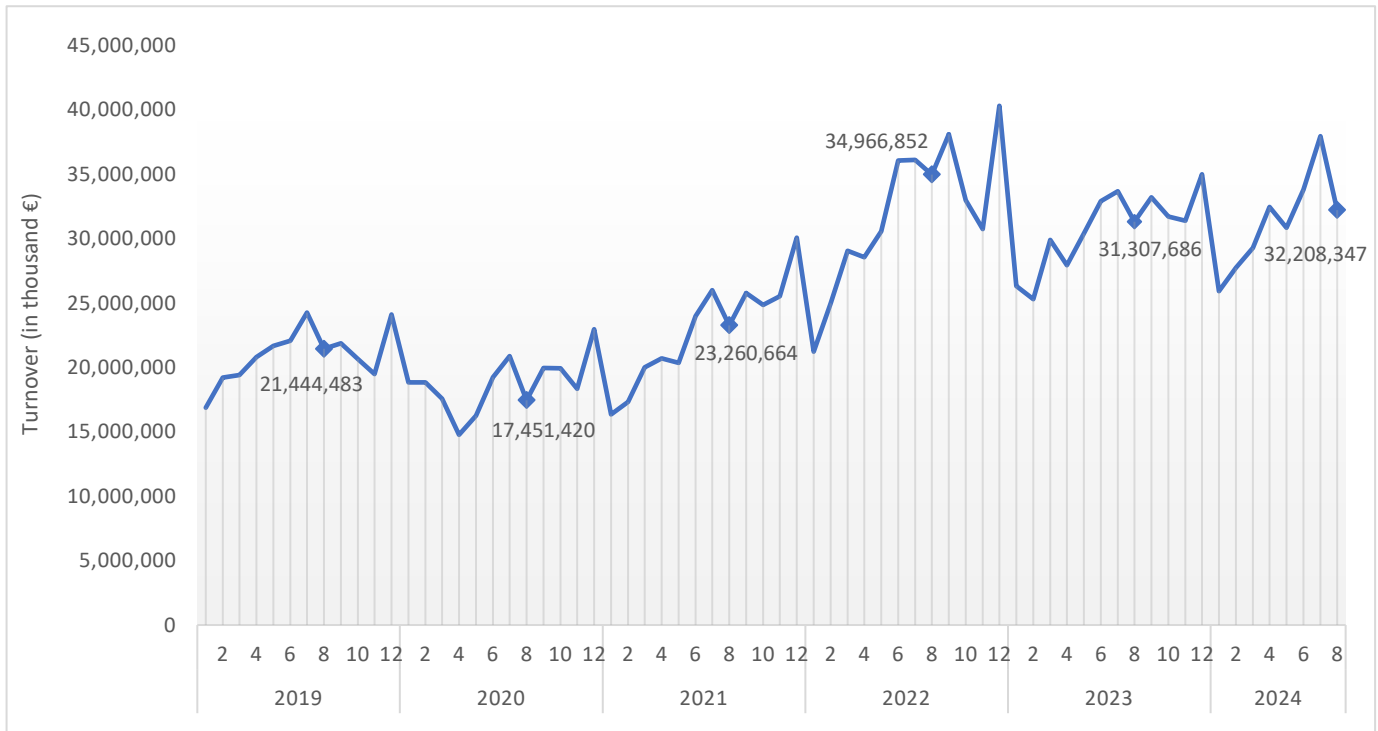
EVOLUTION OF TURNOVER OF ENTERPRISES AUGUST 2024

The Hellenic Statistical Authority (ELSTAT) announces data on the evolution of turnover of enterprises in all sectors of the economy, incorporating the most recent data on turnover from Administrative Sources for **August 2024**.

For the enterprises of the economy as a whole, obliged to double-entry accounting bookkeeping, for which data are available on a monthly basis, the turnover in August 2024 amounted to 32,208,347 thousand euro, recording an increase of 2.9% in comparison with August 2023, when the respective turnover was 31,307,686 thousand euro (Graph 1, Table 1).

The biggest increase in turnover in August 2024 compared with August 2023 was recorded from the enterprises of the section Mining and Quarrying, per 27.7% and the smallest increase was recorded from the enterprises of the section Arts, Entertainment and Recreation, per 1,1%, while the biggest decrease was recorded from the enterprises of the section Agriculture, Forestry and Fishing, per 4.4% (Table 1).

METHODOLOGICAL NOTES

Generally The current announcement provides statistical data on turnover for all enterprises and sections of the economy.

These statistical data have been compiled on the basis of the linking and processing of primary data from the following sources:

- The final Statistical Business Register of ELSTAT, of the reference year 2021.
- Administrative registers of enterprises, of the reference years 2022 and 2023.
- Administrative transactions files (tax, etc) of the reference years 2019 to 2024.

In particular, the following primary data have been used per source:

- Active enterprises and the economic activity class from the final Statistical Business Register of the reference year 2021.
- The economic activity class for the enterprises that started their activity after the reference year 2021 and have a significant turnover, from administrative registers of enterprises of the reference years 2022 and 2023.
- Income data from administrative transactions files of the reference years 2019 to 2024.

Statistical classifications For the economic activities, the European statistical classification of economic activities [NACE Rev. 2](#) is used.

Reference Period August 2024.

Statistical unit The statistical unit is the legal unit (distinct TIN).

Comparability The announced statistical data are comparable with the data of the final Statistical Business Register of ELSTAT, of the reference year 2021 (relevant link from the webpage of ELSTAT, where tables and information on the methodology applied are provided [Statistical Business Register](#)).
