## **PRESS RELEASE**

### **ANNUAL NATIONAL ACCOUNTS**

Year 2021 : 8.4% (2<sup>nd</sup> estimate in volume terms) & revision of years 2019-2020

The Hellenic Statistical Authority (ELSTAT) announces the 2<sup>nd</sup> estimate of the Annual National Accounts for the year 2021 (provisional data) and the revised data for the years 2019-2020 according to the European System of National and Regional Accounts ESA 2010 (Regulation (EU) No 549/2013 of the European Parliament and of the Council on the European System of National and Regional Accounts in the European Union - ESA 2010).

According to the revised data the Gross Domestic Product (GDP) of the year 2021 in volume terms increased by 8.4% in comparison with the year 2020, against an increase of 8.3% that was announced for the first estimate in March 2022.

The revision of the Annual National Accounts data was based on the utilization of new and incorporation of updated information, from various sources, such as:

- Incorporation of the results of the Structural Business Surveys for the year 2019.
- Updated estimates for the final consumption expenditure of households based on the results of the Household Budget Survey (HBS) for the years 2019 and 2020 and incorporation of new estimates for the year 2021.
- Integration of the Statistical Business Register of ELSTAT for the year 2019.
- Incorporation of updated International Trade in Good Statistics (ITGS) data for the years 2019-2021.
- Integration of General Government updated data for years 2019 -2021.
- Integration of updated data for Non-Profit Institutions Serving Households (NPISHs) using administrative tax data, for years 2019-2021.
- Integration of updated data for Agriculture, Forestry and Fishing industries for years 2019-2021.
- Incorporation of updated Short-Term Indicators for years 2020-2021.
- Integration of updated employment data for years 2019-2021.

Specifically for the year 2021, it is noted that the second estimate was made using annual data from sources (such as estimates of household final consumption expenditure based on the results of the Household Budget Survey, annual Balance of Payments and International Trade in Goods data, annual General Government data and NPISHs etc.), by means of the Supply and Use tables. The first estimate in March 2022, which was announced with the Press Release of 4/3/2022, was produced as the sum of the quarterly results of year 2021 (non-seasonally adjusted).

It is noted that the data for the year 2021 reflect the impact on GDP of the gradual lifting of the restrictive measures that were put into place. All the best available data sources were used to compile the estimates.

The final consumption expenditure of the year 2021 in volume terms increased by 4.9% in comparison with the year 2020, against an increase of 6.8% that was announced for the first estimate in March 2022.

The imports of goods and services of the year 2021 in volume terms increased by 17.7% in comparison with the year 2020, against an increase of 16.1% that was announced for the first estimate in March 2022.

The exports of goods and services of the year 2021 in volume terms increased by 24.1% in comparison with the year 2020, against an increase of 21.9% that was announced for the first estimate in March 2022.

According to the revised data the Gross Domestic Product (GDP) of the year 2021 at current prices increased by 9.8% in comparison with the year 2020, against an increase of 10.6% that was announced for the first estimate in March 2022.

The final consumption expenditure of the year 2021 at current prices increased by 6.1% in comparison with the year 2020, against an increase of 7.6% that was announced for the first estimate in March 2022.

The imports of goods and services of the year 2021 at current prices increased by 34.5% in comparison with the year 2020, against an increase of 35.6% that was announced for the first estimate in March 2022.

The exports of goods and services of the year 2021 at current prices increased by 40.3% in comparison with the year 2020, against an increase of 40.5% that was announced for the first estimate in March 2022.

In addition, in the framework of the Gross National Income (GNI) verification cycle, the works continue for the further improvement of the sources and methods for estimating national accounts data. The GNI verification cycle is carried out by the European Statistical Office (Eurostat) in all member-states of the European Union in accordance with Regulation (EU) 2019/516 on the harmonisation of Gross National Income at market prices.
