SHORT-TERM INDICES OF EMPLOYMENT

(PERSONS EMPLOYED, HOURS WORKED AND GROSS WAGES AND SALARIES) IN MAIN SECTIONS OF THE ECONOMY¹: 3rd Quarter 2020

The Hellenic Statistical Authority (ELSTAT) announces data on Short-term Indices of Employment (Persons Employed, Hours Worked and Gross Wages and Salaries) without adjustment (seasonal or adjustment for the number of working days) in main sections of the economy for the 3rd quarter 2020.

The evolution of the Short-term Indices of Employment in the 3rd quarter 2020 in comparison to the corresponding indices of the 3rd quarter 2019 is as follows:



In the following table, the Short-term Indices of Persons Employed, Hours Worked and Gross Wages and Salaries without adjustment (seasonal or adjustment for the number of working days) are presented analytically in ten main sections of the NACE Rev.2 statistical classification of economic activities. Furthermore, data on the annual and quarterly rates of change of each index are presented, for the years 2019 – 2020 (3rd quarter).

In the Graphs 2 to 11 that follow, the evolution over time of the Indices of Persons Employed, Hours Worked and Gross Wages and Salaries broken down by NACE Rev. 2 section of the years 2018 – 2020 (3rd quarter) is shown.






























METHODOLOGICAL NOTES

Generally

The Short-term Indices of Persons Employed, Hours Worked and Gross Wages and Salaries are quarterly indices concerning the Sections of economic activities B to E (Mining and Quarrying, Manufacturing, Electricity Supply and Water Supply), F (Construction), H to J and M to N (Other Services) of the statistical classification of economic activities NACE Rev.2 of EU, having 2015 as the base year (2015=100.0).

Purpose of the index

The purpose of the indices is to present the evolution of Persons Employed, Hours Worked and Gross Wages and Salaries on a quarterly basis in sections of economic activities B to E (Mining and Quarrying, Manufacturing, Electricity Supply and Water Supply), F (Construction), H to J and M to N (Other Services) of the statistical classification NACE Rev.2.

Legal Framework

The Council Regulation (EC) No 1165/1998 concerning short-term statistics and Council Regulation (EC) No 1503/2006 as regards definitions of variables, list of variables and frequency of data compilation.

Geographical coverage

Greece, total.

Reference Period

Quarter.

Definitions

As **Number of Persons Employed** is defined the total number of persons employed in the enterprise, irrespectively of their status (owners, partners and their family members) and the nature of their work (managers, sales persons and auxiliary staff) and irrespectively of whether they work temporarily or seasonally, full-time or part-time employment, with or without remuneration.

As **Hours Worked** is defined the total number of hours actually worked in the enterprise during the reference quarter. It includes hours actually worked during regular working hours; hours worked overtime, whether paid or unpaid; hours worked during nights, Sundays or public holidays. It also includes the time which is spent at the place of work on tasks such as preparing the site and time corresponding to short periods of rest at the work place. This variable excludes hours paid but not actually worked such as for annual leave, holidays and sickness leave.

As **Wages and Salaries** is defined the total remuneration, in cash or in kind, payable to all persons counted on the payroll, in return for work done.

Statistical Classifications

The statistical classification of economic activities NACE Rev. 2 of EU is used.

Data collection, processing and imputation in the context of the COVID-19 pandemic The compilation of the indices was based on data collected by enterprises and the use of an estimation method for the calculation of the missing data on the basis of the rate of changes of the values collected by enterprises, at section of economic activity and stratum level (class). For the 3rd quarter 2020, the response rate of the enterprises was lower compared to the corresponding response rate of the 3rd quarter 2019 by approximately 9%.
