EVOLUTION OF TURNOVER OF ENTERPRISES IN

ACCOMMODATION AND FOOD SERVICE ACTIVITIES

APRIL 2022

The Hellenic Statistical Authority (ELSTAT) with this sectoral publication, presents the map with the evolution of the turnover of enterprises classified in the **Accommodation and Food and Beverage Service Activities** divisions. These economic activities have been over time in the focus of interest due to the significant weight they bear on the Greek economy as a whole, but also due to their extensive dispersion, with a significant presence in all regional units and a significant contribution to the respective local economies of Greece, often associated with the tourist product of the country.

The current publication is part of the Press Releases series published by ELSTAT (<u>PR link</u>), since April 2020, incorporating the most recent data on turnover from Administrative Sources for **April 2022**.

Similar publications have been planned and are released on a monthly basis, throughout the whole period during which the regular monitoring of the evolution of the turnover of enterprises providing Accommodation and Food and Beverage Service Activities remains relevant and warranted.

In particular, the Hellenic Statistical Authority (ELSTAT) announces data on a monthly basis and at the regional unit country-level of analysis, for the turnover of enterprises classified in the divisions Accommodation and Food and Beverage Service Activities (divisions 55 and 56 of the NACE Rev.2 classification) for the period 2019-2022.

The published data can highlight, at a detailed local level, the current evolution in the performance, in terms of turnover, of enterprises having activity in key classes of the tourism sector and thus provide quick and highly relevant information on the evolution of the tourist product of Greece.

Specifically,

For the enterprises in Accommodation Activities (division 55 of NACE Rev.2 classification), obliged to double-entry bookkeeping, for which data are available on a monthly basis, the turnover in April 2022 amounted to 221,978,672 euro, recording an increase of 518.7% in comparison with April 2021, when the respective turnover was 35,880,264 euro (Table 2).

For the enterprises in **Food and Beverage Service Activities (division 56 of NACE Rev.2 classification)**, obliged to double-entry **bookkeeping**, for which data are available on a monthly basis, the turnover in April 2022 amounted to 149,376,858 euro, recording an increase of 134.2% in comparison with April 2021, when the respective turnover was 63,794,118 euro (Table 2).

In total, for the enterprises **in Accommodation and Food and Beverage Service Activities (divisions 55 and 56 of NACE Rev. 2 classification)**, **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in April 2022 amounted to 371,355,530 euro, recording an increase of 272.6% in comparison with April 2021, when the respective turnover was 99,674,382 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2021 greater than 1.0% (Table 1), the biggest increase in the turnover of April 2022 compared with April 2021 was recorded in the Regional Unit Rodos (1,042.7%) and the smallest increase was recorded in the Regional Unit Evia (111.5%) (Table 3). **Table 1:** Annual turnover of enterprises in Accommodation Activities (division 55 of NACE Rev. 2 classification), of enterprises in Food and Beverage Service Activities (division 56 of NACE Rev. 2 classification), and in total, of enterprises in the Accommodation and Food and Beverage Service Activities (divisions 55 and 56 of NACE Rev. 2 classification), per Region and Regional Unit, 2021

Therefore, for the total of enterprises data are available only on a quarterly basis.

METHODOLOGICAL NOTES

Generally The statistical data presented in this Press Release have been compiled on the basis of the linking and processing of primary data from the following sources:

- The final Statistical Business Register of ELSTAT of the reference year 2019.
- Administrative transactions files (tax etc) of the reference years 2019, 2020, 2021 and 2022.

In particular the following primary data have been used per source:

- Active enterprises and the economic activity class from the final Statistical Business Register of the reference year 2019.
- Income data from administrative transaction files of the years 2019, 2020, 2021 and 2022.

It is noted that the geographical classification of enterprises is based on the location of the enterprise's headquarters.

Statistical For the economic activities the European statistical classification of economic activities NACE Rev.2 is used. **classifications**

Statistical unit The statistical unit is the legal unit (distinct Tax Identification Numbers (TIN)).
