


## Arrivals and Nights Spent in Hotels, Similar Establishments, Tourist Campsites and Short-Stay Accommodation Establishments November 2023



The Hellenic Statistical Authority (ELSTAT) announces the monthly provisional data of arrivals and nights spent in hotels, similar establishments, tourist campsites and short-stay accommodation establishments, for reference month November 2023.

According to the survey, during November 2023, arrivals in tourist accommodation establishments amounted to 936,081 and nights spent amounted to 2,173,551, recording an increase of 8.0% in arrivals and of 10.5% in nights spent when compared to the corresponding month of 2022 (Graph 1, Table 1).

In specific, in November 2023 compared with the corresponding month of 2022, an increase of 8.1% in arrivals and of 12.4% in nights spent was observed for non-residents and an increase of 7.9% in arrivals and of 8.7% in nights spent was observed for residents (Table 1). The highest contribution in both arrivals and nights spent for the total of tourist accommodation establishments was observed for residents with 56.5% and 51.1%, accordingly (Graphs 2 and 3). The average length of stay for all types of tourist accommodation establishments amounted to 2.3 days (Table 2).






## Graph 3. Distribution of arrivals and nights spent of residents and non-residents by type of tourist accommodation establishment, November 2023 (provisional data)

## **EXPLANATORY NOTES**

Arrivals and nights spent at hotels, similar establishments, tourist campsites and short stay accommodation establishments Legal frame	The survey on arrivals and nights spent at hotels, similar establishments, tourist campsites and short-stay accommodation establishments is carried out monthly to all tourist accommodation establishments, pursuant to Regulation (EU) 692/2011 of the European Parliament and of the Council. The main objective of the survey is to collect and compile statistical data on the arrivals and nights spent of residents and non-residents in tourist accommodation establishments, by country of permanent residence. Data are also collected on the occupancy and capacity of tourist accommodations establishments. Regulation (EE) <u>692/2011</u> of the European Parliament and of the Council.			
Reference unit	The reference units are the tourist accommodations establishments of ELSTAT's Statistical Register of Touris Accommodations Establishments.

Definitions	<ul> <li><u>Resident</u>: Every person, regardless of citizenship, that has resided in Greece for at least a year, or has arrived in Greece with the intention to reside in the country for at least 1 year.</li> <li><u>Non-resident</u>: Every person, regardless of citizenship, that is not considered to be resident.</li> <li><u>Arrivals</u>: The arrivals at the establishments are calculated for every person separately. The data refer to the total number of persons and not to the total number of rooms that were occupied. Only the persons that had at least one overnight stay at the establishment are counted.</li> <li><u>Nights spent</u>: The nights spent are calculated for every person separately. The data refer to the total number of nights spent by every person and not to the total number of nights spent in every room.</li> </ul>			
Methodology	The survey is a census survey and statistical data are collected from all hotel-type accommodations, tourist campsites and short-stay accommodation establishments of the country. The survey is based on ELSTAT's Statistical Register of Tourist Accommodations Establishments, which is updated for the hotel-type and camping establishments from the Register of the Hellenic Chamber of Hotels, while for short-stay accommodation establishments, from data of the Ministry of Tourism. Additional data are obtained from the ELSTAT's Statistical Business Register. Statistical data is collected for each month of operation of the establishments, mainly through ELSTAT's web application "Xenios Zeus" and secondarily through a paper questionnaire for those establishments that cannot submit data electronically. The compilation of the provisional monthly data is based on the collection and processing of the questionnaires completed by each establishment, that is in operation during the reference month. Non-response to the survey is addressed with automatic reminders to the establishment for the obligation to submit the statistical data. Statistical methods of estimation are applied, for the establishment sthat despite the reminders, have not responded to the survey. During the processing of the statistical data, additional data from administrative sources is used, such as tax data from the Independent Public Revenue Authority (AADE), to identify the establishments that are in operation. Final data of the survey are announced six months after the end of the reference year, pursuant to the Regulation (EU) 692/2011 of the European Parliament and of the Council.
