



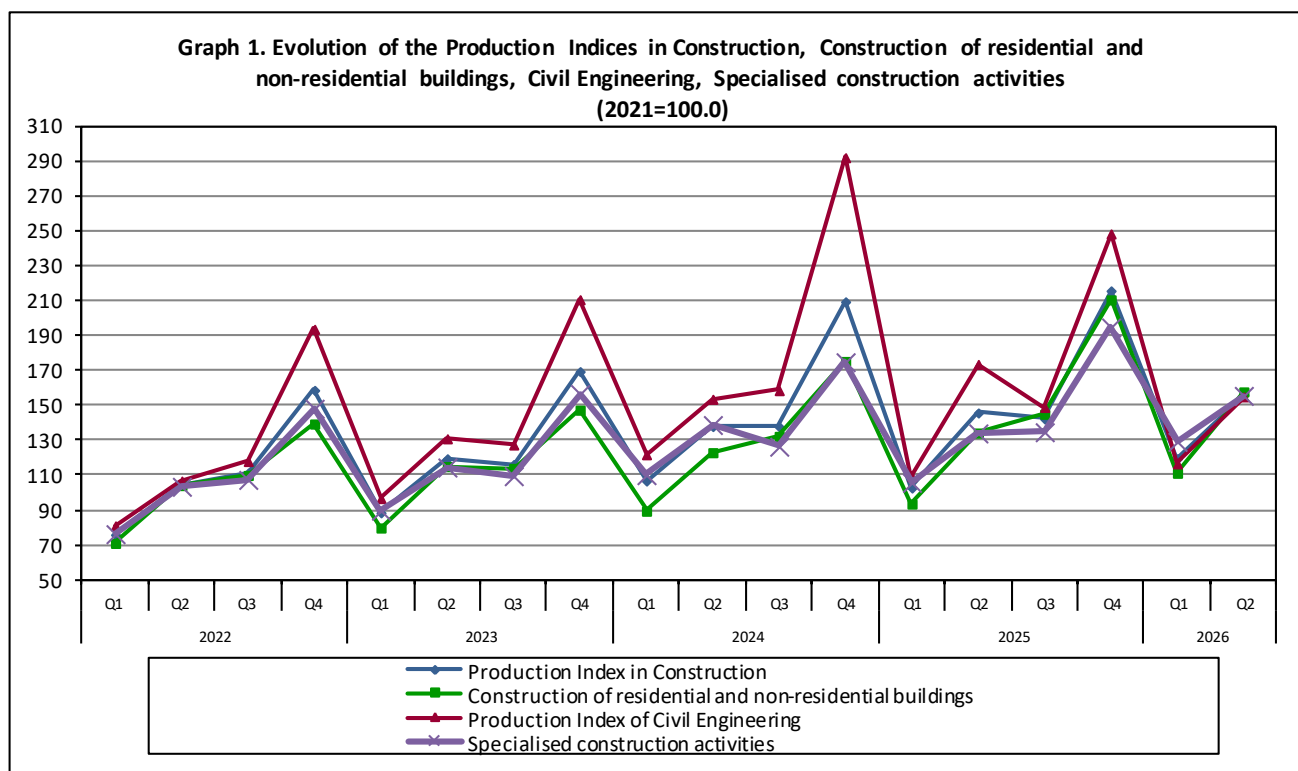
## PRODUCTION INDEX IN CONSTRUCTION: 2<sup>nd</sup> quarter 2026, y-o-y increase of 7.1%

The evolution of the Production Index in Construction (IPC) with base year 2021=100.0 and reference period the 2<sup>nd</sup> quarter 2026, on the basis of provisional and working day adjusted data is as follows:

The Production Index in Construction (IPC) in the 2<sup>nd</sup> quarter 2026 recorded an increase of 7.1% compared with the 2<sup>nd</sup> quarter 2025. The IPC in 2<sup>nd</sup> quarter 2025 increased by 5.6% compared with the corresponding index in the 2<sup>nd</sup> quarter 2024 (Table 1).

The Production Index in Construction (IPC) in the 2<sup>nd</sup> quarter 2026 recorded an increase of 30.6% compared with the 1<sup>st</sup> quarter 2026. In the 2<sup>nd</sup> quarter 2025, the IPC increased by 41.9% compared with the corresponding index in the 1<sup>st</sup> quarter 2025 (Table 2).

The seasonally adjusted Production Index in Construction in the 2<sup>nd</sup> quarter of 2026 recorded an increase of 0.02% compared with the 1<sup>st</sup> quarter 2026 (Table 3).



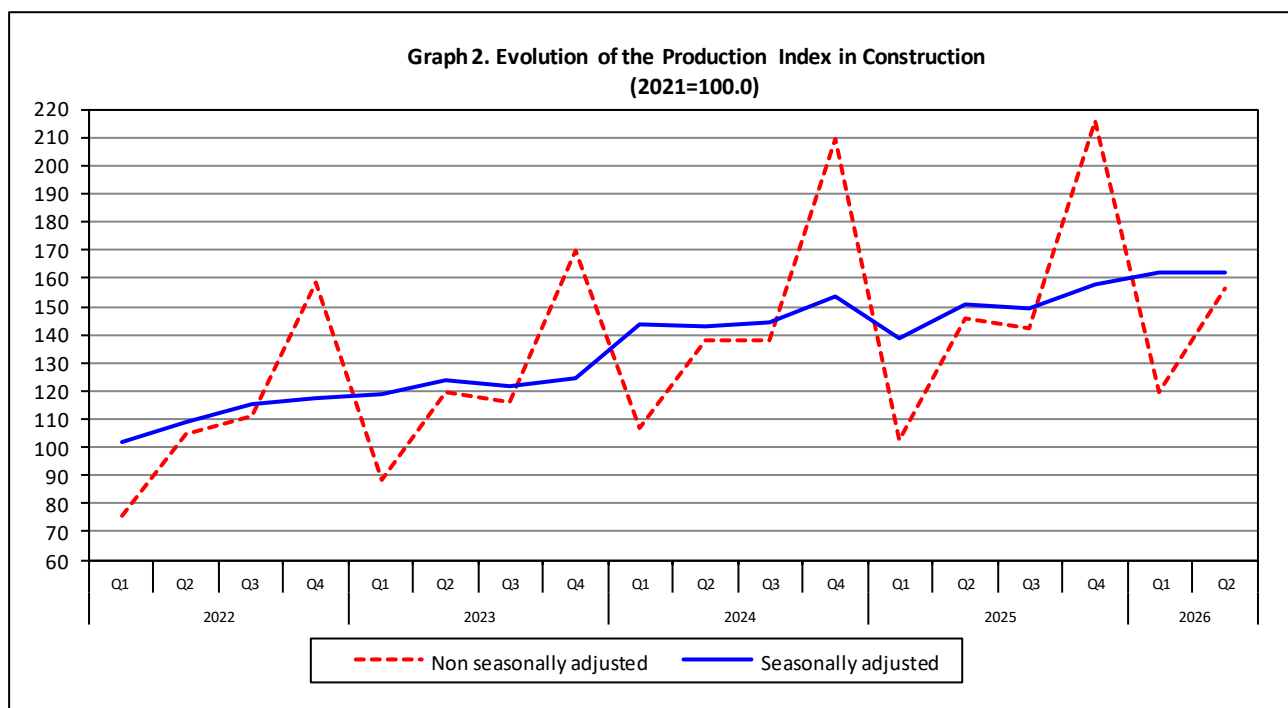

| <b>Seasonal adjustment</b>                                | Seasonal adjustment is the procedure followed to remove the impact of seasonality on time-series (i.e. the impact of effects, e.g. holidays, weather conditions etc), in order to improve comparability over time. The method applied is TRAMO-SEATS with the use of JDemetra+ 2.0.0.
