COMMERCIAL TRANSACTIONS OF GREECE : June 2021

(Provisional Data)

The total value of imports-arrivals, in June 2021 amounted to 5,367.5 million euros (6,446.7 million dollars) in comparison with 4,015.5 million euros (4,505.7 million dollars) in June 2020, recording an increase, in euros, of **33.7%**. The corresponding value excluding oil products in June 2021 recorded an increase of 770.1 million euros or 22.3% and the corresponding value excluding oil products and ships in June 2021 recorded an increase of 778.2 million euros or 22.7%, in comparison with June 2020 (Table 1).

The total value of exports-dispatches, in June 2021 amounted to 3,384.6 million euros (4,089.6 million dollars) in comparison with 2,573.8 million euros (2,905.3 million dollars) in June 2020, recording an increase, in euros, of **31.5%**. The corresponding value excluding oil products recorded in June 2021 an increase of 443.6 million euros or 21.4% and the corresponding value excluding oil products and ships in June 2021 recorded an increase of 438.2 million euros or 21.2%, in comparison with June 2020 (Table 1).

The deficit of the trade balance, in June 2021 amounted to 1,982.9 million euros (2,357.1 million dollars) in comparison with 1,441.7 million euros (1,600.4 million dollars) in June 2020, recording an increase, in euros, of **37.5%**. The corresponding value of deficit excluding oil products in June 2021 recorded an increase of 326.5 million euros or 23.7% and the corresponding value excluding oil products and ships in June 2021 recorded an increase of 340.0 million euros or 25.0%, in comparison with June 2020 (Table 1).

The total value of imports-arrivals, for the 6-month period from January to June 2021 amounted to 28,854.0 million euros (34,649.2 million dollars) in comparison with 23,749.9 million euros (26,104.3 million dollars) for the corresponding period of the year 2020, recording an increase, in euros, of **21.5%**. The corresponding value excluding oil products recorded an increase of 3,475.4 million euros or 18.3% and the corresponding value excluding oil products and ships recorded an increase of 3,491.2 million euros or 18.5%, in comparison with the period from January to June 2020 (Table 5).

The total value of exports-dispatches, for the 6-month period from January to June 2021 amounted to 18,591.9 million euros (22,464.9 million dollars) in comparison with 14,807.0 million euros (16,370.9 million dollars) for the corresponding period of the year 2020, recording an increase, in euros, of **25.6%**. The corresponding value excluding oil products recorded an increase of 2,280.3 million euros or 19.8% and the corresponding value excluding oil products and ships recorded an increase of 2,257.9 million euros or 19.6%, in comparison with the period from January to June 2020 (Table 5).

The deficit of the trade balance, for the 6-month period from January to June 2021 amounted to 10,262.1 million euros (12,184.3 million dollars) in comparison with 8,942.9 million euros (9,733.4 million dollars) for the corresponding period of the year 2020, recording an increase, in euros, of **14.8%**. The corresponding deficit excluding oil products recorded an increase of 1,195.1 million euros or 16.1% and the corresponding deficit excluding oil products and ships recorded an increase of 1,233.3 million euros or 16.7% (Table 5).

The monthly data of Intra EU transactions, have been adjusted to the total trade transactions with EU countries, including the transactions below the statistical threshold⁽¹⁾, on the basis of the Recapitulative Statements of Intra-EU Deliveries and Acquisitions that are submitted by the enterprises to the Ministry of Finance. Accordingly, the provisional data from the "incomplete customs declarations" have been incorporated in the monthly data on trade with third countries and, after having been completed, they will be replaced by the final data.

⁽¹⁾ By virtue of EU Regulations on the compilation of intra-EU trade statistics, Member States set out a "statistical exemption threshold". On the basis of the exemption threshold, the enterprises whose transactions are below the statistical threshold are exempted from the obligation to submit data on their intra-Community transactions (Intrastat declaration). The aim is to reduce the burden on enterprises. The statistical exemption threshold, valid for each year, is specified and released by ELSTAT on a yearly basis.

Diagram 1. Imports - Arrivals, Exports - Dispatches, June 2019-2021, million €



Diagram 2. Imports - Arrivals, Exports - Dispatches excluding oil products, June 2019-2021, million €



Diagram 3. Imports - Arrivals, Exports - Dispatches, excluding oil products and ships, June 2019-2021, million €



Diagram 4. Imports - Arrivals, Exports - Dispatches, January - June 2019-2021, million €



Diagram 5. Imports - Arrivals, Exports - Dispatches, excuding oil products, January - June 2019-2021, million €



Diagram 6. Imports - Arrivals, Exports - Dispatches, excluding oil products and ships, January - June 2019-2021, million €



Diagram 7a. Percentage (%) distribution of E.U. arrivals by SITC sections, June 2021




Diagram 7b. Percentage (%) distribution of Third countries imports by SITC sections, June 2021




Diagram 8a. Percentage (%) distribution of E.U. dispatches by SITC sections, June 2021




Diagram 8b. Percentage (%) distribution of Third countries exports by SITC sections, June 2021




Diagram 9. Imports - Arrivals E.U. & Third countries by SITC sections, Jan. - Jun 2021, million €




Diagram 10. Exports - Dispatches E.U. & Third countries by SITC sections, Jan. - Jun 2021, million €








