COMMERCIAL TRANSACTIONS OF GREECE : November 2025

(Provisional Data)

The total value of imports, in November 2025 amounted to 6,870.8 million euros (7,919.3 million dollars) in comparison with 7,353.2 million euros (7,793.6 million dollars) in November 2024, recording a drop, in euros, of **6.6%**. The corresponding value excluding oil products in November 2025 recorded a drop of 244.0 million euros or 4.3% and the corresponding value excluding oil products and ships in November 2025 recorded a drop of 244.8 million euros or 4.4%, in comparison with November 2024 (Table 1).

The total value of exports, in November 2025 amounted to 4,070.1 million euros (4,719.5 million dollars) in comparison with 4,053.8 million euros (4,322.2 million dollars) in November 2024, recording an increase, in euros, of **0.4%**. The corresponding value excluding oil products recorded in November 2025 a drop of 170.7 million euros or 5.4% and the corresponding value excluding oil products and ships in November 2025 recorded a drop of 163.9 million euros or 5.2%, in comparison with November 2024 (Table 1).

The deficit of the trade balance, in November 2025 amounted to 2,800.7 million euros (3,199.8 million dollars) in comparison with 3,299.4 million euros (3,471.4 million dollars) in November 2024, recording a drop, in euros, of **15.1%**. The corresponding value of deficit excluding oil products in November 2025 recorded a drop of 73.3 million euros or 3.0% and the corresponding value excluding oil products and ships in November 2025 recorded a drop of 80.9 million euros or 3.3%, in comparison with November 2024 (Table 1).

The total value of imports, for the 11-month period from January to November 2025 amounted to 74,396.1 million euros (83,491.6 million dollars) in comparison with 78,053.5 million euros (84,412.9 million dollars) for the corresponding period of the year 2024, recording a drop, in euros, of **4.7%**. The corresponding value excluding oil products recorded an increase of 968.9 million euros or 1.6% and the corresponding value excluding oil products and ships recorded an increase of 800.3 million euros or 1.4%, in comparison with the period from January to November 2024 (Table 5).

The total value of exports, for the 11-month period from January to November 2025 amounted to 44,477.7 million euros (50,215.5 million dollars) in comparison with 45,923.9 million euros (49,964.0 million dollars) for the corresponding period of the year 2024, recording a drop, in euros, of **3.1%**. The corresponding value excluding oil products recorded an increase of 700.3 million euros or 2.1% and the corresponding value excluding oil products and ships recorded an increase of 771.3 million euros or 2.3%, in comparison with the period from January to November 2024 (Table 5).

The deficit of the trade balance, for the 11-month period from January to November 2025 amounted to 29,918.4 million euros (33,276.1 million dollars) in comparison with 32,129.6 million euros (34,448.9 million dollars) for the corresponding period of the year 2024, recording a drop, in euros, of **6.9%**. The corresponding deficit excluding oil products recorded an increase of 268.6 million euros or 1.0% and the corresponding deficit excluding oil products and ships recorded an increase of 29.0 million euros or 0.1% (Table 5).

The monthly data of Intra-Union transactions, have been adjusted to the total trade transactions with EU countries, including the transactions below the statistical threshold⁽¹⁾, on the basis of the Recapitulative Statements of Intra-EU Deliveries and Acquisitions that are submitted by the enterprises to the Independent Authority of Public Revenue. Accordingly, the provisional data from the "incomplete customs declarations" have been incorporated in the monthly data on trade with third countries and, after having been completed, they will be replaced by the final data.

⁽¹⁾ By virtue of Union Regulations on the compilation of intra-Union trade statistics, Member States set out a "statistical exemption threshold". On the basis of the exemption threshold, the enterprises whose transactions are below the statistical threshold are exempted from the obligation to submit data on their intra-Union transactions (Intrastat declaration). The aim is to reduce the burden on enterprises. The statistical exemption threshold, valid for each year, is specified and released by Hellenic Statistical Authority on a yearly basis.

Diagram 1. Imports, Exports, November 2023-2025, million €



Diagram 2. Imports, Exports excluding oil products, November 2023–2025, million €



Diagram 3. Imports, Exports, excluding oil products and ships, November 2023-2025, million €



Diagram 4. Imports, Exports, January - November 2023-2025, million €



Diagram 5. Imports, Exports, excuding oil products, January - November 2023-2025, million €



Diagram 6. Imports, Exports, excluding oil products and ships, January - November 2023-2025, million €



Diagram 7a. Percentage (%) distribution of E.U. imports by SITC sections, November 2025




Diagram 7b. Percentage (%) distribution of Third countries imports by SITC sections, November 2025




Diagram 8a. Percentage (%) distribution of E.U. exports by SITC sections, November 2025




Diagram 8b. Percentage (%) distribution of Third countries exports by SITC sections, November 2025




Diagram 9. Imports E.U. & Third countries by SITC sections, Jan. - Nov. 2025, million €




Diagram 10. Exports E.U. & Third countries by SITC sections, Jan. - Nov. 2025, million €



Diagram 11. Commercial Transactions with EU & Third countries 2023-2025








EXPLANATORY NOTES

Commercial Transactions	The Commercial Transactions are recorded on a monthly basis aiming at monitoring the total value of imports, exports and their changes. This recording does not include the imports and exports of services.
Legal Framework	The survey is conducted for Intra-Union trade and for trade with third countries in accordance with Regulations (EU) 2019/2152 and (EU) 2020/1197.
Reference Period	November 2025
Provision of Results	38 days after the end of the reference month (provisional data). The provisional data are revised and disseminated on a monthly basis for all the previous months until the finalization of the yearly data, which takes place ten months after the end of the reference year.
Definitions	INTRASTAT is the system for collecting Intra-Union statistical data (among the EU countries). It was implemented on January 1st, 1993. Import is considered every import of goods from a country of the EU. Export is considered every export of goods to a country of the EU. Extra-Union trade is the system for collecting external trade data with third countries (countries outside the EU). Import is considered every import of goods from a third country (outside the EU). Export is considered every export of goods to a third country (outside the EU).
Methodology	INTRASTAT: It is an exhaustive statistical survey. The parties responsible for providing statistical information through Intrastat System are the enterprises which perform Intra-Union trade transactions and they have exceeded the applied statistical thresholds. The statistical thresholds are readjusted each year. The statistical thresholds for 2025 are the following: <ul style="list-style-type: none">• Intra-Union Imports: € 200,000.00 (95.7% coverage)• Intra-Union Exports: € 90,000.00 (98.7% coverage) The statistical data of Intra-Union Trade include also the transactions of the enterprises, which are not obliged to submit Intrastat data since the value of their transactions is below the applied statistical threshold. In compliance with the obligations provided in the EU Regulations regarding the compilation of external trade statistics, these transactions are calculated on the basis of the Recapitulative Statements of Intra-EU Deliveries and Acquisitions that all the enterprises are obliged to submit to the Independent Authority of Public Revenue .
	ELECTRONIC SUBMISSION: Intrastat declarations are submitted electronically via the following links: http://eurostat.statistics.gr or www.statistics.gr .
	Extra-Union trade: It is a statistical survey where data are collected by administrative sources. The Customs Authorities collect the relevant statistical data on trade by filling in the Single Administrative Document (SAD). All the transactions with third countries are registered. At the end of each month Customs Authorities transmit to the Hellenic Statistical Authority an electronic file with the customs data of statistical relevance of the previous reference month.
	The statistical data of imports and exports of goods with the Third Countries, are derived from the data transmitted by the Customs Authorities. Henceforth, the provisional data from the "incomplete customs declarations" - which concern mainly petroleum products - are incorporated in the monthly data on trade with third countries; the "incomplete customs declarations" data after having been completed will be replaced by the final data.
	IMPORTS AND EXPORTS OF SHIPS AND AIRCRAFTS: In accordance with EU Regulations entered into force in 2010 (Regulations (EU) 2010/96, 2010/113) and in accordance with Regulations (EU) 2019/2152 and (EU) 2020/1197 entered into force in 2022, the EU Member States are obliged to record the transactions of special goods and movements and more specifically of vessels and aircrafts in line with the principle of economic ownership. "Economic ownership" means the right of a taxable person to claim the benefits associated with the use of a vessel or aircraft in the course of an economic activity by virtue of accepting the associated risks. For the compilation of statistics on imports and exports of ships are used Intrastat statistical survey data, data from administrative sources (Customs, Ministry of Marine and Island Policy), as well as data from national and international commercial databases based on the estimation model of the Bank of Greece for the Greek shipping (see Press Release on Balance of Payments published by the Bank of Greece on 20.11.2018). The compilation of statistics on imports and exports of aircrafts is based on Intrastat statistical survey data and data from administrative sources (Customs, Hellenic Civil Aviation Authority).
	Classification of goods: The goods are classified in compliance with the 8-digit Combined Nomenclature Code (CN8) and the Standard International Trade Classification (SITC).
