
## EVOLUTION OF TURNOVER OF ENTERPRISES NOVEMBER 2024

The Hellenic Statistical Authority (ELSTAT) announces data on the evolution of turnover of enterprises in all sectors of the economy, incorporating the most recent data on turnover from Administrative Sources for **November 2024**.

For the enterprises of the economy as a whole, obliged to double-entry accounting bookkeeping, for which data are available on a monthly basis, the turnover in November 2024 amounted to 30,973,102 thousand euro, recording an increase of 3.4% in comparison with November 2023, when the respective turnover was 29,965,400 thousand euro (Graph 1, Table 1).

The biggest increase in turnover in November 2024 compared with November 2023 was recorded from the enterprises of the section Construction, per 15.9% and the smallest increase was recorded from the enterprises of the section Human Health and Social Work Activities, per 0.3%, while the biggest decrease was recorded from the enterprises of the section Manufacturing, per 5.0% (Table 1).
