**EVOLUTION OF TURNOVER OF ENTERPRISES IN**  
**ACCOMMODATION AND FOOD SERVICE ACTIVITIES**  
**JUNE AND 2<sup>ND</sup> QUARTER 2022**

The Hellenic Statistical Authority (ELSTAT) with this sectoral publication, presents the map with the evolution of the turnover of enterprises classified in the **Accommodation and Food and Beverage Service Activities** divisions. These economic activities have been over time in the focus of interest due to the significant weight they bear on the Greek economy as a whole, but also due to their extensive dispersion, with a significant presence in all regional units and a significant contribution to the respective local economies of Greece, often associated with the tourist product of the country. At the same time, under the recent circumstances, the monitoring and dedicated publication of the evolution of these economic activities has become imperative, given the direct and indirect adverse impact they have been subjected to, due to the pandemic of coronavirus disease 2019 (COVID-19).

The current publication is part of the Press Releases series published by ELSTAT ([PR link](#)), since April 2020, incorporating the most recent data on turnover from Administrative Sources for **June and 2<sup>nd</sup> quarter 2022**.

In particular, ELSTAT announces data on a monthly basis and at the regional unit country-level of analysis, for the turnover of enterprises classified in the divisions Accommodation and Food and Beverage Service Activities (divisions 55 and 56 of the NACE Rev.2 classification) for the period 2019-2022.

The published data can highlight, at a detailed local level, the current evolution in the performance, in terms of turnover, of enterprises having activity in key classes of the tourism sector and thus provide quick and highly relevant information on the evolution of the tourist product of Greece.

Specifically,

For the total of enterprises in **Accommodation Activities (division 55 of NACE Rev.2 classification)**, the turnover in the second quarter 2022 amounted to 2,051,499,115 euro, recording an increase of 238.8% in comparison with the second quarter 2021, when the respective turnover was 605,517,814 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2021 greater than 1.0% (Table 1), the biggest increase in the turnover of the second quarter 2022 compared to the second quarter of 2021 was recorded in the Regional Unit Kos (399.6%) and the smallest increase (125.8%) was recorded in the Regional Unit Chalkidiki (Table 2).

For the total of enterprises in **Food and Beverage Service Activities (division 56 of NACE Rev.2 classification)**, the turnover in the second quarter 2022 amounted to 1,931,545,816 euro, recording an increase of 70.2% in comparison with the second quarter 2021, when the respective turnover was 1,134,960,057 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2021 greater than 1.0% (Table 1), the biggest increase in the turnover of the second quarter 2022 compared to the second quarter of 2021 was recorded in the Regional Unit Thira (275.8%) and the smallest increase (32.3%) was recorded in the Regional Unit Achaia (Table 3).

For the enterprises in **Accommodation Activities (division 55 of NACE Rev.2 classification), obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in June 2022 amounted to 1,007,709,216 euro, recording an increase of 174.4% in comparison with June 2021, when the respective turnover was 367,247,183 euro (Table 4).

For the enterprises in **Food and Beverage Service Activities (division 56 of NACE Rev.2 classification), obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in June 2022 amounted to 221,518,425 euro, recording an increase of 56.0% in comparison with June 2021, when the respective turnover was 141,979,349 euro (Table 4).

For the enterprises in **Accommodation and Food and Beverage Service Activities (divisions 55 and 56 of NACE Rev. 2 classification), obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in June 2022 amounted to 1,229,227,641 euro, recording an increase of 141.4% in comparison with June 2021, when the respective turnover was 509,226,532 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2021 greater than 1.0% (Table 1), the biggest increase in the turnover of June 2022 compared with June 2021 was recorded in the Regional Unit Kos (325.5%) and the smallest increase (58.0%) was recorded in the Regional Unit Achaia (Table 5).

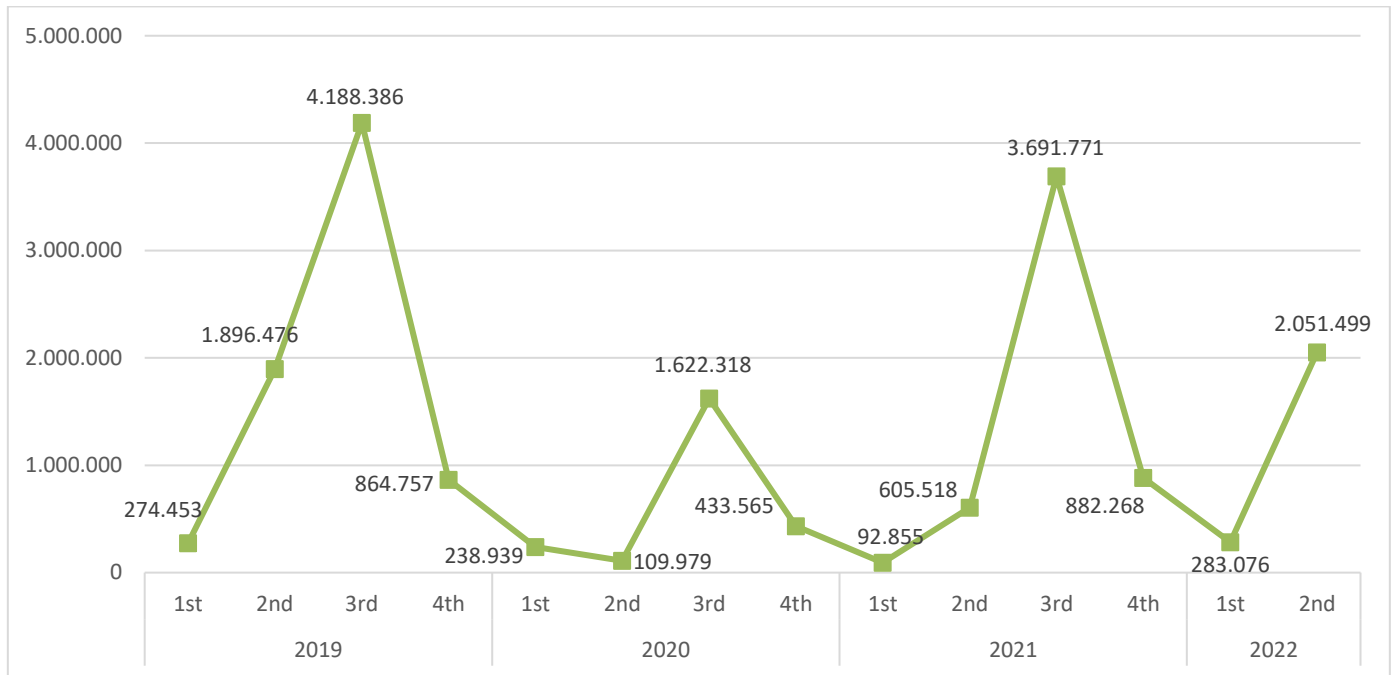

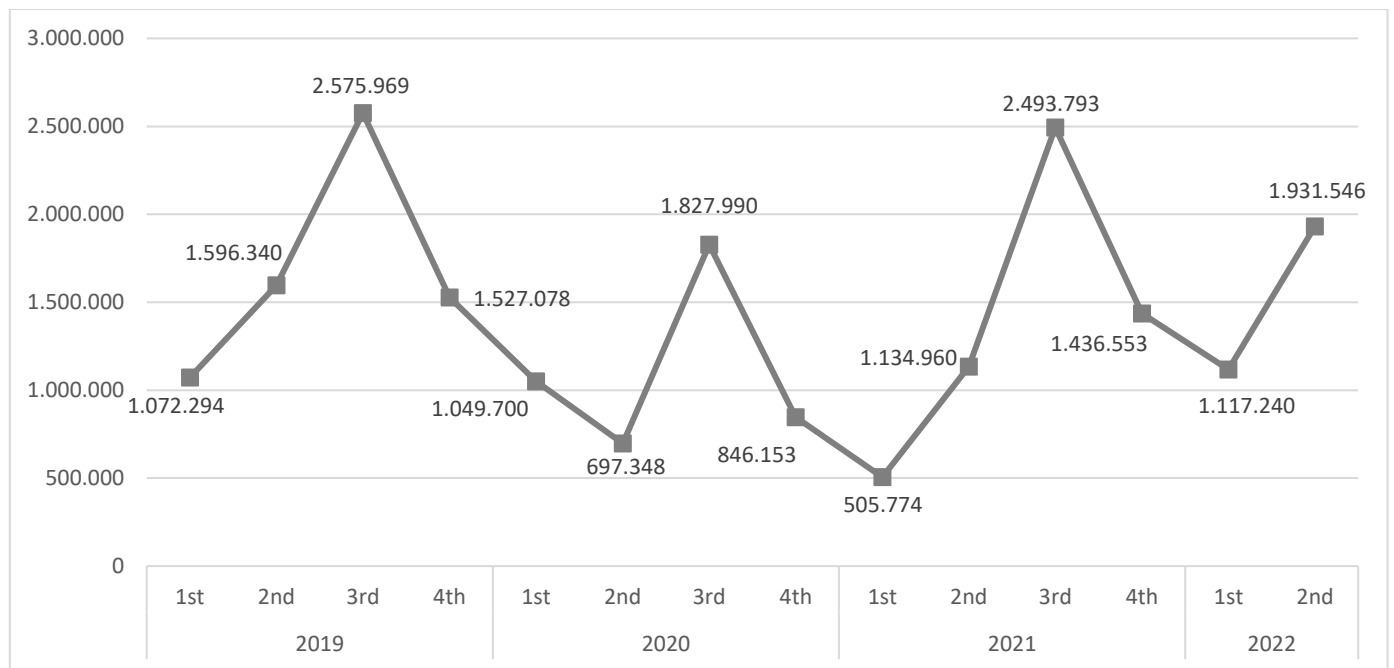

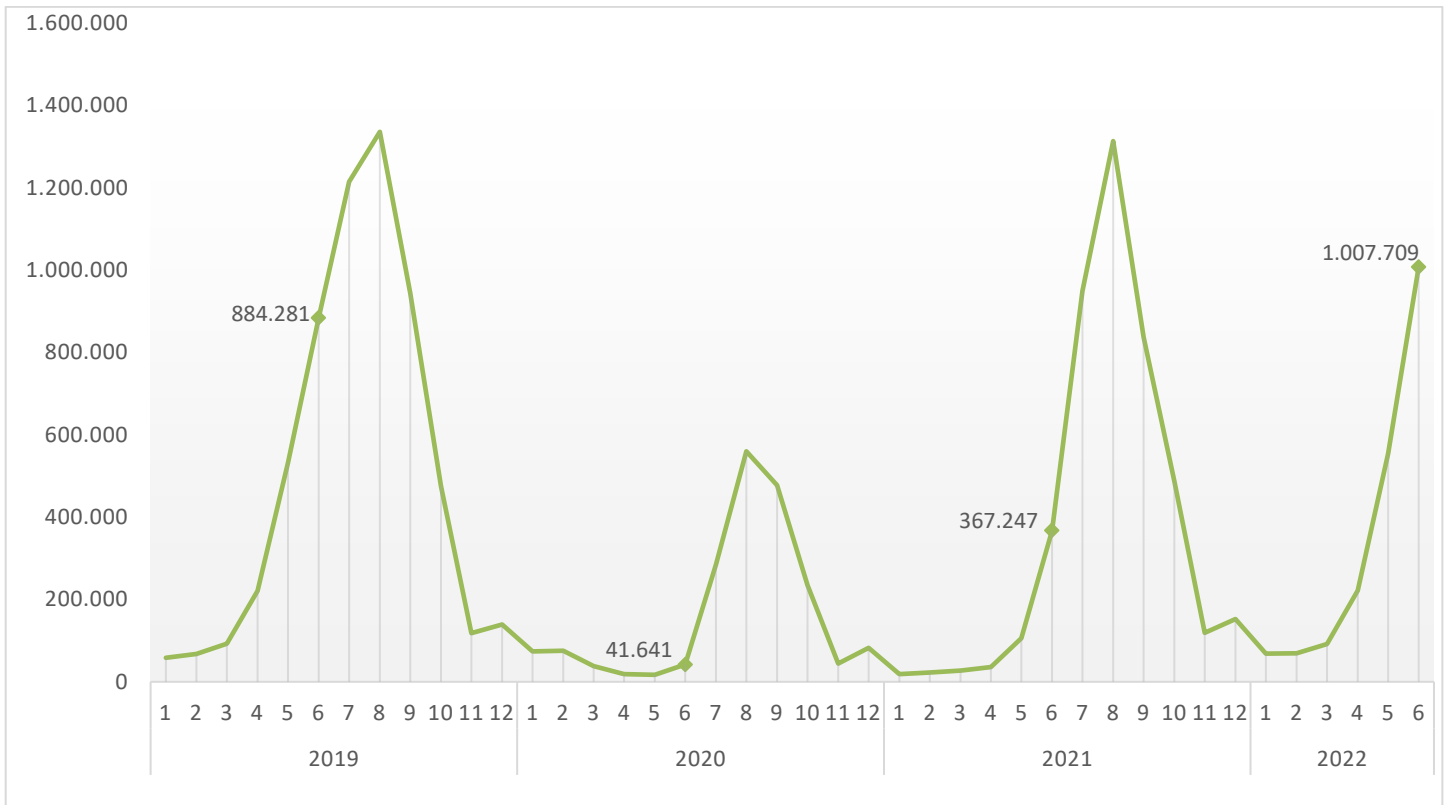
**Graph 1:** Turnover (in thousand €) of the total of enterprises in the Accommodation Activities (division 55 of NACE Rev. 2 classification)



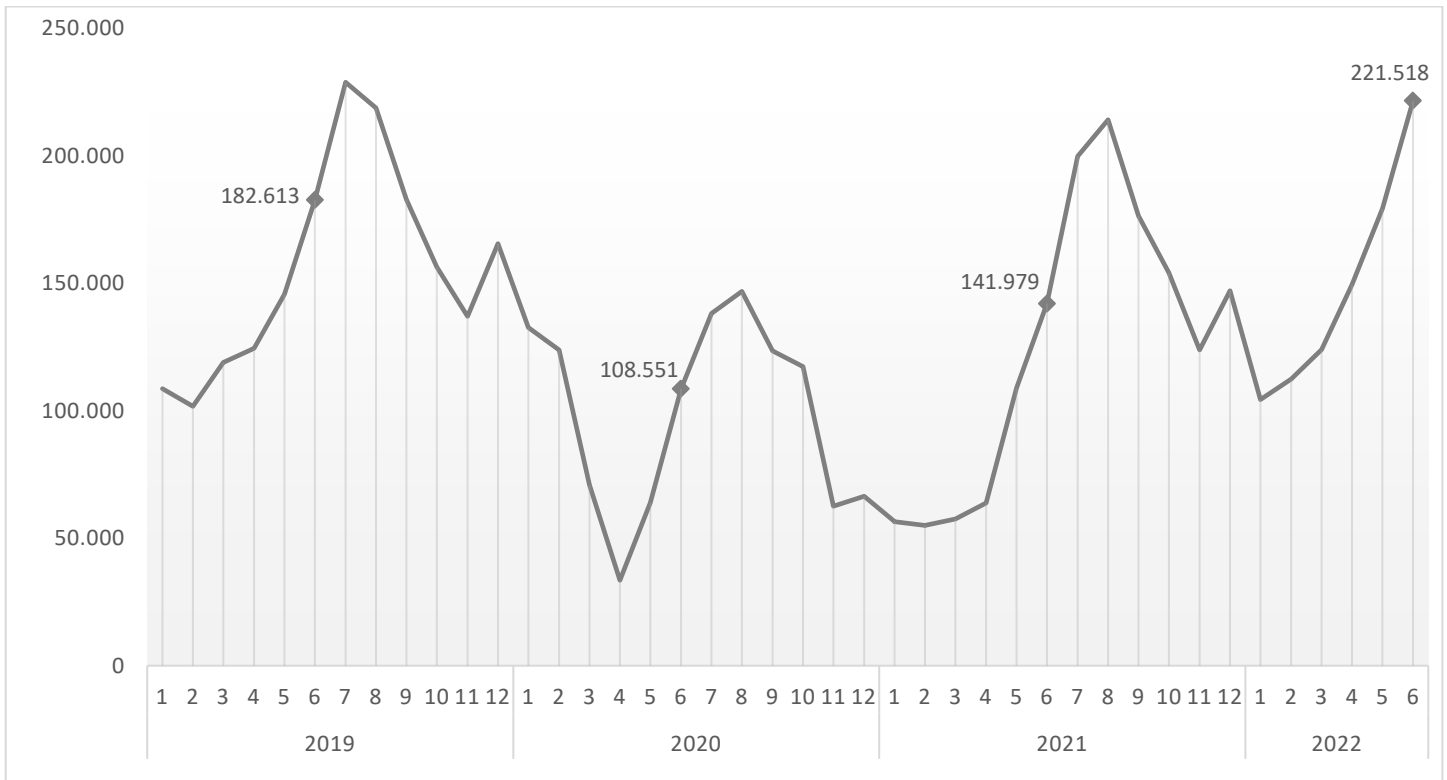

- Administrative transactions files (tax etc) of the reference years 2019, 2020, 2021 and 2022.

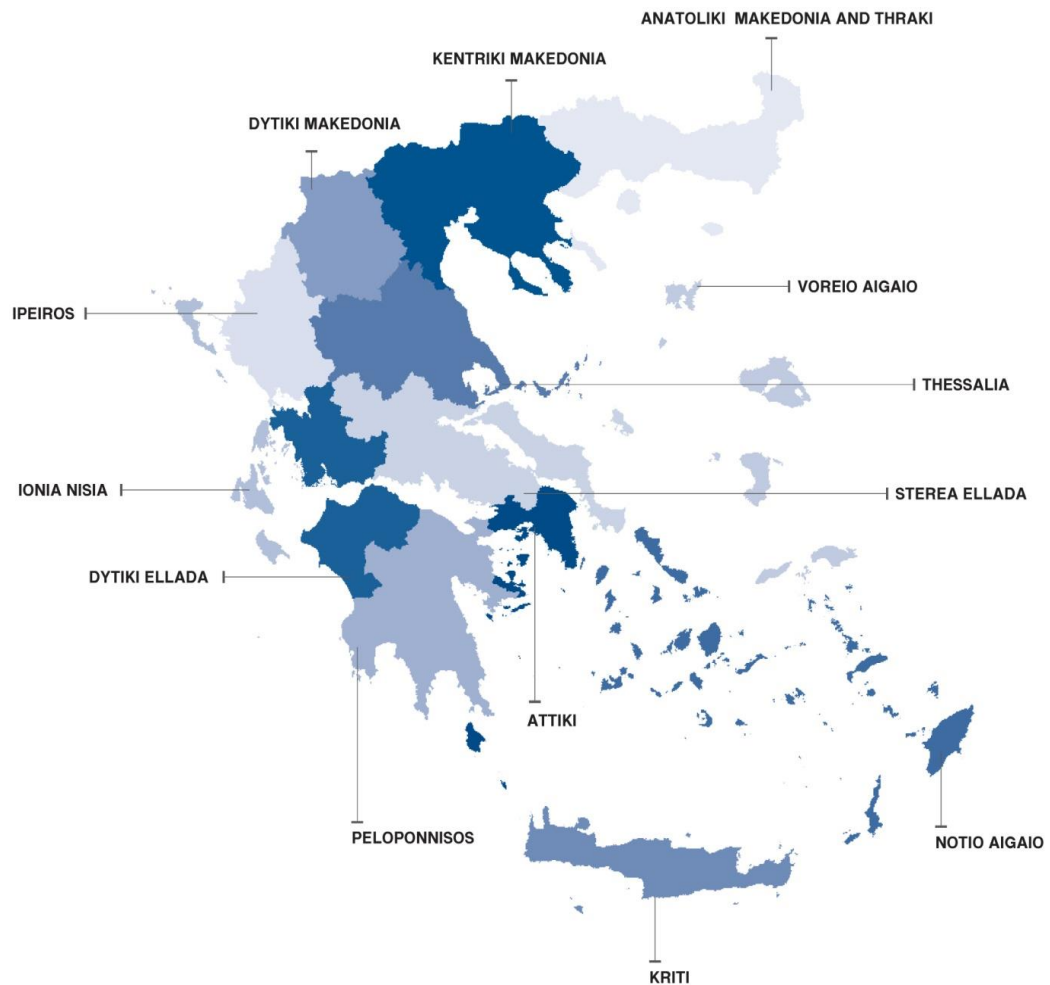
In particular the following primary data have been used per source:

- Income data from administrative transaction files of the years 2019, 2020, 2021 and 2022.
