The Hellenic Statistical Authority (ELSTAT) announces data on Short-Term Indices of Employment, Hours Worked and Gross Wages and Salaries in main sections of the economy for the 4th quarter 2019.



In the following table, the Short-Term Indices of Employment, Hours Worked and Gross Wages and Salaries without adjustment (seasonal or adjustment for the number of working days) are presented analytically in ten main sections¹ of the NACE Rev.2 classification of economic activities. Furthermore, data on the annual rate of change of each index are presented.

In the Graphs 2 to 11 that follow the evolution over time of the Indices of Employment, Hours Worked and Gross Wages and Salaries broken down by NACE Rev. 2 section for the 4th quarter of the years 2010 up to 2019 is shown, as well as their annual rates of change.



Graph 2. B-Mining and Quarrying





Graph 3. C-Manufacturing





Graph 4. D-Electricity, Gas, Steam and Air Conditioning Supply





Graph 5. E-Water Supply, Sewerage, Waste Management and Remediation Activities





Graph 6. F-Construction





Graph 7. H-Transportation and Storage





Graph 8. I- Accommodation and Food Services Activities





Graph 9. J-Information and Communication

METHODOLOGICAL NOTES

Generally The Short-term Indices of Persons Employed, Hours Worked and Gross Wages and Salaries are quarterly indices concerning the Sections of economic activities B to E (Mining and Quarrying, Manufacturing, Electricity Supply and Water Supply), F (Construction), H to J and M to N (Other Services) of the European Economic classification NACE Rev.2, having 2015 as the base year (2015=100.00).

Purpose of the index The purpose of the indices is to present the evolution of Persons Employed, Hours Worked and Gross Wages and Salaries on a quarterly basis in sections of economic activities B to E (Mining and Quarrying, Manufacturing, Electricity Supply and Water Supply), F (Construction), H to J and M to N (Other Services) of the European classification NACE Rev.2.

Legal Framework The Council Regulation (EC) No.1165/98 concerning short-term statistics and Council Regulation (EC) No.1503/2006 as regards definitions of variables, list of variables and frequency of data compilation.

Geographical coverage Greece, total.

Reference Period Quarter.

Definitions As **Number of Persons Employed** is defined the total number of persons employed in the enterprise, irrespectively of their status (owners, partners and their family members) and the nature of their work (managers, sales persons and auxiliary staff) and irrespectively of whether they work temporarily or seasonally, full-time or part-time employment, with or without remuneration.

As **Hours Worked** is defined the total number of hours actually worked in the enterprise during the reference quarter. It includes hours actually worked during regular working hours; hours worked overtime, whether paid or unpaid; hours worked during nights, Sundays or public holidays. It also includes the time which is spent at the place of work on tasks such as preparing the site and time corresponding to short periods of rest at the work place. This variable excludes hours paid but not actually worked such as for annual leave, holidays and sickness leave.

As **Wages and Salaries** is defined the total remuneration, in cash or in kind, payable to all persons counted on the payroll, in return for work done.

Statistical Classifications The European statistical classification of economic activities NACE Rev. 2 is used.
