
EVOLUTION OF TURNOVER OF ENTERPRISES IN RETAIL TRADE SEPTEMBER, 3rd QUARTER 2024

The Hellenic Statistical Authority (ELSTAT), presents the evolution of the sales/turnover of all classes of activity of the retail trade section, incorporating the most recent data on turnover from Administrative Sources for **September and 3rd quarter 2024**.

For the **total of enterprises in retail trade**, the turnover in the **third quarter of 2024** amounted to 18.84 billion euro, recording an increase of 0.8% in comparison with the third quarter of 2023, when the respective turnover was 18.68 billion euro and an increase of 4.0% in comparison with the second quarter of 2024, when the respective turnover was 18.11 billion euro.

For the **enterprises in retail trade divisions, excluding vehicles, food and fuel classes**, the turnover in the **third quarter of 2024** amounted to 6.82 billion euro, recording an increase of 1.2% in comparison with the third quarter of 2023, when the respective turnover was 6.73 billion euro and an increase of 3.8% in comparison with the second quarter of 2024, when the respective turnover was 6,57 billion euro (Graph 1, Table 1).

1. Total of enterprises in retail trade

1.1 Quarterly Data (Tables 1, 3)

For the **total of enterprises in retail trade**, the activities that recorded the <u>biggest increase</u> in turnover in the **third quarter of 2024** compared with the corresponding quarter of 2023 are:

- Sale, maintenance and repair of motorcycles and related parts and accessories, increase 18.8%.
- Retail sale of music and video recordings in specialized stores, increase 15.7%.

The activities that recorded the <u>biggest decrease</u> in turnover in the **third quarter of 2024** compared with the corresponding quarter of 2023 are:

- Retail sale of footwear and leather goods in specialized stores, decrease 8.9%.
- Retail sale of electrical household appliances in specialized stores, decrease 8.6%.

The Regions that recorded the <u>biggest increase</u> in turnover in the **third quarter of 2024** compared with the corresponding quarter of 2023 are:

- Region of Voreio Aigaio, increase 5.6%.
- Region of Kriti, increase 2.3%.

The Regions that recorded the <u>biggest decrease</u> in turnover in the **third quarter of 2024** compared with the corresponding quarter of 2023 are:

- Region of Anatoliki Makedonia Thraki, decrease 2.6%.
- Region of Dytiki Makedonia, decrease 2.4%.

1.2 Monthly Data - Enterprises obliged to double-entry accounting bookkeeping (Tables 2, 5)

For the **enterprises in retail trade divisions obliged to double-entry accounting bookkeeping**, for which data are available on a monthly basis, the turnover in **September 2024** amounted to 3.77 billion euro, recording an increase of 0.4% in comparison with September 2023, when the respective turnover was 3.75 billion euro and an increase of 1.3% in comparison with August 2024, when the respective turnover was 3.72 billion euro.

The activities that recorded the <u>biggest increase</u> in turnover in **September 2024** compared with September 2023 are:

- Retail sale of cosmetic and toilet articles in specialized stores, increase 13.7%.
- Other retail sale of food in specialized stores, increase 13.4%.

The activities that recorded the <u>biggest decrease</u> in turnover in **September 2024** compared with September 2023 are:

- Retail sale of tobacco products in specialized stores, decrease 9.3%.
- Retail sale of audio and video equipment in specialized stores, decrease 7.7%.

The Regions that recorded the <u>biggest increase</u> in turnover in **September 2024** compared with September 2023 are:

- Region of Dytiki Makedonia, increase 5.8%.
- Region of Sterea Ellada, increase 2.8%.
- Region of Dytiki Ellada, increase 2.8%.

The Region that recorded <u>decrease</u> in turnover in **September 2024** compared with September 2023 is:

• Region of Attiki, decrease 1.0%.

2. Enterprises in retail trade divisions, excluding vehicles, food and fuel classes¹

2.1 Quarterly Data (Table 3)

For the **enterprises in retail trade divisions, excluding vehicles, food and fuel classes**, the Regions that recorded the <u>biggest</u> <u>increase</u> in turnover in the **third quarter of 2024** compared with the corresponding quarter of 2023 are:

- Region of Voreio Aigaio, increase 5.5%.
- Region of Thessalia, increase 3.6%.

The Regions that recorded the <u>biggest decrease</u> in turnover in the **third quarter of 2024** compared with the corresponding quarter of 2023 are:

- Region of Dytiki Makedonia, decrease 2.4%.
- Region of Dytiki Ellada, decrease 2.0%.

2.2 Monthly Data (Tables 2, 5)

For the **enterprises in retail trade divisions, excluding vehicles, food and fuel classes, obliged to double-entry accounting bookkeeping**, for which data are available on a monthly basis, the turnover in **September 2024** amounted to 1.07 billion euro, recording an increase of 4.4% in comparison with September 2023, when the respective turnover was 1.03 billion euro and an increase of 4.4% in comparison with August 2024, when the respective turnover was 1.03 billion euro.

The Regions that recorded an increase in turnover in September 2024 compared with September 2023 are:

- Region of Attiki, increase 4.1%.
- Region of Sterea Ellada, increase 0.7%.

The Region that recorded a <u>decrease</u> in turnover in **September 2024** compared with September 2023 is:

• Region of Kentriki Makedonia, decrease 1.2%.

3. Small and medium sized enterprises (Tables 4, 6)

3.1 Small and medium sized enterprises in retail trade divisions

For the total of small and medium sized enterprises² in retail trade divisions, the turnover in the **third quarter 2024** amounted to 11.15 billion euro, recording a decrease of 0.1% in comparison with the third quarter of 2023, when the respective turnover was 11.17 billion euro.

For the small and medium sized enterprises in retail trade divisions **obliged to double-entry accounting bookkeeping**, for which data are available on a monthly basis, the turnover in **September 2024** amounted to 1.30 billion euro, recording an increase of 3.7% in comparison with September 2023, when the respective turnover was 1.26 billion euro.

3.2 Small and medium sized enterprises in retail trade divisions, excluding vehicles, food and fuel classes

For the total of small and medium sized enterprises in retail trade divisions, excluding vehicles, food and fuel classes, the turnover in the **third quarter of 2024** amounted to 5.088 billion euro, recording a decrease of 0.1% in comparison with the third quarter of 2023, when the respective turnover was 5,093 billion euro.

For the small and medium sized enterprises in retail trade divisions, excluding vehicles, food and fuel classes, **obliged to doubleentry accounting bookkeeping**, for which data are available on a monthly basis, the turnover in **September 2024** amounted to 0.50 billion euro, recording an increase of 3.5% in comparison with September 2023, when the respective turnover was 0.49 billion euro.











METHODOLOGICAL NOTES

Generally The statistical data presented in this announcement have been compiled on the basis of the linking and processing of primary data from the following sources:


- The final Statistical Business Register of ELSTAT, of the reference year 2021.
- Administrative registers of enterprises, of the reference years 2022 and 2023.
- Administrative transactions files (tax, etc) of the reference years 2019 to 2024.


In particular, the following primary data have been used per source:

- Active enterprises and the economic activity class from the final Statistical Business Register of the reference year 2021.
- The economic activity class for the enterprises that started their activity after the reference year 2021 and have a significant turnover, from administrative registers of enterprises of the reference years 2022 and 2023.
 - Income data from administrative transactions files of the reference years 2019 to 2024.

Definitions Small and Medium sized enterprises (SMEs) (from the European business statistics methodological manual for statistical business registers – 2021 edition)

- 1. The category of micro, small and medium-sized enterprises (SMEs) is made up of enterprises which employ fewer than 250 persons and which have an annual turnover not exceeding EUR 50 million, and/or an annual balance sheet total not exceeding EUR 43 million.
- 2. Within the SME category, a small enterprise is defined as an enterprise which employs fewer than 50 persons and whose annual turnover and/or annual balance sheet total does not exceed EUR 10 million.
- Within the SME category, a micro enterprise is defined as an enterprise which employs fewer than 10 persons and whose annual turnover and/or annual balance sheet total does not exceed EUR 2 million.
 It is noted that as "Medium enterprises" are defined the enterprises of the "Small and Medium sized enterprises" category, which are not classified in the categories of "Small enterprises" and "Micro enterprises".





Reference Period September, 3rd Quarter 2024

Statistical unit The statistical unit is the legal unit (distinct TIN – Tax Identification Numbers).

Comparability The announced statistical data are comparable with the data of the final Statistical Business Register of ELSTAT, of the reference year 2021 (relevant link from the webpage of ELSTAT, where tables and information on the methodology applied are provided <u>Statistical Business Register</u>).
