SHORT-TERM INDICES OF EMPLOYMENT (PERSONS EMPLOYED, HOURS WORKED, GROSS WAGES AND SALARIES) IN MAIN SECTIONS OF THE ECONOMY¹ AND RETAIL TRADE²: 4^{rth} Quarter 2022 (Provisional Data)

The Hellenic Statistical Authority (ELSTAT) announces data on Short-term Indices of Employment (Persons Employed, Hours Worked and Gross Wages and Salaries) without adjustment (seasonal or adjustment for the number of working days) in main sections of the economy for the 4^{rth} quarter 2022.

The evolution of the Short-term Indices of Employment in the 4^{rth} quarter 2022* in comparison to the corresponding indices of the 4^{rth} quarter 2021 is as follows:



In the following tables, the Short-term Indices of Persons Employed, Hours Worked and Gross Wages and Salaries without adjustment (seasonal or adjustment for the number of working days) are presented analytically in eleven main sections of the NACE Rev. 2 statistical classification of economic activities. Furthermore, data on the annual and quarterly rates of change of each index are presented, for the years 2021 - 2022 (4^{rth} quarter).

In the Graphs 2 to 13 that follow, the evolution over time of the Indices of Persons Employed, Hours Worked and Gross Wages and Salaries broken down by NACE Rev. 2 section, for the years 2019 – 2022 (4^{rth} quarter) is shown.





































METHODOLOGICAL NOTES

Generally

The Short-term Indices of Employment (Persons Employed, Hours Worked and Gross Wages and Salaries) are quarterly indices in eleven main sections of economic activities B to E (Mining and Quarrying, Manufacturing, Electricity Supply and Water Supply), F (Construction), G (Trade), H to J and M to N (Other Services) of the statistical classification of economic activities NACE Rev. 2 of EU, with base year 2015=100.0.

The index of persons employed in retail trade is a quarterly index that was first compiled in 2004 with base year 2000=100.0, while the indices of hours worked, gross wages and salaries are quarterly indices that were first compiled in March 2016 with base year 2010=100.0.

Purpose of the indices

The purpose of the indices is to present the evolution of Persons Employed, Hours Worked by Employees and Gross Wages and Salaries on a quarterly basis in eleven main sections (and the division 47 of Retail Trade) of economic activities B to E (Mining and Quarrying, Manufacturing, Electricity Supply and Water Supply), F (Construction), G (Trade), H to J and M to N (Other Services) of the statistical classification NACE Rev. 2.

Legal Framework

The Short-term Indices of Employment (Persons Employed, Hours Worked and Gross Wages and Salaries) are compiled in the framework of the implementation of Council Regulation (EC) No 1165/1998 concerning short-term statistics (STS-R), Regulation (EC) No 1158/2005 of the European Parliament and of the Council, as well as Commission Regulation (EC) No 329/2009 both amending Council Regulation (EC) No 1165/1998. Furthermore, the indices are governed by Regulation (EU) No 2019/2152 of the European Parliament and of the Council on European business statistics, as well as Commission Implementing Regulation (EU) No 2020/1197 laying down technical specifications and arrangements pursuant to Regulation (EU) No 2019/2152. Finally, for the compilation of the aforementioned indices, Regulation (EC) No 1893/2006 of the European Parliament and of the Council establishing the statistical classification of economic activities NACE Rev. 2.

Revision

The latest revision of the Short-term Indices of Employment (base year 2015=100.0) took place in the implementation framework of Council Regulation (EC) No 1165/1998. In accordance with this regulation the index is revised every five years, in years ending in 0 or 5. The purpose of the revision is to adapt the indices to the latest developments in the employment structure in the sectors of economic activity.

Definitions

As **Number of Persons Employed** is defined the total number of persons employed in the enterprise, irrespectively of their status (owners, partners and their family members) and the nature of their work (managers, sales persons and auxiliary staff) and irrespectively of whether they work temporarily or seasonally, full-time or part-time employment, with or without remuneration.

As **Hours Worked** is defined the total number of hours actually worked in the enterprise by Employees during the reference quarter. It includes hours actually worked during regular working hours; hours worked overtime, whether paid or unpaid; hours worked during nights, Sundays or public holidays. It also includes the time which is spent at the place of work on tasks such as preparing the site and time corresponding to short periods of rest at the work place. This variable excludes hours paid but not actually worked such as for annual leave, holidays and sickness leave.

As **Wages and Salaries** is defined the total remuneration, in cash or in kind, payable to all persons counted on the payroll, in return for work done.

Statistical Classification

The statistical classification of economic activities NACE Rev. 2 of EU is used.

Calculation of the indices

The Short-term Indices of Employment are calculated by applying the chaining method. Firstly, the moving base index is calculated by comparing the estimated value (number of persons employed, hours worked, wages and salaries) for the current quarter with the corresponding value of the previous quarter. Afterwards, the fixed base index for the current quarter is calculated by multiplying the moving base index by the fixed base index of the previous quarter.

Employment Indices in division 47 of Retail Trade

<u>Compiled index series</u>: Concerning the index of persons employed, from the 1st quarter 2000 onwards, four time series are compiled as follows: 1) Overall Index, 2) Overall Index (excluding the persons employed in the automotive fuel sector), 3) Index of persons employed in the food sector and 4) Overall Index of persons employed in the non-food sector except automotive fuel.

Concerning, the time series of the hours worked, wages and salaries indices are complied from 1st quarter 2010 onwards. The above time series are published on ELSTAT's website:

<u>Publication of data</u>: The time series of the Index of persons employed in retail trade (2015=100.0) have being published since December 2018 (3rd quarter 2018), with revised data since 1st quarter 2000. The time series of the hours worked, and wages and salaries indices (2015=100.0) have been published since December 2018 (3rd quarter 2018), with retrospective data since 1st quarter 2010.

In the revised results of 3rd Quarter 2022, published in the current Announcement, newly collected data of enterprises have been incorporated.
