




EVOLUTION OF TURNOVER OF ENTERPRISES JULY 2025

The Hellenic Statistical Authority (ELSTAT) announces data on the evolution of turnover of enterprises in all sectors of the economy, incorporating the most recent data on turnover from Administrative Sources for **July 2025**.

For the enterprises of the economy as a whole, obliged to double-entry accounting bookkeeping, for which data are available on a monthly basis, the turnover in July 2025 amounted to 39,463,054 thousand euro, recording an increase of 2.2% in comparison with July 2024, when the respective turnover was 38,615,032 thousand euro (Graph 1, Table 1).

The biggest increase in turnover in July 2025 compared with July 2024 was recorded from the enterprises of the section Human Health and Social Work Activities, per 19.2%, while the biggest decrease was recorded from the enterprises of the section Electricity, Gas, Steam and Air Conditioning Supply, per 14.3% (Table 1).

** Extraordinary transactions were recorded in the data. Therefore, they are not published as they are not comparable.

Generally The current announcement provides statistical data on turnover for all enterprises and sections of the economy.

These statistical data have been compiled on the basis of the linking and processing of primary data from the following sources:

- The final Statistical Business Register of ELSTAT, of the reference year 2022.
- Administrative transactions files (tax, etc) of the reference years 2019 to 2025.

In particular, the following primary data have been used per source:

- Active enterprises and the economic activity class from the final Statistical Business Register of the reference year 2022.
- Income data from administrative transactions files of the reference years 2019 to 2025.

Statistical classifications For the economic activities, the European statistical classification of economic activities [NACE Rev. 2](#) is used.

Reference Period July 2025.

Statistical unit The statistical unit is the legal unit (distinct TIN).

Comparability The announced statistical data are comparable with the data of the final Statistical Business Register of ELSTAT, of the reference year 2022 (relevant link from the webpage of ELSTAT, where tables and information on the methodology applied are provided [Statistical Business Register](#)).
