



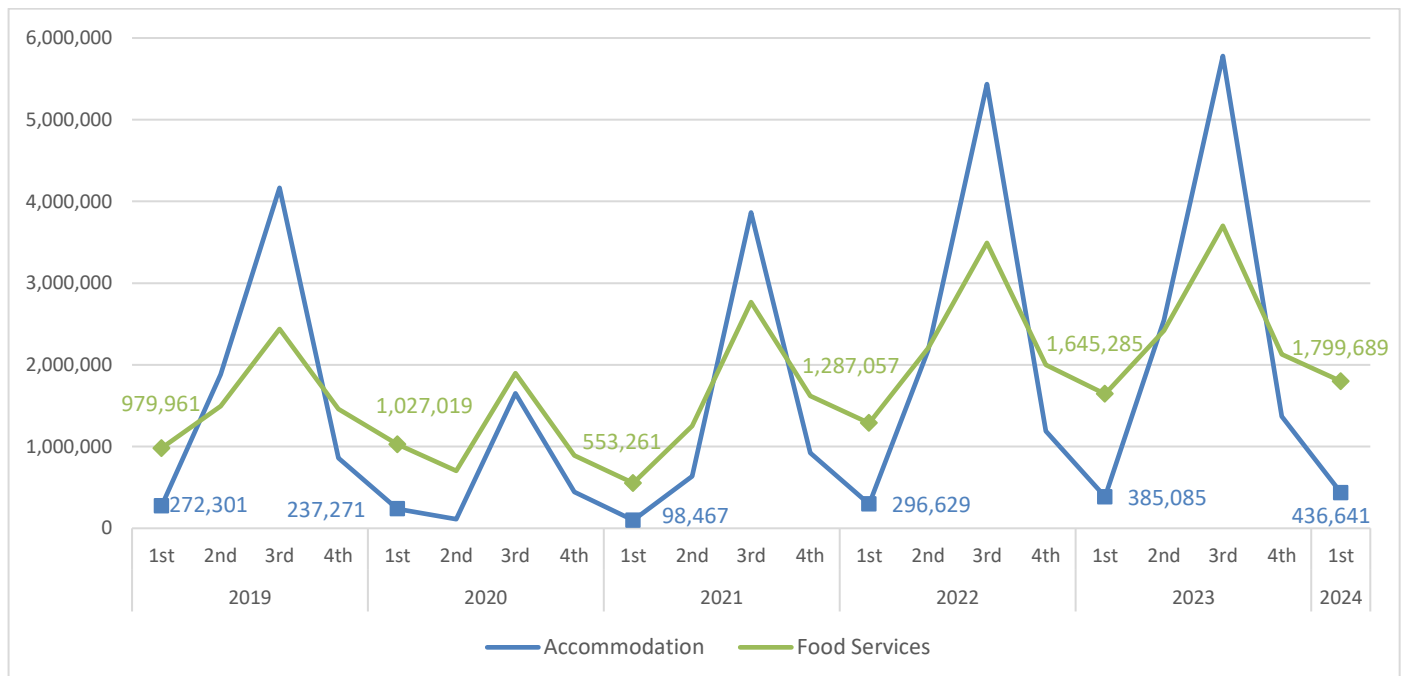
## EVOLUTION OF TURNOVER OF ENTERPRISES IN ACCOMMODATION AND FOOD SERVICE ACTIVITIES MARCH, 1<sup>st</sup> QUARTER 2024

The Hellenic Statistical Authority (ELSTAT) announces data on the evolution of turnover of enterprises in the Accommodation and Food and Beverage Service Activities divisions, per Regional Unit, incorporating the most recent data on turnover from Administrative Sources for **March and 1<sup>st</sup> quarter 2024**.

For the total of enterprises in **Accommodation Activities** (division 55 of NACE Rev. 2 classification), the turnover in the first quarter 2024 amounted to 436,641,282 euro, recording an increase of 13.4% in comparison with the first quarter 2023, when the respective turnover was 385,084,572 euro (Graph 1, Table 1).

For the total of enterprises in **Food and Beverage Service Activities** (division 56 of NACE Rev. 2 classification), the turnover in the first quarter 2024 amounted to 1,799,689,378 euro, recording an increase of 9.4% in comparison with the first quarter 2023, when the respective turnover was 1,645,284,897 euro (Graph1, Table 2).

For the enterprises in **Accommodation Activities** (division 55 of NACE Rev. 2 classification), of the Regional Units with a contribution to the total turnover of the year 2023 greater than 1.0% (Table 5), the biggest increase in the turnover of the first quarter 2024 compared to the first quarter of 2023 was recorded in the Regional Unit Kos (62.9%) and the smallest increase (5.2%) was recorded in the Regional Unit Thessaloniki, while a decrease was recorded in the Regional Units Thira (20.2%) (Table 1).

For the enterprises in **Food and Beverage Service Activities** (division 56 of NACE Rev. 2 classification), of the Regional Units with a contribution to the total turnover of the year 2023 greater than 1.0% (Table 5), the biggest increase in the turnover of the first quarter 2024 compared to the first quarter of 2023 was recorded in the Regional Unit Messinia (16.1%) and the smallest increase (1.8%) was recorded in the Regional Unit Zakynthos, while a decrease was recorded in the Regional Units Mykonos (11.2%) and Thira (2.0%) (Table 2).

For the enterprises in **Accommodation Activities** (division 55 of NACE Rev.2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in March 2024 amounted to 148,438,574 euro, recording an increase of 11.9% in comparison with March 2023, when the respective turnover was 132,613,175 euro (Table 3).

For the enterprises in **Food and Beverage Service Activities** (division 56 of NACE Rev.2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in March 2024 amounted to 200,162,454 euro, recording an increase of 15.7% in comparison with March 2023, when the respective turnover was 173,064,235 euro (Table 3).

In total, for the enterprises in **Accommodation and Food and Beverage Service Activities** (divisions 55 and 56 of NACE Rev. 2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in March 2024 amounted to 348,601,028 euro, recording an increase of 14.0% in comparison with March 2023, when the respective turnover was 305,677,410 euro (Table 3). For the Regional Units with a contribution to the total turnover of the year 2023 greater than 1.0% (Table 5), the biggest increase in the turnover of March 2024 compared with March 2023 was recorded in the Regional Unit Kos (83.3%) and the smallest increase (13.7%) was recorded in the Regional Unit Messinia (Table 4).

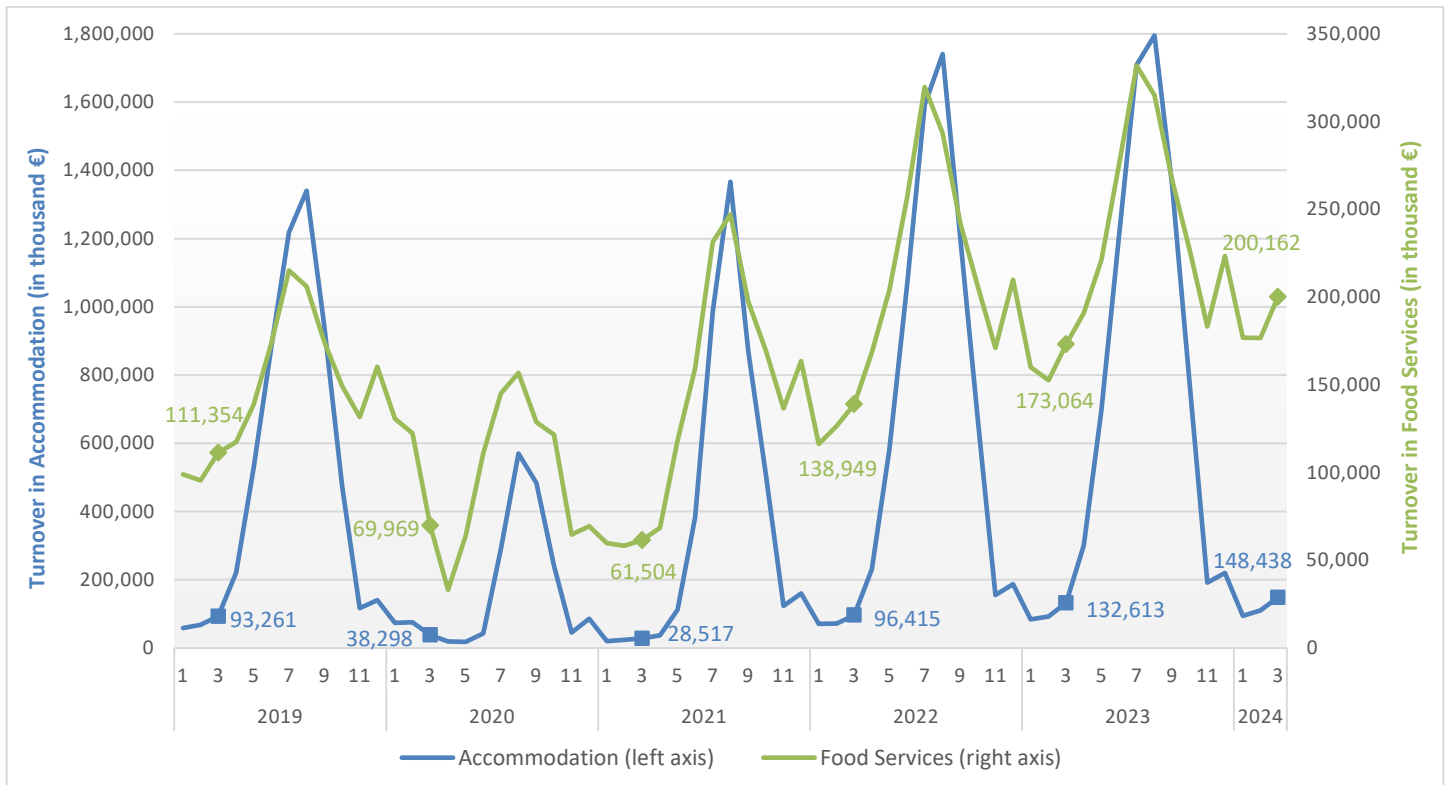

- The final Statistical Business Register of ELSTAT of the reference year 2021.
- Administrative registers of enterprises, of the reference years 2022 and 2023.
- Administrative transactions files (tax, etc) of the reference years 2019 to 2024.

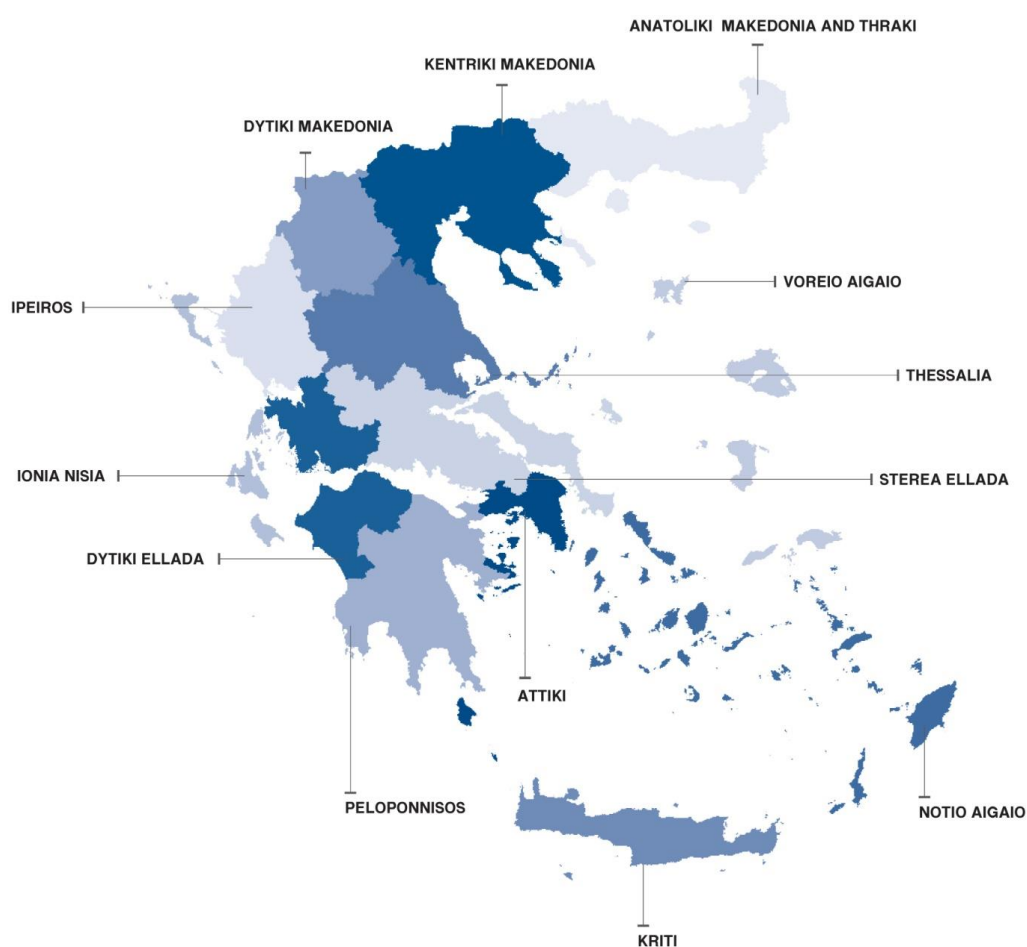
In particular the following primary data have been used per source:

- Active enterprises and the economic activity class from the final Statistical Business Register of the reference year 2021.
- The economic activity class for the enterprises that started their activity after the reference year 2021 and have a significant turnover, from administrative registers of enterprises of the reference years 2022 and 2023.
- Income data from administrative transaction files of the years 2019 to 2024.

It is noted that the geographical classification of enterprises is based on the location of the enterprise's headquarters.

**Statistical classifications** For the economic activities the European statistical classification of economic activities [NACE Rev.2](#) is used.
