EVOLUTION OF TURNOVER OF ENTERPRISES IN

ACCOMMODATION AND FOOD SERVICE ACTIVITIES

DECEMBER AND 4th QUARTER 2022 ANNUAL DATA 2022

The Hellenic Statistical Authority (ELSTAT) with this sectoral publication, presents the map with the evolution of the turnover of enterprises classified in the **Accommodation and Food and Beverage Service Activities** divisions. These economic activities have been over time in the focus of interest due to the significant weight they bear on the Greek economy as a whole, but also due to their extensive dispersion, with a significant presence in all regional units and a significant contribution to the respective local economies of Greece, often associated with the tourist product of the country.

The current publication is part of the announcements published by ELSTAT (<u>link</u>), since April 2020, incorporating the most recent data on turnover from Administrative Sources for **December and 4**th **quarter 2022.**

In particular, ELSTAT announces data on a monthly, quarterly and annual basis and at the regional unit country-level of analysis, for the turnover of enterprises classified in the divisions Accommodation and Food and Beverage Service Activities (divisions 55 and 56 of the NACE Rev.2 classification) for the period 2019-2022.

The published data can highlight, at a detailed local level, the current evolution in the performance, in terms of turnover, of enterprises having activity in key classes of the tourism sector and thus provide quick and highly relevant information on the evolution of the tourist product of Greece.

Specifically,

For the total of enterprises in **Accommodation Activities** (division 55 of NACE Rev. 2 classification), the turnover in 2022 amounted to 8,573,340,400 euro, recording an increase of 62.6% in comparison with 2021, when the respective turnover was 5,272,412,336 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2022 greater than 1.0%, the biggest increase in turnover in 2022 compared with 2021 was recorded in the Regional Unit Kefallinia (108,0%) and the smallest increase (28.6%) was recorded in the Regional Unit Lassithi. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2021 greater than 1.0%, the biggest increase in turnover in 2022 compared with 2021 was recorded in the Regional Unit Kos (85.3%) and the smallest increase (28.6%) was recorded in the Regional Unit Lassithi (Table 1).

For the total of enterprises in **Food and Beverage Service Activities** (division 56 of NACE Rev. 2 classification), the turnover in 2022 amounted to 7,882,914,951 euro, recording an increase of 41.5% in comparison with 2021, when the respective turnover was 5,571,079,508 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2022 greater than 1.0%, the biggest increase in turnover in 2022 compared with 2021 was recorded in the Regional Unit Zakynthos (81.4%) and the smallest increase (28.3%) was recorded in the Regional Unit Achaia. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2021 greater than 1.0%, the biggest increase in turnover in 2022 compared with 2021 was recorded in the Regional Unit Rodos (67.2%) and the smallest increase (28.3%) was recorded in the Regional Unit Achaia (Table 3).

In total, for the enterprises in Accommodation and Food and Beverage Service Activities (divisions 55 and 56 of NACE Rev. 2 classification), the turnover in 2022 amounted to 16,456,255,351 euro, recording an increase of 51.8% in comparison with 2021, when the respective turnover was 10,843,491,844 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2022 greater than 1.0% and for the enterprises of the Regional Units with a contribution to the total turnover of the year 2021 greater than 1.0%, the biggest increase in turnover in 2022 compared with 2021 was recorded in the Regional Unit Kos (83.3%) and the smallest increase (30.7%) was recorded in the Region Achaia (Table 5).

For the total of enterprises in **Accommodation Activities** (division 55 of NACE Rev. 2 classification), the turnover in the fourth quarter 2022 amounted to 1,122,153,207 euro, recording an increase of 27.2% in comparison with the fourth quarter 2021, when the respective turnover was 882,267,756 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2021 greater than 1.0% (Table 1), the biggest increase in the turnover of the fourth quarter 2022 compared to the fourth quarter of 2021 was recorded in the Regional Unit Zakynthos (46.3%) and the smallest increase (12.7%) was recorded in the Regional Unit Rethymno (Table 2).

For the total of enterprises in **Food and Beverage Service Activities** (division 56 of NACE Rev. 2 classification), the turnover in the fourth quarter 2022 amounted to 1,747,184,075 euro, recording an increase of 21.6% in comparison with the fourth quarter 2021, when the respective turnover was 1,436,552,567 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2021 greater than 1.0% (Table 3), the biggest increase in the turnover of the fourth quarter 2022 compared to the fourth quarter of 2021 was recorded in the Regional Unit Evia (33.5%) and the smallest increase (14.9%) was recorded in the Regional Unit Achaia (Table 4).

For the enterprises in **Accommodation Activities** (division 55 of NACE Rev.2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in December 2022 amounted to 175,800,135 euro, recording an increase of 15.1% in comparison with December 2021, when the respective turnover was 152,765,104 euro (Table 6).

For the enterprises in **Food and Beverage Service Activities** (division 56 of NACE Rev.2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in December 2022 amounted to 187,786,180 euro, recording an increase of 27.7% in comparison with December 2021, when the respective turnover was 147,067,072 euro (Table 6).

In total, for the enterprises in **Accommodation and Food and Beverage Service Activities** (divisions 55 and 56 of NACE Rev. 2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in December 2022 amounted to 363,586,315 euro, recording an increase of 21.3% in comparison with December 2021, when the respective turnover was 299,832,176 euro. For the Regional Units with a contribution to the total turnover of the year 2021 greater than 1.0% (Table 5), the biggest increase in the turnover of December 2022 compared with December 2021 was recorded in the Regional Unit Zakynthos (47.2%) and the smallest increase (9.5%) was recorded in the Regional Unit Magnissia, while the biggest decrease (15.5%) was recorded in the Regional Unit Chalkidiki (Table 7).






Graph 1: Annual turnover (in thousand €) for the total of enterprises in the Accommodation division (55 of NACE Rev. 2 classification)




Graph 2: Annual turnover (in thousand €) for the total of enterprises in the Food and Beverage Service Activities division (56 of NACE Rev. 2 classification)











METHODOLOGICAL NOTES

Generally

The statistical data presented in this announcement have been compiled on the basis of the linking and processing of primary data from the following sources:

- The final Statistical Business Register of ELSTAT of the reference year 2019.
- Administrative transactions files (tax etc) of the reference years 2019, 2020, 2021 and 2022.

In particular the following primary data have been used per source:

- Active enterprises and the economic activity class from the final Statistical Business Register of the reference year 2019.
- Income data from administrative transaction files of the years 2019, 2020, 2021 and 2022.

It is noted that the geographical classification of enterprises is based on the location of the enterprise's headquarters.

Statistical classifications

For the economic activities the European statistical classification of economic activities NACE Rev.2 is used.
