EVOLUTION OF TURNOVER OF ENTERPRISES IN

ACCOMMODATION AND FOOD SERVICE ACTIVITIES

SEPTEMBER AND 3rd QUARTER 2022

The Hellenic Statistical Authority (ELSTAT) with this sectoral publication, presents the map with the evolution of the turnover of enterprises classified in the **Accommodation and Food and Beverage Service Activities** divisions. These economic activities have been over time in the focus of interest due to the significant weight they bear on the Greek economy as a whole, but also due to their extensive dispersion, with a significant presence in all regional units and a significant contribution to the respective local economies of Greece, often associated with the tourist product of the country.

The current publication is part of the Press Releases series published by ELSTAT (<u>PR link</u>), since April 2020, incorporating the most recent data on turnover from Administrative Sources for **September and 3rd quarter 2022.**

In particular, ELSTAT announces data on a monthly basis and at the regional unit country-level of analysis, for the turnover of enterprises classified in the divisions Accommodation and Food and Beverage Service Activities (divisions 55 and 56 of the NACE Rev.2 classification) for the period 2019-2022.

The published data can highlight, at a detailed local level, the current evolution in the performance, in terms of turnover, of enterprises having activity in key classes of the tourism sector and thus provide quick and highly relevant information on the evolution of the tourist product of Greece.

Specifically,

For the total of enterprises in **Accommodation Activities (division 55 of NACE Rev.2 classification)**, the turnover in the third quarter 2022 amounted to 5,116,612,280 euro, recording an increase of 38.6% in comparison with the third quarter 2021, when the respective turnover was 3,691,771,473 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2021 greater than 1.0% (Table 1), the biggest increase in the turnover of the third quarter 2022 compared to the third quarter of 2021 was recorded in the Regional Unit Kos (60.6%) and the smallest increase (14.5%) was recorded in the Regional Unit Lassithi (Table 2).

For the total of enterprises in **Food and Beverage Service Activities (division 56 of NACE Rev.2 classification)**, the turnover in the third quarter 2022 amounted to 3,086,944,873 euro, recording an increase of 23.8% in comparison with the third quarter 2021, when the respective turnover was 2,493,793,109 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2021 greater than 1.0% (Table 1), the biggest increase in the turnover of the third quarter 2022 compared to the third quarter of 2021 was recorded in the Regional Unit Rodos (53.5%) and the smallest increase (2.8%) was recorded in the Regional Unit Achaia (Table 3).

For the enterprises in **Accommodation Activities (division 55 of NACE Rev.2 classification)**, **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in September 2022 amounted to 1,141,961,800 euro, recording an increase of 36.3% in comparison with September 2021, when the respective turnover was 837,649,666 euro (Table 4).

For the enterprises in **Food and Beverage Service Activities (division 56 of NACE Rev.2 classification)**, **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in September 2022 amounted to 212,441,653 euro, recording an increase of 20.4% in comparison with September 2021, when the respective turnover was 176,433,963 euro (Table 4).

For the enterprises in Accommodation and Food and Beverage Service Activities (divisions 55 and 56 of NACE Rev. 2 classification), obliged to double-entry bookkeeping, for which data are available on a monthly basis, the turnover in September 2022 amounted to 1,354,403,453 euro, recording an increase of 33.6% in comparison with September 2021, when the respective turnover was 1,014,083,628 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2021 greater than 1.0% (Table 1), the biggest increase in the turnover of September 2022 compared with September 2021 was recorded in the Regional Unit Kos (48.2%) and the smallest increase (6.5%) was recorded in the Regional Unit Achaia (Table 5).

- The final Statistical Business Register of ELSTAT of the reference year 2019.
- Administrative transactions files (tax etc) of the reference years 2019, 2020, 2021 and 2022.

In particular the following primary data have been used per source:

- Active enterprises and the economic activity class from the final Statistical Business Register of the reference year 2019.
- Income data from administrative transaction files of the years 2019, 2020, 2021 and 2022.

It is noted that the geographical classification of enterprises is based on the location of the enterprise's headquarters.

Statistical For the economic activities the European statistical classification of economic activities NACE Rev.2 is used. **classifications**
