



DEMOGRAPHIC EVENTS OF ENTERPRISES REGISTRATIONS AND BANKRUPTCIES 4th QUARTER 2023 ANNUAL DATA 2023

The Hellenic Statistical Authority (ELSTAT) announces data on business demography in Greece and specifically on <u>Registrations</u> and <u>Bankruptcies</u>, for the **4th quarter 2023** and for the **year 2023**.

In specific, the number of registrations in all economic sections in **2023** amounted to 112,002, recording an increase of 6.1% in comparison with 2022, when the respective number was 105,565 (Graph 1, Table 1).

Annual data (Table 1)

- <u>Registrations</u>: Among the sections of economic activity with the biggest contribution to the total turnover, according to the data of the Statistical Business Register for the reference year 2020 (Table 2), the biggest increase in the number of registrations in **2023** in comparison with 2022, was recorded in section "Construction" (16.1%) and in section "Transportation and Storage" (16.1%), while a decrease was recorded in section "Electricity, Gas, Steam and Air Conditioning Supply" (56.1%) and in section "Information and Communication" (3.7%).
- The number of bankruptcies in all economic sections in 2023 amounted to 11, while the number of bankruptcies for 2022 are not disclosed for statistical confidentiality reasons regarding the protection of the identity of the enterprises.

Quarterly data (Table 2)

The number of registrations in all economic sections in the 4th quarter 2023 amounted to 27,542, recording a decrease of 9.2% in comparison with the 4th quarter 2022, when the respective number was 30,316 and an increase of 18.0% in comparison with the 3rd quarter 2023, when the respective number was 23,350.

Among the sections of economic activity with the largest contribution to the total turnover, according to the data of the Statistical Business Register for the reference year 2020, the biggest increase in the number of registrations in the **4**th **quarter 2023** compared with the 4th quarter 2022, was recorded in section "Transportation and Storage" (37.2%) and in section "Construction" (13.4%), while the biggest decrease was recorded in section "Electricity, Gas, Steam and Air Conditioning Supply" (65.4%) and in section "Information and Communication" (25.8%).

The number of bankruptcies in all economic sections in the 4th quarter of 2023 amounted to 5 in comparison with the 4th quarter 2022, when the respective number was 3.

Sections of Economic Activity by Large Geographical Area (NUTS 1) of Greece, 4th quarter 2023 (Table 3)

The sections of economic activity with the biggest number of registrations by Large Geographical Area of Greece are:

- Voreia Ellada: "Wholesale and Retail Trade; Repair of Motor Vehicles and Motorcycles", with 984 registrations out of 6,112 in total.
- Kentriki Ellada: "Agriculture, Forestry and Fishing"⁽¹⁾, with 1,978 registrations out of 6,201 in total.
- Attiki: "Professional, Scientific and Technical Activities" with 2,211 registrations out of 11,602 in total.
- Nissia Aigaiou Kriti: "Agriculture, Forestry and Fishing"⁽¹⁾, with 1,370 registrations out of 3,627 in total.

¹ <u>Note</u>: The data recorded for the economic activity section Agriculture, Forestry and Fishing include farmers subjected to the special regime (of VAT), i.e. farmers who are registered in the tax registry of farmers, having both received subsidies of value less than 5,000 euro during the previous tax year and conducted during the previous tax year, sales of agricultural products of own production, as well as provision of agricultural services of value less than 15,000 euro, to any person.

Sections of Economic Activity by category of Legal Form of enterprise, 4th quarter 2023 (Table 4)

The sections of economic activity with the biggest number of registrations by category of Legal Form of enterprise are:

- Sole Proprietorships: "Agriculture, Forestry and Fishing"⁽¹⁾, with 4,732 registrations out of 17,908 in total.
- **Partnerships:** "Wholesale and Retail Trade; Repair of Motor Vehicles and Motorcycles", with 984 registrations out of 4,471 in total.
- Capital Enterprises: "Real Estate Activities", with 114 registrations out of 464 in total.
- **Other Legal Forms:** "Wholesale and Retail Trade; Repair of Motor Vehicles and Motorcycles", with 794 registrations and "Real Estate Activities" with 794 registrations out of 4,699 in total.








Graph 3. Number of Registrations per week of the years 2022 and 2023





METHODOLOGICAL NOTES

GeneralThe compilation of the statistical data is made in accordance with the new European Regulation on BusinessInformationStatistics, which entered into force on the 1st of January 2021 (Regulation (EU) 2019/2152 of the European
Parliament and of the Council of 27th November 2019) and is among the key changes introduced by this Regulation
for new and high-frequency official business statistics at European level.

The statistical data presented in this announcement refer to business demography and more specifically to the registrations and bankruptcies of enterprises, which are defined as follows:

<u>Registrations</u>: The number of entered legal units in the registration register at any time during the reference quarter, according to the respective administrative or legal procedure.

Bankruptcies: The number of legal units that have started the procedure of being declared bankrupt, by issuing a court declaration, at any time during the reference quarter (which is often provisional and does not always mean cessation of an activity).

- **Purpose** The purpose of the short-term business statistics, is to provide up-to-date and high frequency information on the evolution of business activity and, subsequently, of the economic climate expectations.
- Legal framework
 Short-term business statistics are compiled in accordance with Regulation (EU) 2019/2152 of the European Parliament and of the Council of 27th November 2019, on European business statistics and Commission Implementing Regulation (EU) 2020/1197 of 30th July 2020, laying down technical specifications and arrangements pursuant to Regulation (EU) 2019/2152.
 - CompilationThe statistical data have been compiled after processing quarterly data from administrative registers of enterprises,methodologySpecifically, information has been used for the date of registration in the register of legal units (Tax Identification
Number TIN), economic activity, geographical code, legal form and business status of the enterprise.
 - StatisticalAs regards the economic activities, the European statistical classification of economic activities MACE Rev.2 is used.classificationsAs regards the geographical representation, the European Nomenclature of territorial units for statistics, NUTS, is used.
